## A BILL

- 5 made available to the Committees on Appropriations of the
- 6 Senate and House of Representatives and to the President.
- 7 The President shall provide for suitable distribution of the
- 8 Schedule, or of appropriate portions of the Schedule, within
- 9 the executive branch.
- 10 SEC. 103. PERSONNEL CEILING ADJUSTMENTS.
- 11 (a) AUTHORITY FOR ADJUSTMENTS.—With the ap-
- 12 proval of the Director of the Office of Management and
- 13 Budget, the Director of National Intelligence may authorize
- 14 employment of civilian personnel in excess of the number
- 15 authorized for fiscal year 2006 under section 102 when the
- 16 Director of National Intelligence determines that such ac-
- 17 tion is necessary to the performance of important intel-
- 18 ligence functions.
- 19 (b) Notice to Intelligence Committees.—The Di-
- 20 rector of National Intelligence shall notify promptly the Se-
- 21 lect Committee on Intelligence of the Senate and the Perma-

3	(a) Authorization of Appropriations.—There is
4	authorized to be appropriated for the Intelligence Commu-
5	nity Management Account of the Director of National Intel-
6	ligence for fiscal year 2006 the sum of \$446,144,000. Within
7	such amount, funds identified in the classified Schedule of
8	Authorizations referred to in section 102(a) for advanced
9	research and development shall remain available until Sep-
10	tember 30, 2007.
11	(b) Authorized Personnel Levels.—The elements
12	within the Intelligence Community Management Account of
13	the Director of National Intelligence are authorized 817
14	full-time personnel as of September 30, 2006. Personnel
15	serving in such elements may be permanent employees of
16	the Intelligence Community Management Account or per-
17	sonnel detailed from other elements of the United States
18	Government.
19	(c) Classified Authorizations.—
20	(1) Authorization of Appropriations.—In
21	addition to amounts authorized to be appropriated

6	(5) a plan to incorporate technology from re-
7	search and development projects into National Intel-
8	ligence Program acquisition programs.
9	SEC. 307. COMPREHENSIVE INVENTORY OF SPECIAL AC-
10	CESS PROGRAMS.
11	Not later than January 15, 2006, the Director of Na-
12	tional Intelligence shall submit to the congressional intel-
13	ligence committees (as defined in section 3(7) of the Na-
14	tional Security Act of 1947 (50 U.S.C. 401a(7))) a classi-
15	fied report providing a comprehensive inventory of all spe-
16	cial access programs under the National Intelligence Pro-
17	gram (as defined in section 3(6) of the National Security
18	Act of 1947 (50 U.S.C. 401a(6))).
19	SEC. 308. SENSE OF CONGRESS ON BUDGET EXECUTION AU-
20	THORITY PROCEDURES.
21	It is the sense of Congress that the Director of National
22	Intelligence should expeditiously establish the necessary
23	budgetary processes and procedures with the heads of the
24	departments containing agencies or organizations within

the intelligence community, and the heads of such agencies 1 and organizations, in order to— 3 (1) implement the budget execution authorities 4 provided under, and submit the reports to Congress 5 required by, subsection (c) of section 102A of the Na-6 tional Security Act of 1947 (50 U.S.C. 403-1), as 7 amended by section 1011(a) of the National Security 8 Intelligence Reform Act of 2004 (title I of Public Law 9 108–458; 118 Stat. 3643); and 10 (2) carry out the duties and authorities of the 11 Director of National Intelligence with respect to the 12 transfer and reprogramming of funds under the Na-13 tional Intelligence Program under subsection (d) of 14 such section, as so amended. 15 SEC. 309. SENSE OF CONGRESS WITH RESPECT TO MULTI-16 LEVEL SECURITY CLEARANCES. 17 It is the sense of Congress that the Director of National 18 Intelligence should promptly establish and oversee the implementation of a multi-level security clearance system 19 across the intelligence community to leverage the cultural 21 and linguistic skills of subject matter experts and individuals proficient in foreign languages critical to national se-23 curity.
