A BILL

To amend the Carl D. Perkins Vocational and Technical
Education Act of 1998 to improve the Act.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE; TABLE OF CONTENTS.**

3 **SEC. 2. REFERENCES.**

4 Except as otherwise expressly provided, wherever in
 5 this Act an amendment or repeal is expressed in terms
 6 of an amendment to, or repeal of, a section or other provi-
 7 sion, the reference shall be considered to be made to a

1 section or other provision of the Carl D. Perkins Voca-
 2 tional and Technical Education Act of 1998 (20 U.S.C.
 3 2301 et seq.).

4 **SEC. 3. PURPOSE.**

5 Section 2 (20 U.S.C. 2301) is amended—

6 (1) by striking “vocational” each place the term
 7 appears and inserting “career”;

8 (2) in paragraph (1), by striking “standards”
 9 and inserting “and technical standards, and to assist
 10 students in meeting such standards, especially in
 11 preparation for high skill, high wage, or high de-
 12 mand occupations in emerging or established profes-
 13 sions”;

14 (3) in paragraph (2), by inserting “challenging”
 15 after “integrate”;

16 (4) in paragraph (3), by striking “and” after
 17 the semicolon;

18 (5) in paragraph (4)—

19 (A) by inserting “conducting and” before
 20 “disseminating national”;

21 (B) by inserting “disseminating informa-
 22 tion on best practices,” after “national re-
 23 search,”; and

24 (C) by striking the period at the end and
 25 inserting a semicolon; and

1 (6) by adding at the end the following:

2 “~~(5)~~ promoting leadership and professional de-
3 velopment at the State and local levels; and devel-
4 oping research and best practices for improving the
5 quality of career and technical education teachers;
6 faculty; principals; administrators; and counselors;

7 “~~(6)~~ supporting partnerships among secondary
8 schools; postsecondary institutions; area career tech-
9 nical centers; business and industry; professional as-
10 sociations; and intermediaries; and

11 “~~(7)~~ developing a highly skilled workforce need-
12 ed to keep America competitive in the global econ-
13 omy in conjunction with other Federal education and
14 training programs; including workforce investment
15 programs; that provide lifelong learning for the
16 workforce of today and tomorrow.”.

17 **SEC. 4. DEFINITIONS.**

18 Section 3 (20 U.S.C. 2302) is amended—

19 (1) in paragraph (2), by inserting “, including
20 employment statistics and information relating to
21 national, regional, and local labor market areas; as
22 provided pursuant to section 118; and career ladder
23 information; where appropriate” after “to enter”;

24 (2) in paragraph (3)—

1 (A) in the paragraph heading, by striking
2 “~~VOCATIONAL~~” and inserting “~~CAREER~~”; and

3 (B) by striking “~~vocational~~” each place the
4 term appears and inserting “~~career~~”;

5 (3) by striking paragraph (4);

6 (4) by redesignating paragraphs (5) through
7 (30) as paragraphs (10) through (35), respectively;

8 (5) by inserting after paragraph (3) the fol-
9 lowing:

10 “(4) ~~ARTICULATION AGREEMENT.~~—The term
11 ‘~~articulation agreement~~’ means a written commit-
12 ment, approved annually by the relevant administra-
13 tors of the secondary and postsecondary institutions,
14 to a program that is designed to provide students
15 with a nonduplicative sequence of progressive
16 achievement leading to technical skill proficiency, a
17 credential, a certificate, or a degree, and linked
18 through credit transfer agreements.

19 “(5) ~~CAREER AND TECHNICAL EDUCATION.~~—
20 The term ‘~~career and technical education~~’ means or-
21 ganized educational activities that—

22 “(A) offer a sequence of courses (which
23 may include technical learning experiences)
24 that—

1 “(i) provides individuals with the chal-
 2 lenging academic and technical knowledge
 3 and skills the individuals need to prepare
 4 for further education and for careers in
 5 emerging and established professions; and

6 “(ii) may lead to technical skill pro-
 7 ficiency, a credential, a certificate, or a de-
 8 gree; and

9 “(B) include competency-based applied
 10 learning that contributes to the academic
 11 knowledge, higher-order reasoning and problem-
 12 solving skills, work attitudes, general employ-
 13 ability skills, technical skills, and occupation-
 14 specific skills, of an individual.

15 “(6) CAREER AND TECHNICAL EDUCATION STU-
 16 DENT.—The term ‘career and technical education
 17 student’ means a student who enrolls in a clearly de-
 18 fined sequence of career and technical education
 19 courses leading to attainment of technical skill pro-
 20 ficiency, a credential, a certificate, or a degree.

21 “(7) CAREER AND TECHNICAL STUDENT ORGA-
 22 NIZATION.—

23 “(A) IN GENERAL.—The term ‘career and
 24 technical student organization’ means an orga-
 25 nization for individuals enrolled in a career and

1 technical education program that engages in ca-
 2 reer and technical education activities as an in-
 3 tegral part of the instructional program.

4 “(B) STATE AND NATIONAL UNITS.—An
 5 organization described in subparagraph (A)
 6 may have State and national units that aggre-
 7 gate the work and purposes of instruction in ca-
 8 reer and technical education at the local level.

9 “(8) CAREER GUIDANCE AND ACADEMIC COUN-
 10 SELING.—The term ‘career guidance and academic
 11 counseling’ means providing access to information
 12 regarding career awareness and planning with re-
 13 spect to an individual’s occupational and academic
 14 future that shall involve guidance and counseling
 15 with respect to career options, financial aid, and
 16 postsecondary options.

17 “(9) CAREER PATHWAY.—The term ‘career
 18 pathway’ means a coordinated and nonduplicative
 19 sequence of courses (which may include technical
 20 learning experiences) and associated credits that—

21 “(A) shall identify both secondary and
 22 postsecondary education elements;

23 “(B) shall include challenging academic
 24 and career and technical education content;

1 “(C) may include the opportunity for sec-
 2 ondary students to participate in dual or con-
 3 current enrollment programs or other ways to
 4 acquire postsecondary credits; and

5 “(D) may culminate in technical skill pro-
 6 ficiency, a credential, a certificate, or a de-
 7 gree.”;

8 (6) in paragraph (10) (as redesignated by para-
 9 graph (4) of this section), by striking “5206” and
 10 inserting “5210”;

11 (7) by redesignating paragraphs (11) through
 12 (35) (as redesignated by paragraph (4) of this sec-
 13 tion) as paragraphs (12) through (36), respectively;

14 (8) by inserting after paragraph (10) (as redesi-
 15 gnated by paragraph (4) of this section) the fol-
 16 lowing:

17 “(11) COMMUNITY COLLEGE.—The term ‘com-
 18 munity college’—

19 “(A) means an institution of higher edu-
 20 cation, as defined in section 101 of the Higher
 21 Education Act of 1965, that provides not less
 22 than a 2-year program that is acceptable for
 23 full credit toward a baccalaureate degree; and

24 “(B) includes tribally controlled colleges or
 25 universities.”;

1 (9) in paragraph (12) (as redesignated by para-
2 graph (7) of this section)—

3 (A) by striking “method of instruction”
4 and inserting “method”; and

5 (B) by striking “vocational” and inserting
6 “career”;

7 (10) by redesignating paragraphs (13) through
8 (36) (as redesignated by paragraph (7) of this sec-
9 tion) as paragraphs (14) through (37), respectively;

10 (11) by inserting after paragraph (12) the fol-
11 lowing:

12 “(13) CORE ACADEMIC SUBJECTS.—The term
13 ‘core academic subjects’ has the meaning given the
14 term in section 9101 of the Elementary and Sec-
15 ondary Education Act of 1965, except that under
16 this Act such subjects included in such term shall be
17 only those subjects in a secondary school context.”;

18 (12) in paragraph (16) (as redesignated by
19 paragraph (10) of this section), by striking “voca-
20 tional” both places the term appears and inserting
21 “career”;

22 (13) in paragraph (17) (as redesignated by
23 paragraph (10) of this section)—

24 (A) in subparagraph (A), by striking “an
25 institution of higher education” and inserting

1 “a public or nonprofit private institution of
 2 higher education that offers career and tech-
 3 nical education courses that lead to technical
 4 skill proficiency, an industry-recognized creden-
 5 tial, a certificate, or a degree”; and

6 (B) in subparagraph (C), by striking “vo-
 7 cational” and inserting “career”;

8 (14) in paragraph (18)(A) (as redesignated by
 9 paragraph (10) of this section), by striking “agency,
 10 an area vocational” and inserting “agency (including
 11 a public charter school that operates as a local edu-
 12 cational agency); an area career”;

13 (15) by redesignating paragraphs (20) through
 14 (37) (as redesignated by paragraph (10) of this sec-
 15 tion) as paragraphs (21) through (38), respectively;

16 (16) by inserting after paragraph (19) (as re-
 17 designating by paragraph (10) of this section) the
 18 following:

19 “(20) GRADUATION AND CAREER PLAN.—The
 20 term ‘graduation and career plan’ means a written
 21 plan for a secondary career and technical education
 22 student, that—

23 “(A) is developed with career guidance and
 24 academic counseling or other professional staff,
 25 and in consultation with parents, not later than

1 in the first year of secondary school or upon en-
 2 rollment in career and technical education;

3 “(B) is reviewed annually and modified as
 4 needed;

5 “(C) includes relevant information on—

6 “(i) secondary school requirements for
 7 graduating with a diploma;

8 “(ii) postsecondary education admis-
 9 sion requirements; and

10 “(iii) high skill, high wage, or high de-
 11 mand occupations and nontraditional fields
 12 in emerging and established professions,
 13 and labor market indicators; and

14 “(D) states the student’s secondary school
 15 graduation goals, postsecondary education and
 16 training, or employment goals, and identifies 1
 17 or more career pathways that correspond to the
 18 goals.”;

19 (17) in paragraph (25) (as redesignated by
 20 paragraph (15) of this section)—

21 (A) in the paragraph heading, by striking
 22 “TRAINING AND EMPLOYMENT” and inserting
 23 “FIELDS”; and

24 (B) by striking “training and employment”
 25 and inserting “fields”;

1 (18) in paragraph (26) (as redesignated by
2 paragraph (15) of this section), by striking “the
3 Commonwealth” and all that follows through the pe-
4 riod and inserting “and the Commonwealth of the
5 Northern Mariana Islands.”;

6 (19) by redesignating paragraphs (31) through
7 (38) (as redesignated by paragraph (15) of this sec-
8 tion) as paragraphs (32) through (39), respectively;

9 (20) by inserting after paragraph (30) (as re-
10 designated by paragraph (15) of this section) the
11 following:

12 “(31) SELF-SUFFICIENCY.—The term ‘self-suf-
13 ficiency’ means a standard that is adopted, cal-
14 culated, or commissioned by a local area or State,
15 and which adjusts for local factors, in specifying the
16 income needs of families, by family size, the number
17 and ages of children in the family, and sub-State
18 geographical considerations.”;

19 (21) in paragraph (32) (as redesignated by
20 paragraph (19) of this section)—

21 (A) in subparagraph (C), by striking
22 “training and employment” and inserting
23 “fields”; and

1 (B) in subparagraph (F), by striking “indi-
2 viduals with other barriers to educational
3 achievement, including”;

4 (22) in paragraph (34) (as redesignated by
5 paragraph (19) of this section) by striking “; and in-
6 structional aids and devices” and inserting “instruc-
7 tional aids, and work supports”;

8 (23) by striking paragraph (35) (as redesi-
9 gnated by paragraph (19) of this section) and insert-
10 ing the following:

11 “(35) TECH-PREP PROGRAM.—The term ‘tech-
12 prep program’ means a program of study that—

13 “(A) combines at a minimum 2 years of
14 secondary education (as determined under State
15 law) with a minimum of 2 years of postsec-
16 ondary education in a nonduplicative, sequential
17 course of study;

18 “(B) integrates academic and career and
19 technical education instruction, and utilizes
20 work-based and worksite learning where appro-
21 priate and available;

22 “(C) provides technical preparation in a
23 career field, including high skill, high wage, or
24 high demand occupations;

1 “(D) builds student competence in tech-
 2 nical skills and in core academic subjects, as
 3 appropriate, through applied, contextual, and
 4 integrated instruction, in a coherent sequence
 5 of courses;

6 “(E) leads to technical skill proficiency, a
 7 credential, a certificate, or a degree, in a spe-
 8 cific career field;

9 “(F) leads to placement in appropriate em-
 10 ployment or to further education; and

11 “(G) utilizes career pathways, to the extent
 12 practicable.”;

13 (24) in paragraph (37) (as redesignated by
 14 paragraph (19) of this section)—

15 (A) in the paragraph heading, by striking
 16 “VOCATIONAL” and inserting “CAREER”;

17 (B) in the matter preceding subparagraph
 18 (A)—

19 (i) by striking “vocational” and in-
 20 serting “career”;

21 (ii) by striking “paragraph (2)” and
 22 inserting “subsection (a)(2)”; and

23 (iii) by striking “paragraph (5)(A)”
 24 and inserting “subsection (a)(5)”; and

1 (C) in subparagraph (F), by striking “vo-
2 eational” and inserting “career”; and
3 (25) by striking paragraphs (38) and (39) (as
4 redesignated by paragraph (19) of this section).

5 **SEC. 5. TRANSITION PROVISIONS.**

6 Section 4 (20 U.S.C. 2303) is amended by striking
7 “the Carl D. Perkins Vocational and Applied Technology
8 Education Act” and all that follows through the period
9 and inserting “this Act, as this Act was in effect on the
10 day before the date of enactment of the Carl D. Perkins
11 Career and Technical Education Improvement Act of
12 2005. Each eligible agency shall be assured a full fiscal
13 year for transition to plan for and implement the require-
14 ments of this Act.”.

15 **SEC. 6. LIMITATION.**

16 Section 6 (20 U.S.C. 2305) is amended by striking
17 the second sentence.

18 **SEC. 7. AUTHORIZATION OF APPROPRIATIONS.**

19 Section 8 (20 U.S.C. 2307) is amended—

20 (1) by striking “title II” and inserting “part D
21 of title I”; and

22 (2) by striking “1999 through 2003” and in-
23 serting “2006 through 2011”.

4 **SEC. 101. CAREER AND TECHNICAL EDUCATION ASSIST-**
 5 **ANCE TO THE STATES.**

6 Title I (20 U.S.C. 2321 et seq.) is amended by strik-
 7 ing the title heading and inserting the following:

8 **“TITLE I—CAREER AND TECH-**
 9 **NICAL EDUCATION ASSIST-**
 10 **ANCE TO THE STATES”.**

11 **SEC. 102. RESERVATIONS AND STATE ALLOTMENT.**

12 Section 111(a) (20 U.S.C. 2321(a)) is amended—

13 (1) in paragraph (1)(C), by striking “2001
 14 through 2003,” and inserting “2006 through 2011,
 15 not more than”;

16 (2) in paragraph (2), in the matter preceding
 17 subparagraph (A), by striking “paragraph (1)” and
 18 inserting “paragraph (1), that are not allotted under
 19 paragraph (5),”;

20 (3) in paragraph (3)—

21 (A) in subparagraph (B), by striking “(or
 22 in the case” and all that follows through
 23 “1998)”;

24 (B) in subparagraph (C)—

1 (i) in clause (i)(I), by striking “(or in
2 the ease” and all that follows through
3 “1998)”; and

4 (ii) in clause (ii)(II), by striking “(or
5 in the ease” and all that follows through
6 “1998)”; and

7 (4) by adding at the end the following:

8 “(5) FORMULA FOR AMOUNTS IN EXCESS OF
9 THE FISCAL YEAR 2005 FUNDING LEVEL.—

10 “(A) IN GENERAL.—For any fiscal year
11 for which the remainder of the sums appro-
12 priated under section 8 and not reserved under
13 paragraph (1) exceeds the remainder of the
14 sums appropriated under section 8 and not re-
15 served under paragraph (1) for fiscal year
16 2005, such excess amount shall be allotted to
17 the States according to the formula under sub-
18 paragraphs (A) through (D) of paragraph (2).

19 “(B) MINIMUM ALLOTMENT.—

20 “(i) IN GENERAL.—Notwithstanding
21 any other provision of law and subject to
22 clause (ii), no State shall receive for a fis-
23 cal year under this paragraph less than $\frac{1}{2}$
24 of 1 percent of the excess amount de-
25 scribed in subparagraph (A).

1 “(ii) REQUIREMENT.—No State, by
2 reason of the application of clause (i), shall
3 be allotted under this paragraph for a fis-
4 cal year more than the amount determined
5 by multiplying—

6 “(I) the number of individuals in
7 the State counted under paragraph
8 (2); by

9 “(II) 185 percent of the national
10 average per pupil payment made with
11 the excess amount described in sub-
12 paragraph (A) for that year.”.

13 **SEC. 103. WITHIN STATE ALLOCATION.**

14 Section 112 (20 U.S.C. 2322) is amended—

15 (1) in subsection (a)—

16 (A) in paragraph (1), by adding “and”
17 after the semicolon; and

18 (B) by striking paragraphs (2) and (3) and
19 inserting the following:

20 “(2) not more than 15 percent for—

21 “(A) State leadership activities described
22 in section 124, of which—

23 “(i) an amount determined by the eli-
24 gible agency shall be made available to
25 serve individuals in State institutions; such

1 as State correctional institutions and insti-
 2 tutions that serve individuals with disabili-
 3 ties; and

4 “(ii) not less than \$60,000 shall be
 5 available for services that prepare individ-
 6 uals for nontraditional fields; and

7 “(B) administration of the State plan;
 8 which may be used for the costs of—

9 “(i) developing the State plan;

10 “(ii) reviewing the local plans;

11 “(iii) monitoring and evaluating pro-
 12 gram effectiveness;

13 “(iv) assuring compliance with all ap-
 14 plicable Federal laws;

15 “(v) providing technical assistance;
 16 and

17 “(vi) supporting and developing State
 18 data systems relevant to the provisions of
 19 this Act.”;

20 (2) in subsection (b), by striking “subsection
 21 (a)(3)” both places the term appears and inserting
 22 “subsection (a)(2)(B)”; and

23 (3) by striking subsection (c) and inserting the
 24 following:

1 “(e) RESERVE.—From amounts made available
2 under subsection (a)(1) to carry out this subsection, an
3 eligible agency may—

4 “(1) award grants to eligible recipients, or con-
5 sortia of eligible recipients, for career and technical
6 education activities described in section 135 in—

7 “(A) rural areas; or

8 “(B) areas with high percentages or high
9 numbers of career and technical education stu-
10 dents;

11 “(2) reserve funds, with the approval of partici-
12 pating eligible recipients, for—

13 “(A) innovative statewide initiatives that
14 demonstrate benefits for eligible recipients,
15 which may include—

16 “(i) developing and implementing
17 technical assessments;

18 “(ii) improving the professional devel-
19 opment of career and technical education
20 teachers, faculty, principals, and adminis-
21 trators; and

22 “(iii) establishing, enhancing, and
23 supporting systems for accountability data
24 collection or reporting purposes; or

1 “(B) the development and implementation
 2 of career pathways or career clusters; and
 3 “(3) carry out activities described in para-
 4 graphs (1) and (2).”.

5 **SEC. 104. ACCOUNTABILITY.**

6 Section 113 (20 U.S.C. 2323) is amended—

7 (1) by striking “vocational” each place the term
 8 appears and inserting “career”;

9 (2) in subsection (a)—

10 (A) by striking “a State performance ac-
 11 countability system” and inserting “and sup-
 12 port State and local performance accountability
 13 systems”; and

14 (B) by inserting “and its eligible recipi-
 15 ents” after “of the State”;

16 (3) in subsection (b)—

17 (A) in paragraph (1)—

18 (i) in subparagraph (A), by striking
 19 “paragraph (2)(A)” and inserting “sub-
 20 paragraphs (A) and (B) of paragraph (2)”;
 21 and

22 (ii) in subparagraph (B), by striking
 23 “(2)(B)” and inserting “(2)(C)”;

24 (B) in paragraph (2)—

1 (i) by striking subparagraph (A) and
2 inserting the following:

3 “(A) CORE INDICATORS OF PERFORMANCE
4 FOR SECONDARY CAREER AND TECHNICAL EDU-
5 CATION STUDENTS.—Each eligible agency shall
6 identify in the State plan core indicators of per-
7 formance for secondary career and technical
8 education students that include, at a minimum,
9 measures of each of the following:

10 “(i) Student achievement on technical
11 assessments and attainment of career and
12 technical skill proficiencies that are aligned
13 with nationally recognized industry stand-
14 ards, if available and appropriate.

15 “(ii) Student attainment of chal-
16 lenging academic content standards and
17 student academic achievement standards,
18 as adopted by the State under section
19 1111(b)(1) of the Elementary and Sec-
20 ondary Education Act of 1965 and meas-
21 ured by the academic assessments de-
22 scribed in section 1111(b)(3) of such Act,
23 consistent with State requirements.

24 “(iii) Student rates of attainment
25 of—

1 “(I) a secondary school diploma;

2 “(II) the recognized equivalent of

3 a secondary school diploma;

4 “(III) technical skill proficiency;

5 “(IV) a credential;

6 “(V) a certificate; and

7 “(VI) a degree.

8 “(iv) Placement in postsecondary edu-
9 cation, military service, apprenticeship pro-
10 grams, or employment.

11 “(v) Student participation in, and
12 completion of, career and technical edu-
13 cation programs that lead to employment
14 in nontraditional fields.”;

15 (ii) by redesignating subparagraphs
16 (B) through (D) as subparagraphs (C)
17 through (E), respectively;

18 (iii) by inserting after subparagraph
19 (A) the following:

20 “(B) CORE INDICATORS OF PERFORMANCE
21 FOR POSTSECONDARY CAREER AND TECHNICAL
22 STUDENTS.—Each eligible agency shall identify
23 in the State plan core indicators of performance
24 for postsecondary career and technical edu-

1 cation students that include, at a minimum,
2 measures of each of the following:

3 “(i) Student achievement on technical
4 assessments and attainment of career and
5 technical skill proficiencies that are aligned
6 with nationally recognized industry stand-
7 ards, if available and appropriate.

8 “(ii) Student attainment of technical
9 skill proficiency, a credential, a certificate,
10 or a degree, or retention in postsecondary
11 education, including transfer to a bacea-
12 laurate degree program.

8 stantial progress in meeting the purpose of this Act,
9 based on the State’s adjusted levels of performance,
10 the Secretary shall work with the eligible agency to
11 implement improvement activities consistent with the
12 requirements of this Act.

14 “(A) IN GENERAL.—If an eligible agency
15 fails to meet the State adjusted levels of per-
16 formance, has not implemented an improvement
17 plan as described in paragraph (1), has shown

22 consecutive years, the Secretary may, after no-
23 tice and opportunity for a hearing, withhold

4 the progress being made toward reaching
5 the local adjusted levels of performance, as

7 progress on implementing the improvement
8 plan.

9 “~~(B)~~ CONSULTATION.—The eligible agency
10 shall conduct the activities described in sub-
11 paragraph ~~(A)~~ in consultation with teachers,
12 principals, administrators, faculty, parents,
13 other school staff, appropriate agencies, and
14 other appropriate individuals and organizations.

15 “~~(3)~~ TECHNICAL ASSISTANCE.—If the eligible
16 agency determines that an eligible recipient is not
17 properly implementing the eligible recipient’s respon-
18 sibilities under section ~~134~~, or is not making sub-
19 stantial progress in meeting the purpose of this Act,
