AN ACT

To reauthorize the National Sea Grant College Program Act, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "National Sea Grant
- 5 College Program Act Amendments of 2002".
- 6 SEC. 2. AMENDMENTS TO FINDINGS.
- 7 Section 202(a)(6) of the National Sea Grant College
- 8 Program Act (33 U.S.C. 1121(a)(6)) is amended by strik-
- 9 ing the period at the end and inserting ", including strong

- 1 collaborations between Administration scientists and sci-
- 2 entists at academic institutions.".
- 3 SEC. 3. REQUIREMENTS APPLICABLE TO NATIONAL SEA
- 4 GRANT COLLEGE PROGRAM.
- 5 (a) Quadrennial Strategic Plan.—Section 204
- 6 (c)(1) of the National Sea Grant College Program Act (33
- 7 U.S.C. 1123 (c)(1)) is amended to read as follows:
- 8 "(1) The Secretary, in consultation with the
- 9 panel, sea grant colleges, and sea grant institutes,
- shall develop at least every 4 years a strategic plan
- that establishes priorities for the national sea grant
- 12 college program, provides an appropriately balanced
- response to local, regional, and national needs, and
- is reflective of integration with the relevant portions
- of the strategic plans of the Department of Com-
- merce and of the Administration.".
- 17 (b) Ranking of Programs.—Section 204(d)(3)(A)
- 18 of the National Sea Grant College Program Act (33
- 19 U.S.C. 1123(d)(3)(A)) is amended by inserting "and com-
- 20 petitively rank" after "evaluate".
- 21 (c) Functions of Director.—Section
- 22 204(d)(3)(B) of the National Sea Grant College Program
- 23 Act (33 U.S.C. 1123(d)(3)(B)) is amended by striking
- 24 "and" after the semicolon at the end of clause (ii) and
- 25 by adding at the end the following:

1 "(iv) encourage and promote coordi-2 nation and cooperation between the re-3 search, education, and outreach programs 4 of the Administration and those of aca-5 demic institutions; and".

6 SEC. 4. COST SHARE.

- 7 Section 205(a) of the National Sea Grant College
- 8 Program Act (33 U.S.C. 1124(a)) is amended by striking
- 9 "section 204(d)(6)" and inserting "section 204(c)(4)(F)".

10 SEC. 5. FELLOWSHIPS.

- 11 (a) Access.—Section 208(a) of the National Sea
- 12 Grant College Program Act (33 U.S.C. 1127(a)) is
- 13 amended by adding at the end the following: "The Sec-
- 14 retary shall strive to ensure equal access for minority and
- 15 economically disadvantaged students to the program car-
- 16 ried out under this subsection. Not later than 1 year after
- 17 the date of the enactment of the National Sea Grant Col-
- 18 lege Program Act Amendments of 2002, and every 2 years
- 19 thereafter, the Secretary shall submit a report to the Con-
- 20 gress describing the efforts by the Secretary to ensure
- 21 equal access for minority and economically disadvantaged
- 22 students to the program carried out under this subsection,
- 23 and the results of such efforts.".

- 1 (b) Postdoctoral Fellows.—Section 208(c) of
- 2 the National Sea Grant College Program Act (33 U.S.C.
- 3 1127(c)) is repealed.
- 4 SEC. 6. TERMS OF MEMBERSHIP FOR SEA GRANT REVIEW
- 5 PANEL.
- 6 Section 209(c)(2) of the National Sea Grant College
- 7 Program Act (33 U.S.C. 1128(c)(2)) is amended by strik-
- 8 ing the first sentence and inserting the following: "The
- 9 term of office of a voting member of the panel shall be
- 10 3 years for a member appointed before the date of enact-
- 11 ment of the National Sea Grant College Program Act
- 12 Amendments of 2002, and 4 years for a member ap-
- 13 pointed or reappointed after the date of enactment of the
- 14 National Sea Grant College Program Act Amendments of
- 15 2002. The Director may extend the term of office of a
- 16 voting member of the panel appointed before the date of
- 17 enactment of the National Sea Grant College Program Act
- 18 Amendments of 2002 by up to 1 year.".
- 19 SEC. 7. AUTHORIZATION OF APPROPRIATIONS.
- Subsections (a), (b), and (c) of section 212 of the
- 21 National Sea Grant College Program Act (33 U.S.C.
- 22 1131) are amended to read as follows:
- 23 "(a) Authorization.—

1	"(1) In general.—There is authorized to be
2	appropriated to the Secretary to carry out this
3	title—
4	"(A) \$60,000,000 for fiscal year 2003;
5	"(B) \$75,000,000 for fiscal year 2004;
6	"(C) $77,500,000$ for fiscal year 2005;
7	"(D) \$80,000,000 for fiscal year 2006;
8	"(E) $$82,500,000$ for fiscal year 2007; and
9	"(F) $$85,000,000$ for fiscal year 2008.
10	"(2) Priority activities.—In addition to the
11	amount authorized under paragraph (1), there is au-
12	thorized to be appropriated for each of fiscal years
13	2003 through 2008—
14	"(A) \$5,000,000 for competitive grants for
15	university research on the biology and control
16	of zebra mussels and other important aquatic
17	nonnative species;
18	"(B) \$5,000,000 for competitive grants for
19	university research on oyster diseases, oyster
20	restoration, and oyster-related human health
21	risks;
22	"(C) \$5,000,000 for competitive grants for
23	university research on the biology, prevention,
24	and forecasting of harmful algal blooms, includ-
25	ing Pfiesteria piscicida; and

1	"(D) \$3,000,000 for competitive grants for
2	fishery extension activities conducted by sea
3	grant colleges or sea grant institutes.
4	"(b) Program Elements.—
5	"(1) Limitation.—No more than 5 percent of
6	the lesser of—
7	"(A) the amount authorized to be appro-
8	priated; or
9	"(B) the amount appropriated,
10	for each fiscal year under subsection $(a)(1)$ may be
11	used to fund the program element contained in sec-
12	tion $204(b)(2)$.
13	"(2) Use for other offices or pro-
14	GRAMS.—Sums appropriated under the authority of
15	subsection (a)(2) shall not be available for adminis-
16	tration of this title by the National Sea Grant Of-
17	fice, for any other Administration or department
18	program, or for any other administrative expenses.
19	"(c) Distribution of Funds.—In any fiscal year
20	in which the appropriations made under subsection $(a)(1)$
21	exceed the amounts appropriated for fiscal year 2002 for
22	the purposes described in such subsection, the Secretary
23	shall distribute any excess amounts (except amounts used
24	for the administration of the sea grant program) to—

1	"(1) sea grant programs that, based on the
2	evaluation and competitive ranking required under
3	section 204(d)(3)(A), are determined to be the best
4	managed and to carry out the highest quality re-
5	search, education, extension, and training activities;
6	"(2) national strategic investments authorized
7	under section 204(b)(4);
8	"(3) a college, university, institution, associa-
9	tion, or alliance for activities that are necessary for
10	it to be designated as a sea grant college or sea
11	grant institute; or
12	"(4) a sea grant college or sea grant institute
13	designated after the date of enactment of the Na-
14	tional Sea Grant College Program Act Amendments
15	of 2002.".
16	SEC. 8. ANNUAL REPORT ON PROGRESS IN BECOMING DES-
17	IGNATED AS SEA GRANT COLLEGES AND SEA
18	GRANT INSTITUTES.
19	Section 207 of the National Sea Grant College Pro-
20	gram Act (16 U.S.C. 1126) is amended by adding at the
21	end the following:
22	"(e) Annual Report on Progress.—
23	"(1) Report requirement.—The Secretary
24	shall report annually to the Committee on Resources
25	and the Committee on Science of the House of Rep-

1	resentatives, and to the Committee on Commerce,
2	Science, and Transportation of the Senate, on ef-
3	forts and progress made by colleges, universities, in-
4	stitutions, associations, and alliances to become des-
5	ignated under this section as sea grant colleges or
6	sea grant institutes, including efforts and progress
7	made by sea grant institutes in being designated as
8	sea grant colleges.
9	"(2) Territories and freely associated
10	STATES.—The report shall include description of—
11	"(A) efforts made by colleges, universities,
12	associations, institutions, and alliances in
13	United States territories and freely associated
14	States to develop the expertise necessary to be
15	designated as a sea grant institute or sea grant
16	college;
17	"(B) the administrative, technical, and fi-
18	nancial assistance provided by the Secretary to
19	those entities seeking to be designated; and
20	"(C) the additional actions or activities

"(C) the additional actions or activities necessary for those entities to meet the qualifications for such designation under subsection (a)(1)."

1 SEC. 9. COORDINATION.

- 2 Not later than February 15 of each year, the Under
- 3 Secretary of Commerce for Oceans and Atmosphere and
- 4 the Director of the National Science Foundation shall
- 5 jointly submit to the Committees on Resources and
- 6 Science of the House of Representatives and the Com-
- 7 mittee on Commerce, Science, and Transportation of the
- 8 Senate a report on how the oceans and coastal research
- 9 activities of the National Oceanic and Atmospheric Ad-
- 10 ministration, including the Coastal Ocean Program and
- 11 the National Sea Grant College Program, and of the Na-
- 12 tional Science Foundation will be coordinated during the
- 13 fiscal year following the fiscal year in which the report
- 14 is submitted. The report shall describe in detail any over-
- 15 lapping ocean and coastal research interests between the
- 16 agencies and specify how such research interests will be
- 17 pursued by the programs in a complementary manner.

- 19 Section 201(c) of Public Law 102–567 is amended
- 20 by—
- 21 (1) striking "Of the sums authorized under
- subsection (b)(1), \$17,352,000 for each of the fiscal
- years 1992 and 1993 are authorized to be appro-
- priated" and inserting "There are authorized to be
- appropriated to the Secretary of Commerce
