| 8 | (a) Requirements Applicable to the Director |

| 10 | United States Code (commonly referred to as the "Paper- |
| 11 | work Reduction Act"), is amended— |
| 12 | (1) in paragraph (4), by striking "; and" and |
| 13 | inserting a semicolon; |
| 14 | (2) in paragraph (5), by striking the period and |

| 17 | paragraphs: |

- 13 Tact.—Section 3506 of such chapter 35 is amended by
- 14 adding at the end the following new subsection:

- 16 section (c), each agency shall, with respect to the collection
- 17 of information and the control of paperwork, establish one
- 18 point of contact in the agency to act as a liaison between
- 19 the agency and small-business concerns (within the mean-
- 20 ing of section 3 of the Small Business Act (15 U.S.C. 631
- 21 et seq.)).".

| 11 | "(a) There is hereby established a task force (in this |
| 12 | section referred to as the 'task force') to study the feasi- |
| 13 | bility of streamlining requirements with respect to small- |
| 14 | business concerns regarding collection of information and |
| 15 | strengthening dissemination of information. |
| 16 | "(b) The members of the task force shall be ap- |
| 17 | pointed by the Director, and shall include the following |
| 18 | "(1) At least two representatives of the Depart- |
| 19 | ment of Labor, including one representative of the |
| 20 | Bureau of Labor Statistics and one representative of |
| 21 | the Occupational Safety and Health Administration |
| 22 | "(2) At least one representative of the Environ- |

| 19 | garding such collections of information, in order that each |

- "(D) recommendations, created in consultation with the Chief Information Officers Council (established pursuant to Executive Order 13011, issued July 16, 1996), for the coordination of information among the points of contact described in section 3506(i), so that those points of contact can provide small-business concerns with information collection requirements from other agencies.
- 13 "(e) As used in this section, the term 'small-business 14 concern' has the meaning given that term under section
- 15 3 of the Small Business Act (15 U.S.C. 631 et seq.).".
- 16 (b) Conforming Amendment.—The table of sec-
- 17 tions at the beginning of such chapter is amended by in-
- 18 serting after the item relating to section 3520 the fol-
- 19 lowing new item:

"3521. Establishment of task force on feasibility of streamlining information collection requirements and dissemination.".
