

***In the Senate of the United States,***

*November 3, 1999.*

*Resolved*, That the bill from the House of Representatives (H.R. 3194) entitled “An Act making appropriations for the government of the District of Columbia and other activities chargeable in whole or in part against revenues of said District for the fiscal year ending September 30, 2000, and for other purposes.”, do pass with the following

**AMENDMENT:**

Strike out all after the enacting clause and insert:

1 *That, the following sums are appropriated, out of any*  
2 *money in the Treasury not otherwise appropriated, for the*  
3 *District of Columbia for the fiscal year ending September*  
4 *30, 2000, and for other purposes, namely:*

5 *TITLE I—FISCAL YEAR 2000 APPROPRIATIONS*

6 *FEDERAL FUNDS*

7 *FEDERAL PAYMENT FOR RESIDENT TUITION SUPPORT*

8 *For a Federal payment to the District of Columbia*

9 *for a program to be administered by the Mayor for District*

1 of Columbia resident tuition support, subject to the enact-  
2 ment of authorizing legislation for such program by Con-  
3 gress, \$17,000,000, to remain available until expended: Pro-  
4 vided, That such funds may be used on behalf of eligible  
5 District of Columbia residents to pay an amount based  
6 upon the difference between in-State and out-of-State tui-  
7 tion at public institutions of higher education, usable at  
8 both public and private institutions of higher education:  
9 Provided further, That the awarding of such funds may be  
10 prioritized on the basis of a resident's academic merit and  
11 such other factors as may be authorized: Provided further,  
12 That if the authorized program is a nationwide program,  
13 the Mayor may expend up to \$17,000,000: Provided further,  
14 That if the authorized program is for a limited number of  
15 States, the Mayor may expend up to \$11,000,000: Provided  
16 further, That the District of Columbia may expend funds  
17 other than the funds provided under this heading, including  
18 local tax revenues and contributions, to support such pro-  
19 gram.

22 *For a Federal payment to the District of Columbia*  
23 *to create incentives to promote the adoption of children in*  
24 *the District of Columbia foster care system, \$5,000,000:*  
25 *Provided, That such funds shall remain available until Sep-*

1 tember 30, 2001 and shall be used in accordance with a  
2 program established by the Mayor and the Council of the  
3 District of Columbia and approved by the Committees on  
4 Appropriations of the House of Representatives and the  
5 Senate: Provided further, That funds provided under this  
6 heading may be used to cover the costs to the District of  
7 Columbia of providing tax credits to offset the costs in-  
8 curred by individuals in adopting children in the District  
9 of Columbia foster care system and in providing for the  
10 health care needs of such children, in accordance with legis-  
11 lation enacted by the District of Columbia government.

20 *For a Federal payment to the Department of Human*  
21 *Services for a mentoring program and for hotline services,*  
22 *\$250,000.*

1     *FEDERAL PAYMENT TO THE DISTRICT OF COLUMBIA*2                     *CORRECTIONS TRUSTEE OPERATIONS*

3             *For salaries and expenses of the District of Columbia*  
4 *Corrections Trustee, \$176,000,000 for the administration*  
5 *and operation of correctional facilities and for the adminis-*  
6 *trative operating costs of the Office of the Corrections Trust-*  
7 *ee, as authorized by section 11202 of the National Capital*  
8 *Revitalization and Self-Government Improvement Act of*  
9 *1997 (Public Law 105-33; 111 Stat. 712): Provided, That*  
10 *notwithstanding any other provision of law, funds appro-*

2 *For payments authorized under section 11–2604 and*  
3 *section 11–2605, D.C. Code (relating to representation pro-*  
4 *vided under the District of Columbia Criminal Justice Act),*  
5 *payments for counsel appointed in proceedings in the Fam-*  
6 *ily Division of the Superior Court of the District of Colum-*  
7 *bia under chapter 23 of title 16, D.C. Code, and payments*  
8 *for counsel authorized under section 21–2060, D.C. Code*  
9 *(relating to representation provided under the District of*  
10 *Columbia Guardianship, Protective Proceedings, and Dura-*  
11 *ble Power of Attorney Act of 1986), \$33,336,000, to remain*  
12 *available until expended: Provided, That the funds provided*  
13 *in this Act under the heading “Federal Payment to the Dis-*  
14 *trict of Columbia Courts” (other than the \$8,000,000 pro-*  
15 *vided under such heading for capital improvements for Dis-*  
16 *trict of Columbia courthouse facilities) may also be used*

18 *in addition to the funds provided under this heading, the*

1 *FEDERAL PAYMENT TO THE COURT SERVICES AND OF-*  
2 *FENDER SUPERVISION AGENCY FOR THE DISTRICT OF*  
3 *COLUMBIA*

4 *For salaries and expenses of the Court Services and*  
5 *Offender Supervision Agency for the District of Columbia,*  
6 *as authorized by the National Capital Revitalization and*  
7 *Self-Government Improvement Act of 1997, (Public Law*  
8 *105-33; 111 Stat. 712), \$93,800,000, of which \$58,600,000*  
9 *shall be for necessary expenses of Parole Revocation, Adult*  
10 *Probation, Offender Supervision, and Sex Offender Reg-*  
11 *istration, to include expenses relating to supervision of*  
12 *adults subject to protection orders or provision of services*  
13 *for or related to such persons; \$17,400,000 shall be available*  
14 *to the Public Defender Service; and \$17,800,000 shall be*  
15 *available to the Pretrial Services Agency: Provided, That*  
16 *notwithstanding any other provision of law, all amounts*  
17 *under this heading shall be apportioned quarterly by the*  
18 *Office of Management and Budget and obligated and ex-*  
19 *pended in the same manner as funds appropriated for sala-*  
20 *ries and expenses of other Federal agencies: Provided fur-*  
21 *ther, That of the amounts made available under this head-*  
22 *ing, \$20,492,000 shall be used in support of universal drug*  
23 *screening and testing for those individuals on pretrial, pro-*  
24 *bation, or parole supervision with continued testing, inter-*



1 *mediate sanctions, and treatment for those identified in*  
2 *need, of which \$7,000,000 shall be for treatment services.*

3 *CHILDREN'S NATIONAL MEDICAL CENTER*

4 *For a Federal contribution to the Children's National*  
5 *Medical Center in the District of Columbia, \$2,500,000 for*  
6 *construction, renovation, and information technology infra-*  
7 *structure costs associated with establishing community pe-*  
8 *diatric health clinics for high risk children in medically un-*  
9 *derserved areas of the District of Columbia.*

10 *FEDERAL PAYMENT FOR METROPOLITAN POLICE*

12 *For payment to the Metropolitan Police Department,*  
13 *\$1,000,000, for a program to eliminate open air drug traf-*

15 *Chief of Police shall provide quarterly reports to the Com-*  
16 *mittees on Appropriations of the Senate and House of Rep-*  
17 *resentatives by the 15th calendar day after the end of each*  
18 *quarter beginning December 31, 1999, on the status of the*  
19 *project financed under this heading.*

20 *DISTRICT OF COLUMBIA FUNDS*

21 *OPERATING EXPENSES*

22 *DIVISION OF EXPENSES*

23 *The following amounts are appropriated for the Dis-*  
24 *trict of Columbia for the current fiscal year out of the gen-*

1 eral fund of the District of Columbia, except as otherwise  
2 specifically provided.

3 *GOVERNMENTAL DIRECTION AND SUPPORT*

4 *Governmental direction and support, \$162,356,000*  
5 *(including \$137,134,000 from local funds, \$11,670,000 from*  
6 *Federal funds, and \$13,552,000 from other funds): Pro-*  
7 *vided, That not to exceed \$2,500 for the Mayor, \$2,500 for*  
8 *the Chairman of the Council of the District of Columbia,*  
9 *and \$2,500 for the City Administrator shall be available*  
10 *from this appropriation for official purposes: Provided fur-*  
11 *ther, That any program fees collected from the issuance of*  
12 *debt shall be available for the payment of expenses of the*  
13 *debt management program of the District of Columbia: Pro-*  
14 *vided further, That no revenues from Federal sources shall*  
15 *be used to support the operations or activities of the State-*  
16 *hood Commission and Statehood Compact Commission:*  
17 *Provided further, That the District of Columbia shall iden-*  
18 *tify the sources of funding for Admission to Statehood from*  
19 *its own locally-generated revenues: Provided further, That*  
20 *all employees permanently assigned to work in the Office*  
21 *of the Mayor shall be paid from funds allocated to the Office*  
22 *of the Mayor: Provided further, That, notwithstanding any*  
23 *other provision of law now or hereafter enacted, no Member*  
24 *of the District of Columbia Council eligible to earn a part-*  
25 *time salary of \$92,520, exclusive of the Council Chairman,*

1 *shall be paid a salary of more than \$84,635 during fiscal*  
2 *year 2000.*

3 *ECONOMIC DEVELOPMENT AND REGULATION*

4 *Economic development and regulation, \$190,335,000*  
5 *(including \$52,911,000 from local funds, \$84,751,000 from*  
6 *Federal funds, and \$52,673,000 from other funds), of which*  
7 *\$15,000,000 collected by the District of Columbia in the*  
8 *form of BID tax revenue shall be paid to the respective*  
9 *BIDs pursuant to the Business Improvement Districts Act*  
10 *of 1996 (D.C. Law 11-134; D.C. Code, sec. 1-2271 et seq.),*  
11 *and the Business Improvement Districts Temporary*  
12 *Amendment Act of 1997 (D.C. Law 12-23): Provided, That*  
13 *such funds are available for acquiring services provided by*  
14 *the General Services Administration: Provided further,*  
15 *That Business Improvement Districts shall be exempt from*  
16 *taxes levied by the District of Columbia.*

17 *PUBLIC SAFETY AND JUSTICE*

18 *Public safety and justice, including purchase or lease*  
19 *of 135 passenger-carrying vehicles for replacement only, in-*  
20 *cluding 130 for police-type use and five for fire-type use,*  
21 *without regard to the general purchase price limitation for*  
22 *the current fiscal year, \$778,770,000 (including*  
23 *\$565,511,000 from local funds, \$29,012,000 from Federal*  
24 *funds, and \$184,247,000 from other funds): Provided, That*  
25 *the Metropolitan Police Department is authorized to replace*

1 *not to exceed 25 passenger-carrying vehicles and the De-*  
2 *partment of Fire and Emergency Medical Services of the*  
3 *District of Columbia is authorized to replace not to exceed*  
4 *five passenger-carrying vehicles annually whenever the cost*  
5 *of repair to any damaged vehicle exceeds three-fourths of*  
6 *the cost of the replacement: Provided further, That not to*  
7 *exceed \$500,000 shall be available from this appropriation*  
8 *for the Chief of Police for the prevention and detection of*  
9 *crime: Provided further, That the Metropolitan Police De-*  
10 *partment shall provide quarterly reports to the Committees*  
11 *on Appropriations of the House of Representatives and the*  
12 *Senate on efforts to increase efficiency and improve the pro-*  
13 *fessionalism in the department: Provided further, That not-*  
14 *withstanding any other provision of law, or Mayor's Order*  
15 *86-45, issued March 18, 1986, the Metropolitan Police De-*  
16 *partment's delegated small purchase authority shall be*  
17 *\$500,000: Provided further, That the District of Columbia*  
18 *government may not require the Metropolitan Police De-*  
19 *partment to submit to any other procurement review proc-*  
20 *ess, or to obtain the approval of or be restricted in any*  
21 *manner by any official or employee of the District of Co-*  
22 *lumbia government, for purchases that do not exceed*  
23 *\$500,000: Provided further, That the Mayor shall reimburse*  
24 *the District of Columbia National Guard for expenses in-*  
25 *curred in connection with services that are performed in*

1 *emergencies by the National Guard in a militia status and*  
2 *are requested by the Mayor, in amounts that shall be jointly*  
3 *determined and certified as due and payable for these serv-*  
4 *ices by the Mayor and the Commanding General of the Dis-*  
5 *trict of Columbia National Guard: Provided further, That*  
6 *such sums as may be necessary for reimbursement to the*  
7 *District of Columbia National Guard under the preceding*  
8 *proviso shall be available from this appropriation, and the*  
9 *availability of the sums shall be deemed as constituting*  
10 *payment in advance for emergency services involved: Pro-*  
11 *vided further, That the Metropolitan Police Department is*  
12 *authorized to maintain 3,800 sworn officers, with leave for*  
13 *a 50 officer attrition: Provided further, That no more than*  
14 *15 members of the Metropolitan Police Department shall*  
15 *be detailed or assigned to the Executive Protection Unit,*  
16 *until the Chief of Police submits a recommendation to the*  
17 *Council for its review: Provided further, That \$100,000*  
18 *shall be available for inmates released on medical and geri-*  
19 *atric parole: Provided further, That commencing on Decem-*  
20 *ber 31, 1999, the Metropolitan Police Department shall pro-*  
21 *vide to the Committees on Appropriations of the Senate and*  
22 *House of Representatives, the Committee on Governmental*  
23 *Affairs of the Senate, and the Committee on Government*  
24 *Reform of the House of Representatives, quarterly reports*  
25 *on the status of crime reduction in each of the 83 police*

1 *service areas established throughout the District of Colum-*  
2 *bia: Provided further, That up to \$700,000 in local funds*  
3 *shall be available for the operations of the Citizen Com-*  
4 *plaint Review Board.*

5 *PUBLIC EDUCATION SYSTEM*

6 *Public education system, including the development of*  
7 *national defense education programs, \$867,411,000 (includ-*  
8 *ing \$721,847,000 from local funds, \$120,951,000 from Fed-*  
9 *eral funds, and \$24,613,000 from other funds), to be allo-*  
10 *cated as follows: \$713,197,000 (including \$600,936,000*  
11 *from local funds, \$106,213,000 from Federal funds, and*  
12 *\$6,048,000 from other funds), for the public schools of the*  
13 *District of Columbia; \$10,700,000 from local funds for the*  
14 *District of Columbia Teachers' Retirement Fund;*  
15 *\$17,000,000 from local funds, previously appropriated in*  
16 *this Act as a Federal payment, for resident tuition support*  
17 *at public and private institutions of higher learning for eli-*  
18 *gible District of Columbia residents; \$27,885,000 from local*  
19 *funds for public charter schools: Provided, That if the en-*  
20 *tirety of this allocation has not been provided as payments*  
21 *to any public charter schools currently in operation through*  
22 *the per pupil funding formula, the funds shall be available*  
23 *for new public charter schools on a per pupil basis: Pro-*  
24 *vided further, That \$480,000 of this amount shall be avail-*  
25 *able to the District of Columbia Public Charter School*

1 *Board for administrative costs; \$72,347,000 (including*  
2 *\$40,491,000 from local funds, \$13,536,000 from Federal*  
3 *funds, and \$18,320,000 from other funds) for the University*  
4 *of the District of Columbia; \$24,171,000 (including*  
5 *\$23,128,000 from local funds, \$798,000 from Federal funds,*  
6 *and \$245,000 from other funds) for the Public Library;*  
7 *\$2,111,000 (including \$1,707,000 from local funds and*  
8 *\$404,000 from Federal funds) for the Commission on the*  
9 *Arts and Humanities: Provided further, That the public*  
10 *schools of the District of Columbia are authorized to accept*  
11 *not to exceed 31 motor vehicles for exclusive use in the driv-*  
12 *er education program: Provided further, That not to exceed*  
13 *\$2,500 for the Superintendent of Schools, \$2,500 for the*  
14 *President of the University of the District of Columbia, and*  
15 *\$2,000 for the Public Librarian shall be available from this*  
16 *appropriation for official purposes: Provided further, That*  
17 *none of the funds contained in this Act may be made avail-*  
18 *able to pay the salaries of any District of Columbia Public*  
19 *School teacher, principal, administrator, official, or em-*  
20 *ployee who knowingly provides false enrollment or attend-*  
21 *ance information under article II, section 5 of the Act enti-*  
22 *tled "An Act to provide for compulsory school attendance,*  
23 *for the taking of a school census in the District of Columbia,*  
24 *and for other purposes", approved February 4, 1925 (D.C.*  
25 *Code, sec. 31-401 et seq.): Provided further, That this ap-*

1 *proprietion shall not be available to subsidize the education*  
2 *of any nonresident of the District of Columbia at any Dis-*  
3 *trict of Columbia public elementary and secondary school*  
4 *during fiscal year 2000 unless the nonresident pays tuition*  
5 *to the District of Columbia at a rate that covers 100 percent*  
6 *of the costs incurred by the District of Columbia which are*  
7 *attributable to the education of the nonresident (as estab-*  
8 *lished by the Superintendent of the District of Columbia*  
9 *Public Schools): Provided further, That this appropriation*  
10 *shall not be available to subsidize the education of non-*  
11 *residents of the District of Columbia at the University of*  
12 *the District of Columbia, unless the Board of Trustees of*  
13 *the University of the District of Columbia adopts, for the*  
14 *fiscal year ending September 30, 2000, a tuition rate sched-*  
15 *ule that will establish the tuition rate for nonresident stu-*  
16 *dents at a level no lower than the nonresident tuition rate*  
17 *charged at comparable public institutions of higher edu-*  
18 *cation in the metropolitan area: Provided further, That the*  
19 *District of Columbia Public Schools shall not spend less*  
20 *than \$365,500,000 on local schools through the Weighted*  
21 *Student Formula in fiscal year 2000: Provided further,*  
22 *That notwithstanding any other provision of law, the Chief*  
23 *Financial Officer of the District of Columbia shall appor-*  
24 *tion from the budget of the District of Columbia Public*  
25 *Schools a sum totaling 5 percent of the total budget to be*



1 *set aside until the current student count for Public and*  
2 *Charter schools has been completed, and that this amount*  
3 *shall be apportioned between the Public and Charter schools*  
4 *based on their respective student population count: Pro-*  
5 *vided further, That the District of Columbia Public Schools*  
6 *may spend \$500,000 to engage in a Schools Without Vio-*  
7 *lence program based on a model developed by the University*  
8 *of North Carolina, located in Greensboro, North Carolina.*

9 *HUMAN SUPPORT SERVICES*

10 *Human support services, \$1,526,361,000 (including*  
11 *\$635,373,000 from local funds, \$875,814,000 from Federal*  
12 *funds, and \$15,174,000 from other funds): Provided, That*  
13 *\$25,150,000 of this appropriation, to remain available*  
14 *until expended, shall be available solely for District of Co-*  
15 *lumbia employees' disability compensation: Provided fur-*  
16 *ther, That a peer review committee shall be established to*  
17 *review medical payments and the type of service received*  
18 *by a disability compensation claimant: Provided further,*  
19 *That the District of Columbia shall not provide free govern-*  
20 *ment services such as water, sewer, solid waste disposal or*  
21 *collection, utilities, maintenance, repairs, or similar serv-*  
22 *ices to any legally constituted private nonprofit organiza-*  
23 *tion, as defined in section 411(5) of the Stewart B. McKin-*  
24 *ney Homeless Assistance Act (101 Stat. 485; Public Law*  
25 *100-77; 42 U.S.C. 11371), providing emergency shelter*

1 *services in the District, if the District would not be quali-*  
2 *fied to receive reimbursement pursuant to such Act (101*  
3 *Stat. 485; Public Law 100-77; 42 U.S.C. 11301 et seq.).*

#### 4 *PUBLIC WORKS*

5 *Public works, including rental of one passenger-car-*  
6 *rying vehicle for use by the Mayor and three passenger-car-*  
7 *rying vehicles for use by the Council of the District of Co-*  
8 *lumbia and leasing of passenger-carrying vehicles,*  
9 *\$271,395,000 (including \$258,341,000 from local funds,*  
10 *\$3,099,000 from Federal funds, and \$9,955,000 from other*  
11 *funds): Provided, That this appropriation shall not be*  
12 *available for collecting ashes or miscellaneous refuse from*  
13 *hotels and places of business.*

#### 14 *RECEIVERSHIP PROGRAMS*

15 *For all agencies of the District of Columbia govern-*  
16 *ment under court ordered receivership, \$342,077,000 (in-*  
17 *cluding \$217,606,000 from local funds, \$106,111,000 from*  
18 *Federal funds, and \$18,360,000 from other funds).*

#### 19 *WORKFORCE INVESTMENTS*

20 *For workforce investments, \$8,500,000 from local*

3 *SEC. 127. (a) The University of the District of Colum-*  
4 *bia shall submit to the Mayor, the District of Columbia Fi-*  
5 *nancial Responsibility and Management Assistance Author-*  
6 *ity and the Council of the District of Columbia no later*  
7 *than 15 calendar days after the end of each quarter a report*  
8 *that sets forth—*

5 *SEC. 129. (a) None of the funds contained in this Act*  
6 *may be made available to pay the fees of an attorney who*  
7 *represents a party who prevails in an action, including an*  
8 *administrative proceeding, brought against the District of*  
9 *Columbia Public Schools under the Individuals with Dis-*  
10 *abilities Education Act (20 U.S.C. 1400 et seq.) if—*

11 *(1) the hourly rate of compensation of the attor-*  
12 *ney exceeds 120 percent of the hourly rate of com-*  
13 *penation under section 11–2604(a), District of Co-*  
14 *lumbia Code; or*

15 *(2) the maximum amount of compensation of the*

2           are required to be, and have been, submitted to the  
3           Board of Education; and

4           (5) changes made in the last quarter to the orga-  
5           nizational structure of the District of Columbia Pub-  
6           lic Schools, displaying previous and current control  
7           centers and responsibility centers, the names of the or-  
8           ganizational entities that have been changed, the  
9           name of the staff member supervising each entity af-  
10          fected, and the reasons for the structural change.

11          SEC. 133. (a) IN GENERAL.—The Superintendent of  
12          the District of Columbia Public Schools and the University  
13          of the District of Columbia shall annually compile an accu-  
14          rate and verifiable report on the positions and employees  
15          in the public school system and the university, respectively.  
16          The annual report shall set forth—

11          (b) *SUBMISSION.—The annual report required by sub-*  
12          *section (a) of this section shall be submitted to the Congress,*

15       **SEC. 135.** *The District of Columbia Financial Respon-*  
16 *sibility and Management Assistance Authority, acting on*  
17 *behalf of the District of Columbia Public Schools (DCPS)*  
18 *in formulating the DCPS budget, the Board of Trustees of*  
19 *the University of the District of Columbia, the Board of*  
20 *Library Trustees, and the Board of Governors of the Uni-*  
21 *versity of the District of Columbia School of Law shall vote*  
22 *on and approve the respective annual or revised budgets for*  
23 *such entities before submission to the Mayor of the District*  
24 *of Columbia for inclusion in the Mayor's budget submission*  
25 *to the Council of the District of Columbia in accordance*

1 *with section 442 of the District of Columbia Home Rule*  
2 *Act (Public Law 93–198; D.C. Code, sec. 47–301), or before*  
3 *submitting their respective budgets directly to the Council.*

4 *SEC. 136. (a) CEILING ON TOTAL OPERATING EX-*  
5 *PENSES.—*

6 *(1) IN GENERAL.—Notwithstanding any other*  
7 *provision of law, the total amount appropriated in*  
8 *this Act for operating expenses for the District of Co-*  
9 *lumbia for fiscal year 2000 under the heading “Divi-*  
10 *sion of Expenses” shall not exceed the lesser of—*

11 *(A) the sum of the total revenues of the Dis-*  
12 *trict of Columbia for such fiscal year; or*

4       *REPORT AND AUTHORITY APPROVAL.—No such Fed-*  
5       *eral, private, or other grant may be accepted, obli-*  
6       *gated, or expended pursuant to paragraph (1) until—*

7               (A) *the Chief Financial Officer of the Dis-*  
8       *trict of Columbia submits to the Authority a re-*  
9       *port setting forth detailed information regarding*  
10       *such grant; and*

11              (B) *the Authority has reviewed and ap-*  
12       *proved the acceptance, obligation, and expendi-*  
13       *ture of such grant in accordance with review and*  
14       *approval procedures consistent with the provi-*  
15       *sions of the District of Columbia Financial Re-*  
16       *sponsibility and Management Assistance Act of*  
17       *1995.*

18              (3) *PROHIBITION ON SPENDING IN ANTICIPATION*  
19       *OF APPROVAL OR RECEIPT.—No amount may be obli-*

23       *(2)(B) of this subsection or in anticipation of the ap-*

1           (4) *QUARTERLY REPORTS.*—*The Chief Financial*  
2           *Officer of the District of Columbia shall prepare a*  
3           *quarterly report setting forth detailed information re-*  
4           *garding all Federal, private, and other grants subject*  
5           *to this subsection. Each such report shall be submitted*  
6           *to the Council of the District of Columbia, and to the*  
7           *Committees on Appropriations of the House of Rep-*

10          (c) *REPORT ON EXPENDITURES BY FINANCIAL RE-*  
11          *SPONSIBILITY AND MANAGEMENT ASSISTANCE AUTHOR-*  
12          *ITY.*—*Not later than 20 calendar days after the end of each*  
13          *fiscal quarter starting October 1, 1999, the Authority shall*  
14          *submit a report to the Committees on Appropriations of the*  
15          *House of Representatives and the Senate, the Committee on*  
16          *Government Reform of the House, and the Committee on*  
17          *Governmental Affairs of the Senate providing an itemized*  
18          *accounting of all non-appropriated funds obligated or ex-*

2 *receiver or official shall prepare and submit to the Mayor,*  
3 *for inclusion in the annual budget of the District of Colum-*  
4 *bia for the year, annual estimates of the expenditures and*  
5 *appropriations necessary for the maintenance and oper-*  
6 *ation of the department or agency. All such estimates shall*  
7 *be forwarded by the Mayor to the Council, for its action*

16 *SEC. 138. (a) Notwithstanding any other provision of*  
17 *law, rule, or regulation, an employee of the District of Co-*  
18 *lumbia public schools shall be—*

19 *(1) classified as an Educational Service em-*  
20 *ployee;*

21 *(2) placed under the personnel authority of the*  
22 *Board of Education; and*

23 *(3) subject to all Board of Education rules.*

24 *(b) School-based personnel shall constitute a separate*  
25 *competitive area from nonschool-based personnel who shall*

1 *not compete with school-based personnel for retention pur-*  
2 *poses.*

3       *SEC. 139. (a) RESTRICTIONS ON USE OF OFFICIAL VE-*  
4 *HICLES.—Except as otherwise provided in this section, none*  
5 *of the funds made available by this Act or by any other*  
6 *Act may be used to provide any officer or employee of the*  
7 *District of Columbia with an official vehicle unless the offi-*  
8 *cer or employee uses the vehicle only in the performance*  
9 *of the officer’s or employee’s official duties. For purposes*  
10 *of this paragraph, the term “official duties” does not in-*  
11 *clude travel between the officer’s or employee’s residence and*  
12 *workplace (except: (1) in the case of an officer or employee*  
13 *of the Metropolitan Police Department who resides in the*  
14 *District of Columbia or is otherwise designated by the Chief*  
15 *of the Department; (2) at the discretion of the Fire Chief,*  
16 *an officer or employee of the District of Columbia Fire and*  
17 *Emergency Medical Services Department who resides in the*  
18 *District of Columbia and is on call 24 hours a day; (3)*  
19 *the Mayor of the District of Columbia; and (4) the Chair-*  
20 *man of the Council of the District of Columbia).*

21       *(b) INVENTORY OF VEHICLES.—The Chief Financial*  
22 *Officer of the District of Columbia shall submit, by Novem-*  
23 *ber 15, 1999, an inventory, as of September 30, 1999, of*  
24 *all vehicles owned, leased or operated by the District of Co-*  
25 *lumbia government. The inventory shall include, but not*

1 *be limited to, the department to which the vehicle is as-*  
2 *signed; the year and make of the vehicle; the acquisition*  
3 *date and cost; the general condition of the vehicle; annual*  
4 *operating and maintenance costs; current mileage; and*  
5 *whether the vehicle is allowed to be taken home by a District*  
6 *officer or employee and if so, the officer or employee's title*  
7 *and resident location.*

8       *SEC. 140. (a) SOURCE OF PAYMENT FOR EMPLOYEES*  
9 *DETAILED WITHIN GOVERNMENT.—For purposes of deter-*  
10 *mining the amount of funds expended by any entity within*  
11 *the District of Columbia government during fiscal year*  
12 *2000 and each succeeding fiscal year, any expenditures of*  
13 *the District government attributable to any officer or em-*  
14 *ployee of the District government who provides services*  
15 *which are within the authority and jurisdiction of the enti-*  
16 *ty (including any portion of the compensation paid to the*  
17 *officer or employee attributable to the time spent in pro-*  
18 *viding such services) shall be treated as expenditures made*  
19 *from the entity's budget, without regard to whether the offi-*  
20 *cer or employee is assigned to the entity or otherwise treated*  
21 *as an officer or employee of the entity.*

22       *(b) MODIFICATION OF REDUCTION IN FORCE PROCE-*  
23 *DURES.—The District of Columbia Government Com-*  
24 *prehensive Merit Personnel Act of 1978 (D.C. Code, sec. 1-*  
25 *601.1 et seq.), is further amended in section 2408(a) by*

1 *striking “1999” and inserting “2000”; in subsection (b), by*  
2 *striking “1999” and inserting “2000”; in subsection (i), by*  
3 *striking “1999” and inserting “2000”; and in subsection*  
4 *(k), by striking “1999” and inserting “2000”.*

5 *SEC. 141. Notwithstanding any other provision of law,*  
6 *not later than 120 days after the date that a District of*  
7 *Columbia Public Schools (DCPS) student is referred for*  
8 *evaluation or assessment—*

9 *(1) the District of Columbia Board of Education,*  
10 *or its successor, and DCPS shall assess or evaluate a*  
11 *student who may have a disability and who may re-*  
12 *quire special education services; and*

13 *(2) if a student is classified as having a dis-*  
14 *ability, as defined in section 101(a)(1) of the Individ-*  
15 *uals with Disabilities Education Act (84 Stat. 175;*  
16 *20 U.S.C. 1401(a)(1)) or in section 7(8) of the Reha-*  
17 *ilitation Act of 1973 (87 Stat. 359; 29 U.S.C.*

21 *SEC. 142. (a) COMPLIANCE WITH BUY AMERICAN*  
22 *ACT.—None of the funds made available in this Act may*  
23 *be expended by an entity unless the entity agrees that in*  
24 *expending the funds the entity will comply with the Buy*  
25 *American Act (41 U.S.C. 10a–10c).*

1       **(b) SENSE OF THE CONGRESS; REQUIREMENT RE-**  
2 **GARDING NOTICE.—**

3           **(1) PURCHASE OF AMERICAN-MADE EQUIPMENT**  
4 **AND PRODUCTS.—***In the case of any equipment or*  
5 *product that may be authorized to be purchased with*  
6 *financial assistance provided using funds made avail-*  
7 *able in this Act, it is the sense of the Congress that*  
8 *entities receiving the assistance should, in expending*  
9 *the assistance, purchase only American-made equip-*  
10 *ment and products to the greatest extent practicable.*

11           **(2) NOTICE TO RECIPIENTS OF ASSISTANCE.—***In*  
12 *providing financial assistance using funds made*  
13 *available in this Act, the head of each agency of the*  
14 *Federal or District of Columbia government shall pro-*  
15 *vide to each recipient of the assistance a notice de-*  
16 *scribing the statement made in paragraph (1) by the*  
17 *Congress.*

18       **(c) PROHIBITION OF CONTRACTS WITH PERSONS**  
19 **FALSELY LABELING PRODUCTS AS MADE IN AMERICA.—**  
20 *If it has been finally determined by a court or Federal agen-*  
21 *cy that any person intentionally affixed a label bearing a*  
22 *“Made in America” inscription, or any inscription with*  
23 *the same meaning, to any product sold in or shipped to*  
24 *the United States that is not made in the United States,*  
25 *the person shall be ineligible to receive any contract or sub-*

1 *contract made with funds made available in this Act, pur-*  
2 *suant to the debarment, suspension, and ineligibility proce-*  
3 *dures described in sections 9.400 through 9.409 of title 48,*  
4 *Code of Federal Regulations.*

5 *SEC. 143. None of the funds contained in this Act may*  
6 *be used for purposes of the annual independent audit of*  
7 *the District of Columbia government (including the District*

10 *(1) the audit is conducted by the Inspector Gen-*  
11 *eral of the District of Columbia pursuant to section*  
12 *208(a)(4) of the District of Columbia Procurement*  
13 *Practices Act of 1985 (D.C. Code, sec. 1–*  
14 *1182.8(a)(4)); and*

15 *(2) the audit includes a comparison of audited*  
16 *actual year-end results with the revenues submitted in*  
17 *the budget document for such year and the appropria-*  
18 *tions enacted into law for such year.*

19 *SEC. 144. Nothing in this Act shall be construed to*  
20 *authorize any office, agency or entity to expend funds for*  
21 *programs or functions for which a reorganization plan is*  
22 *required but has not been approved by the District of Co-*  
23 *lumbia Financial Responsibility and Management Assist-*  
24 *ance Authority. Appropriations made by this Act for such*

1 *programs or functions are conditioned only on the approval*  
2 *by the Authority of the required reorganization plans.*

3 *SEC. 145. Notwithstanding any other provision of law,*  
4 *rule, or regulation, the evaluation process and instruments*

14 *SEC. 147. None of the funds contained in this Act may*  
15 *be used to transfer or confine inmates classified above the*  
16 *medium security level, as defined by the Federal Bureau*  
17 *of Prisons classification instrument, to the Northeast Ohio*  
18 *Correctional Center located in Youngstown, Ohio.*

19 *SEC. 148. (a) Section 202(i) of the District of Colum-*  
20 *bia Financial Responsibility and Management Assistance*  
21 *Act of 1995 (Public Law 104–8), as added by section 155*  
22 *of the District of Columbia Appropriations Act, 1999, is*  
23 *amended to read as follows:*

24 *“(j) RESERVE.—*

1           “(1) *IN GENERAL.*—Beginning with fiscal year  
2           2000, the plan or budget submitted pursuant to this

2           *shall notify the Appropriations Committees of both*  
3           *the Senate and House of Representatives in writing*  
4           *30 days in advance of any expenditure of the reserve*  
5           *funds.”.*

13       *SEC. 150. None of the funds contained in this Act may*  
14 *be used for any program of distributing sterile needles or*  
15 *syringes for the hypodermic injection of any illegal drug.*

16       *SEC. 151. (a) RESTRICTIONS ON LEASES.—Upon the*  
17 *expiration of the 60-day period that begins on the date of*  
18 *the enactment of this Act, none of the funds contained in*  
19 *this Act may be used to make rental payments under a lease*  
20 *for the use of real property by the District of Columbia gov-*  
21 *ernment (including any independent agency of the District)*  
22 *unless the lease and an abstract of the lease have been filed*  
23 *(by the District of Columbia or any other party to the lease)*  
24 *with the central office of the Deputy Mayor for Economic*

1 *Development, in an indexed registry available for public in-*  
2 *spection.*

3 (b) *ADDITIONAL RESTRICTIONS ON CURRENT*  
4 *LEASES.—*

5 (1) *IN GENERAL.—Upon the expiration of the*  
6 *60-day period that begins on the date of the enact-*  
7 *ment of this Act, in the case of a lease described in*  
8 *paragraph (3), none of the funds contained in this*  
9 *Act may be used to make rental payments under the*  
10 *lease unless the lease is included in periodic reports*  
11 *submitted by the Mayor and Council of the District*  
12 *of Columbia to the Committees on Appropriations of*

2 *GOVERNMENT PROPERTY.—Upon the expiration of the 60-*  
3 *day period that begins on the date of the enactment of this*  
4 *Act, none of the funds contained in this Act may be used*  
5 *to enter into a lease (or to make rental payments under*  
6 *such a lease) for the use of real property by the District*  
7 *of Columbia government (including any independent agen-*  
8 *cy of the District) or to purchase real property for the use*  
9 *of the District of Columbia government (including any*

2        *date the determination is published.*

3            *(3) The Mayor and Council implement a pro-*  
4        *gram for the periodic survey of all District property*  
5        *to determine if it is surplus to the needs of the Dis-*  
6        *trict.*

7            *(4) The Mayor and Council within 60 days of*  
8        *the date of the enactment of this Act have filed with*  
9        *the Committees on Appropriations of the House of*  
10       *Representatives and Senate, the Committee on Gov-*  
11       *ernment Reform and Oversight of the House of Rep-*  
12       *resentatives, and the Committee on Governmental Af-*  
13       *airs of the Senate a report which provides a com-*

1        *SEC. 159. (a) IN GENERAL.—The Mayor of the Dis-*  
2 *trict of Columbia shall carry out through the Army Corps*  
3 *of Engineers, an Anacostia River environmental cleanup*  
4 *program.*

5        *(b) SOURCE OF FUNDS.—There are hereby transferred*  
6 *to the Mayor from the escrow account held by the District*  
7 *of Columbia Financial Responsibility and Management As-*  
8 *sistance Authority pursuant to section 134 of division A*  
9 *of the Omnibus Consolidated and Emergency Supplemental*  
10 *Appropriations Act, 1999 (Public Law 105–277; 112 Stat.*  
11 *2681–552), for infrastructure needs of the District of Co-*  
12 *lumbia, \$5,000,000.*

13        *SEC. 160. (a) PROHIBITING PAYMENT OF ADMINISTRA-*  
14 *TIVE COSTS FROM FUND.—Section 16(e) of the Victims of*  
15 *Violent Crime Compensation Act of 1996 (D.C. Code, sec.*  
16 *3–435(e)) is amended—*

17            *(1) by striking “and administrative costs nec-*  
18 *essary to carry out this chapter”; and*

19            *(2) by striking the period at the end and insert-*  
20 *ing the following: “, and no monies in the Fund may*  
21 *be used for any other purpose.”.*

22        *(b) MAINTENANCE OF FUND IN TREASURY OF THE*  
23 *UNITED STATES.—*

24            *(1) IN GENERAL.—Section 16(a) of such Act*  
25 *(D.C. Code, sec. 3–435(a)) is amended by striking the*

1       *second sentence and inserting the following: “The*  
2       *Fund shall be maintained as a separate fund in the*

9 *tained in this Act may be used after the expiration of the*

11 *this Act to pay the salary of any chief financial officer of*  
12 *any office of the District of Columbia government (includ-*  
13 *ing any independent agency of the District) who has not*  
14 *filed a certification with the Mayor and the Chief Financial*  
15 *Officer of the District of Columbia that the officer under-*  
16 *stands the duties and restrictions applicable to the officer*  
17 *and their agency as a result of this Act.*

18           *SEC. 162. The proposed budget of the government of*  
19 *the District of Columbia for fiscal year 2001 that is sub-*

18 (2) *EFFECTIVE DATE.—This subsection shall take*  
19 *effect as if included in the District of Columbia Ap-*

21 (c) *ADDITIONAL FUNDING FOR IMPROVEMENTS CAR-*  
22 *RIED OUT THROUGH CORPS OF ENGINEERS.—*

23 (1) *IN GENERAL.—There is hereby transferred*

13       *Columbia.*

14           (d) *QUARTERLY REPORTS ON PROJECT.—The Mayor*  
15       *shall submit reports to the Committee on Appropriations*  
16       *of the House of Representatives and the Committee on Ap-*  
17       *propriations of the Senate on the status of the improvements*  
18       *described in subsection (a) for each calendar quarter occur-*  
19       *ring until the improvements are completed.*

20           *SEC. 165. It is the sense of the Congress that the Dis-*  
21       *trict of Columbia should not impose or take into consider-*  
22       *ation any height, square footage, set-back, or other construc-*  
23       *tion or zoning requirements in authorizing the issuance of*  
24       *industrial revenue bonds for a project of the American Na-*  
25       *tional Red Cross at 2025 E Street Northwest, Washington,*

1 *D.C., in as much as this project is subject to approval of*  
2 *the National Capital Planning Commission and the Com-*

8 *lic Law 100–637; 36 U.S.C. 300108 note).*

9       *SEC. 166. (a) PERMITTING COURT SERVICES AND OF-*  
10 *FENDER SUPERVISION AGENCY TO CARRY OUT SEX OF-*  
11 *FENDER REGISTRATION.—Section 11233(c) of the National*  
12 *Capital Revitalization and Self-Government Improvement*  
13 *Act of 1997 (D.C. Code, sec. 24–1233(c)) is amended by*  
14 *adding at the end the following new paragraph:*

15             *“(5) SEX OFFENDER REGISTRATION.—The Agen-*  
16             *cy shall carry out sex offender registration functions*  
17             *in the District of Columbia, and shall have the au-*  
18             *thority to exercise all powers and functions relating*  
19             *to sex offender registration that are granted to the*  
20             *Agency under any District of Columbia law.”.*

21       *(b) AUTHORITY DURING TRANSITION TO FULL OPER-*  
22 *ATION OF AGENCY.—*

23             *(1) AUTHORITY OF PRETRIAL SERVICES, PAROLE,*  
24             *ADULT PROBATION AND OFFENDER SUPERVISION*  
25             *TRUSTEE.—Notwithstanding section 11232(b)(1) of*



1        *the National Capital Revitalization and Self-Govern-*  
2        *ment Improvement Act of 1997 (D.C. Code, sec. 24-*  
3        *1232(b)(1)), the Pretrial Services, Parole, Adult Pro-*  
4        *bation and Offender Supervision Trustee appointed*  
5        *under section 11232(a) of such Act (hereafter referred*  
6        *to as the “Trustee”) shall, in accordance with section*  
7        *11232 of such Act, exercise the powers and functions*  
8        *of the Court Services and Offender Supervision Agen-*  
9        *cy for the District of Columbia (hereafter referred to*  
10       *as the “Agency”) relating to sex offender registration*  
11       *(as granted to the Agency under any District of Co-*  
12       *lumbia law) only upon the Trustee’s certification that*  
13       *the Trustee is able to assume such powers and func-*  
14       *tions.*

15                (2) *AUTHORITY OF METROPOLITAN POLICE DE-*  
16        *PARTMENT.—During the period that begins on the*  
17        *date of the enactment of the Sex Offender Registration*  
18        *Emergency Act of 1999 and ends on the date the*  
19        *Trustee makes the certification described in para-*  
20        *graph (1), the Metropolitan Police Department of the*  
21        *District of Columbia shall have the authority to carry*  
22        *out any powers and functions relating to sex offender*  
23        *registration that are granted to the Agency or to the*  
24        *Trustee under any District of Columbia law.*

1        *SEC. 167. (a) None of the funds contained in this Act*  
2 *may be used to enact or carry out any law, rule, or regula-*  
3 *tion to legalize or otherwise reduce penalties associated with*  
4 *the possession, use, or distribution of any schedule I sub-*  
5 *stance under the Controlled Substances Act (21 U.S.C. 802)*  
6 *or any tetrahydrocannabinols derivative.*

7        *(b) The Legalization of Marijuana for Medical Treat-*  
8 *ment Initiative of 1998, also known as Initiative 59, ap-*  
9 *proved by the electors of the District of Columbia on Novem-*  
10 *ber 3, 1998, shall not take effect.*

11        *SEC. 168. (a) IN GENERAL.—There is hereby trans-*  
12 *ferred from the District of Columbia Financial Responsi-*  
13 *bility and Management Assistance Authority (hereinafter*  
14 *referred to as the “Authority”) to the District of Columbia*  
15 *the sum of \$5,000,000 for the Mayor, in consultation with*  
16 *the Council of the District of Columbia, to provide offsets*  
17 *against local taxes for a commercial revitalization program,*  
18 *such program to be available in enterprise zones and low*  
19 *and moderate income areas in the District of Columbia:*  
20 *Provided, That in carrying out such a program, the Mayor*

23        *(b) SOURCE OF FUNDS.—The amount transferred*

1 *on accounts held by the Authority on behalf of the District*  
2 *of Columbia.*

3 (c) *REPORT.*—*Not later than 180 days after the date*  
4 *of the enactment of this Act, the Mayor shall report to the*  
5 *Committees on Appropriations of the Senate and House of*  
6 *Representatives on the progress made in carrying out the*  
7 *commercial revitalization program.*

8 *SEC. 169. Section 456 of the District of Columbia*  
9 *Home Rule Act (section 47–231 et seq. of the D.C. Code,*  
10 *as added by the Federal Payment Reauthorization Act of*  
11 *1994 (Public Law 103–373)) is amended—*

12 (1) *in subsection (a)(1), by striking “District of*  
13 *Columbia Financial Responsibility and Management*  
14 *Assistance Authority” and inserting “Mayor”; and*

15 (2) *in subsection (b)(1), by striking “Authority”*  
16 *and inserting “Mayor”.*

17 *SEC. 170. (a) FINDINGS.*—*The Congress finds the fol-*  
18 *lowing:*

19 (1) *The District of Columbia has recently wit-*  
20 *nessed a spate of senseless killings of innocent citizens*  
21 *caught in the crossfire of shootings. A Justice Depart-*  
22 *ment crime victimization survey found that while the*  
23 *city saw a decline in the homicide rate between 1996*  
24 *and 1997, the rate was the highest among a dozen cit-*  
25 *ies and more than double the second highest city.*

1           (2) *The District of Columbia has not made ade-*  
2 *quate funding available to fight drug abuse in recent*  
3 *years, and the city has not deployed its resources as*  
4 *effectively as possible. In fiscal year 1998,*  
5 *\$20,900,000 was spent on publicly funded drug treat-*  
6 *ment in the District compared to \$29,000,000 in fis-*  
7 *cal year 1993. The District's Addiction and Preven-*  
8 *tion and Recovery Agency currently has only 2,200*  
9 *treatment slots, a 50 percent drop from 1994, with*  
10 *more than 1,100 people on waiting lists.*

11           (3) *The District of Columbia has seen a rash of*  
12 *inmate escapes from halfway houses. According to De-*  
13 *partment of Corrections records, between October 21,*  
14 *1998 and January 19, 1999, 376 of the 1,125 inmates*  
15 *assigned to halfway houses walked away. Nearly 280*  
16 *of the 376 escapees were awaiting trial including two*  
17 *charged with murder.*

18           (4) *The District of Columbia public schools sys-*  
19 *tem faces serious challenges in correcting chronic*  
20 *problems, particularly long-standing deficiencies in*  
21 *providing special education services to the 1 in 10*  
22 *District students needing program benefits, including*  
23 *backlogged assessments, and repeated failure to meet*  
24 *a compliance agreement on special education reached*  
25 *with the Department of Education.*

1           (5) *Deficiencies in the delivery of basic public*  
2           *services from cleaning streets to waiting time at De-*  
3           *partment of Motor Vehicles to a rat population esti-*  
4           *mated earlier this year to exceed the human popu-*  
5           *lation have generated considerable public frustration.*

6           (6) *Last year, the District of Columbia forfeited*  
7           *millions of dollars in Federal grants after Federal*  
8           *auditors determined that several agencies exceeded*  
9           *grant restrictions and in other instances, failed to*  
10          *spend funds before the grants expired.*

11          (7) *Findings of a 1999 report by the Annie E.*  
12          *Casey Foundation that measured the well-being of*  
13          *children reflected that, with one exception, the Dis-*  
14          *trict ranked worst in the United States in every cat-*  
15          *egory from infant mortality to the rate of teenage*  
16          *births to statistics chronicling child poverty.*

17          (b) *SENSE OF THE CONGRESS.—It is the sense of the*  
18          *Congress that in considering the District of Columbia’s fis-*  
19          *cal year 2001 budget, the Congress will take into consider-*  
20          *ation progress or lack of progress in addressing the fol-*  
21          *lowing issues:*

22                 (1) *Crime, including the homicide rate, imple-*  
23                 *mentation of community policing, the number of po-*  
24                 *lice officers on local beats, and the closing down of*  
25                 *open-air drug markets.*

1           (2) *Access to drug abuse treatment, including the*  
2           *number of treatment slots, the number of people*  
3           *served, the number of people on waiting lists, and the*  
4           *effectiveness of treatment programs.*

5           (3) *Management of parolees and pretrial violent*  
6           *offenders, including the number of halfway house es-*  
7           *capades and steps taken to improve monitoring and su-*  
8           *pervision of halfway house residents to reduce the*  
9           *number of escapes.*

10          (4) *Education, including access to special edu-*  
11          *cation services and student achievement.*

12          (5) *Improvement in basic city services, including*  
13          *rat control and abatement.*

14          (6) *Application for and management of Federal*  
15          *grants.*

16          (7) *Indicators of child well-being.*

17          *SEC. 171. The Mayor, prior to using Federal Medicaid*  
18          *payments to Disproportionate Share Hospitals to serve a*  
19          *small number of childless adults, should consider the rec-*  
20          *ommendations of the Health Care Development Commission*  
21          *that has been appointed by the Council of the District of*  
22          *Columbia to review this program, and consult and report*  
23          *to Congress on the use of these funds.*

24          *SEC. 172. GAO STUDY OF DISTRICT OF COLUMBIA*  
25          *CRIMINAL JUSTICE SYSTEM. Not later than 1 year after the*

1 *date of the enactment of this Act, the Comptroller General*  
2 *of the United States shall—*

3           (1) *conduct a study of the law enforcement,*  
4 *court, prison, probation, parole, and other compo-*  
5 *nents of the criminal justice system of the District of*  
6 *Columbia, in order to identify the components most*  
7 *in need of additional resources, including financial,*  
8 *personnel, and management resources; and*

9           (2) *submit to Congress a report on the results of*  
10 *the study under paragraph (1).*

11       *SEC. 173. Nothing in this Act bars the District of Co-*  
12 *lumbia Corporation Counsel from reviewing or commenting*  
13 *on briefs in private lawsuits, or from consulting with offi-*  
14 *cial of the District government regarding such lawsuits.*

15       *SEC. 174. WIRELESS COMMUNICATIONS. (a) IN GEN-*  
16 *ERAL.—Not later than 7 days after the date of the enact-*  
17 *ment of this Act, the Secretary of the Interior, acting*  
18 *through the Director of the National Park Service, shall—*

19           (1) *implement the notice of decision approved by*  
20 *the National Capital Regional Director, dated April*  
21 *7, 1999, including the provisions of the notice of deci-*  
22 *sion concerning the issuance of right-of-way permits*  
23 *at market rates; and*

24           (2) *expend such sums as are necessary to carry*  
25 *out paragraph (1).*

1       **(b) ANTENNA APPLICATIONS.**—

2           **(1) IN GENERAL.**—*Not later than 120 days after*  
3 *the receipt of an application, a Federal agency that*  
4 *receives an application submitted after the enactment*  
5 *of this Act to locate a wireless communications an-*  
6 *tenna on Federal property in the District of Colum-*  
7 *bia or surrounding area over which the Federal agen-*  
8 *cy exercises control shall take final action on the ap-*  
9 *plication, including action on the issuance of right-*  
10 *of-way permits at market rates.*

11           **(2) EXISTING LAW.**—*Nothing in this subsection*  
12 *shall be construed to affect the applicability of exist-*  
13 *ing laws regarding—*

14                   **(A)** *judicial review under chapter 7 of title*  
15 *5, United States Code (the Administrative Proce-*

17                   **(B)** *the National Environmental Policy Act,*  
18 *the National Historic Preservation Act and other*  
19 *applicable Federal statutes; and*

20                   **(C)** *the authority of a State or local govern-*  
21 *ment or instrumentality thereof, including the*  
22 *District of Columbia, in the placement, construc-*  
23 *tion, and modification of personal wireless serv-*  
24 *ice facilities.*



1        *SEC. 175. (a)(1) The first paragraph under the head-*  
2 *ing “Community Development Block Grants” in title II of*  
3 *H.R. 2684 (Public Law 106–74) is amended by inserting*  
4 *after “National American Indian Housing Council,” the*  
5 *following: “\$4,000,000 shall be available as a grant for the*  
6 *Special Olympics in Anchorage, Alaska to develop the Ben*  
7 *Boeke Arena and Hilltop Ski Area,”; and*

8        *(2) The paragraph that includes the words “Economic*

1           “—\$925,000 for the Florida Association of  
2           Counties for a Rural Capacity Building Pilot Project  
3           in Tallahassee, Florida;

4           “—\$500,000 for the Osceola County Agriculture  
5           Center for construction of a new and expanded agri-  
6           culture center in Osceola County, Florida;

7           “—\$1,000,000 for the University of Syracuse in  
8           Syracuse, New York for electrical infrastructure im-  
9           provements.”; and the current descriptions are  
10          amended as follows:

11          “—\$1,700,000 to the City of Miami, Florida for  
12          the development of a Homeownership Zone to assist  
13          residents displaced by the demolition of public hous-  
14          ing in the Model City area;” is amended to read as  
15          follows:

16          “—\$1,700,000 to Miami-Dade County, Florida  
17          for an economic development project at the Opa-locka  
18          Neighborhood Center;”;

19          “—\$250,000 to the Arizona Science Center in  
20          Yuma, Arizona for its after-school program for inner-  
21          city youth;” is amended to read as follows:

24          inner-city youth;”;

1           “—\$200,000 to the Schuylkill County Fire  
2           *Fighters Association for a smoke-maze building on the*  
3           *grounds of the firefighters facility in Morea, Pennsyl-*  
4           *vania;” is amended to read as follows:*

5           “—\$200,000 to the Schuylkill County Fire  
6           *Fighters Association for a smoke-maze building and*  
7           *other facilities and improvements on the grounds of*  
8           *the firefighters facility in Morea, Pennsylvania;”.*

9           (c) *Notwithstanding any other provision of law, the*  
10          *\$2,000,000 made available pursuant to Public Law 105-*  
11          *276 for Pittsburgh, Pennsylvania to redevelop the Sun Co./*  
12          *LTV Steel Site in Hazelwood, Pennsylvania is available*  
13          *to the Department of Economic Development in Allegheny*  
14          *County, Pennsylvania for the development of a technology*  
15          *based project in the county.*

16          (d) *Insert the following new sections at the end of the*  
17          *administrative provisions in title II of H.R. 2684 (Public*  
18          *Law 106-74):*

20          “*SEC. 226. Section 542 of the Housing and Commu-*
