AN ACT

Making appropriations for the government of the District of Columbia and other activities chargeable in whole or in part against revenues of said District for the fiscal year ending September 30, 2000, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*
3 **(1)**That the following sums are appropriated, out of any
4 money in the Treasury not otherwise appropriated, for the
5 District of Columbia for the fiscal year ending September
6 30, 2000, and for other purposes, namely:

1 **TITLE I—FISCAL YEAR 2000**
2 **APPROPRIATIONS**

3 FEDERAL FUNDS

4 FEDERAL PAYMENT FOR RESIDENT TUITION SUPPORT

5 For a Federal payment to the District of Columbia
6 for a program to be administered by the Mayor for Dis-
7 trict of Columbia resident tuition support, subject to the
8 enactment of authorizing legislation for such program by
9 Congress, \$17,000,000, to remain available until ex-
10 pended: *Provided*, That such funds may be used on behalf
11 of eligible District of Columbia residents to pay an amount
12 based upon the difference between in-State and out-of-
13 State tuition at public institutions of higher education, us-
14 able at both public and private institutions of higher edu-
15 cation: *Provided further*, That the awarding of such funds
16 may be prioritized on the basis of a resident's academic
17 merit and such other factors as may be authorized: *Pro-*
18 *vided further*, That if the authorized program is a nation-
19 wide program, the Mayor may expend up to \$17,000,000:
20 *Provided further*, That if the authorized program is for
21 a limited number of states, the Mayor may expend up to
22 \$11,000,000: *Provided further*, That the District of Co-
23 lumbia may expend funds other than the funds provided
24 under this heading, including local tax revenues and con-
25 tributions, to support such program.

1 FEDERAL PAYMENT FOR INCENTIVES FOR ADOPTION OF
2 CHILDREN

3 For a Federal payment to the District of Columbia
4 to create incentives to promote the adoption of children
5 in the District of Columbia foster care system,
6 \$5,000,000: *Provided*, That such funds shall remain avail-
7 able until September 30, 2001 and shall be used in accord-
8 ance with a program established by the Mayor and the
9 Council of the District of Columbia and approved by the
10 Committees on Appropriations of the House of Represent-
11 atives and the Senate: *Provided further*, That funds pro-
12 vided under this heading may be used to cover the costs
13 to the District of Columbia of providing tax credits to off-
14 set the costs incurred by individuals in adopting children
15 in the District of Columbia foster care system and in pro-
16 viding for the health care needs of such children, in ac-
17 cordance with legislation enacted by the District of Colum-
18 bia government.

19 FEDERAL PAYMENT TO THE CITIZEN COMPLAINT
20 REVIEW BOARD

21 For a Federal payment to the District of Columbia
22 for administrative expenses of the Citizen Complaint Re-
23 view Board, \$500,000, to remain available until Sep-
24 tember 30, 2001.

1 FEDERAL PAYMENT TO THE DEPARTMENT OF HUMAN
2 SERVICES

3 For a Federal payment to the Department of Human
4 Services for a mentoring program and for hotline services,
5 \$250,000.

6 FEDERAL PAYMENT TO THE DISTRICT OF COLUMBIA
7 CORRECTIONS TRUSTEE OPERATIONS

8 For salaries and expenses of the District of Columbia
9 Corrections Trustee, \$176,000,000 for the administration
10 and operation of correctional facilities and for the admin-
11 istrative operating costs of the Office of the Corrections
12 Trustee, as authorized by section 11202 of the National
13 Capital Revitalization and Self-Government Improvement
14 Act of 1997 (Public Law 105-33; 111 Stat. 712): *Pro-*
15 *vided*, That notwithstanding any other provision of law,
16 funds appropriated in this Act for the District of Columbia
17 Corrections Trustee shall be apportioned quarterly by the
18 Office of Management and Budget and obligated and ex-
19 pended in the same manner as funds appropriated for sal-
20 aries and expenses of other Federal agencies: *Provided fur-*
21 *ther*, That in addition to the funds provided under this
22 heading, the District of Columbia Corrections Trustee
23 may use a portion of the interest earned on the Federal
24 payment made to the Trustee under the District of Colum-

1 bia Appropriations Act, 1998, (not to exceed \$4,600,000)
2 to carry out the activities funded under this heading.

3 FEDERAL PAYMENT TO THE DISTRICT OF COLUMBIA
4 COURTS

5 For salaries and expenses for the District of Colum-
6 bia Courts, \$99,714,000 to be allocated as follows: for the
7 District of Columbia Court of Appeals, \$7,209,000; for the
8 District of Columbia Superior Court, \$68,351,000; for the
9 District of Columbia Court System, \$16,154,000; and
10 \$8,000,000, to remain available until September 30, 2001,
11 for capital improvements for District of Columbia court-
12 house facilities: *Provided*, That of the amounts available
13 for operations of the District of Columbia Courts, not to
14 exceed \$2,500,000 shall be for the design of an Integrated
15 Justice Information System and that such funds shall be
16 used in accordance with a plan and design developed by
17 the courts and approved by the Committees on Appropria-
18 tions of the House of Representatives and the Senate: *Pro-*
19 *vided further*, That notwithstanding any other provision
20 of law, all amounts under this heading shall be appor-
21 tioned quarterly by the Office of Management and Budget
22 and obligated and expended in the same manner as funds
23 appropriated for salaries and expenses of other Federal
24 agencies, with payroll and financial services to be provided
25 on a contractual basis with the General Services Adminis-

1 heading *Provided further*, That in addition to the funds
2 provided under this heading, the Joint Committee on Ju-
3 dicial Administration in the District of Columbia may use
4 a portion (not to exceed \$1,200,000) of the interest earned
5 on the Federal payment made to the District of Columbia
6 courts under the District of Columbia Appropriations Act,
7 1999, together with funds provided in this Act under the
8 heading "Federal Payment to the District of Columbia
9 Courts" (other than the \$8,000,000 provided under such
10 heading for capital improvements for District of Columbia
11 courthouse facilities), to make payments described under
12 this heading for obligations incurred during fiscal year
13 1999 if the Comptroller General certifies that the amount
14 of obligations lawfully incurred for such payments during
15 fiscal year 1999 exceeds the obligational authority other-
16 wise available for making such payments: *Provided further*,
17 That such funds shall be administered by the Joint Com-
18 mittee on Judicial Administration in the District of Co-
19 lumbia: *Provided further*, That notwithstanding any other
20 provision of law, this appropriation shall be apportioned
21 quarterly by the Office of Management and Budget and
22 obligated and expended in the same manner as funds ap-
23 propriated for expenses of other Federal agencies, with
24 payroll and financial services to be provided on a contrac-
25 tual basis with the General Services Administration

1 (GSA), said services to include the preparation of monthly
2 financial reports, copies of which shall be submitted di-
3 rectly by GSA to the President and to the Committees
4 on Appropriations of the Senate and House of Representa-
5 tives, the Committee on Governmental Affairs of the Sen-
6 ate, and the Committee on Government Reform of the
7 House of Representatives.

8 FEDERAL PAYMENT TO THE COURT SERVICES AND OF-
9 FENDER SUPERVISION AGENCY FOR THE DISTRICT
10 OF COLUMBIA

11 For salaries and expenses of the Court Services and
12 Offender Supervision Agency for the District of Columbia,
13 as authorized by the National Capital Revitalization and
14 Self-Government Improvement Act of 1997, (Public Law
15 105-33; 111 Stat. 712), \$93,800,000, of which
16 \$58,600,000 shall be for necessary expenses of Parole
17 Revocation, Adult Probation, Offender Supervision, and
18 Sex Offender Registration, to include expenses relating to
19 supervision of adults subject to protection orders or provi-
20 sion of services for or related to such persons;
21 \$17,400,000 shall be available to the Public Defender
22 Service; and \$17,800,000 shall be available to the Pretrial
23 Services Agency: *Provided*, That notwithstanding any
24 other provision of law, all amounts under this heading
25 shall be apportioned quarterly by the Office of Manage-

1 ment and Budget and obligated and expended in the same
2 manner as funds appropriated for salaries and expenses
3 of other Federal agencies: *Provided further*, That of the
4 amounts made available under this heading, \$20,492,000
5 shall be used in support of universal drug screening and
6 testing for those individuals on pretrial, probation, or pa-
7 role supervision with continued testing, intermediate sanc-
8 tions, and treatment for those identified in need, of which
9 \$7,000,000 shall be for treatment services.

10 CHILDREN'S NATIONAL MEDICAL CENTER

11 For a Federal contribution to the Children's National
12 Medical Center in the District of Columbia, \$2,500,000
13 for construction, renovation, and information technology
14 infrastructure costs associated with establishing commu-
15 nity pediatric health clinics for high risk children in medi-
16 cally underserved areas of the District of Columbia.

17 FEDERAL PAYMENT FOR METROPOLITAN POLICE

18 DEPARTMENT

19 For payment to the Metropolitan Police Department,
20 \$1,000,000, for a program to eliminate open air drug traf-
21 ficking in the District of Columbia: *Provided*, That the
22 Chief of Police shall provide quarterly reports to the Com-
23 mittees on Appropriations of the Senate and House of
24 Representatives by the 15th calendar day after the end

1 of each quarter beginning December 31, 1999, on the sta-
2 tus of the project financed under this heading.

3 DISTRICT OF COLUMBIA FUNDS

4 OPERATING EXPENSES

5 DIVISION OF EXPENSES

6 The following amounts are appropriated for the Dis-
7 trict of Columbia for the current fiscal year out of the
8 general fund of the District of Columbia, except as other-
9 wise specifically provided.

10 GOVERNMENTAL DIRECTION AND SUPPORT

11 Governmental direction and support, \$162,356,000
12 (including \$137,134,000 from local funds, \$11,670,000
13 from Federal funds, and \$13,552,000 from other funds):
14 *Provided*, That not to exceed \$2,500 for the Mayor,
15 \$2,500 for the Chairman of the Council of the District
16 of Columbia, and \$2,500 for the City Administrator shall
17 be available from this appropriation for official purposes:
18 *Provided further*, That any program fees collected from the
19 issuance of debt shall be available for the payment of ex-
20 penses of the debt management program of the District
21 of Columbia: *Provided further*, That no revenues from
22 Federal sources shall be used to support the operations
23 or activities of the Statehood Commission and Statehood
24 Compact Commission: *Provided further*, That the District
25 of Columbia shall identify the sources of funding for Ad-

1 mission to Statehood from its own locally-generated reve-
 2 nues: *Provided further*, That all employees permanently
 3 assigned to work in the Office of the Mayor shall be paid
 4 from funds allocated to the Office of the Mayor.

5 ECONOMIC DEVELOPMENT AND REGULATION

6 Economic development and regulation, \$190,335,000
 7 (including \$52,911,000 from local funds, \$84,751,000
 8 from Federal funds, and \$52,673,000 from other funds),
 9 of which \$15,000,000 collected by the District of Colum-
 10 bia in the form of BID tax revenue shall be paid to the
 11 respective BIDs pursuant to the Business Improvement
 12 Districts Act of 1996 (D.C. Law 11-134; D.C. Code, sec-
 13 1-2271 et seq.), and the Business Improvement Districts
 14 Temporary Amendment Act of 1997 (D.C. Law 12-23):
 15 *Provided*, That such funds are available for acquiring serv-
 16 ices provided by the General Services Administration: *Pro-*
 17 *vided further*, That Business Improvement Districts shall
 18 be exempt from taxes levied by the District of Columbia.

19 PUBLIC SAFETY AND JUSTICE

20 Public safety and justice, including purchase or lease
 21 of ~~135~~ passenger-carrying vehicles for replacement only,
 22 including 130 for police-type use and five for fire-type use,
 23 without regard to the general purchase price limitation for
 24 the current fiscal year, \$778,770,000 (including
 25 \$565,511,000 from local funds, \$29,012,000 from Federal

1 funds, and \$184,247,000 from other funds): *Provided,*
2 That the Metropolitan Police Department is authorized to
3 replace not to exceed 25 passenger-carrying vehicles and
4 the Department of Fire and Emergency Medical Services
5 of the District of Columbia is authorized to replace not
6 to exceed five passenger-carrying vehicles annually when-
7 ever the cost of repair to any damaged vehicle exceeds
8 three-fourths of the cost of the replacement: *Provided fur-*
9 *ther,* That not to exceed \$500,000 shall be available from
10 this appropriation for the Chief of Police for the preven-
11 tion and detection of crime: *Provided further,* That the
12 Metropolitan Police Department shall provide quarterly
13 reports to the Committees on Appropriations of the House
14 and Senate on efforts to increase efficiency and improve
15 the professionalism in the department: *Provided further,*
16 That notwithstanding any other provision of law, or May-
17 or's Order 86-45, issued March 18, 1986, the Metropoli-
18 tan Police Department's delegated small purchase author-
19 ity shall be \$500,000: *Provided further,* That the District
20 of Columbia government may not require the Metropolitan
21 Police Department to submit to any other procurement re-
22 view process, or to obtain the approval of or be restricted
23 in any manner by any official or employee of the District
24 of Columbia government, for purchases that do not exceed
25 \$500,000: *Provided further,* That the Mayor shall reim-

1 burse the District of Columbia National Guard for ex-
2 penses incurred in connection with services that are per-
3 formed in emergencies by the National Guard in a militia
4 status and are requested by the Mayor, in amounts that
5 shall be jointly determined and certified as due and pay-
6 able for these services by the Mayor and the Commanding
7 General of the District of Columbia National Guard: *Pro-*
8 *vided further*, That such sums as may be necessary for
9 reimbursement to the District of Columbia National
10 Guard under the preceding proviso shall be available from
11 this appropriation, and the availability of the sums shall
12 be deemed as constituting payment in advance for emer-
13 gency services involved: *Provided further*, That the Metro-
14 politan Police Department is authorized to maintain 3,800
15 sworn officers, with leave for a 50 officer attrition: *Pro-*
16 *vided further*, That no more than 15 members of the Met-
17 ropolitan Police Department shall be detailed or assigned
18 to the Executive Protection Unit, until the Chief of Police
19 submits a recommendation to the Council for its review:
20 *Provided further*, That \$100,000 shall be available for in-
21 mates released on medical and geriatric parole: *Provided*
22 *further*, That commencing on December 31, 1999, the
23 Metropolitan Police Department shall provide to the Com-
24 mittees on Appropriations of the Senate and House of
25 Representatives, the Committee on Governmental Affairs

1 of the Senate, and the Committee on Government Reform
2 of the House of Representatives, quarterly reports on the
3 status of crime reduction in each of the 83 police service
4 areas established throughout the District of Columbia:
5 *Provided further*, That up to \$700,000 in local funds shall
6 be available for the operations of the Citizen Complaint
7 Review Board.

8 PUBLIC EDUCATION SYSTEM

9 Public education system, including the development
10 of national defense education programs, \$867,411,000 (in-
11 cluding \$721,847,000 from local funds, \$120,951,000
12 from Federal funds, and \$24,613,000 from other funds),
13 to be allocated as follows: \$713,197,000 (including
14 \$600,936,000 from local funds, \$106,213,000 from Fed-
15 eral funds, and \$6,048,000 from other funds), for the pub-
16 lic schools of the District of Columbia; \$10,700,000 from
17 local funds for the District of Columbia Teachers' Retire-
18 ment Fund; \$17,000,000 from local funds, previously ap-
19 propriated in this Act as a Federal payment, for resident
20 tuition support at public and private institutions of higher
21 learning for eligible District of Columbia residents;
22 \$27,885,000 from local funds for public charter schools:
23 *Provided*, That if the entirety of this allocation has not
24 been provided as payments to any public charter schools
25 currently in operation through the per pupil funding for-

1 mula, the funds shall be available for new public charter
2 schools on a per pupil basis: *Provided further*, That
3 \$480,000 of this amount shall be available to the District
4 of Columbia Public Charter School Board for administra-
5 tive costs: \$72,347,000 (including \$40,491,000 from local
6 funds, \$13,536,000 from Federal funds, and \$18,320,000
7 from other funds) for the University of the District of Co-
8 lumbia; \$24,171,000 (including \$23,128,000 from local
9 funds, \$798,000 from Federal funds, and \$245,000 from
10 other funds) for the Public Library; \$2,111,000 (including
11 \$1,707,000 from local funds and \$404,000 from Federal
12 funds) for the Commission on the Arts and Humanities:
13 *Provided further*, That the public schools of the District
14 of Columbia are authorized to accept not to exceed 31
15 motor vehicles for exclusive use in the driver education
16 program: *Provided further*, That not to exceed \$2,500 for
17 the Superintendent of Schools, \$2,500 for the President
18 of the University of the District of Columbia, and \$2,000
19 for the Public Librarian shall be available from this appro-
20 priation for official purposes: *Provided further*, That none
21 of the funds contained in this Act may be made available
22 to pay the salaries of any District of Columbia Public
23 School teacher, principal, administrator, official, or em-
24 ployee who knowingly provides false enrollment or attend-
25 ance information under article II, section 5 of the Act enti-

1 tled “An Act to provide for compulsory school attendance,
2 for the taking of a school census in the District of Colum-
3 bia, and for other purposes”, approved February 4, 1925
4 (D.C. Code, sec. 31-401 et seq.): *Provided further*, That
5 this appropriation shall not be available to subsidize the
6 education of any nonresident of the District of Columbia
7 at any District of Columbia public elementary and sec-
8 ondary school during fiscal year 2000 unless the non-
9 resident pays tuition to the District of Columbia at a rate
10 that covers 100 percent of the costs incurred by the Dis-
11 trict of Columbia which are attributable to the education
12 of the nonresident (as established by the Superintendent
13 of the District of Columbia Public Schools): *Provided fur-*
14 *ther*, That this appropriation shall not be available to sub-
15 sidize the education of nonresidents of the District of Co-
16 lumbia at the University of the District of Columbia, un-
17 less the Board of Trustees of the University of the District
18 of Columbia adopts, for the fiscal year ending September
19 30, 2000, a tuition rate schedule that will establish the
20 tuition rate for nonresident students at a level no lower
21 than the nonresident tuition rate charged at comparable
22 public institutions of higher education in the metropolitan
23 area: *Provided further*, That the District of Columbia Pub-
24 lic Schools shall not spend less than \$365,500,000 on local
25 schools through the Weighted Student Formula in fiscal

1 year 2000: *Provided further*, That notwithstanding any
 2 other provision of law, the Chief Financial Officer of the
 3 District of Columbia shall apportion from the budget of
 4 the District of Columbia Public Schools a sum totaling
 5 5 percent of the total budget to be set aside until the cur-
 6 rent student count for Public and Charter schools has
 7 been completed, and that this amount shall be apportioned
 8 between the Public and Charter schools based on their re-
 9 spective student population count: *Provided further*, That
 10 the District of Columbia Public Schools may spend
 11 \$500,000 to engage in a Schools Without Violence pro-
 12 gram based on a model developed by the University of
 13 North Carolina, located in Greensboro, North Carolina.

14 HUMAN SUPPORT SERVICES

15 Human support services, \$1,526,361,000 (including
 16 \$635,373,000 from local funds, \$875,814,000 from Fed-
 17 eral funds, and \$15,174,000 from other funds): *Provided*,
 18 That \$25,150,000 of this appropriation, to remain avail-
 19 able until expended, shall be available solely for District
 20 of Columbia employees' disability compensation: *Provided*
 21 *further*, That a peer review committee shall be established
 22 to review medical payments and the type of service re-
 23 ceived by a disability compensation claimant: *Provided fur-*
 24 *ther*, That the District of Columbia shall not provide free
 25 government services such as water, sewer, solid waste dis-

1 posal or collection, utilities, maintenance, repairs, or simi-
2 lar services to any legally constituted private nonprofit or-
3 ganization, as defined in section 411(5) of the Stewart B.
4 McKinney Homeless Assistance Act (101 Stat. 485; Pub-
5 lie Law 100-77; 42 U.S.C. 11371), providing emergency
6 shelter services in the District, if the District would not
7 be qualified to receive reimbursement pursuant to such
8 Act (101 Stat. 485; Public Law 100-77; 42 U.S.C. 11301
9 et seq.).

10 PUBLIC WORKS

11 Public works, including rental of one passenger-car-
12 rying vehicle for use by the Mayor and three passenger-
13 carrying vehicles for use by the Council of the District of
14 Columbia and leasing of passenger-carrying vehicles,
15 \$271,395,000 (including \$258,341,000 from local funds,
16 \$3,099,000 from Federal funds, and \$9,955,000 from
17 other funds): *Provided*, That this appropriation shall not
18 be available for collecting ashes or miscellaneous refuse
19 from hotels and places of business.

20 RECEIVERSHIP PROGRAMS

21 For all agencies of the District of Columbia govern-
22 ment under court ordered receivership, \$342,077,000 (in-
23 cluding \$217,606,000 from local funds, \$106,111,000
24 from Federal funds, and \$18,360,000 from other funds).

1 WORKFORCE INVESTMENTS

2 For workforce investments, \$8,500,000 from local
3 funds, to be transferred by the Mayor of the District of
4 Columbia within the various appropriation headings in
5 this Act for which employees are properly payable.

6 RESERVE

7 For a reserve to be established by the Chief Financial
8 Officer of the District of Columbia and the District of Co-
9 lumbia Financial Responsibility and Management Assist-
10 ance Authority, \$150,000,000.

11 DISTRICT OF COLUMBIA FINANCIAL RESPONSIBILITY

12 AND MANAGEMENT ASSISTANCE AUTHORITY

13 For the District of Columbia Financial Responsibility
14 and Management Assistance Authority, established by sec-
15 tion 101(a) of the District of Columbia Financial Respon-
16 sibility and Management Assistance Act of 1995 (109
17 Stat. 97; Public Law 104-8), \$3,140,000: *Provided*, That
18 none of the funds contained in this Act may be used to
19 pay any compensation of the Executive Director or Gen-
20 eral Counsel of the Authority at a rate in excess of the
21 maximum rate of compensation which may be paid to such
22 individual during fiscal year 2000 under section 102 of
23 such Act, as determined by the Comptroller General (as
24 described in GAO letter report B-279095.2).

1 REPAYMENT OF LOANS AND INTEREST

2 For payment of principal, interest and certain fees
3 directly resulting from borrowing by the District of Co-
4 lumbia to fund District of Columbia capital projects as
5 authorized by sections 462, 475, and 490 of the District
6 of Columbia Home Rule Act, approved December 24,
7 1973, as amended, and that funds shall be allocated for
8 expenses associated with the Wilson Building,
9 \$328,417,000 from local funds: *Provided*, That for equip-
10 ment leases, the Mayor may finance \$27,527,000 of equip-
11 ment cost, plus cost of issuance not to exceed 2 percent
12 of the par amount being financed on a lease purchase
13 basis with a maturity not to exceed 5 years: *Provided fur-*
14 *ther*, That \$5,300,000 is allocated to the Metropolitan Po-
15 lice Department, \$3,200,000 for the Fire and Emergency
16 Medical Services Department, \$350,000 for the Depart-
17 ment of Corrections, \$15,949,000 for the Department of
18 Public Works and \$2,728,000 for the Public Benefit Cor-
19 poration.

20 REPAYMENT OF GENERAL FUND RECOVERY DEBT

21 For the purpose of eliminating the \$331,589,000
22 general fund accumulated deficit as of September 30,
23 1990, \$38,286,000 from local funds, as authorized by sec-
24 tion 461(a) of the District of Columbia Home Rule Act
25 (105 Stat. 540; D.C. Code, sec. 47-321(a)(1)).

1 PAYMENT OF INTEREST ON SHORT-TERM BORROWING

2 For payment of interest on short-term borrowing,
3 \$9,000,000 from local funds.

4 CERTIFICATES OF PARTICIPATION

5 For lease payments in accordance with the Certifi-
6 cates of Participation involving the land site underlying
7 the building located at One Judiciary Square, \$7,950,000
8 from local funds.

9 OPTICAL AND DENTAL INSURANCE PAYMENTS

10 For optical and dental insurance payments,
11 \$1,295,000 from local funds.

12 PRODUCTIVITY BANK

13 The Chief Financial Officer of the District of Colum-
14 bia, under the direction of the Mayor and the District of
15 Columbia Financial Responsibility and Management As-
16 sistance Authority, shall finance projects totaling
17 \$20,000,000 in local funds that result in cost savings or
18 additional revenues, by an amount equal to such financing:
19 *Provided*, That the Mayor shall provide quarterly reports
20 to the Committees on Appropriations of the House of Rep-
21 resentatives and the Senate by the 15th calendar day after
22 the end of each quarter beginning December 31, 1999,

1 PRODUCTIVITY BANK SAVINGS

2 The Chief Financial Officer of the District of Colum-
3 bia, under the direction of the Mayor and the District of

7 For the District of Columbia Health and Hospitals
 8 Public Benefit Corporation, established by D.C. Law 11-
 9 212, D.C. Code, sec. 32-262.2, \$133,443,000 of which
 10 \$44,435,000 shall be derived by transfer from the general
 11 fund and \$89,008,000 from other funds.

12 DISTRICT OF COLUMBIA RETIREMENT BOARD

13 For the District of Columbia Retirement Board, es-
 14 tablished by section 121 of the District of Columbia Re-
 15 tirement Reform Act of 1979 (93 Stat. 866; D.C. Code,
 16 sec. 1-711), \$9,892,000 from the earnings of the applica-
 17 ble retirement funds to pay legal, management, invest-

11 **SEC. 102.** Except as otherwise provided in this Act,
12 all vouchers covering expenditures of appropriations con-
13 tained in this Act shall be audited before payment by the
14 designated certifying official, and the vouchers as ap-
15 proved shall be paid by checks issued by the designated
16 disbursing official.

17 **SEC. 103.** Whenever in this Act, an amount is speci-
18 fied within an appropriation for particular purposes or ob-
19 jects of expenditure, such amount, unless otherwise speci-
20 fied, shall be considered as the maximum amount that
21 may be expended for said purpose or object rather than
22 an amount set apart exclusively therefor.

23 **SEC. 104.** Appropriations in this Act shall be avail-

23 SEC. 107. Appropriations in this Act shall be avail-
24 able for the payment of public assistance without reference
25 to the requirement of section 544 of the District of Colum-

1 bia Public Assistance Act of 1982 (D.C. Law 4-101; D.C.
2 Code, sec. 3-205.44), and for the payment of the non-
3 Federal share of funds necessary to qualify for grants
4 under subtitle A of title II of the Violent Crime Control
5 and Law Enforcement Act of 1994.

6 SEC. 108. No part of any appropriation contained in
7 this Act shall remain available for obligation beyond the
8 current fiscal year unless expressly so provided herein.

9 SEC. 109. No funds appropriated in this Act for the
10 District of Columbia government for the operation of edu-
11 cational institutions, the compensation of personnel, or for
12 other educational purposes may be used to permit, encour-
13 age, facilitate, or further partisan political activities.
14 Nothing herein is intended to prohibit the availability of
15 school buildings for the use of any community or partisan
16 political group during non-school hours.

17 SEC. 110. None of the funds appropriated in this Act
18 shall be made available to pay the salary of any employee
19 of the District of Columbia government whose name, title,
20 grade, salary, past work experience, and salary history are
21 not available for inspection by the House and Senate Com-
22 mittees on Appropriations, the Subcommittee on the Dis-
23 trict of Columbia of the House Committee on Government
24 Reform, the Subcommittee on Oversight of Government
25 Management, Restructuring and the District of Columbia

1 of the Senate Committee on Governmental Affairs, and
2 the Council of the District of Columbia, or their duly au-
3 thorized representative.

4 SEC. 111. There are appropriated from the applicable
5 funds of the District of Columbia such sums as may be
6 necessary for making payments authorized by the District
7 of Columbia Revenue Recovery Act of 1977 (D.C. Law
8 2-20; D.C. Code, sec. 47-421 et seq.).

9 SEC. 112. No part of this appropriation shall be used
10 for publicity or propaganda purposes or implementation
11 of any policy including boycott designed to support or de-
12 feat legislation pending before Congress or any State legis-
13 lature.

14 SEC. 113. At the start of the fiscal year, the Mayor
15 shall develop an annual plan, by quarter and by project,
16 for capital outlay borrowings: *Provided*, That within a rea-
17 sonable time after the close of each quarter, the Mayor
18 shall report to the Council of the District of Columbia and
19 the Congress the actual borrowings and spending progress
20 compared with projections.

21 SEC. 114. The Mayor shall not borrow any funds for
22 capital projects unless the Mayor has obtained prior ap-
23 proval from the Council of the District of Columbia, by
24 resolution, identifying the projects and amounts to be fi-
25 nanced with such borrowings.

1 SEC. 115. The Mayor shall not expend any moneys
2 borrowed for capital projects for the operating expenses
3 of the District of Columbia government.

4 SEC. 116. None of the funds provided under this Act
5 to the agencies funded by this Act, both Federal and Dis-
6 trict government agencies, that remain available for obli-
7 gation or expenditure in fiscal year 2000, or provided from
8 any accounts in the Treasury of the United States derived
9 by the collection of fees available to the agencies funded
10 by this Act, shall be available for obligation or expenditure
11 for an agency through a reprogramming of funds which:
12 (1) creates new programs; (2) eliminates a program,
13 project, or responsibility center; (3) establishes or changes
14 allocations specifically denied, limited or increased by Con-
15 gress in the Act; (4) increases funds or personnel by any
16 means for any program, project, or responsibility center
17 for which funds have been denied or restricted; (5) rees-
18 tablishes through reprogramming any program or project
19 previously deferred through reprogramming; (6) augments
20 existing programs, projects, or responsibility centers
21 through a reprogramming of funds in excess of
22 \$1,000,000 or 10 percent, whichever is less; or (7) in-
23 creases by 20 percent or more personnel assigned to a spe-
24 cific program, project, or responsibility center; unless the
25 Appropriations Committees of both the Senate and House

1 of Representatives are notified in writing 30 days in ad-
2 vance of any reprogramming as set forth in this section.

3 SEC. 117. None of the Federal funds provided in this
4 Act shall be obligated or expended to provide a personal

7 SEC. 118. None of the Federal funds provided in this
8 Act shall be obligated or expended to procure passenger
9 automobiles as defined in the Automobile Fuel Efficiency
10 Act of 1980 (94 Stat. 1824; Public Law 96-425; 15
11 U.S.C. 2001(2)), with an Environmental Protection Agen-
12 cy estimated miles per gallon average of less than 22 miles
13 per gallon. *Provided*, That this section shall not apply to
14 security, emergency rescue, or armored vehicles.

15 SEC. 119. (a) CITY ADMINISTRATOR.—The last sen-
16 tence of section 422(7) of the District of Columbia Home
17 Rule Act (D.C. Code, sec. 1-242(7)) is amended by strik-
18 ing “; not to exceed” and all that follows and inserting
19 a period.

20 resentative under section 4(d) of the District of Columbia
21 Statehood Constitutional Convention Initiatives of 1979
22 (D.C. Law 3-171; D.C. Code, sec. 1-113(d)).

23 SEC. 127. (a) The University of the District of Co-
24 lumbia shall submit to the Mayor, the District of Columbia
25 Financial Responsibility and Management Assistance Au-

1 thority and the Council of the District of Columbia no
2 later than 15 calendar days after the end of each quarter
3 a report that sets forth—

4 (1) current quarter expenditures and obliga-
5 tions, year-to-date expenditures and obligations, and
6 total fiscal year expenditure projections versus budg-
7 et broken out on the basis of control center, respon-
8 sibility center, and object class, and for all funds,
9 non-appropriated funds, and capital financing;

10 (2) a list of each account for which spending is
11 frozen and the amount of funds frozen, broken out
12 by control center, responsibility center, detailed ob-
13 ject, and for all funding sources;

14 (3) a list of all active contracts in excess of

4 ance with applicable law; and

2 Act may be used to implement or enforce the Health Care
3 Benefits Expansion Act of 1992 (D.C. Law 9-114; D.C.

6 iting couples (whether homosexual, heterosexual, or les-

6 the Mayor of the District of Columbia and 2 individ-
7 uals appointed by the Public Charter School Board
8 established under section 2214 of the District of Co-
9 lumbia School Reform Act of 1995.”.

10 SEC. 154. The Mayor, District of Columbia Financial
11 Responsibility and Management Assistance Authority, and
12 the Superintendent of Schools shall implement a process
13 to dispose of excess public school real property within 90
14 days of the enactment of this Act.

15 REAUTHORIZATION ACT OF 1994 (PUBLIC LAW 103-

17 (1) in subsection (a)(1), by striking “District of
18 Columbia Financial Responsibility and Management
19 Assistance Authority” and inserting “Mayor”; and

20 (2) in subsection (b)(1), by striking “Author-
21 ity” and inserting “Mayor”.

22 SEC. 170. (a) FINDINGS.—The Congress finds the
23 following:

24 (1) The District of Columbia has recently wit-
25 nessed a spate of senseless killings of innocent citi-

1 zens caught in the crossfire of shootings. A Justice
2 Department crime victimization survey found that
3 while the city saw a decline in the homicide rate be-
4 tween 1996 and 1997, the rate was the highest
5 among a dozen cities and more than double the sec-
6 ond highest city.

7 (2) The District of Columbia has not made ade-
8 quate funding available to fight drug abuse in recent
9 years, and the city has not deployed its resources as
10 effectively as possible. In fiscal year 1998,
11 \$20,900,000 was spent on publicly funded drug
12 treatment in the District compared to \$29,000,000
13 in fiscal year 1993. The District's Addiction and
14 Prevention and Recovery Agency currently has only
15 2,200 treatment slots, a 50 percent drop from 1994,
16 with more than 1,100 people on waiting lists.

17 (3) The District of Columbia has seen a rash
18 of inmate escapes from halfway houses. According to
19 Department of Corrections records, between October
20 21, 1998 and January 19, 1999, 376 of the 1,125
21 inmates assigned to halfway houses walked away.
22 Nearly 280 of the 376 escapees were awaiting trial
23 including 2 charged with murder.

24 (4) The District of Columbia public schools sys-
25 tem faces serious challenges in correcting chronic

1 problems, particularly long-standing deficiencies in
2 providing special education services to the 1 in 10
3 District students needing program benefits, includ-
4 ing backlogged assessments, and repeated failure to
5 meet a compliance agreement on special education
6 reached with the Department of Education.

7 (5) Deficiencies in the delivery of basic public
8 services from cleaning streets to waiting time at De-
9 partment of Motor Vehicles to a rat population esti-
10 mated earlier this year to exceed the human popu-
11 lation have generated considerable public frustration.

12 (6) Last year, the District of Columbia forfeited
13 millions of dollars in Federal grants after Federal
14 auditors determined that several agencies exceeded
15 grant restrictions and in other instances, failed to
16 spend funds before the grants expired.

17 (7) Findings of a 1999 report by the Annie E.
18 Casey Foundation that measured the well-being of
19 children reflected that, with 1 exception, the District
20 ranked worst in the United States in every category
21 from infant mortality to the rate of teenage births
22 to statistics chronicling child poverty.

23 (b) SENSE OF THE CONGRESS.—It is the sense of
24 the Congress that in considering the District of Colum-
25 bia's fiscal year 2001 budget, the Congress will take into

1 consideration progress or lack of progress in addressing
2 the following issues:

3 (1) Crime, including the homicide rate, imple-
4 mentation of community policing, the number of po-
5 lice officers on local beats, and the closing down of
6 open-air drug markets.

7 (2) Access to drug abuse treatment, including
8 the number of treatment slots, the number of people
9 served, the number of people on waiting lists, and
10 the effectiveness of treatment programs.

11 (3) Management of parolees and pretrial violent
12 offenders, including the number of halfway house es-
13 capes and steps taken to improve monitoring and su-
14 pervision of halfway house residents to reduce the
15 number of escapes.

16 (4) Education, including access to special edu-
17 cation services and student achievement.

18 (5) Improvement in basic city services, includ-
19 ing rat control and abatement.

20 (6) Application for and management of Federal
21 grants.

22 (7) Indicators of child well-being.

23 SEC. 171. The Mayor, prior to using Federal Med-
24 icaid payments to Disproportionate Share Hospitals to
25 serve a small number of childless adults, should consider

1 the recommendations of the Health Care Development
2 Commission that has been appointed by the Council of the
3 District of Columbia to review this program, and consult
4 and report to Congress on the use of these funds.

5 SEC. 172. GAO STUDY OF DISTRICT OF COLUMBIA
6 CRIMINAL JUSTICE SYSTEM. Not later than 1 year after
7 the date of the enactment of this Act, the Comptroller
8 General of the United States shall—

9 (1) conduct a study of the law enforcement,
10 court, prison, probation, parole, and other compo-
11 nents of the criminal justice system of the District
12 of Columbia, in order to identify the components
13 most in need of additional resources, including fi-
14 nancial, personnel, and management resources; and

15 (2) submit to Congress a report on the results
16 of the study under paragraph (1).

17 This title may be cited as the “District of Columbia
18 Appropriations Act, 2000”.

19 **TITLE II—TAX REDUCTION**

20 **SEC. 201. COMMENDING REDUCTION OF TAXES BY DIS-**
21 **TRICT OF COLUMBIA.**

22 Congress commends the District of Columbia for its

25 2000 Budget Support Act of 1999).

2 Nothing in this title may be construed to limit the
3 ability of the Council of the District of Columbia to amend

4 *and approved by the District of Columbia Financial Re-*
5 *sponsibility and Management Assistance Authority.*

6 *SEC. 123. For purposes of the Balanced Budget and*
7 *Emergency Deficit Control Act of 1985 (99 Stat. 1037; Pub-*
8 *lic Law 99–177), the term “program, project, and activity”*
9 *shall be synonymous with and refer specifically to each ac-*
10 *count appropriating Federal funds in this Act, and any*
11 *sequestration order shall be applied to each of the accounts*
12 *rather than to the aggregate total of those accounts: Pro-*
13 *vided, That sequestration orders shall not be applied to any*
14 *account that is specifically exempted from sequestration by*
15 *the Balanced Budget and Emergency Deficit Control Act*

6 *government may accept and use a gift or donation during*

10 *SEC. 127. (a) The University of the District of Colum-*
11 *bia shall submit to the Mayor, the District of Columbia Fi-*
12 *nancial Responsibility and Management Assistance Author-*
13 *ity and the Council of the District of Columbia no later*
14 *than 15 calendar days after the end of each quarter a report*
15 *that sets forth—*

16 *(1) current quarter expenditures and obligations,*
17 *year-to-date expenditures and obligations, and total*
18 *fiscal year expenditure projections versus budget bro-*
19 *ken out on the basis of control center, responsibility*
20 *center, and object class, and for all funds, non-appro-*
21 *priated funds, and capital financing;*

22 *(2) a list of each account for which spending is*
23 *frozen and the amount of funds frozen, broken out by*

11 *(5) changes made in the last quarter to the orga-*
12 *nizational structure of the District of Columbia Pub-*
13 *lic Schools, displaying previous and current control*
14 *centers and responsibility centers, the names of the or-*
15 *ganizational entities that have been changed, the*
16 *name of the staff member supervising each entity af-*
17 *fected, and the reasons for the structural change.*

18 *SEC. 133. (a) IN GENERAL.—The Superintendent of*
19 *the District of Columbia Public Schools and the University*
20 *of the District of Columbia shall annually compile an accu-*
21 *rate and verifiable report on the positions and employees*
22 *in the public school system and the university, respectively.*
23 *The annual report shall set forth—*

24 *(1) the number of validated schedule A positions*
25 *in the District of Columbia public schools and the*

1 *University of the District of Columbia for fiscal year*
2 *1999, fiscal year 2000, and thereafter on full-time*
3 *equivalent basis, including a compilation of all posi-*
4 *tions by control center, responsibility center, funding*
5 *source, position type, position title, pay plan, grade,*
6 *and annual salary; and*

7 (2) *a compilation of all employees in the District*
8 *of Columbia public schools and the University of the*
9 *District of Columbia as of the preceding December 31,*
10 *verified as to its accuracy in accordance with the*
11 *functions that each employee actually performs, by*
12 *control center, responsibility center, agency reporting*
13 *code, program (including funding source), activity,*
14 *location for accounting purposes, job title, grade and*
15 *classification, annual salary, and position control*
16 *number.*

17 (b) *SUBMISSION.—The annual report required by sub-*
18 *section (a) of this section shall be submitted to the Congress,*
19 *the Mayor, the District of Columbia Council, the Consensus*
20 *Commission, and the Authority, not later than February*
21 *15 of each year.*

22 *SEC. 134. (a) No later than November 1, 1999, or with-*
23 *in 30 calendar days after the date of the enactment of this*
24 *Act, whichever occurs later, and each succeeding year, the*
25 *Superintendent of the District of Columbia Public Schools*

1 *and the University of the District of Columbia shall submit*
2 *to the appropriate congressional committees, the Mayor, the*
3 *District of Columbia Council, the Consensus Commission,*
4 *and the District of Columbia Financial Responsibility and*
5 *Management Assistance Authority, a revised appropriated*
6 *funds operating budget for the public school system and the*
7 *University of the District of Columbia for such fiscal year*
8 *that is in the total amount of the approved appropriation*
9 *and that realigns budgeted data for personal services and*
10 *other-than-personal services, respectively, with anticipated*
11 *actual expenditures.*

12 **(b)** *The revised budget required by subsection (a) of*
13 *this section shall be submitted in the format of the budget*
14 *that the Superintendent of the District of Columbia Public*
15 *Schools and the University of the District of Columbia sub-*
16 *mit to the Mayor of the District of Columbia for inclusion*
17 *in the Mayor's budget submission to the Council of the Dis-*
18 *trict of Columbia pursuant to section 442 of the District*
19 *of Columbia Home Rule Act (Public Law 93-198; D.C.*
20 *Code, sec. 47-301).*

21 **SEC. 135.** *The District of Columbia Financial Respon-*
22 *sibility and Management Assistance Authority, acting on*
23 *behalf of the District of Columbia Public Schools [DCPS]*
24 *in formulating the DCPS budget, the Board of Trustees of*
25 *the University of the District of Columbia, the Board of*

1 *Library Trustees, and the Board of Governors of the Uni-*
2 *versity of the District of Columbia School of Law shall vote*
3 *on and approve the respective annual or revised budgets for*
4 *such entities before submission to the Mayor of the District*
5 *of Columbia for inclusion in the Mayor's budget submission*
6 *to the Council of the District of Columbia in accordance*
7 *with section 442 of the District of Columbia Home Rule*
8 *Act (Public Law 93-198; D.C. Code, sec. 47-301), or before*
9 *submitting their respective budgets directly to the Council.*

10 *SEC. 136. (a) CEILING ON TOTAL OPERATING EX-*
11 *PENSES.—*

12 *(1) IN GENERAL.—Notwithstanding any other*
13 *provision of law, the total amount appropriated in*
14 *this Act for operating expenses for the District of Co-*
15 *lumbia for fiscal year 2000 under the caption “Divi-*
16 *sion of Expenses” shall not exceed the lesser of—*

17 *(A) the sum of the total revenues of the Dis-*
18 *trict of Columbia for such fiscal year; or*

19 *(B) \$5,515,379,000 (of which \$152,753,000*
20 *shall be from intra-District funds and*
21 *\$3,113,854,000 shall be from local funds), which*
22 *amount may be increased by the following:*

23 *(i) proceeds of one-time transactions,*
24 *which are expended for emergency or unan-*
25 *ticipated operating or capital needs ap-*

1 *proved by the District of Columbia Finan-*

1 *cial Officer, during a control year, as defined in sec-*
2 *tion 305(4) of the District of Columbia Financial Re-*
3 *sponsibility and Management Assistance Act of 1995*
4 *(Public Law 104–8; 109 Stat. 152), may accept, obli-*
5 *gate, and expend Federal, private, and other grants*
6 *received by the District government that are not re-*
7 *flected in the amounts appropriated in this Act.*

8 (2) *REQUIREMENT OF CHIEF FINANCIAL OFFICER*
9 *REPORT AND AUTHORITY APPROVAL.—No such Fed-*
10 *eral, private, or other grant may be accepted, obli-*
11 *gated, or expended pursuant to paragraph (1) until—*

12 (A) *the Chief Financial Officer of the Dis-*
13 *trict of Columbia submits to the Authority a re-*
14 *port setting forth detailed information regarding*
15 *such grant; and*

16 (B) *the Authority has reviewed and ap-*
17 *proved the acceptance, obligation, and expendi-*
18 *ture of such grant in accordance with review and*
19 *approval procedures consistent with the provi-*
20 *sions of the District of Columbia Financial Re-*
21 *sponsibility and Management Assistance Act of*
22 *1995.*

23 (3) *PROHIBITION ON SPENDING IN ANTICIPATION*
24 *OF APPROVAL OR RECEIPT.—No amount may be obli-*
25 *gated or expended from the general fund or other*

1 *funds of the District government in anticipation of*
2 *the approval or receipt of a grant under paragraph*
3 *(2)(B) of this subsection or in anticipation of the ap-*
4 *proval or receipt of a Federal, private, or other grant*
5 *not subject to such paragraph.*

6 (4) *QUARTERLY REPORTS.—The Chief Financial*
7 *Officer of the District of Columbia shall prepare a*
8 *quarterly report setting forth detailed information re-*
9 *garding all Federal, private, and other grants subject*
10 *to this subsection. Each such report shall be submitted*
11 *to the Council of the District of Columbia, and to the*
12 *Committees on Appropriations of the House of Rep-*
13 *resentatives and the Senate, not later than 15 days*
14 *after the end of the quarter covered by the report.*

15 (c) *REPORT ON EXPENDITURES BY FINANCIAL RE-*
16 *SPONSIBILITY AND MANAGEMENT ASSISTANCE AUTHOR-*
17 *ITY.—Not later than 20 calendar days after the end of each*
18 *fiscal quarter starting October 1, 1999, the Authority shall*

7 *receiver or official shall prepare and submit to the Mayor,*
8 *for inclusion in the annual budget of the District of Colum-*
9 *bia for the year, annual estimates of the expenditures and*
10 *appropriations necessary for the maintenance and oper-*
11 *ation of the department or agency. All such estimates shall*
12 *be forwarded by the Mayor to the Council, for its action*
13 *pursuant to sections 446 and 603(c) of the District of Co-*

21 *SEC. 138. (a) Notwithstanding any other provision of*
22 *law, rule, or regulation, an employee of the District of Co-*
23 *lumbia public schools shall be—*

24 (1) *classified as an Educational Service em-*
25 *ployee;*

1 (2) *placed under the personnel authority of the*
2 *Board of Education; and*

3 (3) *subject to all Board of Education rules.*

4 (b) *School-based personnel shall constitute a separate*
5 *competitive area from nonschool-based personnel who shall*
6 *not compete with school-based personnel for retention pur-*
7 *poses.*

8 *SEC. 139. (a) RESTRICTIONS ON USE OF OFFICIAL VE-*
9 *HICLES.—Except as otherwise provided in this section, none*
10 *of the funds made available by this Act or by any other*
11 *Act may be used to provide any officer or employee of the*
12 *District of Columbia with an official vehicle unless the offi-*
13 *cer or employee uses the vehicle only in the performance*
14 *of the officer’s or employee’s official duties. For purposes*
15 *of this paragraph, the term “official duties” does not in-*
16 *clude travel between the officer’s or employee’s residence and*
17 *workplace (except: (1) in the case of an officer or employee*
18 *of the Metropolitan Police Department who resides in the*
19 *District of Columbia or is otherwise designated by the Chief*
20 *of the Department; (2) at the discretion of the Fire Chief,*
21 *an officer or employee of the District of Columbia Fire and*
22 *Emergency Medical Services Department who resides in the*

1 (b) *INVENTORY OF VEHICLES.*—*The Chief Financial*
2 *Officer of the District of Columbia shall submit, by Novem-*
3 *ber 15, 1999, an inventory, as of September 30, 1999, of*
4 *all vehicles owned, leased or operated by the District of Co-*
5 *lumbia government. The inventory shall include, but not*
6 *be limited to, the department to which the vehicle is as-*
7 *signed; the year and make of the vehicle; the acquisition*
8 *date and cost; the general condition of the vehicle; annual*
9 *operating and maintenance costs; current mileage; and*
10 *whether the vehicle is allowed to be taken home by a District*
11 *officer or employee and if so, the officer or employee’s title*
12 *and resident location.*

13 *SEC. 140. (a) SOURCE OF PAYMENT FOR EMPLOYEES*
14 *DETAILED WITHIN GOVERNMENT.*—*For purposes of deter-*
15 *mining the amount of funds expended by any entity within*
16 *the District of Columbia government during fiscal year*
17 *2000 and each succeeding fiscal year, any expenditures of*
18 *the District government attributable to any officer or em-*
19 *ployee of the District government who provides services*
20 *which are within the authority and jurisdiction of the enti-*
21 *ty (including any portion of the compensation paid to the*
22 *officer or employee attributable to the time spent in pro-*
23 *viding such services) shall be treated as expenditures made*
24 *from the entity’s budget, without regard to whether the offi-*

1 *cer or employee is assigned to the entity or otherwise treated*
2 *as an officer or employee of the entity.*

3 **(b) MODIFICATION OF REDUCTION IN FORCE PROCE-**
4 *DURES.—The District of Columbia Government Com-*
5 *prehensive Merit Personnel Act of 1978 (D.C. Code, sec. 1–*
6 *601.1 et seq.), is further amended in section 2408(a) by de-*
7 *leting “1999” and inserting, “2000”; in subsection (b), by*
8 *deleting “1999” and inserting “2000”; in subsection (i), by*
9 *deleting “1999” and inserting, “2000”; and in subsection*
10 *(k), by deleting “1999” and inserting, “2000”.*

11 **SEC. 141.** *Notwithstanding any other provision of law,*
12 *not later than 120 days after the date that a District of*
13 *Columbia Public Schools [DCPS] student is referred for*
14 *evaluation or assessment—*

15 **(1)** *the District of Columbia Board of Education,*
16 *or its successor, and DCPS shall assess or evaluate a*
17 *student who may have a disability and who may re-*
18 *quire special education services; and*

19 **(2)** *if a student is classified as having a dis-*
20 *ability, as defined in section 101(a)(1) of the Individ-*
21 *uals with Disabilities Education Act (84 Stat. 175;*
22 *20 U.S.C. 1401(a)(1)) or in section 7(8) of the Reha-*
23 *ilitation Act of 1973 (87 Stat. 359; 29 U.S.C.*

3 *SEC. 142. (a) COMPLIANCE WITH BUY AMERICAN*
4 *ACT.—None of the funds made available in this Act may*
5 *be expended by an entity unless the entity agrees that in*
6 *expending the funds the entity will comply with the Buy*
7 *American Act (41 U.S.C. 10a–10c).*

8 *(b) SENSE OF THE CONGRESS; REQUIREMENT RE-*
9 *GARDING NOTICE.—*

10 *(1) PURCHASE OF AMERICAN-MADE EQUIPMENT*
11 *AND PRODUCTS.—In the case of any equipment or*
12 *product that may be authorized to be purchased with*
13 *financial assistance provided using funds made avail-*
14 *able in this Act, it is the sense of the Congress that*
15 *entities receiving the assistance should, in expending*
16 *the assistance, purchase only American-made equip-*
17 *ment and products to the greatest extent practicable.*

18 *(2) NOTICE TO RECIPIENTS OF ASSISTANCE.—In*
19 *providing financial assistance using funds made*
20 *available in this Act, the head of each agency of the*
21 *Federal or District of Columbia government shall pro-*
22 *vide to each recipient of the assistance a notice de-*
23 *scribing the statement made in paragraph (1) by the*
24 *Congress.*

1 (c) *PROHIBITION OF CONTRACTS WITH PERSONS*
2 *FALSELY LABELING PRODUCTS AS MADE IN AMERICA.—*
3 *If it has been finally determined by a court or Federal agen-*
4 *cy that any person intentionally affixed a label bearing a*
5 *“Made in America” inscription, or any inscription with*
6 *the same meaning, to any product sold in or shipped to*
7 *the United States that is not made in the United States,*
8 *the person shall be ineligible to receive any contract or sub-*
9 *contract made with funds made available in this Act, pur-*
10 *suant to the debarment, suspension, and ineligibility proce-*
11 *dures described in sections 9.400 through 9.409 of title 48,*
12 *Code of Federal Regulations.*

13 *SEC. 143. None of the funds contained in this Act may*
14 *be used for purposes of the annual independent audit of*
15 *the District of Columbia government (including the District*
16 *of Columbia Financial Responsibility and Management As-*
17 *sistance Authority) for fiscal year 2000 unless—*

18 (1) *the audit is conducted by the Inspector Gen-*
19 *eral of the District of Columbia pursuant to section*
20 *208(a)(4) of the District of Columbia Procurement*
21 *Practices Act of 1985 (D.C. Code, sec. 1–*
22 *1182.8(a)(4)); and*

23 (2) *the audit includes a comparison of audited*
24 *actual year-end results with the revenues submitted in*

1 *the budget document for such year and the appropri-*
2 *tions enacted into law for such year.*

3 *SEC. 144. Nothing in this Act shall be construed to*
4 *authorize any office, agency or entity to expend funds for*
5 *programs or functions for which a reorganization plan is*
6 *required but has not been approved by the District of Co-*
7 *lumbia Financial Responsibility and Management Assist-*
8 *ance Authority. Appropriations made by this Act for such*
9 *programs or functions are conditioned only on the approval*
10 *by the Authority of the required reorganization plans.*

11 *SEC. 145. Notwithstanding any other provision of law,*
12 *rule, or regulation, the evaluation process and instruments*
13 *for evaluating District of Columbia Public School employees*
14 *shall be a non-negotiable item for collective bargaining pur-*
15 *poses.*

16 *SEC. 146. None of the funds contained in this Act may*
17 *be used by the District of Columbia Corporation Counsel*
18 *or any other officer or entity of the District government*
19 *to provide assistance for any petition drive or civil action*
20 *which seeks to require Congress to provide for voting rep-*
21 *resentation in Congress for the District of Columbia.*

22 *SEC. 147. None of the funds contained in this Act may*
23 *be used to transfer or confine inmates classified above the*
24 *medium security level, as defined by the Federal Bureau*

1 *of Prisons classification instrument, to the Northeast Ohio*
2 *Correctional Center located in Youngstown, Ohio.*

3 *SEC. 148. (a) Section 202(i) of the District of Colum-*
4 *bia Financial Responsibility and Management Assistance*
5 *Act of 1995 (Public Law 104–8), as added by Section 155*
6 *of the District of Columbia Appropriations Act, 1999, is*
7 *amended to read as follows:*

8 *“(j) RESERVE.—*

9 *“(1) IN GENERAL.—Beginning with fiscal year*
10 *2000, the plan or budget submitted pursuant to this*
11 *Act shall contain \$150,000,000 for a reserve to be es-*
12 *tablished by the Mayor, Council of the District of Co-*

22 SEC. 150. None of the funds contained in this Act may
23 be used for any program of distributing sterile needles or
24 syringes for the hypodermic injection of any illegal drug.

1 *SEC. 151. (a) RESTRICTIONS.—None of the funds con-*
2 *tained in this Act may be used to make rental payments*
3 *under a lease for the use of real property by the District*
4 *of Columbia government (including any independent agen-*
5 *cy of the District) unless—*

6 *(1) the lease and an abstract of the lease have*
7 *been filed with the central office of the Deputy Mayor*
8 *for Economic Development; and*

9 *(2)(A) the District of Columbia government occu-*
10 *pies the property during the period of time covered by*
11 *the rental payment; or*

12 *(B) within 60 days of the enactment of this Act*
13 *the Mayor certifies to Congress and the landlord that*
14 *occupancy is impracticable and submits with the cer-*
15 *tification a plan to terminate or renegotiate the lease*
16 *or rental agreement; or*

17 *(C) within 60 days of the enactment of this Act*

22 *(b) UNOCCUPIED PROPERTY.—After 120 days from the*

2 *of this section.*

3 (c) *SEMI-ANNUAL REPORTS BY MAYOR.*—*Not later*
4 *than 20 days after the end of each 6-month period that be-*
5 *gins on October 1, 1999, the Mayor of the District of Colum-*
6 *bia shall submit a report to the Committees on Appropria-*
7 *tions of the House of Representatives and the Senate listing*
8 *the leases for the use of real property by the District of Co-*
9 *lumbia government that were in effect during the 6-month*
10 *period, and including for each such lease the location of*
11 *the property, the name of any person with any ownership*
12 *interest in the property, the rate of payment, the period*

18 *with the appropriations and authorizing committees*
19 *of the House and Senate providing a comprehensive*
20 *plan for the management of District of Columbia real*
21 *property assets and is proceeding with the implemen-*
22 *tation of the plan.*

14 *3–435(e)) is amended—*

15 (1) *by striking “and administrative costs nec-*

20 (b) *MAINTENANCE OF FUND IN TREASURY OF THE*

14 *ond place it appears and inserting “such les-*
15 *sees”.*

16 (2) *EFFECTIVE DATE.—This subsection shall take*
17 *effect as if included in the District of Columbia Ap-*
18 *propriations Act, 1999.*

19 (c) *ADDITIONAL FUNDING FOR IMPROVEMENTS CAR-*
20 *RIED OUT THROUGH CORPS OF ENGINEERS.—*

21 (1) *IN GENERAL.—There is hereby transferred*

12 (d) *QUARTERLY REPORTS ON PROJECT.—The Mayor*
13 *shall submit reports to the Committee on Appropriations*

15 *propriations of the Senate on the status of the improvements*
16 *described in subsection (a) for each calendar quarter occur-*
17 *ring until the improvements are completed.*

18 *SEC. 165. It is the sense of the Congress that the Dis-*

7 SEC. 166. (a) PERMITTING COURT SERVICES AND OF-
8 FENDER SUPERVISION AGENCY TO CARRY OUT SEX OF-
9 FENDER REGISTRATION.—Section 11233(c) of the National
10 Capital Revitalization and Self-Government Improvement
11 Act of 1997 (D.C. Code, sec. 24–1233(c)) is amended by
12 adding at the end the following new paragraph:

13 “(5) SEX OFFENDER REGISTRATION.—The Agen-
14 cy shall carry out sex offender registration functions
15 in the District of Columbia, and shall have the au-
16 thority to exercise all powers and functions relating
17 to sex offender registration that are granted to the
18 Agency under any District of Columbia law.”.

19 (b) AUTHORITY DURING TRANSITION TO FULL OPER-
20 ATION OF AGENCY.—

21 (1) AUTHORITY OF PRETRIAL SERVICES, PAROLE,
22 ADULT PROBATION AND OFFENDER SUPERVISION

3 under section 11232(a) of such Act (hereafter referred
4 to as the “Trustee”) shall, in accordance with section
5 11232 of such Act, exercise the powers and functions
6 of the Court Services and Offender Supervision Agen-

12 *the sum of \$5,000,000 for the Mayor, in consultation with*

4 *SEC. 169. SECTION 456 OF THE DISTRICT OF COLUM-*
5 *BIA HOME RULE ACT (SECTION 47-231 ET SEQ. OF THE*
6 *D.C. CODE, AS ADDED BY THE FEDERAL PAYMENT REAU-*
7 *THORIZATION ACT OF 1994 (PUBLIC LAW 103-373)) IS*
8 *AMENDED—*

9 *(1) in subsection (a)(1), by striking “District of*
10 *Columbia Financial Responsibility and Management*
11 *Assistance Authority” and inserting “Mayor”; and*

12 *(2) in subsection (b)(1), by striking “Authority”*
13 *and inserting “Mayor”.*

14 *SEC. 170. (a) FINDINGS.—The Congress finds the fol-*
15 *lowing:*

16 *(1) The District of Columbia has recently wit-*
17 *nessed a spate of senseless killings of innocent citizens*
18 *caught in the crossfire of shootings. A Justice Depart-*
19 *ment crime victimization survey found that while the*
20 *city saw a decline in the homicide rate between 1996*
21 *and 1997, the rate was the highest among a dozen cit-*
22 *ies and more than double the second highest city.*

23 *(2) The District of Columbia has not made ade-*
24 *quate funding available to fight drug abuse in recent*
25 *years, and the city has not deployed its resources as*

1 *effectively as possible. In fiscal year 1998,*
2 *\$20,900,000 was spent on publicly funded drug treat-*
3 *ment in the District compared to \$29,000,000 in fis-*
4 *cal year 1993. The District's Addiction and Preven-*
5 *tion and Recovery Agency currently has only 2,200*
6 *treatment slots, a 50 percent drop from 1994, with*
7 *more than 1,100 people on waiting lists.*

8 *(3) The District of Columbia has seen a rash of*
9 *inmate escapes from halfway houses. According to De-*
10 *partment of Corrections records, between October 21,*
11 *1998 and January 19, 1999, 376 of the 1,125 inmates*
12 *assigned to halfway houses walked away. Nearly 280*
13 *of the 376 escapees were awaiting trial including 2*
14 *charged with murder.*

15 *(4) The District of Columbia public schools sys-*
16 *tem faces serious challenges in correcting chronic*
17 *problems, particularly long-standing deficiencies in*
18 *providing special education services to the 1 in 10*
19 *District students needing program benefits, including*
20 *backlogged assessments, and repeated failure to meet*
21 *a compliance agreement on special education reached*
22 *with the Department of Education.*

23 *(5) Deficiencies in the delivery of basic public*
24 *services from cleaning streets to waiting time at De-*
25 *partment of Motor Vehicles to a rat population esti-*

1 *mated earlier this year to exceed the human popu-*
2 *lation have generated considerable public frustration.*

3 *(6) Last year, the District of Columbia forfeited*
4 *millions of dollars in Federal grants after Federal*
5 *auditors determined that several agencies exceeded*
6 *grant restrictions and in other instances, failed to*
7 *spend funds before the grants expired.*

8 *(7) Findings of a 1999 report by the Annie E.*
9 *Casey Foundation that measured the well-being of*
10 *children reflected that, with 1 exception, the District*
11 *ranked worst in the United States in every category*
12 *from infant mortality to the rate of teenage births to*
13 *statistics chronicling child poverty.*

14 *(b) SENSE OF THE CONGRESS.—It is the sense of the*
15 *Congress that in considering the District of Columbia’s fis-*
16 *cal year 2001 budget, the Congress will take into consider-*
17 *ation progress or lack of progress in addressing the fol-*
18 *lowing issues:*

19 *(1) Crime, including the homicide rate, imple-*
20 *mentation of community policing, the number of po-*
21 *lice officers on local beats, and the closing down of*
22 *open-air drug markets.*

23 *(2) Access to drug abuse treatment, including the*
24 *number of treatment slots, the number of people*

1 served, the number of people on waiting lists, and the
2 effectiveness of treatment programs.

3 (3) *Management of parolees and pretrial violent*
4 *offenders, including the number of halfway house es-*
5 *capades and steps taken to improve monitoring and su-*
6 *perVISION of halfway house residents to reduce the*
7 *number of escapes.*

8 (4) *Education, including access to special edu-*
9 *cation services and student achievement.*

10 (5) *Improvement in basic city services, including*
11 *rat control and abatement.*

12 (6) *Application for and management of Federal*
13 *grants.*

14 (7) *Indicators of child well-being.*

15 *SEC. 171. The Mayor, prior to using Federal Medicaid*
16 *payments to Disproportionate Share Hospitals to serve a*
17 *small number of childless adults, should consider the rec-*
18 *ommendations of the Health Care Development Commission*
19 *that has been appointed by the Council of the District of*
20 *Columbia to review this program, and consult and report*
21 *to Congress on the use of these funds.*

22 *SEC. 172. GAO STUDY OF DISTRICT OF COLUMBIA*
23 *CRIMINAL JUSTICE SYSTEM. Not later than 1 year after the*
24 *date of enactment of this Act, the Comptroller General of*
25 *the United States shall—*

1 (1) *conduct a study of the law enforcement,*
2 *court, prison, probation, parole, and other compo-*
3 *nents of the criminal justice system of the District of*
4 *Columbia, in order to identify the components most*
5 *in need of additional resources, including financial,*
6 *personnel, and management resources; and*

7 (2) *submit to Congress a report on the results of*
8 *the study under paragraph (1).*

9 *SEC. 173. Nothing in this Act bars the District of Co-*
10 *lumbia Corporation Counsel from reviewing or commenting*
11 *on briefs in private lawsuits, or from consulting with offi-*
12 *cials of the District government regarding such lawsuits.*

13 *SEC. 174. WIRELESS COMMUNICATIONS. (a) IN GEN-*
14 *ERAL.—Not later than 7 days after the date of enactment*
15 *of this Act, the Secretary of the Interior, acting through the*
16 *Director of the National Park Service, shall—*

17 (1) *implement the notice of decision approved by*
18 *the National Capital Regional Director, dated April*
19 *7, 1999, including the provisions of the notice of deci-*
20 *sion concerning the issuance of right-of-way permits*
21 *at market rates; and*

22 (2) *expend such sums as are necessary to carry*
23 *out paragraph (1).*

24 (b) *ANTENNA APPLICATIONS.—*

1 (1) *IN GENERAL.*—Not later than 120 days after
2 the receipt of an application, a Federal agency that
3 receives an application submitted after the enactment
4 of this Act to locate a wireless communications an-
5 tenna on Federal property in the District of Colum-
6 bia or surrounding area over which the Federal agen-
7 cy exercises control shall take final action on the ap-
8 plication, including action on the issuance of right-
9 of-way permits at market rates.

10 (2) *EXISTING LAW.*—Nothing in this subsection
11 shall be construed to affect the applicability of exist-
12 ing laws regarding:

13 (A) *judicial review under chapter 7 of title*
14 5, *United States Code [the Administrative Proce-*
15 *dure Act], and the Communications Act of 1934,*

16 (B) *the National Environmental Policy Act,*
17 *the National Historic Preservation Act and other*
18 *applicable federal statutes, and*

19 (C) *the authority of a State or local govern-*
20 *ment or instrumentality thereof, including the*
21 *District of Columbia, in the placement, construc-*
22 *tion, and modification of personal wireless serv-*
23 *ice facilities.*

24 This title may be cited as the “District of Columbia
