- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

1	That section 1208 of Public Law 103–434 (108 Stat.
2	4562) is amended—
3	(1) in subsection (a)—
4	(A) in the subsection heading, by inserting
5	"OR WATER EXCHANGE" after "ELECTRIFICA-
6	TION'';
7	(B) by redesignating paragraphs (1), (2),
8	and (3) as subparagraphs (A), (B), and (C), re-
9	spectively, and indenting appropriately;
10	(C) by striking "In order to" and inserting
11	the following:
12	"(1) Electrification.—In order to"; and
13	(D) by adding at the end the following:
14	"(2) Water exchange alternative.—
15	"(A) IN GENERAL.—As an alternative to
16	the measures authorized under paragraph (1)
17	for electrification, the Secretary is authorized to
18	use not more than \$4,000,000 of sums appro-
19	priated under paragraph (1) to study the engi-
20	neering feasibility of exchanging water from the
21	Columbia River for water historically diverted
22	from the Yakima River.
23	"(B) Requirements.—In carrying out
24	subparagraph (A), the Secretary, in coordina-
25	tion with the Kennewick Irrigation District and

1	in consultation with the Bonneville Power Ad-
2	ministration, shall—
3	"(i) prepare a report that describes
4	project benefits and contains feasibility
5	level designs and cost estimates;
6	"(ii) secure the critical right-of-way
7	areas for the pipeline alignment;
8	"(iii) prepare an environmental as-
9	sessment; and
10	"(iv) conduct such other studies or in-
11	vestigations as are necessary to develop a
12	water exchange.";
13	(2) in subsection (b)—
14	(A) in paragraph (1), by inserting "or
15	water exchange" after "electrification"; and
16	(B) in the second sentence of paragraph
17	(2)(A), by inserting "or the equivalent of the
18	rate" before the period;
19	(3) in subsection (d), by striking "electrifica-
20	tion," each place it appears and inserting "elec-
21	trification or water exchange"; and

- 1 (4) in subsection (d), by striking "of the two"
- 2 and inserting "thereof".
