Mr. Archer (for himself, Mr. Crane, Mr. Matsui, and Mr. Tanner) (all by request) introduced the following bill; which was referred to the Committee on Ways and Means

A BILL

To authorize extension of nondiscriminatory treatment (normal trade relations treatment) to the People's Republic of China.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. TERMINATION OF APPLICATION OF TITLE IV
- 4 OF THE TRADE ACT OF 1974 TO THE PEOPLE'S
- 5 REPUBLIC OF CHINA.
- 6 (a) Presidential Determinations and Exten-
- 7 SION OF NONDISCRIMINATORY TREATMENT.—Notwith-
- 8 standing any provision of title IV of the Trade Act of 1974
- 9 (19 U.S.C. 2431 et seq.), the President may—

- 1 (1) determine that such title should no longer 2 apply to the People's Republic of China; and
- 3 (2) after making a determination under para-
- 4 graph (1) with respect to the People's Republic of
- 5 China, proclaim the extension of nondiscriminatory
- 6 treatment (normal trade relations treatment) to the
- 7 products of that country.
- 8 (b) Accession of the People's Republic of
- 9 China to the World Trade Organization.—Prior to
- 10 making the determination provided for in subsection
- 11 (a)(1) and pursuant to the provisions of section 122 of
- 12 the Uruguay Round Agreements Act (19 U.S.C. 3532),
- 13 the President shall transmit a report to Congress certi-
- 14 fying that the terms and conditions for the accession of
- 15 the People's Republic of China to the World Trade Orga-
- 16 nization are at least equivalent to those agreed between
- 17 the United States and the People's Republic of China on
- 18 November 15, 1999.
- 19 SEC. 2. EFFECTIVE DATE.
- 20 (a) Effective Date of Nondiscriminatory
- 21 Treatment.—The extension of nondiscriminatory treat-
- 22 ment pursuant to section 1(a)(1) shall be effective no ear-
- 23 lier than the effective date of the accession of the People's
- 24 Republic of China to the World Trade Organization.

- 1 (b) Termination of Applicability of Title
- 2 IV.—On and after the effective date under subsection (a)
- 3 of the extension of nondiscriminatory treatment to the
- 4 products of the People's Republic of China, title IV of the
- 5 Trade Act of 1974 shall cease to apply to that country.
