Governmental Grants

National Endowment for the Humanities: America's Historical and Cultural Organizations grants support projects in the humanities that explore stories, ideas, and beliefs in order to deepen our understanding of our lives and our world. Grants should encourage dialogue, discussion, and civic engagement, and they should foster learning among people of all ages. Grants are available for planning and implementation stages. 501(c)(3) non-profit organizations are eligible to apply. For more information, visit:

National Endowment for the Humanities: Picturing America School Collaboration Projects grants support local initiatives that foster collaboration between teachers and humanities scholars to encourage engagement with American art to tell America's story. The goals of the grants include: strengthening understanding of the connections between great works of American art and significant events, themes, and topics in the American experience; encouraging collaboration between teachers and humanities experts who can bring integration of American artworks in core subjects; fostering discussion of how to use Picturing America images among K-12 teachers within a locality or region; and providing access to scholarly resources and primary materials that support teaching. National Institutes of Health: Grants are available to advance the science of drug abuse and drug-related HIV prevention through: the development of novel prevention approaches; the testing of novel and adapted prevention intervention approaches; the elucidation of processes associated with the selection, adoption, adaptation, implementation, sustainability and financing of empirically validated interventions; and the development of new methodologies suitable for the design and analysis of prevention research studies. Research is intended to provide pathways toward the discovery of population-level approaches for the prevention of drug abuse and dependence, drug-related problems and drug-related illness. New York Department of State: Applications are being accepted for the Brownfield Opportunity Areas program, which is designed to assist communities in redeveloping dormant and blighted land into productive and catalytic areas while restoring environmental quality. The program provides resources to area-wide redevelopment planning, access to expert environmental and economic analysis, and environmental site assessment for strategic redevelopment parcels. New York State Department of Education: The Extended School Day/School Violence Prevention (ESD/SVP) programs are accepting applications to support academic enrichment activities, such as tutoring for reading, math and science, and provide students with opportunities to participate in recreation, art, music, drama, student leadership development and community service. Funds may be used for conflict resolution, peer mediation, diversity awareness, safe corridors programs and parent education. U.S. Department of Agriculture: The Community-based Childhood Obesity Prevention initiative seeks to bring together multi-state, multi-institutional, and multi-disciplinary teams to integrate knowledge about child nutrition, physical activity, psychology, human development, child feeding practices, parenting skills and social and environmental influences on childhood obesity to develop and implement a large-scale multifaceted intervention to prevent childhood obesity. The program intends to promote collaboration, open communication, the exchange of information and the development of resources that accelerate application of knowledge to result in behavior change. - **U.S. Department of Commerce**: Applications are being accepted for projects that fall under one or more programs of the Public Works and Economic Development Act of 1965: Public Works and Economic Development Facilities Program; Planning Program; Local Technical Assistance Program; and Economic Adjustment Assistance Program. Applications should significantly benefit regions with distressed economies, including such distress as high levels of unemployment, low income levels, and large concentrations of low-income families.
