Appropriations

- Congress annually considers 11 or more appropriations measures, which provide funding for numerous activities, for example, national defense, education, homeland security, and crime.
- Congress has developed certain rules and practices for the consideration of appropriations measures, referred to as the congressional appropriations process.
- There are three types of appropriations measures. Regular appropriations bills provide most of the funding that is provided in all appropriations measures for a fiscal year, and must be enacted by October 1 of each year.
- If regular bills are not enacted by the deadline, Congress adopts continuing resolutions to continue funding generally until regular bills are enacted. Supplemental bills are considered later and provide additional appropriations.

Legislation Sponsored in the 110th Congress

H.Con.Res.108:Sense of the Congress that a commemorative postage stamp honoring Ms. Rosa Louise McCauley Parks.

H.R.20: Melanie Blocker-Stokes Postpartum Depression Research and Care Act to expand research and provide funds for postpartum depression research and services.

H.R.555: Family Telephone Connection Protection Act of 2007 to reform inmate telephone service.

H.R.600: Telecommunications Ownership Diversification Act of 2007 to expand business diversity in the telecommunications industry.

H.R. 958: Data Accountability and Trust Act to regulate commerce on electronic data containing drug personal information.

for Existing Television Band Devices Act of 2007 which allows the FCC to permit the operation of personal/portable devices nonlicensed television broadcast channels between 54 megahertz and 698 megahertz in certain circumstances.

H.R. 1321: Medicare Advanced Laboratory Diagnostics Act of 2007 to expand covered diagnostic technologies under Medicare/ Medicaid.

H.R. 1902: Protecting Consumer Access to Generic Drugs Act of 2007 to prohibit the practice of drug companies from paying

generic drug companies for not producing a cheaper form of the same

H.R. 2182: Private Immigration H.R. 1320: Interference Protection Bill for the unification of separated immigrant constituents.

> H.R. 2474: A bill that increase maximum civil penalty for violations under the Consumer Product Safety Act from 1,250,000to \$20,000,000.

> H.R. 2606: 340B Program Improvement and Integrity Act of 2007 to expand the current 340B program to allow hospitals the ability to negotiate for lowered inpatient drug costs and expand the program to rural and children's hospitals.

H.R. 2666: Blair Holt's Firearm Licensing and Record of Sale Act of 2007 to create a national gun registry.
