Mr. Polis, from the Committee on Rules, submitted the following

REPORT

[To accompany H. Res. 578]

The Committee on Rules, having had under consideration House Resolution 578, by a record vote of 8–3, report the same to the House with the recommendation that the resolution be adopted.

SUMMARY OF PROVISIONS OF THE RESOLUTION

The resolution provides for consideration of (H.R. 2996) the Department of the Interior, environment, and related agencies, 2010, under a structured rule. The resolution provides one hour of general debate equally divided and controlled by the chair and ranking minority member of the Committee on Appropriations. The resolution waives all points of order against consideration of the bill except for clauses 9 and 10 of rule XXI. The resolution waives all points of order against provisions in the bill for failure to comply with clause 2 of rule XXI.

The resolution makes in order the following amendments: (1) the amendment printed in part A of this report; (2) the amendments printed in part B of this report; (3) not to exceed three of the amendments printed in part C of this report, if offered by Representative Flake of Arizona or his designee; (4) not to exceed one of the amendments printed in part D of this report, if offered by Representative Campbell of California or his designee; and (5) not to exceed one of the amendments printed in part E of this report, if offered by Representative Hensarling of Texas or his designee.

The resolution provides that each such amendment shall be considered as read, shall be debatable for 10 minutes equally divided and controlled by the proponent and an opponent, and shall not be subject to a demand for division of the question in the House or in the Committee of the Whole. All points of order against such amendments are waived except those arising under clause 9 or 10

of rule XXI. The resolution also provides that the amendments printed in part B, C, D, or E of this report may be offered only at

the appropriate point in the reading.

The resolution provides that for those amendments reported from the Committee of the Whole, the question of their adoption shall be put to the House en gros and without intervening demand for division of the question. The resolution provides one motion to recommit with or without instructions.

The resolution provides that after consideration of the bill for amendment, the chair and ranking minority member of the Committee on Appropriations or their designees each may offer one pro forma amendment to the bill for the purpose of debate, which shall be controlled by the proponent. The resolution provides that the Chair may entertain a motion that the Committee rise only if offered by the chair of the Committee on Appropriations or his designee and that the Chair may not entertain a motion to strike out the enacting words of the bill (as described in clause 9 of rule XVIII). Finally, the resolution provides that during consideration of H.R. 2996, the Chair may reduce to two minutes the minimum time for electronic voting under clause 6 of rule XVIII and clauses 8 and 9 of rule XX.

EXPLANATION OF WAIVERS

The waiver of all points of order against consideration of the bill (except for clauses 9 and 10 of rule XXI) includes a waiver of clause 4 of rule XIII requiring a three-day layover of the committee report and requiring the three-day availability of printed hearings on a general appropriations bill.

The waiver of all points of order against provisions in the bill includes a waiver of clause 2 of rule XXI, prohibiting unauthorized appropriations or legislative provisions in an appropriations bill.

None of the funds provided in this Act under the heading "National Park Service—Save America's Treasures" shall be available for the Tarrytown Music Hall Restoration project of the Friends of the Mozartina Musical Arts Conservatory, Tarrytown, New York, and the amount otherwise provided under such heading (and the portion of such amount specified for congressionally designated items) are hereby reduced by \$150,000.
