REPORT

The Committee on Appropriations submits the following report revising the section 302(b) allocation to subcommittees set forth in Senate Report 111-22 (May 19, 2009).

Section 302(e) of the Congressional Budget Act of 1974, as amended, provides that at any time after a committee reports its allocations such committee may report to its House an alteration of such allocations. This report is submitted pursuant to this section.

The Budget Act requires that as soon as practicable after a concurrent resolution on the budget is agreed to, the Committee on Appropriations shall submit to the Senate a report subdividing among its subcommittees the new budget authority and total outlays allocated to the Committee in the joint explanatory statement accompanying the conference report on such a resolution. The conference report on the concurrent resolution for fiscal year 2010 (S. Con. Res. 13) was agreed to by the Congress on April 29, 2009.

AMOUNTS CONTAINED IN THE RESOLUTION

Pursuant to section 302(a) of the Congressional Budget Act of 1974, as amended, the joint explanatory statement accompanying the conference report on the concurrent resolution on the budget for fiscal year 2010 (H. Rept. 111-89; filed April 27, 2009) contains allocations to the Senate Committee on Appropriations for fiscal year 2009.

On May 19, 2009, the Committee on the Budget filed a revised 302(a) allocation for the Committee (Congressional Record pp. S5607-5608) reflecting an increase in discretionary spending for overseas deployments and other activities pursuant to section 401(c)(4) of the budget resolution. On June 17, 2009, the Com-

mittee on the Budget filed a further modification of the section 302(a) allocation to reflect the conference outcome on the Supplemental Appropriations Act, 2009 for such funding. In total, the adjustment for overseas deployments and other activities is \$99,730,000,000 in budget authority and \$27,029,000,000 in outlays. The adjusted allocations to subcommittees are set forth below:
