The U.S.-China Economic and Security Review Commission will conduct a public hearing on Thursday, February 4, 2010 on “China’s Activities in Southeast Asia and the Implications for U.S. Interests.” **The hearing will be held at 8:45 am in Room 562 of the Dirksen Senate Office Building**, located at First Street and Constitution Avenue, NE, Washington DC, 20510.

The February 4 hearing will examine China’s interests in Southeast Asia, its economic, security, and energy activities in the region; regional views of China, and the impact of Chinese activities on U.S. regional interests.
