- Index veterans' disability compensation to the cost of living to protect veterans and their survivors from inflation
- Expand work-study opportunities for veterans in college

Lipinski Gets Pentagon to Act on Recovering Fallen Service Members' Remains

The remains of 564 brave service members who died in the bloody World War II Battle of Tarawa in the Pacific have never been recovered. But at Congressman Lipinski's urging, the Department of Defense recently sent a team of investigators to Tarawa to search for evidence that could result in more service members' remains being located and returned to the United States for proper burial. This issue has also been championed by Chicago Alderman James Balcer, a decorated Marine veteran of the Vietnam War. Congressman Lipinski believes we must never forget members of our Armed Forces, especially those who have made the ultimate sacrifice.

Supporting Wounded Veterans

Congressman Lipinski applauds America's wounded veterans for their courage. He recently voted for legislation to make more disabled veterans eligible for both military retired pay and veterans' disability compensation, and will continue to work on that issue. Locally, he helped arrange transportation through Pace for wounded veterans participating in the Chicago Marathon and participated in the Wounded Warrior Project's 20-mile bicycle ride on Flag Day. Our disabled veterans set an example of unceasing determination to the entire country.
