## **Surface Transportation Reauthorization Project Requests**

On behalf of the 1st Congressional District, I have made the following requests for funding in the surface transportation authorization bill:

Sonoma County Transportation Authority Hwy 101 Steele Lane to Windsor Construct overcrossing bridge, new northbound and southbound ramps, signalized ramp intersections at Airport Boulevard on Highway 101 and remove all ramps at Fulton Road on Highway 101.

Smith River North/South Indian Roads Safety Improvements. Construct and complete Phases 2&3 of the Tribe's North/South Indian Road Safety Improvement project for State Highway 101 and Del Norte County. Request amount: \$2,570,000.00

**City of Eureka Elk River Pedestrian Trail.** Design, engineering and construction of a bike and pedestrian trail in Eureka. Request amount: \$1,600,000.00

**Nice-Lucerne Cut Off Rehabilitation Project.** Conduct planning, design, environmental review and reconstruction of the Nice-Lucerne cut-off. Request amount: \$1,200,000.00

**North County Railroad Association.** Rehabilitate rail between Windsor and Willits, including signaling improvements, bridge and drainage facility repairs, and structure and roadbed repairs. Request amount: \$10,000,000.00

**SR 29 Rutherford Cross and Petrified Forest SR 128 Roundabouts.** Construct two rural single lane roundabouts at the intersection of State Route 29 and Rutherford Cross Road, and the intersection of State Route 128/Petrified Forest Road in the City of Calistoga. Request amount: \$5,600,000.00

**City of Healdsburg Healdsburg Ave Russian River Bridge.** Conduct preliminary engineering, environmental reviews, design, right-of-way acquisition for and full-scale construction of the Healdsburg Avenue/Russian River bridge. Request amount: \$18,512,000.00

**City of Woodland I-5 SR 113 Interchange Modification.** Construct the freeway-to-freeway connector between northbound I-5 and southbound State Route 113. Request amount: \$25,000,000.00

**HP3.** Construct 6.2 miles of bicycle and multi-use path on the out-of-service Arcata and Mad River Railroad between Arcata and Blue Lake. Request amount: \$5,200,000.00

**South Main-Soda Bay Widening and Bikelanes.** Design and prepare final plans, specifications, and engineer's estimates for the reconstruction of South Main Street and Soda Bay Road. Request amount: \$8,785,000.00

Mendocino Transit Authority Alternative Fuel Infrastructure and Carbon Footprint Reduction. Design, engineer and construct new maintenance facilities, administration/operations building and canopies over all parking spaces on Mendocino Transit Authority's existing property in Ukiah. Request amount: \$10,400,000.00

**Napa County Vine Trail.** Conduct environmental review of Napa County Vine Trail. Request amount: \$1,200,000.00

**Yolo County CR 98 Shoulder Safety Widening Projects.** Construct shoulder widening between Willow Slough Bridge to 1500 feet south of County Road 29. Request amount: \$5,300,000.00

**STAA Access on SR 199/Del Norte County**. Design and construct STAA Access to State Highway System in Del Norte County. Requested Amount: \$925,000.
