# Summary of H.R.1473; FY2011 Appropriations

Below is a summary of key funding levels passed to fund the government for the remaining of the fiscal year:

### Agriculture

- USDA (Rural Utility Service) Rural Water & Waste Disposal Program Total \$529 million (-\$39.7 million, 7 percent)
- USDA (Rural Housing Service) Community Facilities Program Total \$41.5 million (-\$13.5 million, -25 percent)
- The Women, Infants and Children's (WIC) nutrition program is funded at \$6.7 billion;
- The Commodity Supplemental Food Program is funded at \$176 million; \$5 million above the FY2010 enacted;
- Food Safety and Inspection Service is funded at \$1.0 billion; \$10 million below the enacted.

• P.L.480 Food for Peace is funded at \$1.5 billion; \$190 million below the enacted level.

### **Commerce, Justice, Science**

- Economic Development Administration (EDA) Programs Total \$246 million (-\$9 million, -4 percent)
- State and Local Law Enforcement grants are funded at \$1.1 billion; \$414 million below the enacted.
- NOAA is funded at \$4.6 billion; \$140 million below the enacted level.
- COPS grants are funded at \$496 million; \$296 million below the enacted level.
- The Legal Services Corporation is funded at \$405 million; \$15 million below the enacted level.

### **Defense**

- Defense is funded at \$513 billion; \$17 billion below the President's FY11 Budget Request and \$5 billion above the enacted level.
- No funds are provided for continued development of an alternate engine for the F-35 Joint Strike Fighter.

### **Energy and Water**

- EPA State Drinking Water & Waste Water Infrastructure Total \$2.5 billion (-\$997 million, -29 percent)
- DOE Energy Efficiency and Renewable Energy Total \$1.8 billion (-\$438 million, -36 percent)
- The Army Corps of Engineers is funded at \$4.9 billion; \$578 million below the enacted level.
- Energy Efficiency and Renewable Energy is funded at \$1.8 billion; \$407 million below the enacted level.
- Science and ARPA-E programs are funded at \$5 billion; \$161 million above the enacted level.

### **Financial Services**

• The Community Development Financial Institution (CDFI) Fund is funded at \$227 million; \$20 million below the enacted level.

#### **Homeland Security**

- Firefighters Assistance grants is funded at \$810 million; the same as the enacted level. Also includes waivers of cost-share requirements and to retain and hire firefighters. The agreement provides \$405 million for fire equipment grants and \$405 million for Staffing for Adequate Fire and Emergency Response (SAFER), firefighter hiring, compared to \$390 million and \$420 million respectively in FY 2010.
- The FEMA Disaster Relief Fund is funded at \$2.7 billion; \$1.1 billion above the enacted level.
- FEMA State and Local grants is funded at \$2.23 billion; \$815 million below the enacted level.

• Customs and Border Protection Salaries and Expenses is funded at \$8.21 billion; \$149 million above the enacted level. This fully funds 21,370 the Border Patrol agents and Southwest Border security initiatives.

### **Interior and Environment**

- Land & Water Conservation Fund Total \$301 million (-\$149 million, -33 percent)
- National Park Service Historic Preservation Grants\* Total \$55 million (-\$25 million, -31 percent) \*The bill prohibits the use of funds appropriated to this account for Save America's Treasures program grants.
- The EPA is funded at \$8.7 billion; \$1.6 below the enacted level.
- Science and Technology is funded at \$815 million; \$31 million below the enacted level.
- Bureau of Ocean Energy Management, Regulation and Enforcement is funded at \$239 million; \$58 above the enacted level.

### Labor, HHS, Education

- The Maximum Pell Grant award is maintained at \$5,550.
- Head Start is funded at \$7.6 billion; \$340 million above the enacted level.
- Title X Family Planning is funded at \$300 million; \$17 million below the enacted level.
- National Institutes of Health is funded at \$30.7 billion; \$260 million, or 0.8 percent, below the enacted level.
- Corporation for National and Community Service (AmeriCorps and other programs) is funded at 1.1 billion; \$72 million below the enacted level.
- Community Services Block grants are funded at \$680 million; \$20 million below the enacted level 3 per cent. .
- Workforce Investment Act job training grants are funded at \$2.8 billion; \$182 million below the enacted level.

### **Transportation, HUD**

- Veterans Affairs Supportive Housing (VASH) is funded at \$50 million; \$25 million below the enacted level.
- Community Development Block grants are funded at \$3.5 billion; \$942 million below the enacted level -2 per cent.
- Section 8 Housing Renewals are funded at \$25.6 billion; \$987 million above the enacted level.
- High-speed rail is not funded in this bill

### State and Foreign Operations.

- Development Assistance is funded at \$2.5 billion; \$5 million above the enacted level.
- Global Health and Child Survival is funded at \$2.5 billion; \$80 million above the enacted level.

- Family planning is funded at \$615 million; \$88 million below the enacted level.
- Humanitarian Disaster and Refugee Assistance is funded at \$2.6 billion; \$20 million above the enacted level.

### **Grants.Gov Upgrading Site Security**

Grants.gov is improving the security of federal grant applications submitted through its site. "Grants.gov Security Upgrades and How They Impact You" (*Local/State Funding Report*, February 21, 2011) describes these changes:

- Every site user will have to update their password every 90 days.
- Your new password must be different from your last three passwords; it
  has to be at least eight characters long and must include at least one
  numeral, one uppercase letter, and one lowercase letter.
- The person responsible for authorizing individuals in your organization to submit grant applications (your E-Business Point of Contact or E-Biz POC) must provide the required Data Universal System number and Marketing Partner ID Number (MPIN) when initially logging on to the site. You can find the MPIN at <a href="www.ccr.gov">www.ccr.gov</a> by using either your organization's DUNS (Data Universal Numbering System) number or its legal business name.
- If you can't access the site because your password is incorrect or outdated, use the Grants.gov "I forgot my password" function. The system will then generate a new password and send it to you by email.

### Format for Upcoming Nonfiler Automatic Revocation List

Most tax-exempt organizations, other than churches, must file a yearly return or notice with the IRS. If an organization does not file as required for three consecutive years, the law provides that it automatically loses its tax-exempt status. Loss of exempt status means an organization must file income tax returns and pay income tax, and its contributors will not be able to deduct their donations.

The IRS will soon publish and begin maintaining a list, updated monthly, of organizations that have had their federal tax-exempt status revoked. The Nonfiler Revocation List will be available in two formats, Adobe Acrobat and Microsoft Excel. The list will be divided into separate lists for each state, the District of Columbia, and all other territories and countries. The list will provide, for each revoked organization, the name, Employer Identification Number (EIN),

organization type (subsection code), last known address provided to the IRS by the organization, and the effective date of revocation. The effective date of revocation is the original filing due date, without regard to extensions, of the third annual required return or notice that was not filed.

# Economic Development Administration - Jobs and Innovation Accelerator Challenge

The Obama Administration announces the Jobs and Innovation Accelerator Challenge (Accelerator Challenge), an initiative of 16 Federal agencies and bureaus to accelerate innovation-fueled job creation and economic prosperity through public-private partnerships. The Accelerator Challenge will offer, subject to the availability of funds, a combination of \$33 million in funding from three agencies and technical assistance resources from 13 additional agencies and bureaus to support customized solutions for approximately 20 competitively selected industry clusters in urban and rural regions across the nation and across all sectors. A competitive solicitation is expected to be announced in May 2011.

President Obama has prioritized the development of strong regions 1 as the building blocks of a strong and globally competitive American economy and as key elements in our strategy for winning the future. Understanding that jobs are not created on Capitol Hill but in America's regions, the Obama Administration is committed to smarter use of existing Federal resources to support regional innovation and sustainable economic prosperity. Knowing that regional innovation clusters provide a globally proven approach for developing economic prosperity, this new, multi-agency initiative creates an unprecedented platform for integrating and coordinating the wide range of Federal economic development resources.

Each Accelerator Challenge investment will serve as a catalyst for leveraging private capital in the regions from an array of sources such as foundations, financial institutions, corporations and other private sector partners. Through its unprecedented linking, aligning and leveraging of Federal resources and by

building strategic public-private partnerships, the Accelerator Challenge will foster broad regional innovation, job creation, and global competitiveness.

Funds awarded to the winning applicants can be used to support and accelerate a range of measurable outcomes, including innovation, commercialization, business formation and expansion, development of a skilled workforce, job creation, exports, sustainable economic development and global competitiveness in approximately 20 industry clusters that exhibit high-growth development potential. These successful clusters will promote growth that is inclusive of the region's population.

This initiative represents the implementation of a number of Obama Administration policy priorities including:

- Acceleration of bottom-up innovation strategies encompassing urban and rural geographies, as opposed to imposing "one size fits all" solutions from Washington; and
- Reduction of Federal programs silos and promotion of more coordinated Federal funding opportunities that offer a more efficient system for customers to access Federal resources.

The partner agencies and bureaus include: Department of Commerce (EDA, National Institute for Standards and Technology (NIST), International Trade Administration (ITA), and Minority Business Development Agency (MBDA)); Department of Labor (Employment and Training Administration (ETA)); Small Business Administration (SBA); Department of Education (ED); Department of Agriculture (USDA); Environmental Protection Agency (EPA); National Science Foundation (NSF); Department of Transportation (DOT); Department of Health and Human Services (HHS); Department of the Treasury (TREAS); Department of Housing and Urban Development (HUD); and Department of Energy (DOE).

Subject to funding availability, the total proposed funding for the Accelerator Challenge is approximately \$33 million in direct Federal support from the three funding agencies and bureaus: EDA, ETA, and SBA. Specific funding sources will be named in the forthcoming FFO.

Clusters selected for funding may receive specialized technical assistance or other resources from partner agencies and bureaus, which will offer this assistance from existing programs and initiatives. These resources include Federally funded assets that can be leveraged by the clusters and entities that are available for collaborative partnerships to strengthen the clusters.

Applicants will be asked to discuss several components of their cluster. They will be evaluated against criteria that include: evidence of a high-growth cluster; the cluster's needs and opportunities; a proposed project concept and scope of work;

and the projected impact and measurable outcomes. Outcomes might include how Federal funds will be used to:

Achieve sustainable economic growth in the region;

- Augment business formation, especially small businesses, and leverage existing businesses and manufacturing assets;
- Advance commercialization of Federal and private research and increase exports;
- Develop a skilled workforce through outreach, training, and the creation of career pathways;
- Integrate historically underserved businesses and communities into the economic activities of the cluster.

Through its regular grantmaking activities the Division of Public Programs funds exhibitions at museums and historic sites throughout the country. NEH on the Road is a special initiative designed to create wider access to the stories, ideas, and themes explored in these exhibitions. First implemented in 2005, it offers smaller, object-based, low-security versions of some of these exhibitions, which circulate to small and mid-sized museums nationwide. The program now offers a roster of eight exhibitions that deal with a variety of subjects and reach dozens of venues each year. This Request for Proposals seeks applications for the ongoing maintenance of the existing exhibitions, conversion to a rotating core of six exhibitions, the creation of replacement exhibitions as the existing ones are retired from use, and the management of all logistical details connected to their circulation for a three-year period, starting in July 2012 and ending in June 2015. These logistics include (as detailed below) publicizing the exhibitions; application processing; managing bookings; preparing programming materials, training, and resources for the host venues; and arranging for shipping, insurance, storage, repair,

maintenance, and evaluation of the exhibitions. All NEH on the Road exhibitions must adhere to the following parameters: 1) the reconfigured exhibitions are primarily based on artifacts loaned from the original show; 2) they retain the humanities content and the intellectual coherence of the original exhibition; 3) they do not exceed 2,000 square feet in size; 4) they are designed to allow for easy use (e.g., uncrating, installation, etc.) by smaller museums; 5) they include materials that facilitate public programming on the themes of the exhibition; and 6) costs to the venues hosting the exhibitions will not exceed \$1,000 for booking and \$1,000 for shipping. The goal of this program is to provide exhibitions at low cost to museums that would not otherwise be able to participate in an NEH project, partly to provide resources to those museums, partly to broaden the reach of NEH-funded exhibitions, and partly to publicize the work of NEH nationally. The target venues for the program are mid-sized museums that are dispersed throughout the nation, have annual operating budgets between \$250,000 and \$1,000,000, are located in communities of fewer than 300,000 people, have approximately 2,000 square feet of available temporary exhibition space, can offer acceptable security and environmental controls for low-security exhibitions, and can provide additional public humanities programming on themes surrounding one of the exhibitions. Venues typically host an NEH on the Road exhibition for seven weeks (excluding shipping and installation time) and receive materials that can be used to create public programs based on the exhibition; ½s themes and ideas. NEH provides grants directly to the venues to help defray these program costs; venues apply directly to NEH for these funds. A typical NEH on the Road exhibition reaches five venues per year. To date approximately 150 bookings have occurred, and existing shows are fully booked through 2011. An exhibition's life span is normally four to five years, depending on loan arrangements with the originating museum.

The LSAMP program assists universities and colleges in diversifying the STEM workforce through their efforts at significantly increasing the numbers of students successfully completing high quality degree programs in science, technology, engineering and mathematics (STEM) disciplines. Particular emphasis is placed on transforming STEM education through innovative recruitment and retention strategies and experiences in support of groups that historically have been underrepresented in STEM disciplines: African-Americans, Alaskan Natives, Native Americans, Hispanic Americans, and Native Pacific Islanders. The knowledge generation portfolio contributes to the body of literature on successful practices in student recruitment, retention, persistence, and attainment of STEM undergraduate and graduate degrees, especially for the previously mentioned populations underrepresented in STEM disciplines. Managed synergistically, the LSAMP program enables seamless transitions from pre-college to the STEM baccalaureate to

attainment of the doctorate and entry to the STEM professoriate. Support begins at the baccalaureate level with emphasis on development of broadbased regional and national alliances of academic institutions, school districts, state and local governments, and the private sector to increase the diversity and quality of the STEM workforce. Eligible LSAMP undergraduate students may receive continued support for up to two additional years of STEM post baccalaureate study through the Bridge to the Doctorate (BD) Activity. BD participants are expected to transition to STEM Ph.D. programs and the professoriate and/or STEM workforce. Linkages with NSF projects and other graduate programs in the nation furthers the graduate education experience of underrepresented STEM students through the doctorate level, preparing them for fulfilling opportunities and productive careers as STEM faculty and research professionals.
