- For 40 years, AmeriCorps\*VISTA has been helping bring communities and individuals out of poverty.
- Today, nearly 10,000 AmeriCorps\*VISTA members serve in hundreds of nonprofit organizations and public agencies throughout the country.
- AmeriCorps\*VISTA members help organizations fight illiteracy, support youth aging out of foster care, increase job training opportunities, bridge the digital divide and much more.
- All projects focus on building permanent infrastructure in organizations to help them more effectively bring individuals and communities out of poverty



- VISTA members serve 40 hours per week in capacity building roles.
- Projects often focus on the following types of activities:
  - ✓ Resource Development (grant writing and fundraising)
  - ✓ Volunteer Generation
  - ✓ Outreach and Marketing
  - ✓ Building Partnerships and Collaborations
  - ✓ Program Development
- VISTA members may <u>not</u> provide direct services to clients or perform the regular work of agency staff.




#### **Program Development Priority Areas**

# VISTA Project Sponsor "Match"



Projects should provide:

- On-Site Orientation and Training
- Material Support-supplies
- Daily Supervision, Community Support
- On-Assignment Transportation reimbursement
- Projects may "cost share" pay living allowance for member(s).



*Not a grant program* – we provide people power!



- AmeriCorps\*NCCC (National Civilian Community Corps) is a full-time, team-based residential program for men and women ages 18–24.
- Alongside the community and Sponsor Organization, members complete service projects within an assigned region.
- Service projects last from six to eight weeks, address critical needs in education, public safety, the environment and other unmet needs.
- NCCC members construct and rehabilitate low-income housing, respond to disasters, clean up streams, help communities develop emergency plans, tutor students and address countless other local needs.



#### **Project Sponsor Requirements**

- Propose meaningful work that meets compelling community needs;
- ✓ Provide Housing (if 90 miles or more from Campus);
- ✓ Introduction and orientation to the organization and community;
- Project-specific training (e.g., power tools, tutoring skills);
- $\checkmark$  Site supervision;



Who may apply to host an NCCC team?

- ✓ Faith and Community-based organizations
- ✓ National nonprofits
- ✓ Schools
- ✓ Cities and towns
- ✓ National and state parks
- ✓ Indian tribes
- Sponsoring organizations should submit a project Concept Form and Application to the regional campus that covers that organization's state.
- The campus will provide assistance in completing the application, developing a work plan, and preparing the project sponsor for the arrival of the AmeriCorps\*NCCC team.



# **NCCC** Application Process

#### ✓ Complete a Project Concept Form

- ✓ If invited by NCCC, complete a Full Project APPLICATION
- ✓ Project Concept Form & Project applications are available online at <u>www.americorps.gov/nccc</u> or through the Regional Program Office.
- Project application should be submitted 2 to 4 months prior to the preferred start date of the project.
- ✓ Generally with 30 days of submission, the regional Program Office will notify the organization of its status and the next steps in the application process.

Small and medium sized nonprofit organizations are significantly challenged in their ability to sustain and expand services and that organizational development assistance may be necessary to ensure the continuation of much-needed services in local communities. Through grants awarded in this competition CNCS aim to build the capacity of small and midsize nonprofits to develop and implement performance management systems. Research suggests that an established framework of performance management is the pre-requisite and predictor of success on other aspects of nonprofit health such as financial planning and sustainability. Grantees will provide recipients with organizational development assistance to establish procedures for measuring progress and improving performance towards intended outcomes leading to community impact.





#### What are the priorities for this funding?

- 1. Build the capacity of nonprofit organizations that are, or are seeking to become, intermediary nonprofit grantees in geographic areas where nonprofit organizations face significant resource hardship challenges.
- 2. Assist both a large number of small and midsize nonprofit organizations within a geographic service delivery area and demonstrate impact.
- 3. Build the capacity of small and midsize nonprofits to develop and implement a performance management system.
- 4. Provide assistance to organizations that provide services that align with the Corporation's priority areas.
- 5. Increase the capacity of a network of intermediaries committed to leveraging additional resources to assist small and midsize nonprofits.





- CNCS has approximately \$998,000 to award new cooperative agreements.
- The Corporation expects to award up to five awards ranging from approximately \$200,000 to \$998,000 each. The Corporation will select no more than one intermediary based in a particular state.
- The Nonprofit Capacity Building Program award period is two years.
- Application deadline Tuesday, August 9, 2011.





To be eligible for a NCBP award, applicants must:

- Be a nonprofit organization as described in section 501(c) (3) of the Internal Revenue code of 1986 and exempt from taxation under section 501 (a) of such code; or an entity of organization described in paragraph (1) or (2) of section 170(c) of such Code.
- Operate within a defined geographic service area that can be city-wide, multi-city, state-wide, or limited multi-state region, and must be able to demonstrate that the nonprofits in its service area face significant resource challenges (See Section IV for justification criteria).
- Have a strong track record of providing organizational development or capacity building assistance focusing on small- to mid-size nonprofit organizations. A further discussion of the evaluation criteria for experienced and capable intermediary nonprofit organizations can be found in Section V.





#### Martin Luther King Jr. Day of Service Grants FY 2011

The Corporation for National and Community Service (CNCS) provides grants to organizations to plan and carry out projects that bring Americans together to serve in their communities in observance of *Martin Luther King Jr. Day*. The Martin Luther King Jr. Day of Service is administered by CNCS, whose mission is to improve lives, strengthen communities, and foster civic engagement through service and volunteering.





#### Martin Luther King Jr. Day of Service Grants FY 2011

- The purpose of these grants is to mobilize more Americans to observe the Martin Luther King Jr. Federal Holiday as a day of service in communities, to encourage those to serve in this holiday to make a long-term commitment to community service, and to bring people together to focus on service to others.
- In FY 2011, CNCS will award a limited number of Martin Luther King Jr. Day of Service grants to outstanding organizations, referred to in this *Notice* as "intermediaries." These intermediaries will award and manage subgrants and may also directly support and oversee local projects.
- Applicants must propose to provide at least 70 percent of the total project cost in cash and/or in-kind match from non-federal sources.
- Application deadline is July 21, 2011 at 5pm EDT.





#### Martin Luther King Jr. Day of Service Grants FY 2011

- Based on appropriations for fiscal year 2011, CNCS has a total minimum of \$700,000 to award new grants. CNCS anticipates making an estimate of seven (7) awards to intermediary organizations to support 2012 King Day activities.
- CNCS expects to make awards ranging in amounts from approximately \$50,000 to \$300,000,to support the first year of these grants.
- The award period is up to three years, with funding provided in annual increments, subject to availability of annual appropriations. Grantees will be eligible for continuation funding in the second and third years, contingent on the availability of appropriations, compliance with grant conditions, and satisfactory performance, including having secured sufficient matching funds.
