We began 2009 with new leadership in our nation and a renewed commitment to get America back on track and restore the American dream for you and your families.

Since the first of the year I've been traveling around South Florida, listening to people, talking with community leaders, and announcing initiatives we've passed in Washington to help South Floridians.



American Recovery & Reinvestment Act Breakdown of Funding (amounts in billions)



#### **Helping Homeowners**

• Provides an \$8,000 tax credit for first-time home purchases. No repayment required.

#### **Helping Seniors**

- Temporary increase in Social Security checks.
- More funding for home-delivered meals.
- Higher loan limits on reverse mortgages.

#### **Helping Patients**

- Provides a 65% federal subsidy for COBRA premiums for up to 12 months for workers involuntarily terminated from jobs.
- Provides \$1 billion for prevention and wellness programs.
- Assists state Medicaid programs with federal matching grants.

#### **Helping Parents & Students**

- Helps families afford college tuition payments for their children with a \$2,500 tax credit.
- Increases funding for Pell Grants and Stafford Loans.
- Adds \$200 million to the Work-Study program that supports undergraduate and graduate students who work while attending college, allowing 133,000 more students to participate.

#### **Helping The Unemployed**

- Funds job training programs in renewable energy industries.
- Extends unemployment benefits until December 2009.
- Increases food stamp benefits for struggling families.

#### **Helping Small Businesses**


- Provides tax credits to businesses that hire unemployed veterans and youth who have been out of work or school for more than 6 months.
- Enables businesses to write off 90% of losses from 2008 and 2009 against taxes assessed over the previous 5 years.
- Funds new grants and low-cost loans from the Small Business Administration.

## **Fighting to Save Families' Homes**

Rep. Wasserman Schultz was one of 19 original co-sponsors of key anti-foreclosure legislation, the Helping Families Save Their Homes Act



The Helping Families Save Their Homes Act seeks to help the estimated 7-9 million households facing possible foreclosure by including incentives that encourage lenders to renegotiate affordable mortgages for homeowners who are underwater, at risk of foreclosure, or nearing bankruptcy.

Specifically, the bill fixes the Hope for Homeowners program, implemented October 1, 2008, which was designed to get more families into affordable mortgages by:

- reducing current fees that have discouraged lenders from voluntarily participating and
- offering new incentives for lenders to negotiate loans.

To help families who have exhausted options for relief, the bill also allows bankruptcy judges to modify the terms of a loan for existing primary residence mortgages.

Currently, the mortgage for a primary residence cannot be modified in bankruptcy — unlike every other secured debt, including second homes, investment properties, luxury yachts, and private jets.

The fiscal year 2009 federal budget includes \$183.4 million in funds for Everglades restoration which goes a long way toward fulfilling the federal government's commitment to help restore the Everglades. When fully funded, these projects are expected to create more than 1,000 jobs for Floridians.
