A BILL

To rescind the unobligated funding for the FHA Refinance Program and to terminate the program.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "FHA Refinance Pro-
- 5 gram Termination Act".
- 6 SEC. 2. RESCISSION OF FUNDING FOR FHA REFINANCE
- 7 **PROGRAM.**
- 8 Effective on the date of the enactment of this Act,
- 9 there are rescinded and permanently canceled all unex-
- 10 pended balances remaining available as of such date of en-

- 1 actment of the amounts made available under title I of
- 2 the Emergency Economic Stabilization Act (Public Law
- 3 110–343; 12 U.S.C. 5211 et seq.) that have been allocated
- 4 for use under the FHA Refinance Program (pursuant to
- 5 Mortgagee Letter 2010–23 of the Secretary of Housing
- 6 and Urban Development) of the Making Home Affordable
- 7 initiative of the Secretary of the Treasury.

8 SEC. 3. TERMINATION OF FHA REFINANCE PROGRAM.

- 9 (a) TERMINATION OF MORTGAGEE LETTER.—The
- 10 Mortgagee Letter referred to in section 2 shall be void and
- 11 have no effect and the Secretary of Housing and Urban
- 12 Development may not issue any regulation, order, notice,
- 13 or mortgagee letter based on or substantially similar to
- 14 such Mortgagee Letter.
- 15 (b) Treatment of Remaining Funds.—Notwith-
- 16 standing subsection (a) of this section, any amounts made
- 17 available for use under the Program referred to in section
- 18 2 of this Act and expended before the date of the enact-
- 19 ment of this Act shall continue to be governed by the
- 20 Mortgagee Letter specified in subsection (a) of this sec-
- 21 tion, and any other provisions of law, regulations, orders,
- 22 and notices, applicable to such amounts, as in effect imme-
- 23 diately before such date of enactment.
- (c) Termination.—After the enactment of this Act,
- 25 the Secretary of Housing and Urban Development may

- 1 not newly insure any mortgage under the FHA Refinance
- 2 Program referred to in section 2 of this Act except pursu-
- 3 ant to a commitment to insure made before such enact-
- 4 ment, and upon the completion of all activities with re-
- 5 spect to such commitments under the provisions of law,
- 6 regulations, orders, notices, and mortgagee letters referred
- 7 to in subsection (b) of this section, the Secretary of Hous-
- 8 ing and Urban Development shall terminate the FHA Re-
- 9 finance Program referred to in section 2.
