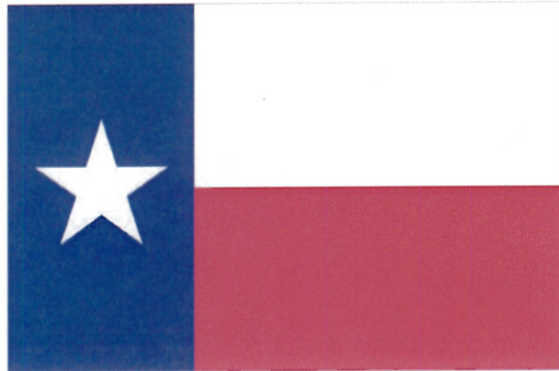

Congressman Marchant Service Academy Nomination Requirements

- ✓ **Residency:** A candidate must be a resident of the 24th Congressional District. A candidate who is temporarily residing outside the 24th District because their parents are involved in government service must prove legal residence within the 24th district and show that the move outside the District is temporary. The legal residence of the father normally determines residency. If the parents are divorced, the residence of the parent with whom the applicant lives determines their residency.
- ✓ **Age:** You must be at least 17 years old by July 1 of the year of your induction but not have passed your 23rd birthday. If you are applying for the Merchant Marine Academy, you must not have attained 25 years of age by July 1 of the year of entry.
- ✓ **Medical Examination:** One of the Academy's requirements is that all applicants are in good physical health and are medically qualified. It is in your best interest to schedule an appointment with DoDMERB prior to submitting your application to Congressman Marchant's office. Please note that DoDMERB generally takes 30 days to process results. Candidates who are medically qualified by the Academy by the application deadline will be given stronger consideration than those who have not yet been reviewed.
- ✓ **Physical Aptitude Test:** The Academy will require that you pass a physical test. Information on requirements is available from the Academy. Please complete the test prior to our application deadline. Candidates who are physically qualified by the Academy by the application deadline will be given stronger consideration than those who have not yet been tested.
- ✓ **Application Form:** The enclosed two-page application form should be completed, signed, and returned by you.
- ✓ **Recommendations:** You must include 2 completed recommendation forms in your packet. People who know you well such as a teacher, counselor, principal, minister, priest, rabbi, coach, employer, scoutmaster or community leader should complete these forms. Please do not have family members complete these forms. When completed, it should be returned to you in a sealed envelope. It is your responsibility to ensure these forms are completed in a timely manner and included in your packet.
- ✓ **Official High School Transcript:** You must include an official high school transcript. Your high school **numerical rank/class size** and **GPA MUST** be included on this transcript. Without this information on your transcript, your file will be considered incomplete. Should your school not rank students, you must have the counselor or principal denote this on your transcript. You should also see that your counselor denotes your GPA on a 4.0 scale.
- ✓ **SAT/ACT Scores:** In order to be considered for a nomination, you must have taken the SAT/ACT prior to October 2012 in order to meet our October 29, 2012 deadline. You may take these tests several times to try to improve your scores – your highest scores will be accepted. You must have official copies of your scores sent to Congressman Marchant's district office. SAT code is 4441, ACT code is 7705.
- ✓ **Questionnaire:** Please complete the questionnaire included in the packet. Type-written answers are preferred.
- ✓ **Resume:** Your resume should include school and community activities, athletic participation, honors, awards, after school and summer jobs, leadership positions and recognitions of achievement.
- ✓ **Other Transcripts:** If you have graduated from high school or attended dual credit classes at another school or university, please include a transcript for those classes with your packet.
- ✓ **Recent Photo:** Please staple a photograph, no larger than 3"x 2.5" of yourself to the first page of the application.

Nomination Process for Service Academies

Selection of Candidates- The 24th district will elect an Academy Advisory Board to assist Congressman Marchant select nominees for candidates seeking appointments. The candidates will have their applications reviewed by the Academy Advisory Board. The Academy Advisory Board will select the most qualified applicants and they will receive nominations. The academies choose from the nominees and extend the actual appointments.

Vacancies- Normally, each congressional district has one place to fill in each class entering each of the three major service academies. The vacancy is created by the graduation of a cadet from our district each year. However, when a cadet leaves an academy for any reason before graduation that creates a vacancy for the next year and changes the cycle. Therefore, it is possible that some years we may have more than one or worst case scenario, no vacancies to fill for a particular academy.

Many young people nominated rank sufficiently high so that academies select them for entrance through quotas other than "congressional". These include "athletic", "additional", "Secretary of the Army", "qualified alternate", etc. Thus, more new candidates now have the opportunity to enter an academy than in past years.

Merchant Marine- A different nomination procedure is followed for the Merchant Marine Academy. Each Texas member of Congress can nominate ten candidates, who then compete with all others nominated for the 15 spots Texas has allocated.

Coast Guard Academy- There is not a congressional nomination or geographic quota for the Coast Guard Academy. These appointments are made by the Commandant of the Coast Guard by means of a national competitive examination. You should contact Coast Guard or visit their website for an application.

In Summary- Selection of candidates by the academies is based on academic records, class standing, SAT or ACT scores, results of the medical examination and physical aptitude tests, leadership potential, and personal interviews.

There are always numerous applications for each vacancy, and competition is heavy. However, **any person who meets the requirements of the academies has a chance to be nominated.**

Congressman Marchant's district office will provide prospective candidates an application packet upon request. **All material should be sent to the district office.**

SAT and ACT Test Dates

Standardized test scores are important elements of your application. In order for your application to be considered complete, you must either send an official copy of your scores or have the testing centers send your scores to my office. The codes for my office are: **SAT: 4441 ACT: 7705**. To meet this deadline, I suggest taking one or both of the tests on these dates:

June 2, 2012

ACT

April 14, 2012
June 09, 2012
September 08, 2012

*Note: All test scores must be postmarked by **October 29, 2012**. However, your test scores can be updated between the time of your application and the time of the Academy Board meeting if your score is higher on a later test; this will only be permitted for students who submit their first score(s) on or before the official deadline to complete their files.
