#### Rep. Clarke Joins the American Jewish Committee and Immigration Reform Groups Pushing for Comprehensive Immigration Reform

On November 23<sup>rd</sup> 2009, I joined Members of the New York Congressional delegation calling for comprehensive immigration reform. The event was co-hosted by the American Jewish Committee, the New York Immigration Coalition, and the New York Interfaith Network for Immigration Reform.

As a proud daughter of Jamaican immigrant parents and an ardent advocate of comprehensive immigration reform, I believe that our immigration laws are inconsistent and inefficient. They place an undue burden on native-born Americans, documented immigrants, and undocumented immigrants alike. This system is unsustainable. When we turn our back on those who come to these shores to become Americans, to be a part of building our great nation, and to embrace the American Dream, we are turning our back on ourselves. We must never forget that this debate is critical to improving the lives of all American citizens, American businesses, and the lives of those who seek to be Americans.

I applaud the Obama Administration for recognizing the importance of addressing our broken immigration system. Last week, I had the opportunity to sit down and meet with Department of Homeland Security Secretary Janet Napolitano. We discussed the importance of addressing comprehensive immigration reform in 2010, as well as ensuring that we broaden the face of immigration to reflect the diversity of the United States.

I look forward to working with the Obama Administration, the American Jewish Committee, the New York Immigration Coalition, the New York Interfaith Network for Immigration Reform, and others to push for comprehensive immigration reform.

# Legislative Spotlight

During the holiday season we look forward to being with family and friends and often times we give thanks to their health and well being.

We are also in the flu season and with the H1N1 pandemic rapidly spreading across the United States, I thought it was important to co-sponsored H.R. 3991 "the Emergency Influenza Containment Act." This bill gives workers the right to 5 days of paid sick leave if they have a contagious illness.

Cutting down on the spread of the H1N1 virus in the work place gives families a peace of mind knowing that their loved ones can fully recuperate from the virus.

#### This bill would:

- Guarantee a sick worker up to five paid sick leave days a year if an employer 'directs' or 'advises' a sick employee to stay or go home.
- Cover both full-time and part-time workers (on a prorated basis) in businesses with 15 and more workers.
- Ensure that employees who follow their employer's direction to stay home because of contagious illness cannot be fired, disciplined, or made subject to retaliation for following directions.

By removing employees' fear of reporting symptoms of illness, employers who maintain a policy of sending home those suspected of H1N1 can have confidence that their policy will work. Employers will be able to better limit the spread and cost of contagious illness within their workforce. By limiting the potential for infecting co-workers and the public, this Act will go a long way toward securing our nation's health during a time of emergency.
