Dear Neighbor,

It is not too late to participate in the 2010 Census. If the Census Bureau did not receive your completed census form, as a courtesy, a census taker may briefly visit your home to assist with the completion of the form. By law, the Census Bureau cannot share your information with anyone, including other federal agencies, immigration authorities or law enforcement agencies.

The census taker will never ask to enter your home. If a census taker visits you, here's what you should do:

- Ask to see their ID. All census workers carry official government badges marked with just their name; they may also have a "U.S. Census Bureau" bag.
- If you're still not certain about their identity, please call the Census Bureau at (347) 328-2540 or (866) 861-2010 to confirm they are employed by the Census Bureau.
- Answer the census form questions for your entire household (you must be at least 15 years old to answer questions) so that the census taker can record the results for submission to the Census Bureau.

Let's do our part so that our voices are heard.

I applaud the local clergy members, union leaders, and members of the New York City Council who took action to highlight the need for Comprehensive Immigration Reform.

Arizona's ill-conceived immigration law, which promotes racial profiling, is an example of why we need to mend our broken immigration system.

The truth of the matter is that this is not just a Hispanic issue, it is not just a border security issue, it is an American issue.

As a Member of Congress, I will work diligently with my colleagues in Washington to ensure that we do everything in our power to pass Comprehensive Immigration Reform legislation as soon as possible.

More Good News for Small Businesses on Health Reform Tax Credits

New guidance from the IRS this week is good news for the 10,300 small businesses in the 11th Congressional District of New York which may qualify for significant tax credits under health insurance reform. The Affordable Care Act is providing tax credits, effective beginning in tax year 2010, for millions of American small businesses to help them offer health insurance coverage to their employees – if they choose to do so.

On Monday, the IRS announced a number of details of how the tax credit works, including:

- that the new tax credit will not be reduced by a state health care tax credit or subsidy (except in limited circumstances to prevent abuse of the credit);
- that small businesses can receive the credit not only for traditional health insurance coverage but also for add-on dental, vision, and other limited-scope coverage; and
- detailed guidance on how a small business can determine whether it is eligible and how large a credit it will receive.

This is even better news for the small businesses in New York, which under health reform can get tax credits to cover 35% of the small business's premium costs this year, and 50% beginning in 2014. These businesses are not required to provide health insurance, but many want to in order to retain and recruit good workers. On Monday, the IRS made it clear that affordable coverage for small businesses is a top priority, and that we will work hard to make sure reform is working for them.

Study Shows Health Reform Will Cover Nearly All Uninsured Young Adults

On Friday, May 21, 2010, the Commonwealth Fund released a new report estimating that 13.7 million uninsured young adults could gain affordable health insurance coverage as a result of the new health reform law. That number represents the vast majority of uninsured Americans under age 29.

Young adults are our most uninsured age group – and health reform was crucial to ensuring they have the security and stability of knowing they are protected in a health crisis. The Affordable Care Act gives young Americans the freedom to start their own businesses, move from job to job, and make career choices without the fear of losing health coverage.

The non-partisan Commonwealth Fund report estimates that 1.2 million young adults could receive coverage immediately, as health insurers implement the requirement that children can be covered by their parents' insurance up to age 26. That specific reform is set to go into effect in September 2010, but numerous health insurers have elected to implement the provision early, filling in the coverage gap for new college graduates. Millions more young adults will receive coverage through the newly-created insurance exchanges that go into effect in 2014. Other provisions, including expanding Medicaid eligibility, would provide health coverage to millions more young Americans.

Additionally, new insurance regulations, essential benefits, and limits on cost-sharing will ensure young adults have comprehensive health insurance that protects them from high out-of-pocket costs. Also, the Affordable Care Act will protect young adults from medical debt in the event of a serious injury or illness through the elimination of lifetime limits on health insurance coverage, which goes into effect later this year.

Now more than ever, Haitians turn to their flag for inspiration and a triumphant resolve, as they unite to rebuild their country.
