Amendments to H.R. 2219 (PART III)—FY 2012 Department of Defense Appropriations Act

The following Legislative Bulletin contains information on the amendments scheduled to be considered this vote series and 100 amendments pre-printed in the Congressional Record through Wednesday, July 6, 2011.

Order of Business: The amendments to H.R. 2219, the FY 2012, Department of Defense Appropriations Act are scheduled to be considered on Wednesday, June 6, and throughout the remainder of the week under an open rule. The rule (H.Res.320) waives all points of order against consideration of the bill and provisions in the bill for failure to comply with clause 2 of rule XXI. The rule also provides for the bill to be read for amendment by paragraph and under the five minute rule. The rule provides priority for recognition to Members who have pre-printed their amendments in the Congressional Record and provides for one motion to recommit with or without instructions.

## SUMMARY OF AMENDMENTS SCHEDULED TO BE CONSIDERED THIS VOTE SERIES

*Lee (D-CA).* This amendment would reduce funding in 41 various accounts with the purposes of ending combat operations in Afghanistan. The \$33,000,124,000 in total reductions would be transferred to the Spending Reduction Account. Please see below in the legislative bulletin under amendment 94 for all the specific reductions to each account.

*Garamendi (D-CA).* The amendment would reduce funding from 38 various accounts dedicated for funding military operations in Afghanistan. According to the bill's sponsor, the specific reductions to each account are based on CRS analysis of how changes in troop levels would impact spending. The \$22,161,542,000 in total reductions would be transferred to the Spending Reduction Account.

*Nadler (D-NY)*. The amendment would increase and subsequently decrease funding for Overseas Operations and Maintenance of the Army by \$15,000,000. According the sponsor, the intent of the amendment is to require at least \$15 million of Army OCO funding to be used for shelter insulation at Forward Operating Bases to reduce energy requirements.

**Poe** (**R-TX**). The amendment would reduce to Overseas Contingency Operations, Defense-wide Operations and Maintenance for the purposes of providing payments to reimburse

cooperating nations for logistical, military, and other support, including access provided to United States military operations in support of Operation New Dawn and Operation Enduring Freedom by \$1,000,000,000 and would place those funds under the Spending Reduction Account. According to the sponsor, the purpose of this amendment is to specifically stop payments to reimburse Pakistan for the war on terror and will not affect payments to other coalition partners.

*Lee* (*D-CA*). This amendment would reduce funding available for the Overseas Contingency Operations Transfer Fund (currently set at \$5 billion) by \$5,000,000,000, and would move this amount into the Spending Reduction Account, thereby eliminating all funding for the Overseas Contingency Operations Transfer Fund.

*Cohen (D-TN)*. This amendment would reduce funding available for the Afghanistan Infrastructure Fund (currently set at \$475,000,000) by \$200,000,000 and would place this amount in the Spending Reduction Account.

*Cicilline (D-RI)*. The amendment would reduce all funding for the Afghanistan Infrastructure Fund of \$475,000,000 and place the funding in the Spending Reduction Account.

*Cohen (D-TN)*. This amendment would reduce funding in the Afghanistan Security Forces Fund (currently set at \$12.8 billion) by \$4,000,000,000 and would place this amount in the Spending Reduction Account.

**Poe** (**R-TX**). The amendment would reduce funding for the Pakistan Counterinsurgency Fund by \$1,000,000,000 and would place those funds under the Spending Reduction Account.

*McCollum (D-MN)*. The amendment would reduce total appropriations at the end of the bill by \$124,800,000. While the text of the amendment reduces total appropriations from the entire bill, the sponsor's intent is to reduce funding for military musical units. Yesterday, an amendment to strike section 8127 of the bill that created a spending limitation of \$200 million on musical military units passed by a voice vote.

*McCollum (D-MN)*. The amendment would allow not more than \$20,000,000 of the funds made available by this Act to be used to pay motorsports drivers, racing teams, or racing cars in the National Association for Stock Car Auto Racing (NASCAR), the National Hot Rod Association (NHRA), the Indy Racing League Indy Car Series, or the American Motorcyclist Association (AMA) Super Bike Racing or otherwise conduct recruiting outreach through motor sports under the authority of section 561(b) of the Floyd D. Spence National Defense Authorization Act for Fiscal Year 2001 (as enacted into law by Public Law 106-398; 114 Stat. 1654A-129). According to opponents of the amendment this would reduce funding for advertising and sponsorship by 80%. In H.R. 1, a similar amendment to prohibit DoD funding at NASCAR races was defeated by a vote of 148 – 281.

## SUMMARY OF AMENDMENTS <u>PREPRINTED</u> IN THE CONGRESSIONAL RECORD THROUGH JULY 5 2011

1. Rigell (R-VA). The amendment prohibits funds from being used to carry out military operations in Libya.

- **2. Rigell (R-VA).** The amendment prohibits funds from being used to support Operation Odyssey Dawn or Operation Unified Protector.
- **3. Rigell (R-VA).** The amendment prohibits funds from being used to support Operation Odyssey Dawn.
- **4.** Cole (R-OK). The amendment prohibits funds from being used to implement any rule, regulation, or executive order regarding the disclosure of political contributions that takes effect on or after the bill becomes law.
- **5.** Cole (R-OK). The amendment prohibits funds from being used Central Intelligence Agency or the Department of Defense until the President formally requests and receives from Congress an authorization for the use of military force in or against Libya.
- **6.** Cole (R-OK): The amendment prohibits funds from being used Central Intelligence Agency or the Department of Defense to "furnish military equipment, military training or advice, or other support for military activities, to any group or individual, not part of a country's armed forces, for the purpose of assisting that group or individual in carrying out military activities in or against Libya."
- 7. **Bishop** (R-UT). The amendment replaces removes the term "acquisition management" and replaces it with term "product support" in section 8113 of the bill. Additionally, the amendment exempts mission assignments or transfers approved by the Secretary of the Air Force prior to June 19, 2011, from a prohibition on the relocation of Air Force Material Command sites until a report on Air Force Material Command functions is issued to Congress.
- **8.** *Sherman (D-CA).* The amendment prohibits funds from being used in contravention of the War Powers Resolution.
- **9.** *Blumenauer* (*D-OR*). The amendment would reduce funding for DoD Maintenance and Operations by \$15,000,000 and would increase funding for Defense wide Research, Development, Test, and Evaluation by \$15,000,000.
- **10.** *Blumenauer* (*D-OR*). The amendment would decrease and increase the Department of the Army Operations and Maintenance Account by \$15,000,000.
- 11. Christensen (D-VI). The amendment would require the Secretary of Health and Human Services and Secretary of the Department of Veterans Affairs to create a lung cancer mortality care program for veterans and members of the Armed Forces, based on smoking history and exposure to carcinogens during active duty service, and are diagnosed with lung cancer.
- **12.** Cole (R-OK). The amendment prohibits funds for the use of military force in or against Libya until such a time that the President formally requests and receives from Congress a authorization for the use of military force in or against Libya.
- **13.** Cole (R-OK). The amendment prohibits funds for the use to "furnish military equipment, military training or advice, or other support for military activities, to any group or

- individual, not part of a country's armed forces, for the purpose of assisting that group or individual in carrying out military activities in or against Libya."
- **14.** *Berman (D-CA)*. The amendment prohibits the use of funds to be obligated or expended for assistance for the benefit of a Hezbollah-dependent government of Lebanon. The amendment also specifically includes language on the prohibition of Section 1206 funding as well. The amendment provides a waiver on the prohibition of fund, if the Secretary of Defense, in consultation with the Secretary of State, determines and certifies in writing to Congress that such waiver is vital to the national security interests of the United States. If a waiver is issued, a report must be submitted to Congress within 15 days describing the reasons for the waiver was needed for the interests of the United States.
- **15. Quayle (R-AZ).** The amendment would increase funding for Operation and Maintenance of the Army National Guard by \$144,000,000 and would reduce funding for the Defense wide Research, Development, Test, and Evaluation by \$144,000,000.
- **16. Burton (R-IN).** The amendment prohibits the use of funds to make a contribution the military budget of the North Atlantic Treaty Organization in excess of \$408,100,000. According to the bill's sponsor, this amendment reduces the U.S. contribution to NATO's military budget to FY09 levels.
- **17. Burton** (**R-IN**). The amendment prohibits the use of funds to be used directly or indirectly support operations in Libya.
- **18. Burton (R-IN).** The amendment states that none of the funds made available by this Act for a military mission of the Armed Forces may be diverted from such military mission to achieve non-mission related objectives for members of the Armed Forces serving in combat zones.
- **19. Burton (R-IN).** The amendment prohibits the use of funds to be used to perform (or to permit the performance of) a marriage or civil union ceremony that does not comply with the definition of marriage in section 7 of title 1, United States Code (the Defense of Marriage Act) or to permit the use of a military installation or other land under the jurisdiction of the Department of Defense as the site of a marriage or civil union ceremony that does not comply with the definition of marriage in such section.
- **20. Burton (R-IN).** The amendment reduces funding for the Drug Interdiction and Counter Drug Activities account by \$51,865,000.
- **21. Broun (R-GA).** The amendment would reduce funding for the Research, Development, Test, and Evaluation from the Army by \$9,140,000 and would increase funding for the Defense wide Research, Development, Test, and Evaluation by \$9,140,000.
- **22. Broun** (**R-GA**). The amendment would reduce funding for the Research, Development, Test, and Evaluation from the Air Force by \$4,424,000 and would increase funding for the Defense wide Research, Development, Test, and Evaluation by \$4,424,000.

- **23. Broun (R-GA).** The amendment would reduce funding for the DoD Maintenance and Operations by \$216,556,400 and would place those funds under the Spending Reduction Account.
- **24. Broun (R-GA).** The amendment would reduce funding for Research Development, Test, and Evaluation of the Army by \$25,798,000 and would place those funds under the Spending Reduction Account.
- **25. Broun** (**R-GA**). The amendment would reduce funding for Research Development, Test, and Evaluation of the Army by \$22,796,000 and would place those funds under the Spending Reduction Account.
- **26. Broun** (**R-GA**). The amendment would reduce funding for Research Development, Test, and Evaluation of the Navy by \$21,714,000 and would place those funds under the Spending Reduction Account.
- **27. Miller** (**R-MI**). The amendment would increase funding for Operation and Maintenance of the Army National Guard by \$144,000,000 and would reduce funding for the Defense wide Research, Development, Test, and Evaluation by \$144,000,000.
- **28. Miller (R-MI).** The amendment would reduce funding for Operation and Maintenance of the Army by \$449,901,000 and would place those funds under the Spending Reduction Account.
- **29.** *Kucinich* (*D-OH*). The amendment prohibits the use of funds to be used for military operations against Libya.
- **30. Flores (R-TX).** The bill prohibits the used of funds to enforce section 526 of the Energy Independence and Security Act of 2007. The RSC's <u>plan</u> to reduce gas prices repeals section 526 of the 2007 energy bill, which bars federal agencies from buying alternative or synthetic fuels if they have higher lifecycle greenhouse gas emissions than conventional petroleum fuels. These resources are abundant in North America and should be utilized rather than sending taxpayer dollars overseas to pay for foreign petroleum fuels. The federal government should embrace and not prohibit the use of advanced alternate fuels.
- **31.** Carter (R-TX). The amendment will strike section 8127 of the bill, as it relates to a spending limitation on military musical units. According to CBO, striking this language will not increase the cost of the bill.
- **32. Gohmert (R-TX).** The amendment prohibits funding to be obligated, expended, or used in any manner to support operations, including NATO or United Nations operations, against Libya.
- **33. Benishek (R-MI).** The amendment strikes the phrase "that upon a determination that all or part of the funds transferred from this appropriation are not necessary for the purposes provided herein, such amounts may be transferred back to this appropriation: Provided further, That the transfer authority provided under this heading is in addition to any other transfer authority provided elsewhere in this Act" from Defense-wide environmental restoration account.

- **34. Benishek** (**R-MI**). The amendment strikes the phrase "that upon a determination that all or part of the funds transferred from this appropriation are not necessary for the purposes provided herein, such amounts may be transferred back to this appropriation: Provided further, That the transfer authority provided under this heading is in addition to any other transfer authority provided elsewhere in this Act" from Environmental restoration for the Navy account.
- **35. Benishek** (**R-MI**). The amendment strikes the phrase "that upon a determination that all or part of the funds transferred from this appropriation are not necessary for the purposes provided herein, such amounts may be transferred back to this appropriation: Provided further, That the transfer authority provided under this heading is in addition to any other transfer authority provided elsewhere in this Act" from Environmental restoration for the Army account.
- **36. Benishek** (**R-MI**). The amendment strikes the phrase "that upon a determination that all or part of the funds transferred from this appropriation are not necessary for the purposes provided herein, such amounts may be transferred back to this appropriation: Provided further, That the transfer authority provided under this heading is in addition to any other transfer authority provided elsewhere in this Act" from Environmental restoration for the Air Force account.
- **37.** *Clarke* (*D-MI*). The amendment would require the Secretary of Defense to transfer \$2 billion from the Department of Defense to the Secretary of Homeland Security to increase funding for the Homeland Security Grant Program under section 2004 of the Homeland Security Act.
- **38.** *Clarke (D-MI).* The amendment would require the Secretary of Defense to transfer \$50 million from the Department of the Army's contingency Operations and Maintenance account designated to support activities for business and stability operations in Afghanistan, to the Small Business Administration's Small Business Development Centers program.
- **39.** *Clarke (D-MI)*. The amendment would require the Secretary of Defense to transfer \$236 million from the Afghanistan Infrastructure Fund Account to the Secretary of Transportation for the National Infrastructure Investments program.
- **40.** *Clarke (D-MI).* The amendment would require the Secretary of Defense to transfer \$227 million from the Operations and Maintenance Account of the Army designated to support the Commanders Emergency Response Program in Afghanistan to the Treasury's Community Development Financial Institutions Fund.
- **41.** *Cohen (D-TN)*. The amendment would reduce funding for the Afghanistan Infrastructure Fund by \$200,000,000 and would place those funds under the Spending Reduction Account.
- **42.** *Cohen (D-TN).* The amendment would reduce funding for the Afghanistan Security Forces Fund by \$14,000,000,000 and would place those funds under the Spending Reduction Account. Note: The Afghanistan Security Forces Fund in the bill appropriates 12,800,000,000 to the account.

- **43.** *Holt* (*D-NJ*). The amendment would prohibit funding to close the defense commissary store at Fort Monmouth, New Jersey.
- **44.** *Holt* (*D-NJ*). The amendment would reduce funding for the Afghanistan Security Forces Fund by \$35,000,000 and would increase funding for the Department of Defense Health Program by \$35,000,000.
- **45. Amash** (**R-MI**). The amendment prohibits the use of funds to carry out or enforce section 2461(a)(1)(F) of title 10, United States Code.
- **46. Amash (R-MI).** The amendment strikes language in the bill that requires a federal contractor to achieve a minimum cost savings (10 percent of the in-house bid or \$10 million) in order to win a public-private competition (competitive sourcing) within Department of Defense.
- **47. Amash** (**R-MI**). The amendment prohibits the use of funds for the deployment of United States Armed Forces participating in North Atlantic Treaty Organization Operation Unified Protector.
- **48. Amash** (**R-MI**). The amendment prohibits funds for the use of force against Libya.
- **49.** *Jackson-Lee* (*D-TX*). The amendment would reduce funding for Defense-wide Operation and Maintenance by \$650,000 and increase funding for the Defense Health Account by \$500,000.
- **50.** *Jackson-Lee* (*D-TX*). The amendment would reduce funding for Defense-wide Operation and Maintenance by \$600,000 and increase funding for the Defense Health Account (TRICARE) by \$500,000.
- **51.** *Jackson-Lee* (*D-TX*). The amendment would reduce funding for Defense-wide Operation and Maintenance by \$350,000 and increase funding for the Defense Health Account (TRICARE) by \$250,000.

- **63. Burton** (**R-IN**). The amendment prohibits the use of funds to carry out training for members of the Armed Forces serving in combat zones related to implementation of any repeal of section 654 of title 10, United States Code, by section 2 of Public Law 111-321. (Don't ask, Don't Tell).
- **64.** *Michaud* (*D-ME*). The amendment prohibits funds from being used in contravention of section 2533a of title 10, United States Code (popularly known as the ``Berry Amendment").
- **65.** *Jackson-Lee* (*D-TX*). The amendment would reduce funding for Defense-wide Operation and Maintenance by \$600,000 and increase funding for the Defense Health Account (TRICARE) by \$500,000.
- **66.** *Jackson-Lee* (*D-TX*). The amendment would reduce funding for Defense-wide Operation and Maintenance by \$350,000 and increase funding for the Defense Health Account (TRICARE) by \$250,000.

- **72. Poe** (**R-TX**). The amendment would reduce funding for the Pakistan Counterinsurgency Fund by \$1,000,000,000 and would place those funds under the Spending Reduction Account.
- 73. Poe (R-TX). The amendment would reduce to Overseas Contingency Operations, Defense-wide Operations and Maintenance for the purposes of providing payments to reimburse cooperating nations for logistical, military, and other support, including access provided to United States military operations in support of Operation New Dawn and Operation Enduring Freedom by \$1,000,000,000 and would place those funds under the Spending Reduction Account. According to the sponsor, the purpose of this amendment is to specifically stop payments to reimburse Pakistan for the war on terror and will not affect payments to other coalition partners.
- **74. Poe** (**R-TX**). The amendment would reduce funding for the Pakistan Counterinsurgency Fund by \$500,000,000 and would place those funds under the Spending Reduction Account.
- **75. Poe** (**R-TX**). The amendment would reduce by \$500,000,000 funding for Overseas Contingency Operations, Defense-wide Operations and Maintenance for the purposes of providing payments to reimburse cooperating nations for logistical, military, and other support, including access provided to United States military operations in support of Operation New Dawn and Operation Enduring Freedom and would place those funds under the Spending Reduction Account.
- **76.** *Shuler (D-NC).* The amendment prohibits the use of funds to restrict cooperation between employees of the Department of Defense and employees of the Department of Homeland Security.
- 77. Huelskamp (R-KS). The amendment prohibits the use of funds from being used to implement the curriculum of the Chaplain Corps Tier 1 DADT repeal training dated April 11, 2011. According to the sponsor, in April of this year, the Office of Navy Chaplains revised training curriculum included provisions and instructions that allow chaplains to conduct same sex marriages. These instructions stand in direct conflict with the Defense of Marriage Act (DOMA).
- **78. Nugent (R-FL).** The amendment prohibits the use of funds to be used for Operation Odyssey Dawn, Operation Unified Protector, or other military operations in Libya in contravention of the War Powers Resolution (50 U.S.C. 1541 et seq.).

- **79. Nugent** (**R-FL**). The amendment prohibits the use of funds to be used for Operation Odyssey Dawn, Operation Unified Protector, or other military operations in Libya.
- **80. Sessions** (**R-TX**). The amendment strikes Section 8101 of the bill which prohibits the use of any funds to convert any functions performed by federal employees to private competition pursuant to a study conducted under OMB Circular A–76.
- **81. Sessions** (**R-TX**). The amendment reduces funding for Army Procurement Account by \$10,000,000 and increases the Defense Health Program account by \$10,000,000. According to the bill's sponsor, funding for the purchase from the Joint Tactical Radio Systems and Ground Mobile Radio Program would be reduced by \$10 million to reinforce the House's previous passage of a pilot program in the National Defense Authorization Act in order to fund "pay-for-performance" pilot programs that can deliver innovative health services to men and women in uniform.
- **82.** *McCollum (D-MN)*. The amendment would reduce total appropriations at the end of the bill by \$119,800,000.
- **83.** *McCollum (D-MN)*. The amendment would allow not more than \$20,000,000 of the funds made available by this Act may be used to pay motorsports drivers, racing teams, or racing cars in the National Association for Stock Car Auto Racing (NASCAR), the National Hot Rod Association (NHRA), the Indy Racing League Indy Car Series, or the American Motorcyclist Association (AMA) Super Bike Racing or otherwise conduct recruiting outreach through motor sports under the authority of section 561(b) of the Floyd D. Spence National Defense Authorization Act for Fiscal Year 2001 (as enacted into law by Public Law 106-398; 114 Stat. 1654A-129). According to opponents of the amendment this would reduce funding for advertising and sponsorship by 80%.
- **84.** *McCollum* (*D-MN*). The amendment would prohibit the use of funds to the Task Force for Business and Stability Operations in Afghanistan or used to carry out section 9012. According to the text of H.R. 2219, the purpose of this program is to assist the commander of the United States Central Command in developing a link between United States military operations in Afghanistan under Operation Enduring Freedom and the economic elements of United States national power in order to reduce violence, enhance stability, and restore economic normalcy in Afghanistan through strategic business and economic opportunities.
- **85.** *Welch* (*D-VT*). The amendment reduces funding for Department of the Air Force Research, Development, Test, and Evaluation by \$297,023,000 and places those funds in the Spending Reduction Account.
- **86.** Sessions (R-TX). The amendment reduces funding Defense-wide Research, Development, Test, and evaluation by \$10,000,000 and increases funding for the Defense Health Program account by \$10,000,000.
- **87.** *Murphy* (*D-CT*). The amendment adds another provision to a required report on Pakistan that includes a discussion of whether and how Pakistan discriminates against religious minorities by requiring denunciations of particular religious minorities or sects on passport applications and other instruments of state.

- **88.** *Cicilline* (*D-RI*). The amendment would reduce all funding for the Afghanistan Infrastructure Fund of \$475,000,000 and place the funding in the Spending Reduction Account.
- **89.** Neugebauer (R-TX)/Thornberry (R-TX)/Conaway (R-TX)/Noem (R-SD). The amendment would prohibit the use of funds from being used to retire any B-1 bombers this year.
- **90. Welch (D-VT)**. The amendment would reduce funding from Overseas Operation and Maintenance of the Army for the purposes of the Commanders Emergency Response Program by \$200,000,000 and places the funds in the Spending Reduction Account.
- **91. Lipinski** (**D**-*IL*). The amendment would prohibit funds from being used by the Department of Defense to replace an information technology system that stores classified information in the United States with an information technology system that stores such classified information outside the United States.
- **92.** *Garamendi (D-CA).* The amendment would reduce funding from 34 various accounts dedicated for funding the war in Afghanistan. According to the bill's sponsor, the specific reductions to each account are based on CRS analysis of how changes in troop levels would impact spending. The \$22,161,542,000 in total reductions would be placed under the Spending Reduction Account.
- **93.** *Connolly (D-VA).* This amendment would reduce funding for Operation and Maintenance, Defense-Wide, by \$10,000,000, and would increase funding for the Research, Development, Test and Evaluation, Defense-Wide by \$10,000,000.
- **94.** *Lee* (*D-CA*). This amendment would reduce funding in 41 various accounts. Specifically, the amendment would reduce funding for:

- > Overseas Contingency Operations for Military Personnel, Navy by \$445,114,000,

The \$33,000,124,000 in total reductions would be placed under the Spending Reduction Account.

- **95.** *Lee (D-CA).* This amendment would reduce funding available for the Overseas Contingency Operations Transfer Fund (currently set at \$5 billion) by \$5,000,000,000, and would move this amount into the Spending Reduction Account, thereby eliminating all funding for the Overseas Contingency Operations Transfer Fund.
- **96.** *DeFazio* (*D-OR*)/Garrett (**R-NJ**). This amendment would prohibit funding in the bill from enforcing section 376 of the National Defense Authorization Act for FY 2006 (P.L. 109-163). According to the sponsor, current law (Section 376 of the Fiscal Year 2006 National Defense Authorization Act) contains a limitation on financial management improvement and audit initiatives with the Department of Defense.
- **97.** *Frank (D-MA).* This amendment would reduce the total amount of appropriations in the bill by \$8,500,000,000, but would mandate that the amounts currently designated for Military Personnel (under title I), the Defense Health Program (under title VI), and Overseas Contingency Operations (under title IX) remain unaffected by this amendment.
- **98.** *Cohen (D-TN)*. This amendment would reduce funding available for the Afghanistan Infrastructure Fund (currently set at \$475,000,000) by \$200,000,000 and would place this amount in the Spending Reduction Account.
- **99.** *Cohen (D-TN).* This amendment would reduce funding in the Afghanistan Security Forces Fund (currently set at \$12.8 billion) by \$4,000,000,000 and would place this amount in the Spending Reduction Account.

- **100. Posey** (**R-FL**). This amendment would require that after the National Aeronautics and Space Administration has completed the final space shuttle mission, the Secretary of Defense shall:
  - ➤ "To the maximum extent practicable, use the unique capabilities of the NASA Shuttle Logistics Depot of the National Aeronautics and Space Administration; and
  - ➤ "Preserve the unique capabilities and the highly skilled, highly certified workforce of such facility."

## SUMMARY OF POTENTIAL AMENDMENTS <u>NOT PRE-PRINTED</u> IN THE CONGRESSIONAL RECORD

*Mulvaney (R-SC)*. The amendment would reduce total funding in the bill by \$17,192,000,000, not to be derived from amounts of appropriations made available by title IX. According to the sponsor, the amendment would freeze funding for the Department of Defense (i.e. Defense Base Budget) at current levels, consistent with the FY11 Continuing Resolution (P.L. 112-10). This would reduce Base Budget funding in the bill by 3%, and it would <u>not</u> impact funding for the Global War on Terrorism (i.e. Title IX, Overseas Contingency Operations).

Conyers (D-MI)/McClintock (R-CA)/Woosley (D-CA). The amendment prohibits the use of funds to:

- deploy members of the Armed Forces on to the ground of Libya for the purposes of engaging in military operations;
- award a contract to a private security contractor to conduct any activity on the ground of Libya; or
- otherwise establish or maintain any presence of members of the Armed Forces or private security contractors on the ground of Libya.

According to the sponsors, a very similar amendment passed the House of Representatives on May 26, 2011 by a vote of 416-5 as a part of the 2012 National Defense Authorization Act (Roll Call Vote 366).
