After recordation, please furnish us with the deed book and page numbers.







Re: Grant of Easement NF(R)-14121

This is to request an amendment to the Grant of Easement NF(R)-14121 between the United States Government and Carolina Telephone and Telegraph Company. This is a fifty (50) year easement dated December 27, 1971, and covers telephone cables and facilities serving unofficial subscribers on Marine Corps Base, Camp LeJeune, North Carolina. The amendment is necessary to include the construction, installation, operation, and maintenance of cables and related facilities required to provide telephone service in the new 250 unit Turnkey housing project under construction off Stone Street on Camp LeJeune.

Enclosed are eight (8) copies of a drawing showing the new housing area labeled exhibit "C" that should be made part of the original easement which now contains exhibits "A" and "B". Exhibit "C" will also become sheet 3 of 3. The route of the proposed buried telephone cables is delineated by a green line as specified in the easement to be amended. The proposed facilities are within the confines of the housing area and generally follow the route of the new power and CATV cables.

Your earliest consideration and approval of this amendment would be appreciated. If any additional information is desired, please advise.
