1. The request contained in reference (a) has been reviewed and the following comments are forwarded for your consideration:

a. The overlay to reference (b) should be removed and replaced with an overlay made from the Camp Lejeune special map of Red-Cockaded Woodpecker habitat.

b. Recommend that the last sentence be deleted from paragraph 4.a.(1) under the Prohibited Activities section.

c. Recommend that paragraph 4.a.(2) and paragraph 4.a.(7) under Authorized Activities section be deleted.

2. Additionally, it is recommended that the following comments be considered for inclusion in reference (c):

a. At the end of the first sentence in paragraph 4.a.(4) add these words "...and the Onslow Beach North Tower Fange". Also add these words after the second sentence in paragraph 3.a.(4) "The Onslow Beach North Tower Range is located between the frontal dunes and the water, extending from Grid Line 29 to the access route at the North Tower".


