PUBLIC NOTICE

THE COMMANDING GENERAL, MARINE CORPS BASE, Office of Assistant Chief of Staff, Facilities, Camp Lejeune, North Carolina 28542, has applied for a Department of the Army permit TO PLACE FILL MATERIAL IN THE NEW RIVER AT TOWN POINT TO STABILIZE THE SHORELINE AT CAMP LEJEUNE, Onside County, North Carolina.

The following description of the work is taken from data provided by the applicant and from observations made during an onsite visit by a representative of the Corps of Engineers. Plans submitted with the application show the proposed placement of concrete rubble building material along approximately 2,100 linear feet of unvegetated shoreline. The riprap is to be placed a maximum 10 feet waterward of the mean high water (MHW) elevation contour to a maximum depth of 1 foot MHW. An estimated 80 cubic yards of fill is to be placed by utilizing dump trucks and buildozers. No wetlands are to be adversely impacted by the project. The purpose of the project is to stabilize the eroding shoreline. Plans showing the work are included with this public notice.

The applicant has determined that the proposed work is consistent with the N. C. Coastal Zone Management Plan and has submitted this determination to the N. C. Office of Coastal Management for their review and concurrence. This proposal shall be reviewed for the applicability of other actions by North Carolina agencies such as:

a. The issuance of a Water Quality Certification under Section 401 of the Clean Water Act by the N. C. Division of Environmental Management.

b. The issuance of a permit to dredge and/or fill under N. C. General Statute 113-229 by the N. C. Office of Coastal Management.

c. The issuance of a permit under the N. C. Coastal Area Management Act (CAMA) by the N. C. Office of Coastal Management or their delegates.


d. The issuance of an easement to fill or otherwise occupy State-owned submerged land under N. C. General Statute 143-341(4), 146-6, 146-11, and 146-12 by the N.C. Department of Administration and the N. C. Council of State.

e. The submittal of an Erosion and Sedimentation Control Plan to the Land Quality Section, Division of Land Resources, pursuant to the State Sedimentation Pollution Control Act of 1973 (NC G.S. 113 A-50-66).

The requested Department of the Army permit will be denied if any required State or local authorization and/or certification is denied. No Department of the Army permit will be issued until a State coordinated viewpoint is received and reviewed by this agency. Recipients of this notice are encouraged to furnish comments on factors of concern represented by the above agencies directly to the respective agency, with a copy furnished to the Corps of Engineers.

This application is being considered pursuant to Section 10 of the River and Harbor Act of 1899 (33 U.S.C. 403) and Section 404 of the Clean Water Act (33 U.S.C. 1344). Any person may request, in writing within the comment period specified in this notice, that a public hearing be held to consider this application. Requests for public hearing shall state, with particularity, the reasons for holding a public hearing.
