1. In accordance with reference (a) the following is provided;

Project: Prepare a running track in the French Creek area. Justification: To comply with the Commandants fitness program, increase the safety of troops, and prevent impeding the flow of traffic.

Project: Pave the parking area adjacent to FC-320 and FC-312. Justification: To eliminate the safety hazard of mudholes and prevent a major resurfacing requirement in the future.


> Project: Install a heating system within the warehouse portion of Building 914. Justification: To provide for the comfort and welfare of troops.

Project: Enlarge the parking lot, install lights and fencing for Building P-517, 8th MT Bn Combat Vehicle Shop. Justification: To accomodate the new LVS system of vehicles and to increase the safety and security of the area.

Project: Construct a small and large vehicle drive up wash Justification: To ensure proper cleaning and maintenance prior to induction into the maintenance system. Estimated cost 50K each.

Project: Construct a High Boy Loading Ramp F. Justification: To eliminate the time-consumming and dangerous method of loading High-Boys with cranes. Estimated cost 150,000.

Project: Install outdoor lights around the exterior of Building 909. Justification: To enable performance of maintenance at night and to increase security of ORF lot. Estimated cost 80,000.



H. Project: Construct a maintenance pad 20'x 30' with cold water, steam, and drainage to an oil separator in ORF Building 909 area.

Justification: To minimize the environmental concerns related to maintenance and incidental spillages. Estimated cost 120,000.

I. Project: Replace wood frame Buildings FC-216, 217, and 218 with new buildings. New Buildings should be 24 ft by 40 ft. dinder block, with brick facing, equipped with utilities, heating and air conditioning. Estimated cost 120,000.

Justification: To provide for the health and comfort of troops.

J. Project: Install heating and cooling systems in warehouses in Buildings 914, 907, 1317, 1211, 1117, 903 and 904.

Justification: To increase the health and comfort of personnel in these buildings and protect government property.

K. Project: Construct a three-sided storage shed for approximately 2600 M-463L aviation pallets on a hardstand. Size of shed 5400 sq.ft.

Justification: To protect aluminum pallets from elements.
