1. In accordance with reference (a), the Semiannual Command Chronology for Marine Corps Air Station (Helicopter) New River is hereby submitted.

2. Organization Data

a. Designation and Location. MCAS(H) New River is located in the vicinity of Jacksonville, North Carolina, and is under the military command of the Commandant of the Marine Corps, who exercises his command through the Commander, Marine Corps Air Bases, Eastern Area. The Commandant of the Marine Corps provides primary logistics support for the Air Station and the Commandant, Fifth Naval District is the designated area coordinator. Aircraft, aircraft spares and related aeronautical support equipment logistics is provided by the Chief of Naval Operations and the Chief of Naval Materiel.

b. The assigned mission is to maintain and operate facilities and provide service and materiel to support operations of a Marine Aircraft Wing, or units thereof, and other activities and units as designated by the Commandant of the Marine Corps in coordination with the Chief of Naval Operations.

c. Period Covered. Period covered by this report is 1 July to 31 December 1976.







e. <u>Average Strength</u>. The average monthly strength during this period was 532 personnel. This figure includes officer and enlisted, permanent and attached personnel.





3. Personnel

a. During this period, 91 permanent personnel and 218 FAP personnel were joined; 34 permanent personnel were transferred and 159 FAP personnel terminated.

b. Ten Marines re-enlisted and 20 Marines were released from active duty; 26 Marines were discharged and 10 transferred to the FMCR.

c. During this period, the following promotions were effected within this Command:

*(2) Ceiling adjustment authorized by HQMC includes two closed Microphone Reporters (reimbursable funds) and six Aviation Training Device Mechanics (direct funds). Also one civilian space (BOQ) was transferred from MCB Camp Lejeune to MCAS(H) effective 1 Dec 76.

(3) The civilian turnover was 12 separations and nine accessions.

(4) The position of manpower utilization assistant, GS-7 (with target level of GS-9) was established and filled on 24 Oct 76. The purpose of the position is to perform a variety of duties in support of the . manpower management program for the station.

4. Training

a. General

The Training Department is responsible to the MCAS(H) S-3 Officer for providing aviation training to units of the Second Marine Aircraft

Wing stationed at MCAS(H) New River and to the Commanding Officer, H&HS for coordinating and implementing individual training of the Station enlisted Marines which includes Rifle Marksmanship, Physical Fitness Testing, Drown Proofing, Pistol Requalification and Familiarization Firing. Further, it monitors the command Weight Control Program, MCI, Essential Subjects Training, SNCO and NCO Leadership Training, and coordinates MOS Training.

b. Military Training

K-

(1) Rifle Marksmanship. 325 personnel fired for qualification with 319 qualifying and six unqualified.

(2) PFT. Twenty Marines remain on the Remedial program, 14 on weight control.

(3) <u>Pistol Requalification</u>. During this time 41 Marines qualified with T/O weapon.

(4) Aviation Training. Construction of new Flight Simulator Building continues. This facility will accommodate the present 2C43, 2F117, and the proposed 2F120 scheduled for construction in FY-77.

(5) Leadership/Human Relations. 83.3% of the Marines trained in CY-76, highest overall percentage of any unit in the Marine Corps.

5. Airfield Operations


a. Air Traffic Control


(1) Air Traffic Operations. Operations for the reporting period totaled 38,237. There were 457 passengers manifested through the Division of whom 118 were VIPS. The Visiting Aircraft Line serviced 386 transient aircraft.

(2) Personnel. The personnel strength average was two officers, 42 enlisted and three civilians. These averages include Fleet Augmentation personnel.

(3) Training. Training and qualification programs continue with emphasis placed on cross-training controllers to obtain FAA Facility Ratings in both Tower and Radar. During the reporting period there were 14 IFR radar, six IFR tower, nine Facility Ratings and five Visibility Observer Qualifications earned by ATC personnel.

(4) Work on the Quonset Hut continues; occupation of the building began on 1 December 1976. Tower rehabilitation includes installation of two portable air traffic control signal lights and a combined airfield lighting console, thereby eliminating three outdated pieces of equipment.





b. Weather Services

(1) Weather Services Division maintains a 24 hour daily forecaster and observation program, with forecasts produced and disseminated locally and observations transmitted via an Air Force Teletype Circuit plus local dissemination.

(a) A total of 522 IFR, 494 VFR and 178 local flight forecasts were issued; in addition 101 destructive weather warnings were disseminated to parent and tenant commands at MCAS(H) New River and Camp Lejeune.

(b) Monthly Climatological, Astronomical, and Tical Data was computed and published for use at the Air Station and Camp Lejeune.

(c) Blast Focus Forecasts were prepared and disseminated on a daily basis to MCB Camp Lejeune G-3 Training who further disseminates this information to Range Control, 2d Mar Div and Force Troops and Cherry Point TACC.

(2) Conus Metrological Data System (COMEDS) was installed and became operational on 27 Dec 76. This system replaced Comet I, II, III and NOTAMS System.

c. Crash Crew

(1) The Crash Crew Division has nine vehicles assigned for crash fire protection. In addition, two MB-5 crash vehicles are on loan from MAG-26 and MAG-29 to supplement the station equipment. During this period, the station received two one-ton rescue command vehicles and one 500 gallon nurse truck w/500 GPM rear mounted pump.


(2) <u>Aircraft Accidents</u>. Crash Crew did not respond to any accidents during this period.

(3) <u>Aircraft Standbys</u>. Crash Crew responded to 20 aircraft emergencies during this period.

(4) Manned Equipment. Crash Crew spent 1780 hours manning the runway alert position for landing and departing aircraft and provided crash vehicles for 42 defuels, 94 washdowns for fuel spills and six airfield escorts.

(5) Training. 2312 man hours were spent on Crash Crew technical training.

d. Flight Support. The Flight Support Division supported an average of 42 pilots from 2nd Mar Div, 2nd ANGLICO, and H&HS New River through 30 Sep 76. This support entailed 868.1 pilot hours on 229 proficiency

or logistic flights with an average of five aircraft assigned. For the period 1 Oct 76 to 31 Dec 76, when proficiency flying was cancelled, the Flight Support Division supported 16 pilots from H&HS. This entailed 466.3 pilot hours on 161 operational or logistic flights.

(1) During the reporting period, 863.4 aircraft flight hours were flown in assigned aircraft. Total flight time by type aircraft was as follows:






