Q5a How are the affected wells at Camp Lejeune being/have been cleaned up/remediated?

A5a All supply water wells contaminated with VOCs have been closed and properly abandoned. Remediation systems (pump and treat plants) have been constructed to clean up the contaminated groundwater.

Q7c What are the current standards regarding use/disposal of these compounds?

A7c Use of these or similar chemical compounds aboard Camp Lejeune, and by tenant commands, is extremely limited and occurs only at authorized facilities under strict management guidelines. These facilities are granted authorization on an annual basis following assessment/inspection by both command operational personnel and compliance personnel assigned to the AC/S Environmental Management Department. Spent compounds are tracked by the Environmental Management Department, Resource Conservation and Recovery Branch through the Defense Reutilization and Marketing Office and to their ultimate point of destruction.
