So far I've got only four letters sent to Mai. Townsend from July to November. The dates follow:

14 Jul 00 re 10 Jun Itr -- Holcomb Blvd Plant constructed in 1972 and request for patience as more info is gathered.

4 Aug 00 re 10 Jun, 6 Jul and 12 Jul Itrs to Camp Lejeune, OJAG & NavFacEngCom (respectively) - 22

attachments...lots of info pertaining to 19 different questions.

16 Aug 00 re 10 Aug ltr -- Describes the coordination with ATSDR and the MarAdmin (misidentified as an AlMar). 6 Nov 00 re 16 Oct ltr which references unanswered questions in ltrs of 11, 16 and 25 Sep and phone query of 19 Oct.

We here at CL also assisted with the response to the 12 Sep Itr to HQMC PA, but I don't have a signed copy of that letter and it wasn't signed by anyone at Lejeune.

There was one other letter written by OJAG. 25 May 00 in response to a 12 May Itr written to CL's Legal Officer, but I'm not talking more on letters written by anyone other than Col. Karle (or Col. Phillips, as in the 14 Jul response).

The letters I have or have copies of from Mai. Townsend include the following in reverse chronological order:

9 Nov -- Second 'follow-up' request (re 16 Oct ltr)

16 Oct -- States he's waiting for answers to questions in four previous letters dated 11,

21 Aug -- No questions, just his opinions.

10 Aug -- Acknowledges receipt of 4 Aug 00 ltr.
22 Jul -- Acknowledges receipt of 14 Jul 00 ltr and states his expectations of rapid response to his questions.

12 Jul -- Second request for info requested in 10 Jun Itr and additional questions about water monitoring.

√6 Jul -- States he's waiting for answers to questions from his 10 Jun letter.

10 Jun -- Requests info on the water distribution systems at CL 1965-67.

I have no copies of letters from him prior to 10 Jun 00. I'll forward copies of the four letters I have from us to him to your office this afternoon.
