
#### Welcome to the Guide to Grants!

### Congresswoman Terri A. Sewell Co-Sponsors Voting Rights Legislation

WASHINGTON, DC -- Today, Congresswoman Terri A. Sewell (AL-07), joined her colleagues as an original co-sponsor on H.R. 5799 the "Voter Empowerment Act of 2012" which seeks to modernize voter registration, ensure equal access to the ballot box and prohibit deceptive practices and voter discrimination.

"As the Representative of Alabama's historic 7th Congressional District, where many fought, bled and died for the right to vote, I am proud to be an original co-sponsor of this important legislation," said Rep. Sewell. "No right is more fundamental to our democracy, than our right to vote. Although great progress has been made since the days of poll taxes and literacy tests, Congress still has important work to do when it comes to ensuring that all Americans are afforded the right to vote without intimidation, prejudice or discrimination. This legislation will help ensure free and fair elections, so that everyone, including students, seniors, minorities and veterans can exercise their constitutional right to vote," Sewell added.

The Voter Empowerment Act of 2012 has been designed to modernize the American electoral system by providing improved access to the ballot, enhanced integrity in our voting systems and greater accountability for the administration of our elections.

# Congresswoman Terri A. Sewell Visits Troops in Afghanistan on Mother's Day

Kabul, Afghanistan – Congresswoman Terri A. Sewell joined Democratic Leader Nancy Pelosi and a bi-partisan Delegation to Afghanistan for the first trip since President Barack Obama signed the historic Strategic Partnership Agreement with President Hamid Karzai. The two-day trip included visits to the provinces of Helmand and Kandahar as well as offered an opportunity for the delegation to visit with troops on Mother's Day weekend and discuss national security and woman issues in the Middle East, Asia and Africa with diplomatic and military officials.

"On this Mother's Day weekend, I've been honored to join Democratic Leader Nancy Pelosi and four of my female colleagues on a bi-partisan Congressional Delegation to Afghanistan," said Rep. Sewell. "Our troops play such an integral role in Afghanistan and it was a pleasure to travel to Helmand and Kandahar provinces to discuss important issues facing Afghans from our commanders and their Afghan coalition partners on the ground. We were also honored to have the opportunity to celebrate Mother's Day at Camp Leatherneck in the Helmand province with so many of our brave troops, many of whom are mothers, daughters and sisters who courageously serve on the frontlines every day in our Armed Forces," Sewell added.

"My appreciation for all of our servicemen and women has deepened with this experience. On this special day, words can't express my gratitude to all of the mothers in the military," Sewell continued. "Thousands of miles away from home, our women in uniform continue to manage the challenges of parenting, while fighting for our liberties. To all our mothers far and near, Happy Mother's Day!"

# Statement from Congresswoman Terri A. Sewell in Response to the U.S. Postmaster General Patrick Donahue's Newly Released Plan to Preserve and Protect Post Offices

WASHINGTON DC,—Today, Congresswoman Terri A. Sewell (D-AL) released the following statement in response to the U.S. Postmaster General Patrick Donahue's newly released plan to preserve and protect local post offices in rural and small town America:

"I am pleased that Postmaster General Patrick Donahue recently released a new plan for the restructuring of the United States Postal Service. This plan is a vital step forward toward ensuring the future of rural, isolated and underserved communities across this nation. The new plan implements a strategy that would keep rural post offices open for business for thousands of my constituents who depend on the post office for their checks, life-saving medications, packages and bills. Rather than turning toward widespread closures, layoffs and costly reductions in service, the Postmaster General has developed a new strategy aimed at solving this fiscal crisis while ensuring that our nation's underserved communities still have access to vital lifelines for commerce and communications.

I applaud the Postal Service for taking decisive action to create a more efficient business model for the United States Postal Service. It is my hope that we develop a comprehensive postal service reform plan that will invest in both urban and rural communities and continue trusted, timely, reliable and affordable services."

## Congresswoman Terri A. Sewell Announces \$1.59 Million in Upward Bound Program Funding to Four Colleges in the 7th Congressional District

Washington, DC – Today, Congresswoman Terri A. Sewell (AL-07) announced that \$1.59 million was awarded to four colleges in the 7th Congressional District for the Upward Bound Program under the U.S. Department of Education. The Upward Bound Program is one of eight Federal TRIO programs targeted to serve and assist low-income individuals, first generation college students and individuals with disabilities to progress through the academic pipeline from middle school to post baccalaureate programs.

The four institutions awarded funding are:

**Lawson State Community College** — \$337,500

**Miles College** — \$353,266

Stillman College — \$553,367

University of West Alabama — \$347,834

"I am pleased that the Department of Education will provide this important funding to four colleges in the 7th Congressional District," said Rep. Sewell. "The Upward Bound Program is critical to ensuring the success of students from all socioeconomic and education backgrounds. This funding will provide the resources needed to level the playing field and give all students the opportunity to achieve and succeed at the college level."

The Upward Bound Program participants must be first-generation college bound high school students, low-income individuals or individuals who have a high risk for academic failure and a critical need for academic support to successfully pursue a secondary school curriculum and complete a postsecondary education program within six years after high school graduation.

"We would like to thank Congresswoman Sewell for her support of the Upward Bound program," said Mattie Crawford, Director of the TRIO Classic Upward Bound Program at Lawson State Community College (LSCC). "This grant will afford LSCC the opportunity to

continue developing students academically, culturally and socially while attending high school as well as prepare them to attend and complete college."

"Miles College is pleased to continue our tradition of over three decades of serving our community and youth through the Upward Bound Program," said Miles College President Dr. George T. French Jr. "We are always appreciative of Congresswoman Sewell's advocacy and support for TRIO Programs like Upward Bound."

"We are delighted to receive this funding because the Upward Bound Program is linked to college success and we are focused on improving college graduation rates for high school students in Sumter County," said Vicki Spruiell, Director of TRIO at the University of West Alabama.

"This is great news and we are excited to receive this funding for our Upward Bound Program which has been in operation at Stillman College since 1966," said Dr. Bettye Mullen, Director of Educational Support Services. "The program has served 130 students annually since its inception and is integral to helping build academic skills that assist these students in pursuing a successful post-secondary education."

Federal TRIO Programs were established by the Higher Education Act of 1965, and amended by the Higher Education Opportunity Act of 2008. Eligible applicants include institutions of higher education, public or private agencies or organizations, including community-based organizations with experience in serving disadvantaged youth, secondary schools, and combinations of institutions, agencies, organizations and secondary schools.

# Statement from Congresswoman Terri A. Sewell about Hyundai's Announcement of Third Shift at Montgomery Plant

Washington, DC – Today, Congresswoman Terri A. Sewell (AL-07) released the following statement about Hyundai Motor Manufacturing Alabama's announcement of adding a third shift to its plant in Montgomery, AL:

"I am pleased that Hyundai Motor Manufacturing Alabama is continuing to make critical investments in Alabama's local economy by adding a third shift to its plant in Montgomery. This third shift will not only create 877 new jobs at Hyundai, but will also generate job growth in auto related industries that will greatly benefit the 7th Congressional District, the State of Alabama and this nation. For nearly 10 years, Hyundai has maintained a strong manufacturing presence in our state employing thousands of hardworking Alabamians. I applaud Hyundai for its efforts to create jobs and strengthen economic development in Alabama."

These additional hires will bring the total number of jobs created at the plant to more than 3,000 and Hyundai's 2012 production capacity will increase by approximately 20,000 units.

# Congresswoman Terri A. Sewell Observes the One-Year Anniversary of the April 27, 2011 Tornadoes

WASHINGTON DC, --Today, Congresswoman Terri A. Sewell (AL-07) released the following statement in observance of the one-year anniversary of the tornadoes on April 27, 2011 that ravished Alabama and claimed the lives of 253 people, including 76 deaths in the 7th Congressional District:

"One year ago, we witnessed some of the strongest and most devastating tornadoes in our nation's history. As we reflect on April 27th, we are reminded of the strength, the generosity and the hope of the human spirit that was displayed in the face of such an unimaginable tragedy. Today, we stand together as a stronger, more united and better prepared community committed to recovering, rebuilding and advancing our state. Since last year, remarkable progress has been made and I am confident that even greater progress is to come.

The strength and resilience of the families across Alabama provide a shining example of what is truly possible when communities work together. I commend the coordinated efforts of the local, state and federal level and honor the first responders who courageously answered the call to duty. We pay tribute to and honor those who have lost so much by rebuilding our community stronger and better than before."

Rep. Sewell assisted the state in securing more than \$245 million in federal disaster assistance from the Federal Emergency Management Agency (FEMA), \$33.9 million of which was awarded to the 7th Congressional District of Alabama; more than \$55.5 million from the U.S. Department of Housing and Urban Development (HUD); more than \$18.5 million in assistance from the Federal Highway Administration (FHA); and \$600,000 in assistance from the U.S. Department of Agriculture (USDA) to the City of Tuscaloosa.
