### Statement from Congresswoman Terri A. Sewell on President Obama's FY2013 Budget

Washington, DC—Today, Congresswoman Terri A. Sewell (D-AL) released the following statement after President Obama released his fiscal year 2013 budget:

"Today, President Obama released his budget for fiscal year 2013. I agree with the President that the recovery of our American economy must be built upon two fundamental principals – protecting the middle class and promoting shared sacrifice and collective responsibility.

In the State of the Union Address, the President outlined his vision for an American economy "built to last," based on American manufacturing, American energy, skills for American workers and a renewal of American values. I believe this budget provides a fair and balanced approach. I applaud the President's aggressive efforts to reduce the deficit. The budget provides for important investments in research and innovation which are vital to preparing our businesses and manufacturing sector to take advantage of new opportunities. This budget promotes public-private partnerships that will increase job creation, workforce development and improve access to higher education for all American workers.

America is and has always been most successful when we invest in our people—middle-class families and small business owners—who can grow our economy from the bottom up. We can no longer afford to provide tax breaks to wealthy Americans by depriving seniors and the middle class of the support they need and deserve. Everyone must do their part.

I look forward to continuing to work with the president and my colleagues in Congress on a comprehensive plan to stimulate our economy and reduce our deficit."

### Congresswoman Terri A. Sewell Announces \$66,589 FEMA Grant Awarded to McAdory Area Fire District

WASHINGTON, D.C. – Today, Congresswoman Terri A. Sewell (AL-7) announced that \$66,589 in funding was awarded to the McAdory Area Fire District by the U.S. Department of Homeland Security's (DHS) Federal Emergency Management Agency's (FEMA) grant program in cooperation with the U.S. Fire Administration. The fiscal year 2011 funds, awarded through the Assistance to Firefighters Grants (AFG) program will be used to improve McAdory's ability to respond to fire and fire-related hazards.

"Firefighters put their lives on the line every day across the State of Alabama," said Rep. Sewell. "These funds will help ensure that the McAdory Area Fire District has the adequate resources they need to protect our communities."

"I want to thank Congresswoman Sewell so much," said Jeff Wyatt, Fire Chief of the McAdory Area Fire District. "This is money that is definitely needed and will be put to good use; especially after all the devastation we suffered from last year's tornadoes."

Assistance to Firefighters Grant (AFG) program supports organizations that lack the tools and resources necessary to protect the health and safety of the public and their emergency response personnel with respect to fire and all other hazards they may face. AFG grants bolster fire departments' ability to respond to fires and fire-related hazards, along with their overall level of preparedness.

# Terri A. Sewell on the Addition of Perry County to the Disaster Declaration Issued for the State of Alabama

Washington, D.C.— Today, Congresswoman Terri A. Sewell (D-AL) released the following statement in response to the Federal Emergency Management Agency's (FEMA) addition of Perry County to last week's Emergency Disaster Declaration issued by President Obama for the State of Alabama on February 1, 2012.

"I am very pleased that Perry County has been added to the emergency disaster declaration issued for the State of Alabama last week. This addition will make federal assistance available for residents of Perry County to help them rebuild and recover in the wake of this disaster.

This federal funding will provide victims of the storms with access to grants to meet their immediate needs such as temporary housing, financing for home repairs not covered by insurance, low-cost loans for uninsured property losses and other programs.

Many of my constituents in the 7th Congressional District of Alabama who have been affected by these storms and tornadoes may be wondering how and when their lives will return to normal. I want the victims of the tornadoes to know that we are here for you. It's going to be important for us to make sure that we are sustaining our efforts at rebuilding in the months ahead. Rest assured that my office will continue to work with federal, state and local officials to ensure that we are doing all we can to assist the victims in the coming days and months. In these difficult times, I know that the resilient spirit of our communities will see us through. I am confident that we will recover, restore and rebuild our communities stronger than before."

The original disaster declaration extended federal assistance to residents of Jefferson and Chilton counties.

The law firm of Cochran, Cherry, Givens and Smith has 22 offices across the country and continues to be one of the most well-known criminal defense and civil plaintiff law firms in this nation.

"Attorney Smith was a well-respected member of the Alabama bar and known nationally throughout the legal community for his exceptional legal abilities, legendary courtroom skills, civic activism and passion for equal justice," said Rep. Sewell. "His commitment to advocacy to fight for the rights of the disenfranchised is a great example for us all to follow. He left an indelible mark in Alabama and across this nation and his legacy will be remembered for generations to come."

Washington, D.C. – Today, Congresswoman Terri A. Sewell (AL-7) released the following statement in recognition of National Black History Month:

"Today begins the month-long celebration honoring black history and the extraordinary accomplishments African Americans have contributed to this nation and the world. The story of the 7th Congressional District and the State of Alabama cannot be told without remembering the significant contributions that African Americans from Alabama have made to our nation through their courage to fight for excellence, equality and justice for all.

The theme for this year's National Black History Month is "Black Women in American Culture and History." We pay special tribute to the historical and cultural contributions made by African American women from all walks of life. As a little girl growing up in Selma, I was surrounded by the legacy of those who marched, prayed and died for justice, equality and the right to vote. In particular, African American women from the State of Alabama have left a rich legacy of activism and leadership. Alabama women like Odessa Woolfolk, Doris Crenshaw, Ethel Hall, Sheyann Webb, Coretta Scott King, Rosa Parks, Amelia Boynton and Theresa Burroughs forged the path for future female leaders. These African American women fought courageous battles so that I can now serve as the first African American Congresswoman elected from Alabama, and for that I am eternally grateful.

Today, African American women from Alabama continue to lead the way in academia, medicine, business and government. Leaders such as Dr. Regina Benjamin, Surgeon General of the United States, former Secretary of State Condoleezza Rice, and former Secretary of Labor Alexis Herman broke down barriers at the highest levels and have been instrumental in shaping policy across this nation and the world. Every day, these extraordinary Alabamians should inspire us to continue building a stronger America for future generations.

The achievements of African Americans are worthy to be praised and acknowledged every day, and not just during the month of February. Every month should be Black History Month because black history is an integral part of American history.

This year as we celebrate Black History Month let us all commit to doing our part to making this country great."

## Rep. Terri A. Sewell Recognizes the Third Anniversary of the Lilly Ledbetter Fair Pay Act

Washington DC – Today, Rep. Terri A. Sewell (D-AL) recognizes the third anniversary of the enactment of the Lilly Ledbetter Fair Pay Act, a critical law championing the fundamental principle of equal pay for women and all American workers.

In January 2009, the President signed the Lilly Ledbetter Fair Pay Act into law, which restored the right of women and other workers to challenge unfair pay in court. With women making up nearly half of the labor force and mothers increasingly serving as the primary breadwinners for American families, the wage gap not only hurts families, but adversely affects small businesses and communities.

"Today we celebrate the sacrifice and hard work of Alabama's own Lilly Ledbetter, a humble activist, for courageously fighting to ensure that our daughters and granddaughters are equally paid for the work they do regardless of race, age or gender," said Rep. Sewell.

"The protections enacted by the Lilly Ledbetter Fair Pay Act will strengthen American families— because equal pay for equal work is not simply an issue for women; it's a family issue," said Rep. Sewell. "However, we must not forget that the journey to securing equality for our nation's women is far from over. We must act now to build on Lilly Ledbetter's work, fight discrimination anywhere it exists and put an end to this and all injustices in America."

According to the National Women's Law Center and 2007 data from the Census Bureau, women earn an average of 78 cents for every dollar earned by men. This is up from when the Equal Pay Act was first enacted and women earned 59 cents for every dollar paid to men, but it still falls far short of wage equality. The wage disparity is even more pronounced for the country's minority women when compared to white males: African American women earned 62 cents for every dollar earned by white males and Hispanic women earned 53 cents per dollar.

"In this difficult economy, when so many Americans are already working harder for less and struggling to get by to pay their mortgage, pay for their medications or to simply put food on the table for their children, the last thing they can afford is losing part of their paycheck to blatant discrimination," Rep. Sewell added. "We must continue to do more to level the playing field and restore fundamental fairness to all American workers."





### **Recent Grant Awards**

- February 16, 2012 More than \$1.2 million in federal assistance approved for January Tornado Survivors in Alabama Almost four weeks after tornadoes struck Alabama, more than \$1.2 million in state and federal aid has been approved to help those affected by the storms. More than 1,200 survivors have contacted the Federal Emergency Management Agency for help or information regarding disaster assistance.
- February 9, 2012 FEMA More than \$571,000 has been approved for January Alabama tornadoes in state and federal aid has been approved to help those affected by the storms. Of this amount \$488,500 has been approved for housing grants and nearly \$83,000 has been approved to cover other disaster related needs such as medical and dental expenses as well as lost personal possessions. - **February 9, 2012** Today, Congresswoman Terri A. Sewell (AL-7) announced that \$66,589 in funding was awarded to the McAdory Area Fire District by the U.S. Department of Homeland Security's (DHS) Federal Emergency Management Agency's (FEMA) grant program in cooperation with the U.S. Fire Administration.
- February 8, 2012 Neighborhood Housing Services of Birmingham, Inc., a member of the national NeighborWorks<sup>®</sup> network is being awarded \$43,500.00 in grant funds from NeighborWorks<sup>®</sup> America.
- January 20, 2012 Congresswoman Terri A. Sewell (AL-07) announced that the state of Alabama will receive \$55 million in community development block grant disaster recovery funding from The U.S. Department of Housing and Urban Development (HUD). Approximately \$16.6 million will be awarded to the City of Tuscaloosa, \$6.4 million to the City of Birmingham, and \$7.8 million to Jefferson County. This funding will enable each community to make vital repairs and improvements in infrastructure, housing, economic development projects, and emergency preparedness.
- January 12, 2012 Economic Development Administration awards \$189,000 to the West Alabama Regional Commission that will establish an economic development planning framework, process and strategy that supports private capital investment and job creation in the region.
- January 4, 2012 Federal Highway Administration's Recreational Trails Grant Program administered through ADECA awards \$17,727 to the Southwest Alabama Economic Development Association (Marengo County) to construct a 1,110-foot-long walking trail in the Dixons Mills community.
- January 4, 2012 Federal Highway Administration's Recreational Trails Grant Program administered through ADECA awards \$100,000 to Birmingham Urban Mountain Peddlers to construct nine miles of trail at Tannehill Ironworks Historical State Park.
