 - PA Application deadline has been extended to 6/6/2011. Applicants may apply for assistance through the state's Public Assistance website, www.AlabamaPA.org.
- The 30-day deadlines for Disaster Unemployment Assistance (DUA).
 - Workers with storm-related job losses <u>must register for DUA within 30 days of a county's federal declaration</u> for FEMA Individual Assistance. The following is a list of DUA registration deadlines:
 - May 31: Autauga, Bibb, Blount, Calhoun, Cherokee, Choctaw, Colbert, Cullman, DeKalb, Elmore, Etowah, Fayette, Franklin, Greene, Hale, Jackson, Jefferson, Lawrence, Limestone, Madison, Marengo, Marion, Marshall, Morgan, St. Clair, Sumter, Tallapoosa, Tuscaloosa, Walker, Washington and Winston;
 - **June 1:** Chilton, Coosa, Pickens, Shelby and Talladega;
 - **June 2:** Lamar and Lauderdale;
 - **June 3**: Chambers, Clarke and Perry; and
 - **June 7:** Monroe County.
 - Individuals must have been working or residing in one of the above-named counties prior to the disaster to be eligible for DUA. If eligible, benefits can last up to 26 weeks from the April 28 federal disaster declaration.

\$10 Million Grant to Fund Temporary Jobs for Tornado Victims

MONTGOMERY—Alabama residents who lost their jobs because of the devastating April 27 tornadoes will be eligible for new employment helping their communities recover. Gov. Robert Bentley announced a \$10 million grant from the U.S. Department of Labor that will be used to hire temporary workers to help local governments in the hardest hit areas. The workers will clear debris and start the rebuilding process and also may staff shelters and food banks. "The April 27 tornadoes left a path of devastation that not only included lives and properties, but also jobs," Bentley said. "This grant will give both communities and unemployed workers a much-needed helping hand." County and municipal governments will work with Alabama Career Centers in their areas to find applicants who are eligible for the temporary jobs. First priority for employment will be given to workers whose employers are closed because of the tornadoes. The workers will assist with the demolition, repair, renovation and reconstruction of destroyed public facilities within the affected communities. Counties targeted for assistance in hiring temporary workers include Bibb, Calhoun, Cullman, DeKalb, Elmore, Fayette, Franklin, Hale, Jackson, Jefferson, Lawrence, Limestone, Madison, Marion, Marshall, St. Clair, Tallapoosa, Tuscaloosa and Walker. Additional counties may be included at a later date.

The Alabama Department of Economic and Community Affairs applied for the National Emergency Grant on April 29. Municipal and county governments should contact ADECA at (334) 242-5886 to request funding for the temporary worker program.
