SOUTHEASTERN DISASTER TAX RELIEF ACT INTRODUCED IN HOUSE

WASHINGTON – Legislation to help promote the recovery of families, businesses, and local governments affected by tornadoes and severe flooding in the Southeast has been introduced in the House by a bipartisan group of 27 members from nine states.

The Southeastern Disaster Tax Relief Act of 2011 would provide temporary tax relief to assist rebuilding efforts in Alabama, Arkansas, Georgia, Kentucky, Mississippi, Missouri, North Carolina, Oklahoma, and Tennessee. The bill is modeled on tax relief offered after previous natural disasters like Hurricane Katrina and is a companion to legislation introduced by Senator Richard Shelby (AL) in the U.S. Senate.

Lead House Democratic sponsor Congresswoman Terri Sewell (AL-7) said, "In April, tornadoes and heavy storms devastated the State of Alabama. And over the past several months, several states across this nation experienced similar devastation. Many families lost their homes and jobs while communities were devastated and even wiped out. As we continue down the long road to recovery, it is critical that we provide communities with the resources and opportunities they need to repair, rebuild, and move forward. The bipartisan disaster relief legislation that my colleagues and I introduced yesterday will help provide tax incentives for homeowners, businesses and the agriculture industry so that they can rebuild. The bill will aid communities in their effort to rebuild and strengthen infrastructure, and it will spur investment. In conjunction with the federal assistance already provided by FEMA, the Department of Agriculture and the Small Business Administration, this legislation will help our communities recover and come out stronger than before."

Lead House Republican sponsor Congressman Spencer Bachus (AL-6) said, "After meeting the emergency needs of our citizens, our next step must be to plan for economic recovery. The targeted tax relief contained in this legislation will help our families, businesses, and communities to help themselves as they rebuild after these devastating storms. We have seen a spirit of resiliency in Alabama and across the Southeast, and this is an additional way to give our citizens confidence about the future."

The legislation would establish a temporary Southeastern disaster area in the Internal Revenue Code to designate regions affected by the severe weather. Individuals, businesses, and communities in disaster areas would be eligible for tax relief including personal losses to home property, penalty-free withdrawals from retirement plans, housing of displaced individuals, a low income housing credit, education tax benefits, an employee retention credit, expensing for demolition and cleanup costs, and tax exempt bond financing.

The provisions in the legislation would be fully paid for by rescinding federal funds that are either unspent or uncommitted, and would not increase the national debt.

Why You Should Return the SBA Disaster Loan Application by June 27

Release Date: June 22, 2011

BIRMINGHAM, Ala. – Tornado survivors not returning their loan application from the <u>U. S.</u> <u>Small Business Administration</u> may be saying no to potential federal assistance. Some survivors may be counting on a future insurance settlement to cover all the costs of rebuilding. Maybe they don't want a disaster loan or fear they can't afford one. Or maybe they don't know how to get help with the paperwork the SBA sent them. But there are good reasons to submit a completed <u>SBA loan application</u> by the **June 27** deadline. SBA offers the disaster loans to tornado-affected homeowners, renters, businesses of all sizes and private nonprofit organizations in the 43 Alabama counties with a federal disaster designation for Individual Assistance. Some of the top reasons for submitting an SBA application by the deadline include:

- A future insurance settlement may fall short. You may find out that you were underinsured for the amount of work it takes to repair or replace a damaged home. An SBA low-interest loan can cover the uninsured costs. By submitting the loan application on time, you may have loan money available when it is needed. SBA can approve a loan for the repair or replacement of your home up to \$200,000. Once your insurance settles, you may apply those funds to your disaster loan. However, the opportunity for an SBA disaster loan may be lost if you wait until after the application deadline.
- SBA can work with a homeowner to shape a loan that fits your personal budget. If you already have a mortgage on the damaged property, SBA specialists can work with you to come up with a low-interest loan package you can afford. In some cases, SBA can refinance all or part of an existing mortgage when the applicant may not qualify for a loan from commercial lenders, has suffered substantial uninsured or underinsured damage and intends to repair the property.
- **SBA can help renters replace their essential items**. Renters, as well as homeowners, may borrow up to \$40,000 to repair or replace clothing, furniture, cars or appliances damaged or destroyed in the disaster.
- By submitting your SBA loan application, you keep the full range of disaster assistance available as an option. If SBA does not approve a loan for you or approves a small loan that doesn't cover all of your needs you may be referred to other programs that can provide grants to replace essential household items replace or repair a damaged vehicle or cover storage expenses, among other serious disaster-related needs. But if you do not submit the loan application you received from SBA, the assistance process may stop.

Churches and Other Nonprofits May Rebuild with SBA Loans

BIRMINGHAM, Ala. – Churches, temples, mosques and other religious centers, as well as other private nonprofit organizations in Alabama's storm-damaged designated counties, are eligible to apply for U.S. Small Business Administration loans to help rebuild. Applications must be received by **June 27**. Private nonprofits of any size may borrow up to \$2 million at interest rates as low as 3 percent to repair or replace damaged or destroyed real estate, furniture, fixtures, appliances, equipment, vehicles, other assets and leasehold improvements. (Leasehold improvements could include items such as paint, carpeting, lighting, office partitions or other items attached to the leased structure but owned by the renter.)

The terms of the loans may be up to 30 years, making payments affordable. The SBA sets loan amounts and terms based on each applicant's financial condition. Interested organizations may apply before their insurance claims are settled. The SBA may increase a loan up to 20 percent of the total amount of disaster damage to real estate and/or leasehold improvements so that you can make changes while repairing or rebuilding that reduce the risk of property damage by future disasters of the same kind.

NEW- IRS Increases Mileage Rate to 55.5 Cents per Mile

IR-2011-69, June 23, 2011

WASHINGTON — The Internal Revenue Service today announced an increase in the optional standard mileage rates for the final six months of 2011. Taxpayers may use the optional standard rates to calculate the deductible costs of operating an automobile for business and other purposes. The rate will increase to 55.5 cents a mile for all business miles driven from July 1, 2011, through Dec. 31, 2011. This is an increase of 4.5 cents from the 51 cent rate in effect for the first six months of 2011, as set forth in Revenue Procedure 2010-51. In recognition of recent gasoline price increases, the IRS made this special adjustment for the final months of 2011. The IRS normally updates the mileage rates once a year in the fall for the next calendar year.
