HUD generally awards noncompetitive, nonrecurring Disaster Recovery grants by a formula that considers disaster recovery needs unmet by other Federal disaster assistance programs.

The City of Birmingham will be able to use the funding for efforts involving housing, economic development, infrastructure and prevention of further damage to affected areas. Earlier today, HUD Secretary Shaun Donovan called Congresswoman Sewell and shared the news with her.

"I am pleased that HUD will provide this critically important funding to the City of Birmingham to rebuild its communities. As a result of the April tornadoes and heavy storms, communities and homes were destroyed and hundreds of lives were lost in the State of Alabama. The road to recovery will be long, but this desperately needed funding will assist Alabama in its effort to rebuild again," said Congresswoman Terri A. Sewell (AL-07).

The <u>Alabama Emergency Management Agency</u> and the <u>Federal Emergency Management Agency</u> encourage you to consider all options available, including local resources, in making a long-term plan.

Save money. Save receipts. Stay in touch.

"Finding and securing permanent housing can be a daunting task, especially for disaster survivors," said Jeff Byard, state coordinating officer for AEMA. "It can be tough to know where to begin. Three things survivors can do now to begin the process is to save money, save receipts and stay in touch." Whether you're looking for long-term rental housing, rebuilding your home or looking to buy a home, the first thing you should do is begin setting aside as much money as you can. By saving up, you'll be better prepared to act when you find a housing solution that fits your needs. It's very important to document your recovery costs, especially if you've received grant money from FEMA. Make sure to save receipts from supplies, contractor work and any other disaster-related expenses. This will help state, federal and voluntary agencies provide further assistance. Some survivors may not know where to go for help. You can stay in touch with FEMA by contacting your caseworker or by calling the FEMA helpline at **800-621-FEMA** (3362) or TTY 800-462-7585. Phone lines are available every day from 7 a.m. to 10 p.m. local time. Different situations call for different plans of action.

This letter is to make you aware of a low interest green energy/economic development loan program through the Center for Alternative Fuels, Alabama Department of Agriculture and Industries. Start-up USDA funds were recently acquired to enable the Center to provide direct funding and/or partner with other lenders to bring to fruition viable projects that meet broad program guidelines. Individual loan use expands beyond just fuel development and contributing to America's energy security to include minority-owned and women-owned businesses in high unemployment/low income areas. The initial \$500,000 offering will enable individual loans in the \$25,000-\$125,000 range via the Center for projects based on need, compliance with program guidelines, evaluation of the project objectives, job creation, collateralization, and loan repayment capacity. Loan terms will likely be limited to a maximum of 5-7 years, depending on project scope. Submitted projects are primarily solicited from counties in Alabama's Black Belt Region\*, but other worthy statewide submissions are encouraged and will be awarded on a case by case basis. Typical project emphasis might address such areas as drought abatement, energy costs, food safety, industry growth, stabilization of local economics, and small business expansion. Again, please note that job creation will be a major factor in individual project evaluation.
