### LEGAL REQUIREMENTS FOR CANDIDATES

- 1) Must be a United States citizen.
- 2) Must be a resident of the 30<sup>th</sup> Congressional District of Texas.
- 3) Must be at least 17 years of age, but not yet 23 years of age, by July 1 of the year of admission.
- 4) Must be unmarried, not pregnant and have no legal obligation to support children or other dependents.
- 5) By law, graduates of the service academies are appointed to active duty as commissioned officers and serve in the appropriate branch of the military for a minimum of five years.

#### **GENERAL QUALIFICATIONS FOR ADMISSION**

- 1) Scholastic Aptitude Test (SAT) or American College Test Program (ACT) is required of all applicants.
- 2) Class rank in the top 40% of the class is usually required.
- 3) A medical and physical examination is required for all nominees, which is handled through academies and the Department of Defense.
- 4) A "whole person" evaluation is determined by Congresswoman Eddie Bernice Johnson's Service Academy Review Board, from evidence of character, scholarship, leadership, psychical aptitude, medical fitness, goals and motivation.
