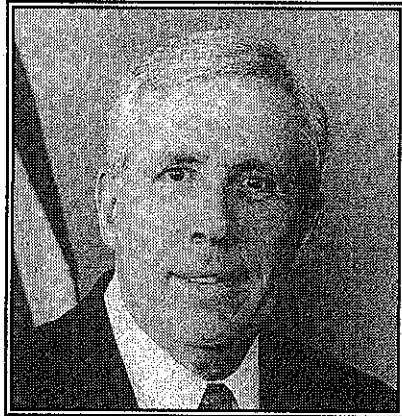

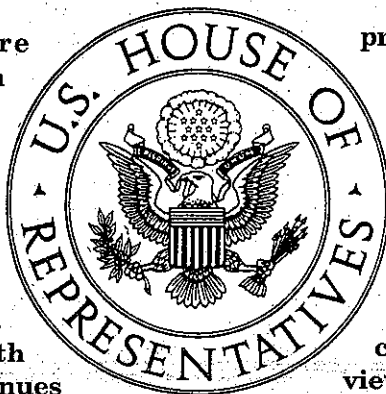
# Congressman Wolf's Voting Record

2nd SESSION, 103rd CONGRESS • JANUARY 25 - NOVEMBER 29, 1994

Dear Friend:

Public responsibility and accountability are principles I have worked to uphold since I began serving in the House of Representatives in 1981. One of the ways that a member of Congress can be held publicly accountable is to make available his or her voting record to let the people know how that member votes in Congress. Because I believe it is important for you to know how I have voted on all matters coming before Congress, I have published and distributed my complete voting record to 10th District citizens each year. The enclosed report continues that practice.

This report includes the votes I cast for the 2nd Session of the 103rd Congress. There were 507 roll call votes during the 2nd Session of the 103rd Congress which convened on January 25 and officially adjourned in the House on November 29, 1994. My voting attendance record for that session was 98.8 percent. The 507 roll calls included 44 procedural votes such as approving the Speaker's journal, quorum calls and motions to adjourn. Those



procedural votes are not included in this report. To assist you in understanding the terminology used in the legislative process, a glossary of terms used in this report to describe the votes as well as a guide to the arrangement of the report may be found on page 2.

I hope you find this voting record information helpful. As the 104th Congress continues its work throughout 1995 on the many issues of importance to the nation, I encourage you to share your comments on this report and to let me know your views on the challenging issues facing our district and the nation and other matters of interest to you.

## AGRICULTURAL & RURAL AFFAIRS

(254) H.R. 4554, FY 1995 agriculture appropriations. Amendment to eliminate the \$3 million in the bill for the Farmers' Home Administration's Socially Disadvantaged Farmers Program. Yes. Failed 139-264. 6/17/94.

(255) H.R. 4554. Motion to rise from the Committee of the Whole and report the bill, as amended, back to the House. No. Passed 232-146. 6/17/94.

(256) H.R. 4554. On passage of the bill to provide \$67.9 billion in FY 1995 appropriations for the Department of Agriculture, agriculture and rural development, the Food and Drug Administration and related agencies. No. Passed 278-127. 6/17/94.

(377) H.R. 4217, Federal Crop Insurance Reform. Amendment as a substitute to make the costs of reimbursing private crop insurers part of the mandatory spending process for FYs 1995-97 and the discretionary process in FYs 1998-99, and make various changes in the crop insurance program to produce \$272 million in savings over five years to offset the spending in the bill, rather than permanently make the cost of reimbursing private insurers mandatory spending and provide \$608 million in offset savings. Yes. Passed 253-156. 8/5/94.

(378) H.R. 4217. Amendment as amended to make the costs of reimbursing private crop insurers part of the mandatory spending process for FYs 1995-97 and the discretionary process in FYs 1998-99, and make various changes in the crop insurance program to produce \$272 million in savings over five years to offset the spending in the bill. Yes. Passed 401-1. 8/5/94.

(438) H.R. 4554, to agree to the conference report to provide \$69.1 billion in FY 1995 appropriations for the Department of Agriculture, rural development, the Food and Drug Administration and related agencies' programs. Yes. Passed 287-107. 9/23/94.

(445) H.R. 3171, Agriculture Department reorganization. Amendment to eliminate the Agricultural Service Agency, which the bill would establish by consolidating the Agricultural Stabilization and Conservation Service, which manages crop subsidy programs, with the Federal Crop Insurance Corporation and the Farmers Home Administration, but require that these agencies' field offices be co-located into a single office in each area, providing a single point of contact for farmers. Yes. Failed 177-247. 9/28/94.

(475) H.R. 967, to provide incentives to manufacturers of minor-use crop pesticides to maintain their Environmental Protection Agency approval and to apply for approval of new types of pesticides. Yes. Passed 334-80, under suspension of rules. 10/4/94.

## APPROPRIATIONS

(6) H.Res. 336, rule to consider H.R. 3759, FY 1994 disaster emergency supplemental appropriations. Motion to order the previous question on the rule. No. Passed 244-168. 2/3/94.

(7) H.Res. 336. To adopt the rule to consider H.R. 3759, FY 1994 disaster emergency supplemental appropriations. Yes. Passed 342-65. 2/3/94.

(8) H.R. 3759, FY 1994 disaster emergency supplemental appropriations. Amendment to delete the \$1.2 billion provided by the bill for peacekeeping and humanitarian assistance in Bosnia, Somalia, the Iraqi "no-fly zone," and Haiti. No. Failed 158-260. 2/3/94.

(9) H.R. 3759. Amendment to offset \$7.5 billion of the \$9.7 billion in the bill by rescinding funding for executive full-time equivalent positions; the Strategic Petroleum Reserve; the Tennessee Valley Authority; the Legal Services Corporation; the Bureau of Alcohol, Tobacco and Firearms; Community Development Block Grants; the World Bank; certain defense programs; the legislative branch; and other programs. Yes. Failed 207-211. 2/3/94.

(10) H.R. 3759. Amendment to fully offset the \$9.7 billion in emergency funding in the bill by cutting spending for more than 70 federal programs, including a \$1.8 billion reduction in agency overhead, a \$1.6 billion savings by cutting 252,000 positions from the federal workforce and a \$400 million reduction in Community Development Block Grants. Yes. Failed 178-240. 2/3/94.

(11) H.R. 3759. Amendment to offset \$2.56 billion of the disaster assistance in the bill by implementing most of the rescissions contained in the Government Reform and Savings bill [H.R. 3400]. Yes. Passed 415-2. 2/3/94.

(12) H.R. 3759. Motion to recommit the bill to the House Appropriations Committee with instructions to report it back after offsetting \$7.5 billion of the \$9.7 billion in disaster assistance with rescissions. Yes. Failed 184-228. 2/3/94.

(13) H.R. 3759. On passage of the bill to provide \$9,719,150,000 in new appropriations for the emergency expenses of the Los Angeles-area earthquake, humanitarian assistance and peacekeeping activities, Midwest flood assistance and highway reconstruction in San Francisco. Yes. Passed 337-74. 2/3/94.

(26) H.R. 3759, FY 1994 emergency disaster supplemental appropriations. Motion to instruct House conferees to agree to the Senate amendment to extend the statute of limitations for Resolution Trust Corporation civil actions for fraud and gross negligence until Dec. 31, 1995. Yes. Passed 390-1. 2/10/94.

(27) H.R. 3759, FY 1994 emergency disaster supplemental appropriations. To agree to the conference report on the bill to fund \$11 billion in FY 1994 supplemental appropriations and provide \$7.8 billion in new FY 1994 appropriations for southern California earthquake assistance, international peacekeeping, Midwest flood relief, low-income energy assistance, and additional aid for the 1989 Loma Prieta earthquake in the San Francisco Bay area and rescind \$3.2 billion in funds already appropriated for a variety of purposes to partially offset the costs of the bill. Yes. Passed 245-65. 2/11/94.

## BUDGET, TAXES & REVENUE

(50) H.Res. 384, rule to consider H.Con.Res. 218, FY 1995 Budget Resolution. No. Passed 245-171. 3/10/94.

(51) H.Con.Res. 218, FY 1995 Budget Resolution. Amendment [Frank] as a substitute to reduce the \$263.3 billion in defense budget authority in the resolution by \$2.4 billion. No. Failed 105-313. 3/10/94.

(52) H.Con.Res. 218. Amendment [Solomon] as a substitute to balance the budget by 1999 through \$698 billion in additional spending cuts. No. Failed 73-342. 3/10/94.

(54) H.Con.Res. 218. Amendment [Mfume] as a substitute incorporating the Congressional Black Caucus budget to shift \$16.8 billion in budget authority and \$9 billion in outlays from defense to domestic programs in FY 1995 and a total of \$175.1 billion in budget authority and \$125.3 billion in outlays over five years. No. Failed 81-326. 3/11/94.

## GLOSSARY OF TERMS

### USED IN VOTING RECORD REPORT

#### HOW THE VOTING RECORD REPORT IS ARRANGED

This report is arranged by general subject areas as follows: each vote begins with the roll call number in parentheses, followed by the number of the bill or resolution being considered and short description of the question on which the vote was taken, including amendments, motions and passage. Next my own vote on the measure is listed by either a "yes" or "no." The vote of the entire House is next indicated by either "passed" or "failed" with the vote total, followed by the date on which the vote occurred. Votes taken under suspension of the rules are so indicated and an explanation of that procedure may be found in the glossary.

**AMENDMENT** — A proposal of a member of Congress to alter the language, provisions or stipulations in a bill or in another amendment. It is usually printed, debated and voted upon in the same way as a bill.

**APPROPRIATIONS** — Legislation which provides the actual funds approved by authorization bills, but not necessarily the full amount authorized. There are 13 regular appropriations bills which must be approved on an annual basis effective for the fiscal year which begins on Oct. 1 (also see Continuing Resolution).

**AUTHORIZATION** — Basic, substantive legislation that establishes or continues (reauthorizes) the legal operation of a federal program or agency, either indefinitely or for a specific period, or which sanctions a particular type of obligation or expenditure.

**BILL** — A legislative proposal, designated as H.R. in the House of Representatives and S. in the Senate, followed by a number assigned in the order in which it is introduced during the two-year period in which a Congress is convened. If approved by both houses of Congress in the same form and signed by the President, a bill becomes a law.

**COMMITTEE OF THE WHOLE** — A procedural device designed to expedite the legislative work in the House in which slightly less formal rules for conduct of debate and voting on amendments apply.

**CONCURRENT RESOLUTION** — A resolution, designated as House Concurrent Resolution (H.Con.Res.) or Senate Concurrent Resolution (S.Con.Res.), often used to express the "sense of Congress" on various domestic or foreign policy issues. Concurrent resolutions do not require or are not intended for approval by the President and therefore do not have the force of law.

**CONFERENCE** — A meeting between the representatives of the House and Senate to reconcile differences between the two houses over provisions of a bill or joint resolution passed by both chambers. A majority of the members of the conference from each chamber must agree on the provisions of a measure before it can be considered by either chamber in the form of a "conference report." Conference reports cannot be amended and if not approved, the legislation may go back to conference or a new conference must be convened. Legislation passed by both houses with only minor differences need not be sent to conference; either chamber may "concur" in the other's amendments, completing action on the legislation.

**CONTINUING RESOLUTION** — A joint resolution which continues in effect appropriations legislation for specific ongoing activities of federal departments or agencies when a fiscal year begins and Congress has not yet enacted all of the 13 regular appropriations bills for that fiscal year.

**DEMAND FOR A SEPARATE VOTE** — A procedure which a member can use to demand that a separate vote on any amendment passed in the Committee of the Whole be voted upon again when the Committee reports a bill or resolution back to the full House for action. During the 1st Session of the 103rd Congress, House rules were changed to allow the resident commissioner of Puerto Rico and the delegates from American Samoa, the District of Columbia, Guam, and the Virgin Islands to vote in and preside over the Committee of the Whole. Those five members, however, are not allowed to vote in the House. The demand for a separate vote was used more frequently during the 1st Session of the 103rd Congress because of that rules change.

**HOUSE** — The House of Representatives, as distinct from the Senate, although each body is a "house" of Congress.

**JOINT RESOLUTION** — A resolution, designated House Joint Resolution (H.J.Res.) or Senate Joint Resolution (S.J.Res.), followed by a number assigned in the order in which it is introduced during the two-year period in which a Congress is convened. If approved by both houses in the same form and signed by the President, it becomes a law just as a bill does. A joint resolution is generally limited to special circumstances and is also used to propose amendments to the Constitution. Under that purpose, it does not require a presidential signature and becomes part of the Constitution when three-fourths of the states ratify or approve it.

**PREVIOUS QUESTION** — A request for the previous question, or a motion to order the previous question in the House brings to a vote the question of whether debate and the possibility of amending the question should end and the merits of the pending issue should be voted upon. For example, the previous question is voted upon during consideration of a rule, which sets the time limits for debate and whether or which amendments are allowed to be considered on a bill. If a member wanted an additional amendment to be considered which was not made in order by the rule, he or she could work to defeat the previous question and if successful, the rule could be amended to include the member's request. If the motion to order the previous question is approved, debate on the issue and the possibility of amendment end.

**RESOLUTION** — A simple resolution, designated House Resolution (H.Res.) or Senate Resolution (S.Res.), deals with matters entirely within the prerogatives of one house or the other. It requires neither passage by the other chamber nor approval by the President, does not have the force of law and is commonly used for internal business of one house or for expressing views of a chamber.

**RULE** — A resolution from the House Rules Committee which, if adopted by the House, sets the procedures and time limits for debate and voting on a pending bill or resolution. A rule can be open, which would allow any member to offer an amendment to the pending legislation, modified, which would allow only certain amendments approved by the Rules Committee to be offered, or closed, which would not allow any amendments to be offered.

**SUSPENSION OF RULES** — A procedure used in the House intended to speed the consideration of non-controversial legislation. Under suspension of the rules, debate is limited to 40 minutes; no amendments from the floor are permitted, and a two-thirds vote of those members voting is required for passage.

(55) H.Con.Res. 218. Amendment [Kasich] as a substitute to provide an additional \$147.5 billion in deficit reduction over five years, and over five years cut taxes by \$119.1 billion, including a \$500-per-child tax credit for families earning up to \$200,000 a year; cut domestic spending by \$284.4 billion; cut foreign aid by \$13.1 billion; and increase defense spending by \$61.1 billion. **Yes.** Failed 165-243. 3/11/94.

(56) H.Con.Res. 218. On passage of the FY 1995 budget resolution generally following the guidelines of President Clinton's budget setting budget authority at \$1.541 trillion, outlays at \$1.541 trillion, revenues at \$1.338 trillion, and a deficit of \$175.3 billion. **No.** Passed 223-175. 3/11/94.

(59) H.Res. 331, rule to consider H.J.Res. 103, Balanced Budget Constitutional Amendment. **Yes.** Passed 387-22. 3/16/94.

(60) H.J.Res. 103. Amendment [Kyl] as a substitute to mandate a balanced budget by 2000 or the third fiscal year following ratification, authorize a presidential line-item veto and limit federal outlays in a given year to 19 percent of the gross national product unless three-fifths of Congress votes to waive the limitation. **Yes.** Failed 179-242. 3/16/94.

(62) H.J.Res. 103. Amendment [Barton] as a substitute to mandate a balanced budget by 2000 or the second fiscal year following ratification and limit the growth in federal spending to the rate of growth in national income in the previous calendar year, unless three-fifths of Congress votes to allow revenue to increase at a faster rate. **Yes.** Failed 213-215. 3/17/94.

(63) H.J.Res. 103. Revote procedure as required when delegate votes provide the margin deciding an issue, as occurred on amendment [Barton] as a substitute [roll 62] to limit the growth in federal spending to no more than the growth in national income unless three-fifths of Congress approves the specific tax increase. **Yes.** Passed 211-204. 3/17/94.

(64) H.J.Res. 103. Amendment [Wise] as a substitute to mandate a balanced budget by 2001 or the second fiscal year following ratification, prohibit the use of surplus Social Security revenues in the deficit calculation, authorize Congress to create a separate capital budget in which borrowing would be permitted for highway improvements and other capital projects, and allow deficit spending during periods of recession, war or a serious military threat. **No.** Failed 111-318. 3/17/94.

(65) H.J.Res. 103. On passage to the joint resolution to propose a constitutional amendment to require a balanced budget by 2001 or the second fiscal year after ratification by three-fifths of the states, whichever is later. Congress could waive the balanced budget requirement if three-fifths of the House and Senate approve deficit spending and could also waive the requirement when a declaration of war was in effect or when there was a declared military threat to national security. **Yes.** Failed 271-153. 3/17/94. [Note: a two-thirds majority vote of those present and voting (283 in this case) is required to pass a joint resolution proposing an amendment to the Constitution.]

(96) H.R. 4066, to temporarily suspend the duty on personal items imported by participants in, and certain individuals associated with, five international sporting events to be held in the U.S. over the next three years. **Yes.** Passed 406-1, under suspension of rules. 4/12/94.

(112) H.Con.Res. 218, FY 1995 Budget Resolution. Motion to instruct the House conferees to agree to the Senate amendment to provide an additional \$26.1 billion in deficit reduction over the next five years and to protect defense spending from further cuts. **Yes.** Failed 202-216. 4/14/94.

(160) H.Res. 418, rule to consider the conference report for H.Con.Res. 218, the FY 1995 budget resolution. **No.** Passed 228-168. 5/5/94.

(161) H.Con.Res. 218, to adopt the conference report on the FY 1995 budget resolution to set budget levels for FY 1995 at: budget authority, \$1.541 trillion; outlays, \$1.514 trillion; revenues, \$1.338 trillion; and a deficit of \$175.4 billion. **No.** Passed 220-183. 5/5/94.

(169) H.R. 4278, to raise the threshold at which individuals are required to pay Social Security taxes for their domestic workers from \$50 per quarter to \$1,200 annually in 1994 and \$1,250 in 1995 and index the threshold thereafter to the national average wage increase. **Yes.** Passed 420-0, under suspension of rules. 5/12/94.

(326) H.Res. 467, rule to consider H.R. 4600, Expedited Rescissions Act, to strengthen the president's existing authority to propose to rescind any part of an appropriations bill by adding a new requirement that Congress vote on that rescission proposal within a specified period. **No.** Passed 240-185. 7/14/94.

(327) H.R. 4600, Expedited Rescissions Act. Substitute amendment to make a presidential rescission package or targeted tax break repeal package automatically effective unless Congress passed a resolution of disapproval over a likely presidential veto. **Yes.** Failed 205-218. 7/14/94.

(328) H.R. 4600. Substitute amendment to require Congress to vote on presidential proposals to cancel individual spending items in appropriations bills or targeted tax breaks in revenue bills, make the procedures permanent, allow the president to utilize the procedures at any time, allow 50 representatives or 15 senators to offer a motion to strike from a rescissions package an individual proposal, and allow the president to specify that the savings go to deficit reduction. **Yes.** Passed 298-121. 7/14/94.

(329) H.R. 4600. On passage of the bill to require Congress to vote on presidential proposals to cancel individual spending items in appropriations bills or targeted tax breaks in revenue bills. **Yes.** Passed 342-69. 7/14/94.

(342) H.Res. 484, rule to consider H.R. 4602, Budget Control Act. Motion to order the previous question on the rule. **No.** Passed 245-180. 7/21/94.

(343) H.R. 4604, Budget Control Act. Substitute amendment to require the president and Congress to annually set a binding, overall cap on entitlement spending [except Social Security] by converting the budget resolution, which is now non-binding, into a measure that would require the president's signature and become law; require authorizing committees to set individual limits on entitlement programs and if the committees failed to cut projected spending enough to prevent the overall cap from being breached, programs that exceeded their individual limits would be automatically cut back. **Yes.** Failed 194-233. 7/21/94.

(344) H.R. 4604. Substitute amendment to set caps on all entitlement spending [including Social Security] for FYs 1996-2000 that would result in some \$150 billion in cuts below current projections; require automatic cuts in all programs [including Social Security] if Congress failed to pass reconciliation legislation to prevent spending from exceeding the caps; and prohibit using tax increases or cuts in discretionary spending to offset excess entitlement spending. **No.** Failed 37-392. 7/21/94.

(345) H.R. 4604. Motion to recommit the bill to the Rules Committee with instructions to report the bill back to the House with an amendment to prohibit any attempt to fix a breach in overall entitlement limits by cutting Social Security benefits, borrowing from the Social Security trust fund or raising the Social Security payroll tax. **Yes.** Passed 424-0. 7/21/94.

(346) H.R. 4604. On passage of the bill to require the Office of Management and Budget to set long-term spending targets for entitlement programs with the exception of Social Security that, if exceeded by more than 0.5 percent, would trigger a process whereby the president would have to recommend legislation to address the excess spending and Congress would have to vote on the proposals. **Yes.** Passed 316-107. 7/21/94.

(393) H.Res. 512, rule to consider H.R. 4907, bill to revise budgeting procedures to require that both the president's budget and the congressional budget resolution include two baselines in estimating discretionary spending, "current policy" that would adjust for inflation and "current funding" that would not adjust for inflation. **No.** Passed 255-178. 8/11/94.

(395) H.R. 4907, baseline budgeting. Substitute amendment to change existing budget practice by barring use of an inflation-adjusted baseline [which allows comparison of the forthcoming year's discretionary spending with an inflation-adjusted version of the previous year's spending] and requiring the use of a "freeze" baseline that would show only the previous year's spending level. **Yes.** Passed 247-171. 8/12/94.

(396) H.R. 4907. Substitute amendment to change existing budget practice by allowing the use of two baselines against which to compare the forthcoming year's discretionary spending—the existing inflation-adjusted baseline and a "freeze" baseline showing the previous year's spending with no adjustment. **No.** Failed 170-243. 8/12/94.

(400) H.R. 4906, emergency spending procedures. Amendment to repeal existing emergency spending procedures and require that any emergency spending above discretionary spending caps be offset by reductions in discretionary spending the following year. **No.** Failed 160-258. 8/17/94.

(401) H.R. 4906. Substitute amendment to require appropriators to set aside adequate money each year in a Budget Reserve Account to pay for natural disasters or national security emergencies, with any money left over at the end of the fiscal year going to deficit reduction. **Yes.** Failed 184-235. 8/17/94.

(402) H.R. 4906. Substitute amendment to prohibit the inclusion of non-emergency spending provisions in emergency spending bills and allow points of order in both chambers against any emergency spending legislation that contains non-emergency spending. **Yes.** Passed 322-99. 8/17/94.

(403) H.R. 4906. On passage of the bill to prohibit the inclusion of non-emergency spending provisions in emergency spending bills and allow points of order in both chambers against any emergency spending legislation that contains non-emergency spending. Yes. Passed 406-6. 8/17/94.

(483) H.Res. 563, rule to consider H.Con.Res. 301, to express the sense of Congress that action must be taken to ensure that current unsustainable entitlement spending trends do not create an unfair debt burden on America's children. No. Failed 83-339. 10/5/94.

(493) H.Res. 565, rule to consider S. 455, Payments in Lieu of Taxes to increase federal payments to local governments to compensate for federally owned land, for which they cannot collect taxes, from the current authorization level of \$105 million to \$227 million by FY 1999 with payments in subsequent years indexed for inflation. Yes. Passed 384-28. 10/6/94.

(494) H.R. 4278, to agree to the conference report on the bill to increase the threshold at which Social Security taxes must be paid for domestic workers from \$50 per calendar quarter to \$1,000 annually. Yes. Passed 423-0. 10/6/94.

## BUSINESS & BANKING

(149) H.R. 3191, to require mortgage lenders to ensure that borrowers in flood prone areas purchase flood insurance as condition of their loan. Yes. Passed 335-60, under suspension of rules. 5/3/94.

(331) H.R. 820, National Competitiveness Act. Motion to instruct the House conferees on the bill to allow judicial review of agency compliance with the Regulatory Flexibility Act [PL 96-354], which requires regulatory agencies to consider the impact of proposed regulations and rules on small businesses and local governments. Yes. Passed 380-36. 7/19/94.

(337) H.R. 1188, Anti-Redlining in Insurance Disclosure Act. Amendment to place the responsibility for collecting and disclosing information required by the bill with the Department of Housing and Urban Affairs rather than the Department of Commerce and require that all reports be transmitted to the Banking, Finance, and Urban Affairs Committee instead of the Energy and Commerce Committee. No. Failed 88-343. 7/20/94.

(338) H.R. 1188. Amendment to increase from 25 to 75 the number of metropolitan areas in which insurers must provide the Commerce Department with data; require insurers to provide voluntarily supplied data from policy applicants and policyholders on their race, ethnicity and gender; require insurers to report the amount paid out in claims by five-digit ZIP code; allow reporting of information by nine-digit ZIP code or census tract; and exempt small insurance companies from the reporting requirements. No. Failed 97-333. 7/20/94.

(339) H.R. 1188. Amendment to require that in addition to other reports made to the Commerce Department, insurers be required to report the reasons when they deny new insurance or decline to renew existing policies. No. Failed 123-305. 7/20/94.
