House Republicans will take the item chosen by the American people and introduce legislation on the House floor to cut that program. Past YouCut winners that were introduced and voted on with the support of Rep. Calvert include:

**H.R. 5546 - \$2.5 billion** in savings from rolling back expanded welfare. In the 1990s, Republicans reformed welfare and demanded more accountability and a cap on benefits. Democrat proposals have begun to roll back those successful reforms. **FAILED, 177 to 240**

**H.R. 5382 - \$30 billion** in savings by eliminating federal employee pay raise. Freezing federal civilian pay at the current level for one year would save approximately \$2 billion next year and \$30 billion over ten years. **FAILED, 183 to 227**

**H.R. 5072 - \$30 billion** in savings from reforming Freddie Mac and Fannie Mae. **FAILED, 180 to 230**

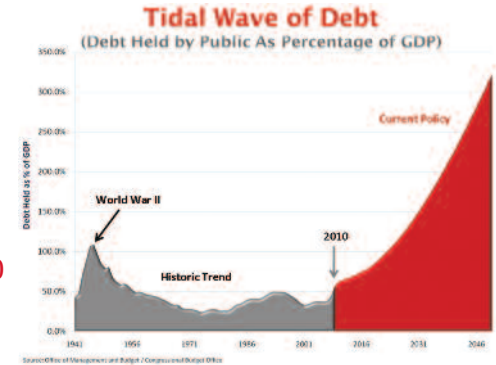
