ACADEMY NOMINATION INFORMATION (PLEASE READ CAREFULLY)

Consideration for nominations will be given to U.S. Citizens who are legal residents of the 8th District of Arizona who reach the age of seventeen, but do not exceed that of twenty-three (twenty-five for the Merchant Marine Academy), prior to July 1st of the year in which they seek entrance. Files must be complete in my Sierra Vista office by **November 2, 2012**. The following items are required to complete your file:

- 1. Application for nomination (attached). Please type or use black ink to fill out application.
- 2. Official High School and/or College Transcript (must be sent directly from High School or College in sealed envelope).
- 3. Three letters of recommendation (at *least* one should be from a teacher, counselor or the principal of your school) addressed to Congressman Barber, with <u>original</u> signatures. Please follow up with my office to be sure the letters have been received before the deadline.
- 4. A wallet-sized, recent color photograph. (Your picture is important to help me associate you with your file). Please print your name on the back of the photo so I can be sure the photo is associated with your file.
- 5. SAT/ACT Scores (originals, not copies). Be sure that your scores are mailed both to the academy *and* to my Sierra Vista office. Our code to insure we receive a copy of your ACT Scores is 7231 and for SAT, the code is 4376. <u>I cannot emphasize enough the importance of taking these tests early.</u> Not having any test scores in your file could prevent you from being considered for an interview with my nominating committee. <u>It is your responsibility to arrange for and take college entrance exams.</u>
- 6. If you are a member of the National Honor Society, a copy of your certificate is required for your file.
- 7. Please be sure you have <u>opened a file</u> at all the academies you would consider attending, this is your responsibility. If you have not opened a file by the time I decide on my nominees, I will not be able to submit a nomination for you.

Nominations to the service academies will be made on a fully competitive basis. For each opening that is available to me, I will nominate up to ten applicants. The selection of these nominees will be determined primarily by high school scholastic records, ACT/SAT test scores, and a personal interview with my committee. Qualified candidates will be notified as far as possible in advance of their interview date.

Each academy will give equal consideration to the nominees following the receipt and evaluation of information derived from college entrance examinations, physical examinations and a review of high school records, and each academy will make the final selections and appointments.

Although you are applying for a nomination to one of the service academies, you should, at the same time, pursue an alternative goal and apply for admission to the college or university of your choice. You might also check into the various ROTC programs available at many colleges and universities.

I strongly suggest that you contact my office <u>before</u> the **November 2nd** deadline to ask if the required documents have reached my office. An incomplete file may prevent you from being given an interview with my nominating committee. I will notify you of your interview date and time as soon as possible after the submission deadline, and I will notify you of your nomination as soon as possible after the interview.
