DOES THE IRS OWE YOU MONEY?

If you have not filed a prior year tax return and are due a refund, you should consider filing the return to claim that refund. If you are missing a refund for a previously filed tax return, you should contact the IRS to check the status of your refund and confirm your current address.

Unclaimed Refunds

Some of you may have had taxes withheld from your wages but were not required to file a tax return because your income was too low. Others of you may not have had any tax withheld but may be eligible for the refundable Earned Income Tax Credit.

- To claim this money, you must file a return with the IRS no later than three years from the due date of the return.
- If you do not file to claim the refund within three years, the money becomes the property of the U.S. Treasury.
- There is no penalty assessed by the IRS for filing a late return that qualifies for a refund.
- Current and prior year tax forms and instructions are available on the Forms and Publications web page of IRS.gov or by calling 1-800-829-3676.

Undeliverable Refunds

Were you expecting a refund check but didn't get it?

- Refund checks are mailed to your last known address. Checks are returned to the IRS if you move without notifying the IRS or the U.S. Postal Service.
- You may be able to update your address with the IRS on the "Where's My Refund?" feature available on IRS.gov. You will be prompted to provide an updated address if there is an undeliverable check outstanding within the last 12 months.
- You may also ensure the IRS has your correct address by filing Form 8822, "Change of Address," which is available on IRS.gov or can be ordered by calling 800-TAX-FORM (800-829-3676).

IRS Reminds Taxpayers to Take Advantage of Recovery Act Benefits

First Time Homebuyer Credit:

The Recovery Act [extended and expanded the first-time homebuyer tax credit](#) for 2009. Taxpayers who didn't own a principal residence during the past three years and purchase a home this year before Dec. 1, may receive a credit of up to \$8,000. The credit is claimed by filling out **Form- 5405** at IRS.gov.

Energy-Efficient Home Improvements:

The Recovery Act increases the rate to 30 percent of the cost of all qualifying improvements and raises the maximum credit limit to a total of \$1,500 for improvements placed in service in 2009 and 2010. Qualifying improvements include the addition of insulation, energy-efficient exterior windows and energy-efficient heating and air conditioning systems. New Vehicle Purchase Incentive:

The Recovery Act provides a [tax break to taxpayers who make qualified new vehicle purchases](#) after Feb. 16, 2009, and before Jan. 1, 2010. Qualifying taxpayers can deduct the state and local sales and excise taxes paid on the purchase of new cars, light trucks, motor homes and motorcycles. There is no limit on the number of vehicles that may be purchased, and you may claim the deduction for taxes paid on multiple purchases. The deduction per vehicle is limited to the tax on up to \$49,500 of the purchase price of each qualifying vehicle and phases out for taxpayers at higher income levels. You will claim this deduction when filing your 2009 federal income tax return in 2010.

Tax Credit for First Four Years of College:

The American opportunity credit is designed to help parents and students pay part of the cost of the first four years of college. The new credit modifies the existing Hope credit for tax years 2009 and 2010, making it available to a broader range of taxpayers, including many with higher incomes and those who owe no tax.
