The final decision to offer an appointment lies with the Service Academies.

- 2. <u>Certified High School Transcripts-</u>Certification from your guidance counselor/principal including GPA, class rank and all coursework.
- 3. ACT or SAT Official Test Scores sent to Congressman Fleischmann.
- 4. <u>Letters of recommendation</u>- at least three letters in a sealed envelope addressed to the Congressman, (only one from Academic source).
- 5. Extracurricular activities resume.
- 6. One page <u>essay</u> explaining your desire to attend a Military Academy.
- 7. Photograph included in the packet. (optional)
- 8. Send the <u>Application for Nomination</u> to Congressman Chuck
