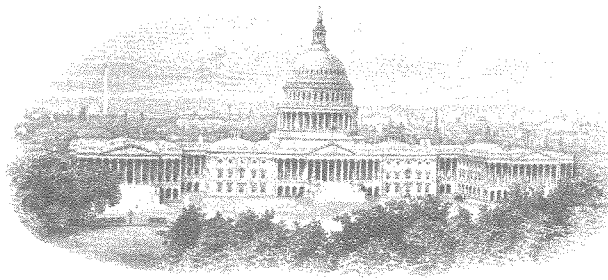

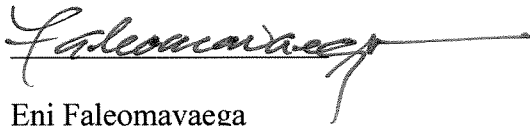
Purpose of such Congressional Earmark:
