#### **House Passes Defense Bill**

By a vote of 391 - 34, the House of Representatives passed the fiscal year 2005 defense authorization bill (H.R. 4200) on May 20, 2004. The annual national defense authorization act sets policies, programs, and funding levels for our nation's military.

This year's act, coming at a time when U.S. forces remain courageously engaged in a struggle for the safety and security of Americans here at home as well as the freedom of the people of Afghanistan and Iraq, was focused both on protecting our troops on the battlefield and supporting their families' needs back home. The largely bipartisan supported bill was based on months of hearings with Department of Defense senior leaders as well as meetings directly with commanders and troops deployed in combat. Some of the critically important aspects of H.R. 4200 include: a 3.5% pay increase for military personnel; an increase in the number of active-duty service members in the Army by 30,000 and in the Marine Corps by 9,000; the provision of additional body armor and armored vehicles for troops deployed in harm's way; improved survivor benefits for spouses of military retirees; and, the provision of a health care program for National Guard members and reservists and their family members who otherwise lack health insur-

I voted in favor of H.R. 4200 and remain committed to ensuring that our men and women in uniform have our nation's full and unequivocal support. The House and Senate are now conferencing on their respective versions of the fiscal year 2005 defense authorization act. ### Reducing Energy Costs

The United States House of Representatives considered three measures on June 15, 2004 aimed at ensuring more affordable, reliable and stable energy prices. I voted in favor of each of these measures.

First, the Gasoline Price Reduction Act (H.R. 4545) would address supply disruptions that have occurred in certain regions of the country due to the government-mandated use of specialized gasoline formulations known as "boutique fuels." Second, the Energy Policy Act (H.R. 4503) would provide incentives for domestic oil and natural gas production as well as the development of alternative and renewable energy sources. Finally, the U.S. Refinery Revitalization Act (H.R. 4517) would streamline the process for building new oil refineries. No new oil refineries have been built in the United States since 1976. Today, 153 refineries operate in the United States, as compared to 324 refineries in 1981. H.R. 4517 and H.R. 4503 passed the full House by a vote of 239-192 and 244-178, respectively. Both bills are now pending in the Senate. Although a majority of members (specifically, 236) voted in favor of H.R. 4545, that measure failed to pass the House because of a special procedure that was in place requiring a super-majority for final passage.

# **Constituent Survey Results**

Surveys such as the one included in my January newsletter are a valuable means of keeping me well informed of your views and concerns regarding legislative proposals. More than 17,459 citizens responded to one or more survey questions. The results are found below. I am pleased to extend my deepest thanks to all who took the time to share their opinions with me.

1. Should the top corporate tax rate be reduced from 35% to 32% for domestic manufacturers in an effort to retain and create jobs for workers here in the United States?

**2.** Do you support the recent decision of the Federal Communications Commission (FCC) to permit national broadcast companies to own local broadcast stations reaching 45% of all U.S. house holds, up from 35%?

**3.** Should the \$1,000 child tax credit be "refundable" (i.e., be made payable to those whose income is too low to owe federal income tax)?

**4.** Do you believe prescription drugs approved for use in the United States can be safely re-imported into the country from Canada, the European Union, and other industrialized countries?

**5.** Should the U.S. Constitution be amended to prohibit states from recognizing same-sex marriages?

**6.** Should the federal government provide federal program benefits that are offered based on marital status (i.e., Social Security spousal benefits) to state-recognized same-sex civil unions?

**7.** Should Congress extend for an additional 13 weeks unemployment compensation benefits for individuals who have exhausted their 26 weeks of standard benefits?

Total responses: 15,962 Yes 9,323 (58%) No 6,639 (42%)

**8.** Should legal "temporary worker" status be offered to currently undocumented illegal immigrants working in agriculture and other industries if the worker follows the established application process, abides by the rules, and agrees to return home after the period of work expires?

Total responses: 16,096 Yes 7,898 (49%) No 8,198 (51%)

### **Continuity in Representation**

Ever since the tragic attacks of September 11, 2001, a debate has been taking place on how the federal government would function in the event of catastrophic terrorist attack resulting in the deaths of a large number of United States House of Representatives and Senate members. Some have advocated the passage of an amendment to the United States Constitution that would allow members of the House to be appointed by state governors, much as Senators currently are when one of them dies in office. Others contend that "the people's House" should always remain a legislative body of elected, not appointed, members.

On April 22, 2004, the House voted 306-97 to pass legislation (H.R. 2844) requiring special elections to fill vacant House seats within 45 days in the event of a catastrophe killing at least 100 members. Some states already have laws on the books that allow for similarly expedited elections. Subsequently, on June 2, 2004, the House voted 63-353 to overwhelmingly reject a proposed Constitutional amendment (H.J. Res. 83) to allow members of the House to instead be appointed. I voted with the majority of my colleagues in favor of H.R. 2844 (expedited elections) and against passage of H.J. Res. 83 (appointed members) because I believe an elected House of Representatives is fundamental to our system of government.
