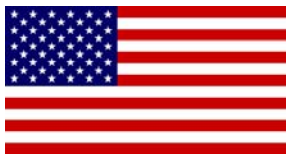

## **I. STATEMENT OF PURPOSE**

Established in 1996, the Congressional Caucus on Hellenic Issues works to foster and improve relations between the United States and Greece. The Caucus brings a renewed congressional focus on key diplomatic, military, and human rights issues in a critical part of the world. The members of the Caucus introduce legislation, arrange briefings on current events, and disseminate information to interested parties. The topics on which the Caucus focuses include U.S. aid to Greece and Cyprus, the conflict in Cyprus, U.S. relations with the Former Yugoslav Republic of Macedonia, the status of the Ecumenical Patriarchate, and developments in the Aegean. In the 112<sup>th</sup> Congress, the Caucus has more than 135 members.

## **II. BILLS INTRODUCED IN THE 112<sup>th</sup> CONGRESS**

**H. Res. 650** Expressing the sense of the House of Representatives that the former Yugoslav Republic of Macedonia should work within the framework of the United Nations process with Greece to achieve longstanding United States and United Nations policy goals of finding a mutually acceptable name, for all uses, for the former Yugoslav Republic of Macedonia. Introduced by Rep. Carolyn B. Maloney (D-NY).

**H.R. 3131** To direct the Secretary of State to submit a report on whether any support organization that participated in the planning or execution of the recent Gaza flotilla attempt should be designated as a foreign terrorist organization and any actions taken by the Department of State to express gratitude to the government of Greece for preventing the Gaza flotilla from setting sail in contravention of Israel's legal blockade of Gaza, and for other purposes. Introduced by Rep. Gus M. Bilirakis (R-FL).

**H. Res. 180** Urging Turkey to respect the rights and religious freedoms of the Ecumenical Patriarchate. Introduced by Rep. Carolyn B. Maloney (D-NY).

**H. Res. 179** To recognize and appreciate the historical significance and the heroic human endeavor and sacrifice of the people of Crete during World War II and commend the PanCretan Association of America. Introduced by Rep. Carolyn B. Maloney (D-NY).

**H.R. 2597, the American Owned Property In Occupied Cyprus Claims Act,** will enable U.S. citizens to seek remedies in the following three different ways:

1. The bill authorizes the President to cause a claims program to be opened under which the claims of U.S. nationals who Turkey has excluded from their property in occupied Cyprus can be adjudicated by the Foreign Claims Settlement Commission (referred to as FCSC) and compensated through government-to-government negotiations between the United States and Turkey.
2. The bill empowers the United States district courts to hear causes of action asserted by U.S. nationals who have been excluded from property in occupied Cyprus against private persons or entities that occupy or use the property of U.S. nationals in occupied Cyprus.

3. The bill empowers the United States district courts to hear causes of action asserted by U.S. nationals who have been excluded from property in occupied Cyprus against Turkey without having to assert those causes of action under the Foreign Sovereign Immunities Act of 1976 as amended.

Introduced by Rep. Frank Pallone (D-NJ).

**H.R. 1337** To support efforts by the Department of State to strengthen the bilateral relationship with Greece. Introduced by Rep. Ileana Ros-Lehtinen (R-FL).

### **III. BILLS INTRODUCED IN THE 111<sup>th</sup> CONGRESS**

**H. Res. 1107** Recognizing the 189<sup>th</sup> anniversary of the independence of Greece and celebrating Greek and American democracy. Introduced by Rep. Ileana Ros-Lehtinen (R-FL). Passed the House of Representatives on March 11, 2010, 414-0.

**H. Res. 486** Expresses the sense of Congress that the former Yugoslav Republic of Macedonia should work with the United Nations and Greece to achieve longstanding United States and United Nations policy goals of finding a mutually-acceptable official name for the FYROM. Introduced by Rep. Carolyn B. Maloney (D-NY).

**H.R. 2261**, which deems Greece to be designated as a visa waiver country under the Immigration and Nationality Act. Introduced by Rep. Carolyn B. Maloney (D-NY).

**H. Res. 838**, Welcoming to the United States and to Washington, DC, His All Holiness Bartholomew, Archbishop of Constantinople, New Rome, Ecumenical Patriarch on his upcoming trip on October 20, 2009, through November 6, 2009. Introduced by Rep. Gus Bilirakis (R-FL). Passed the House of Representatives on October 28, 2009, 424-0.

**H. Res. 273** Recognizing the 188<sup>th</sup> anniversary of the independence of Greece and celebrating Greek and American democracy. Introduced by Rep. Ileana Ros-Lehtinen (R-FL). Passed the House of Representatives on March 25, 2009, 423-0.

**H. Res. 236** Urging Turkey to respect the rights and religious freedoms of the Ecumenical Patriarchate. Introduced by Rep. Carolyn B. Maloney (D-NY).

**H. Res. 227** To recognize and appreciate the historical significance and the heroic human endeavor and sacrifice of the people of Crete during World War II and commend the PanCretan Association of America. Introduced by Rep. Carolyn B. Maloney (D-NY).

**H. Res. 209**, Commemorating the 80th anniversary of the Daughters of Penelope, a preeminent international women's association and affiliate organization of the American Hellenic Educational Progressive Association (AHEPA). Introduced by Rep. Carolyn B. Maloney (D-NY). Passed the House of Representatives by voice vote on October 13, 2009.

#### **IV. BILLS INTRODUCED IN THE 110<sup>th</sup> CONGRESS**

**H.R. 2526**, which deems Greece to be designated as a visa waiver country under the Immigration and Nationality Act. Introduced by Rep. Carolyn B. Maloney (D-NY).

**H.R. 1456, the American Owned Property In Occupied Cyprus Claims Act,** will enable U.S. citizens to seek remedies in the following three different ways:

1. The bill authorizes the President to cause a claims program to be opened under which the claims of U.S. nationals who Turkey has excluded from their property in occupied Cyprus can be adjudicated by the Foreign Claims Settlement Commission (referred to as FCSC) and compensated through government-to-government negotiations between the United States and Turkey.
2. The bill empowers the United States district courts to hear causes of action asserted by U.S. nationals who have been excluded from property in occupied Cyprus against private persons or entities that occupy or use the property of U.S. nationals in occupied Cyprus.

**H.R. 1313**, To direct the Joint Committee on the Library to obtain a statue of Constantino Brumidi for display in the Capitol Visitor Center. Introduced by Rep. Gus Bilirakis (R-FL).

**H. Res. 1024** Recognizing the 187<sup>th</sup> anniversary of the independence of Greece and celebrating Greek and American democracy. Introduced by Rep. Ileana Ros-Lehtinen (R-FL). Passed the House of Representatives by voice vote on March 11, 2008.

**H. Res. 629** Extending the condolences and sympathy of the House of Representatives to the Government and the people of Greece for the grave loss of life and vast destruction caused by the devastating fires raging through Greece since June 2007. Introduced by Rep. John Sarbanes (D-MD). Passed the House of Representatives on September 5, 2007, 407-0.

**H. Res. 627** Supporting the removal of Turkish occupation troops from the Republic of Cyprus. Introduced by Rep. Gus Bilirakis (R-FL).

**H. Res. 620** Expressing the sense of the House of Representatives that Turkey should end its military occupation of the Republic of Cyprus, particularly because Turkey's pretext has been refuted by over 13,000,000 crossings by Turkish-Cypriots and Greek-Cypriots into each other's communities without incident. Introduced by Rep. Albio Sires (D-NJ).

**H. Res. 407** Expressing the strong support of the House of Representatives for the positive actions by the Government of the Republic of Cyprus aimed at opening additional crossing points along the cease-fire line, thereby contributing to efforts for the reunification of the island. Introduced by Rep. Carolyn B. Maloney (D-NY).

**H. Res. 405** Expressing the strong support of the House of Representatives for implementation of the July 8, 2006, United Nations-brokered agreement between President of the Republic of Cyprus Tassos Papadopoulos and Turkish Cypriot leader Mehmet Ali Talat relating to the reunification of Cyprus. Introduced by Rep. Gus M. Bilirakis (R-FL). Passed the House of Representatives by voice vote on October 9, 2007.

**H. Res. 373** Urging Turkey to respect the rights and religious freedoms of the Ecumenical Patriarchate. Introduced by Rep. Carolyn B. Maloney (D-NY).

**H. Res. 356** Expressing the sense of the House of Representatives that the Former Yugoslav Republic of Macedonia (FYROM) should stop the utilization of materials that violate provisions of the United Nations-brokered Interim Agreement between the FYROM and Greece regarding "hostile activities or propaganda" and should work with the United Nations and Greece to achieve longstanding United States and United Nations policy goals of finding a mutually-acceptable official name for the FYROM. Introduced by Rep. Carolyn B. Maloney (D-NY).

**H. Res. 228** Recognizing the 186<sup>th</sup> anniversary of the independence of Greece and celebrating Greek and American democracy. Introduced by Rep. Ileana Ros-Lehtinen (R-FL). Passed the House of Representatives on March 13, 2007, 413-0. Passed the Senate on March 15, 2007, by unanimous consent.

**H. Res. 148** To recognize and appreciate the historical significance and the heroic human endeavor and sacrifice of the people of Crete during World War II and commend the PanCretan Association of America. Introduced by Rep. Carolyn B. Maloney (D-NY).

**H. Con. Res. 199** Expressing the sense of the Congress regarding Turkey's claims of sovereignty over islands and islets in the Aegean Sea. Introduced by Rep. Robert Andrews (D-NJ).

**H. Con. Res. 71** Commemorating the 85th Anniversary of the founding of the American Hellenic Educational Progressive Association (AHEPA), a leading association for the Nation's 1.3 million American citizens of Greek ancestry, and Philhellenes. Introduced by Rep. Carolyn B. Maloney (D-NY). Passed the House of Representatives by voice vote on April 16, 2007. Passed the Senate by unanimous consent on March 19, 2007.

## **V. BILLS INTRODUCED IN THE 109<sup>th</sup> CONGRESS**

**H.R. 5562** To direct the Joint Committee on the Library to obtain a statue of Constantino Brumidi for display in the Capitol Visitor Center. Introduced by Rep. Michael Bilirakis (R-FL)

**H.R. 3138** To award posthumously a Congressional gold medal to Constantino Brumidi.  
Introduced by Rep. John Mica (R-FL)

**H.R. 857, the American Owned Property In Occupied Cyprus Claims Act,** will enable U.S. citizens to seek remedies in the following three different ways:

1. The bill authorizes the President to cause a claims program to be opened under which the claims of U.S. nationals who Turkey has excluded from their property in occupied Cyprus can be adjudicated by the Foreign Claims Settlement Commission (referred to as FCSC) and compensated through government-to-government negotiations between the United States and Turkey.
2. The bill empowers the United States district courts to hear causes of action asserted by U.S. nationals who have been excluded from property in occupied Cyprus against private persons or entities that occupy or use the property of U.S. nationals in occupied Cyprus.

**H.Res. 999** Urging Turkey to respect the rights and religious freedoms of the Ecumenical Patriarch.  
Introduced by Representative Carolyn B. Maloney (D-NY).

**H.Res. 953** Commending the Republic of Cyprus and thanking the Cypriot people for their support and assistance in the evacuation of Americans evacuating from Lebanon. Introduced by Representative Bilirakis (R-FL).

**H.Res. 603** Supporting the removal of Turkish occupation troops from the Republic of Cyprus.  
Introduced by Representative Robert Andrews (D-NJ).

**H.Res. 521** Expressing the sense of the House of Representatives that the Former Yugoslav Republic of Macedonia (FYROM) should cease its distribution of negative and nationalist propaganda and should work with the United Nations and Greece to find a mutually acceptable official name for the FYROM. Introduced by Rep. Carolyn B. Maloney (D-NY).

**H.Res. 411** Urging the Republic of Turkey to comply with all European Union standards and criteria prior to its accession to the European Union. Introduced by Rep. Robert Menendez (D-NJ).

**H.Res. 325** Honoring the spiritual leadership of Archbishop Iakovos to Greek Orthodox Christians in the Western Hemisphere. Introduced by Rep. Vito Fossella (R-NY).

**H.Res. 322** Expressing the sense of the House of Representatives in support of the European Court of Human Rights for its decisions in the *Loizidou v. Turkey* and *Xenides-Arestis v. Turkey* cases

and for admitting similar cases before the Court. Introduced by Rep. Carolyn B. Maloney (D-NY).

**H. Res. 290** To recognize and appreciate the historical significance and the heroic human endeavor and sacrifice of the people of Crete during World War II and commend the PanCretan Association of America. Introduced by Rep. Carolyn B. Maloney (D-NY).

**H. Res. 166**, which urges Turkey to respect the rights and religious freedoms of the Ecumenical Patriarch. Introduced by Rep. Robert Menendez (D-NJ).

**H. Con. Res. 493**, urges the Republic of Turkey to comply with all European Union standards and criteria prior to its accession to the European Union. Introduced by Rep. Carolyn B. Maloney (D-NY).

**H. Con. Res. 306**, encourages The Former Yugoslav Republic of Macedonia (FYROM) and Greece to continue negotiations to determine a mutually acceptable official name for the FYROM. Introduced by Rep. David Price (D-NC).

**H. Con. Res. 202**, which permits the use of the rotunda of the Capitol for a ceremony to honor Constantino Brumidi on the 200th anniversary of his birth. Introduced by Rep. Bill Pascrell (D-NJ). Passed the House of Representatives by voice vote on July 20, 2005.

**H. Con. Res. 137**, expresses the sense of Congress regarding Turkey=s claims of sovereignty over islands and islets in the Aegean Sea. Introduced by Rep. Robert Andrews (D-NJ).

## **VI. BILLS INTRODUCED IN THE 108<sup>th</sup> CONGRESS**

**H.R. 5071, the American Owned Property In Occupied Cyprus Claims Act,** will enable U.S. citizens to seek remedies in the following three different ways:

1. The bill authorizes the President to cause a claims program to be opened under which the claims of U.S. nationals who Turkey has excluded from their property in occupied Cyprus can be adjudicated by the Foreign Claims Settlement Commission (referred to as FCSC) and compensated through government-to-government negotiations between the United States and Turkey.
2. The bill empowers the United States district courts to hear causes of action asserted by U.S. nationals who have been excluded from property in occupied Cyprus against private persons or entities that occupy or use the property of U.S. nationals in occupied Cyprus.
3. The bill empowers the United States district courts to hear causes of action asserted by U.S. nationals who have been excluded from property in occupied Cyprus against Turkey without having to assert those causes of action under the Foreign Sovereign Immunities Act of 1976 as amended.

Introduced by Rep. Frank Pallone (D-NJ).



**H.RES.774** Commending the people and Government of Greece for the successful completion of the 2004 Summer Olympic Games. Introduced by Rep. Martin Meehan (D-MA).

**H.RES. 244** To recognize and appreciate the historical significance and the heroic human endeavor and sacrifice of the people of Crete during World War II and commend the PanCretan Association of America. Introduced by Rep. Carolyn B. Maloney (D-NY).

**H.RES. 165** This bill expresses that it is the sense of the Congress that:

(1) expresses its appreciation for the efforts of the United Nations Secretary General to seek a peaceful, just, and lasting settlement of the Cyprus problem for the benefit of the Greek and Turkish Cypriots and the region;

(2) expresses its strong disappointment that the Secretary General's efforts to bring his plan for a comprehensive settlement to a referenda by the Greek and Turkish Cypriots has been rejected;

(3) expresses its very strong regret that Turkish Cypriot leader, Mr. Denktash, rejected the comprehensive settlement offered by the Secretary General and, by refusing to offer the settlement proposal to referenda, denied the Turkish Cypriot community the opportunity to determine their own future;

(4) remains committed, despite the recent setback, to giving any assistance necessary for finding a just and durable settlement for the Cyprus problem and urges the maximum effort by the United States Government and others to redouble their efforts to seek a just and lasting settlement to the Cyprus problem;

(5) encourages both Greek and Turkish Cypriot leaders to renew their efforts to find a settlement to the Cyprus problem on the basis of the Secretary General's framework for a comprehensive settlement;

(6) urges the Governments of Turkey and Greece to do everything possible to support the search for a settlement, including actions by the Government of Turkey helping to persuade the Turkish Cypriot leader to reach an agreement which would reunite the island and which would serve the interests of both Greek and Turkish Cypriots; and

(7) encourages both sides, upon completion of a comprehensive settlement, to consider putting such an agreement to referenda, if necessary, in order that the will of the Greek and Turkish Cypriots can be democratically expressed.

Introduced by Rep. Doug Bereuter (R-NE).

**H.RES. 37** This bill congratulates the Republic of Cyprus on its recent completion of the accession

process into the European Union. Introduced by Rep. Robert Andrews (D-NJ).

**H.CON.RES. 530** This bill encourages The Former Yugoslav Republic of Macedonia (FYROM) and Greece to continue negotiations to determine a mutually acceptable official name for the FYROM. Introduced by Rep. David Price (D-NC).

**H.CON.RES. 165** This bill expresses that it is the sense of the Congress that the government of the United Kingdom should enter into negotiations with the Government of Greece as soon as possible to facilitate the return of the Parthenon Marbles to Greece before the Olympics in 2004. Introduced by Rep. Donald Payne (D-NJ).

**H.CON.RES. 87** This bill expresses the sense of Congress regarding Turkey=s claims of sovereignty over islands and islets in the Aegean Sea. Introduced by Rep. Robert Andrews (D-NJ).

## **VII. BILLS INTRODUCED IN THE 107<sup>th</sup> CONGRESS**

**H.CON.RES.345** This bill expresses the sense of the Congress that the Orthodox Theological School of Halki in the Republic of Turkey be reopened in order to promote religious freedom. Introduced by Rep. Michael Bilirakis (R-FL).

**H.CON.RES.269** This bill calls for a United States effort to end restrictions on the freedoms and human rights of the enclaved people in the occupied area of Cyprus. Introduced by Rep. Ileana Ros-Lehtinen (R-FL).

**H.CON.RES. 164** This bill expresses the United States' support for Cyprus' admission to the EU. The resolution follows the Helsinki Conclusions of 1999 which state that while a solution to the political crisis in Cyprus is preferable prior to EU accession, it is not a precondition for entry. On July 24, 2002, the Subcommittee on Europe approved this bill by voice vote. Introduced by Rep. Michael Bilirakis (R-FL).

**H.CON.RES.97** This bill expresses the sense of the Congress regarding Turkey's claims of sovereignty over islands and islets in the Aegean Sea. Introduced by Rep. Robert Andrews (D-NJ).

## **VIII. BILLS INTRODUCED IN THE 106<sup>th</sup> CONGRESS**

**H.RES. 361** This bill urges the President to condition discussions about Turkey=s foreign military finances on resolution of that nation=s hostile occupation of the Republic of Cyprus. Introduced by Representatives Michael Bilirakis (R-FL) and Carolyn B. Maloney (D-NY).

**H.CON.RES. 294** Urges the Government of the United Kingdom to seek to enter into negotiations with the Government of Greece to facilitate the return of the Parthenon Marbles to Greece before the Olympics in 2004. Introduced by Rep. Donald Payne (D-NJ).

**H.CON.RES. 159** (Updated version of H. Con. Res. 100) A concurrent resolution that commends

President Clerides for his decision to cancel the deployment of the S-300 antiaircraft missiles in Cyprus and also urges the President to persuade Turkey to comply with United Nations Security Council Resolutions 1217 and 1218 and to cooperate for a solution to the Cyprus problem. Introduced by Representatives Michael Bilirakis (R-FL) and Carolyn B. Maloney (D-NY).

**H.CON.RES. 100** A concurrent resolution that urges the compliance by Turkey with United Nations resolutions relating to Cyprus and for other purposes. Introduced by Representatives Michael Bilirakis (R-FL) and Carolyn B. Maloney (D-NY).

**H.CON.RES. 80** A concurrent resolution that calls for a United States effort to end restrictions on the freedoms and human rights of the enclaved people in the occupied area of Cyprus. Introduced by Representative Ileana Ros-Lehtinen (R-FL).

**H.CON.RES. 36** A concurrent resolution that expresses the sense of Congress regarding Turkey's claim of sovereignty to the islets in the Aegean Sea called Imia by Greece and Kardak by Turkey. Introduced by Representative Frank Pallone (D-NJ).

## **IX. BILLS INTRODUCED IN THE 105<sup>th</sup> CONGRESS**

**H. Con. Res. 259** Recognizing and honoring the people of the Dodecanesian Islands for their stance in fighting fascism and preserving democratic values and beliefs. Introduced by Representative Thomas Manton (D-NY).

**H. Con. Res. 252** Relating to a United States initiative to help resolve the situation in Cyprus. Introduced by Representative Carolyn B. Maloney (D-NY).

**H. Con. Res. 188** A concurrent resolution commending Greece and Turkey for their mutual and swift response to earthquakes in both countries by providing each other humanitarian assistance and rescue relief. It also encourages both countries to expand on the good will displayed during the earthquakes in the continuing talks between the two countries to resolve their issues of disagreement. Introduced by Rep. Bilirakis (R-FL) and Rep. Maloney (D-NY).

**H. Con. Res. 181** Calling for a United States effort to end restrictions on the freedoms and human rights of the enclaved people in the occupied area of Cyprus. Introduced by Representative Ileana Ros-Lehtinen (R-FL).

**H.Con.Res.148** Commemorating the 75th anniversary of the burning of Smyrna and honoring the memory of its civilian victims. Introduced by Representative Carolyn B. Maloney (D-NY).

**H. Con. Res. 81** Calling for a United States initiative seeking a just and peaceful resolution of the situation in Cyprus. Introduced by Representative Benjamin Gilman (R-NY).

## **X. BILLS INTRODUCED IN THE 104<sup>th</sup> CONGRESS**

**H. Con. Res. 50** Concerning the protection and continued livelihood of the Eastern Orthodox Ecumenical Patriarchate. Introduced by Representative Michael Bilirakis (R-FL).

**H. Con. Res. 42** A concurrent resolution that specifies projects aimed at reunification of Cyprus. This resolution welcomes the appointment of a Special Presidential Emissary for Cyprus and supports efforts by the United Nations and the U.S. Government to resolve the Cyprus problem. Introduced by Representative Eliot Engel (D-NY).

**H. Con. Res. 31** Expressing the sense of the Congress that the United States should support the efforts of Greece, in its negotiations with the Former Yugoslav Republic of Macedonia, to find a solution which promotes a solid, cooperative relationship between these two neighboring countries and that the United States should not establish formal diplomatic relations with the Former Yugoslav Republic of Macedonia until this relationship is established. Introduced by Representative Carolyn B. Maloney (D-NY).

## **XI. ACCOMPLISHMENTS - BILLS ENACTED**

**H.R. 1609** To award posthumously a Congressional gold medal to Constantino Brumidi. Introduced by Rep. Bill Pascrell (D-NJ). S. 254, the Senate companion bill, passed the Senate by unanimous consent on May 21, 2007, and the House of Representatives by voice vote on June 10, 2008. S. 254 was signed into law on July 1, 2008 (P.L. 110-259).

**H.R. 2578 Visa Waiver Pilot Program Amendment.** This amendment of the Visa Waiver Pilot Program Reauthorization Act passed on March 25, 1998, due in large part to the work of Rep. Maloney and the Hellenic Caucus. The amendment was signed by the President into Public Law 105-173 on April 27, 1998.

**H.R. 2248** Authorized a gold medal from Congress to Patriarch Bartholomew. Rep. Maloney worked to help get the 290 cosponsors before the Patriarch Bartholomew's visit in October 1997. Rep. Leach introduced the legislation, in which Rep. Maloney was a cosponsor. The bill passed unanimously. Signed by the President into Public Law 105-51 on October 6, 1997.

**H.R. 2826** A bill to provide for an investigation of the whereabouts of the U.S. citizens and others who have been missing from Cyprus since 1974. Introduced by Rep. Engel and cosponsored by Rep. Maloney. Signed into Public Law 103-372 on October 19, 1994.

**H.J. Res. 10** A joint resolution designating March 25, 1993 as a Greek Independence Day: A National Day of Celebration of Greek and American Democracy. Introduced by Rep. Bilirakis and Rep. Maloney. Related to S.J. Res. 22 which was signed into Public Law 103-8 on March 22, 1993.

Greek and American democracy. Introduced by Rep. Ileana Ros-Lehtinen (R-FL). Passed the House of Representatives on March 11, 2010, 414-0.

**H. Res. 209** Commemorating the 80th anniversary of the Daughters of Penelope, a preeminent international women's association and affiliate organization of the American Hellenic Educational Progressive Association (AHEPA) and recognizing the significant contributions of American citizens of Greek ancestry and Philhellenes. Passed the House of Representatives by voice vote on October 13, 2009.

**H. Res. 273** Recognizing the 188<sup>th</sup> anniversary of the independence of Greece and celebrating Greek and American democracy. Introduced by Rep. Ileana Ros-Lehtinen (R-FL). Passed the House of Representatives on March 25, 2009, 423-0.

**H. Res. 405** Expressing the strong support of the House of Representatives for implementation of the July 8, 2006, United Nations-brokered agreement between President of the Republic of Cyprus Tassos Papadopoulos and Turkish Cypriot leader Mehmet Ali Talat relating to the reunification of Cyprus. Introduced by Rep. Gus M. Bilirakis (R-FL). Passed the House of Representatives by voice vote on October 9, 2007.

**H. Res. 629** Extending the condolences and sympathy of the House of Representatives to the Government and the people of Greece for the grave loss of life and vast destruction caused by the devastating fires raging through Greece since June 2007. Introduced by Rep. John Sarbanes (D-MD). Passed the House of Representatives on September 5, 2007, 407-0.

**H. Con. Res. 71** Commemorating the 85th Anniversary of the founding of the American Hellenic Educational Progressive Association (AHEPA), a leading association for the Nation's 1.3 million American citizens of Greek ancestry, and Philhellenes. Introduced by Rep. Carolyn B. Maloney (D-NY). Passed the House of Representatives on April 16, 2007, by voice vote. Passed the Senate (S.Con.Res. 14) by unanimous consent on March 19, 2007.

**H. Res. 228** Recognizing the 186<sup>th</sup> anniversary of the independence of Greece and celebrating Greek and American democracy. Introduced by Rep. Ileana Ros-Lehtinen (R-FL). Passed the House of Representatives on March 13, 2007, 413-0. Passed the Senate (S.Res. 95) by unanimous consent on March 13, 2007.

**H. Con. Res. 202** which permits the use of the rotunda of the Capitol for a ceremony to honor Constantino Brumidi on the 200th anniversary of his birth. Introduced by Rep. Bill Pascrell (D-NJ). Passed the House of Representatives by voice vote on July 20, 2005.

**H. Res. 774** This resolution commends the people and Government of Greece for the successful completion of the 2004 Summer Olympic Games. Introduced by Rep. Meehan and cosponsored by Rep. Maloney. Passed the House of Representatives by voice vote on October 4, 2004.

**H. Res. 165** expresses the appreciation of the House of Representatives for the efforts of the United

Nations Secretary General to seek a peaceful, just, and lasting settlement of the Cyprus problem for the benefit of the people of Cyprus and the region. Passed the House of Representatives on April 9, 2003, 422-0.

**H. Con. Res. 188** A concurrent resolution commending Greece and Turkey for their mutual and swift response to earthquakes in both countries by providing each other humanitarian assistance and rescue relief. It also encourages both countries to expand on the good will displayed during the earthquakes in the continuing talks between the two countries to resolve their issues of disagreement. Introduced by Rep. Bilirakis and Rep. Maloney. Unanimously passed the House on October 26, 1999.

**H. Con. Res. 81** A concurrent resolution calling for a United States initiative seeking a just and peaceful resolution of the situation on Cyprus. Introduced by former representative Benjamin Gilman (R-NY). Passed the House on July 22, 1997, 417-4.

**H. Con. Res. 42** A concurrent resolution that specifies projects aimed at reunification of Cyprus. This resolution welcomes the appointment of a Special Presidential Emissary for Cyprus and supports efforts by the United Nations and the U.S. Government to resolve the Cyprus problem. Introduced by Representative Eliot Engel (D-NY). Passed the House on September 18, 1995, by voice vote.

Finally, the State Department has revised its longstanding policy for allocating scholarships for Turkish-Cypriot and Greek-Cypriot students on a roughly equal basis by changing the allocations to 57% for Turkish-Cypriot students and 43% for Greek-Cypriot students.
