Dear Chairwoman DeLauro:

I respectfully request that funding be provided in the FY 2011 Agriculture Appropriations Bill for two high priority projects in the U.S. Virgin Islands. These projects require designated funding from USDA's Natural Resources Conservation Service ("NRCS") / Conservation Operations Program, including (1) \$433,200 in NRCS funding for watershed protection and management on St. Croix and (2) \$345,000 to address the critical need for drainage improvements at the Charles Harwood Health Complex on St. Croix. The designated recipient of both requests is the Government of the U.S. Virgin Islands, Department of Public Works. The projects are summarized as follows:

### **Creque Dam Restoration Project**

Under the NRCS Conservation Operations program, we request \$433,200 for the Creque Dam Restoration water project. The Creque Dam is located three and a half miles north of Fredriksted, St. Croix. The dam was built by the U.S. Navy in 1926 to supplement the water supply to the public water system. In recent years, two major hurricanes and other natural forces have severely degraded the dam and gut feeding the lake. Recent professional assessments have concluded that the basin is covered with at least 40 feet of silt and mud; the dam has a leak, and wildlife resources present in past years have abandoned the site.

The principal work to be funded includes the excavation of mud, silt, and rock from the basin, the construction of erosion control measures, and the installation of well recharge stations. Once these stations are built, the dam is expected to provide water for farmers hard-hit by droughts and other businesses requiring fresh water. The requested funding, in combination with local measures, will facilitate the restoration of the Creque Dam, which was once an essential element of the Fredriksted-area watershed protection plan.

### **Stormwater Drainage Improvements Project at Charles Harwood Health Complex**

Under the NRCS Conservation Operations program, we request \$345,000 for stormwater drainage improvements at the Charles Harwood Health Complex on St. Croix. The Charles Harwood Health Complex is a 91,000-square foot medical facility that serves as the St. Croix Incident Command Post and Emergency Operations Center. The Government of the Virgin Islands is poised to begin Phase III work on hospital improvements, which consists of, among other exterior work, an extensive stormwater drainage project to protect the complex and surrounding areas from environmental and health hazards caused by polluted stormwater runoff. These hazards also threaten the life and integrity of the coral reef system in St. Croix. The requested funding for this project will cover the costs of design, testing, and construction of an efficient water drainage system.
