Health Pledge

This week, I signed a pledge to assure my constituents of the 10th District that I will not vote on the 1,000+ page health care reform bill unless I have read it in its entirety. This pledge also stipulates that the bill is to be posted on the Internet for 72 hours so the public can also read it.

This proposed legislation will potentially change our health care system and tax structure for many years to come. I believe, and doctors in my district believe, that this bill could be very damaging to quality of care and patients' ability to make their own medical decisions. Congress owes it to the American people to examine this bill and read the fine print, and not be forced into rash decisions because of an artificial deadline.

I believe that quality of care and patient choice must ultimately be protected in any reform of our health care system. I am committed to working in a bipartisan manner to achieve an alternative health care solution that does not include a government-run system.

Border Hearing

On Wednesday, the Border Subcommittee of the House Homeland Security Committee held a hearing on Combating Border Violence. I took this opportunity to question representatives from the Bureau of Alcohol, Tobacco, Firearms and Explosives, Immigration and Customs Enforcement (ICE) and the Drug Enforcement Administration (DEA) about their ongoing efforts to curb smuggling and violence along the Southwest Border.

The Financial Services and Related Agencies Appropriations Act

Today, the House passed H.R. 3170 which provides a total spending level of \$24.2 billion—\$1.5 billion more than last year. This spending comes on top of \$7.1 billion of emergency-designated spending in FY 2009. In addition to these staggering spending levels, this bill also contains almost 200 earmarks. Because of this excess in spending, I voted against this legislation.

The Energy and Water Development and Related Agencies Appropriations Act

Today, the House passed H.R. 3183 which provides a total spending level of \$33.3 billion—\$46 million more than last year. Although similar to last year's funding level, this spending comes on top of \$58.7 billion of emergency-designated spending in FY
