I have had an extremely diverse and well-rounded career, which has provided me with the knowledge, experience and skills to serve as the United States Marshal for the Southern District of New York. I have held a progressive series of responsible law enforcement positions throughout my thirty-two year career with the New York State Police (NYSP).

Since 1982, I have held the ranks and positions of Trooper, Sergeant, Station Commander, Investigator, Narcotics Investigator, Senior Investigator, and Lieutenant. As a Trooper, I conducted routine patrol duties and enforced the criminal and traffic laws of New York State. Arresting, securing and transporting prisoners occurred frequently in this position. As a Sergeant, I provided daily oversight for subordinates; and ensured staff was properly trained and that they adhered to proper police procedures. As a Narcotics Investigator while assigned to the multi-agency New York Drug Enforcement Task Force in New York City (NYC), I investigated many high-profile cases involving drug-related homicides which resulted in numerous arrests, as well as seizures of large sums of cash, drugs, vehicles and property.

Since 2007, I have held the position of Lieutenant and have been designated as the Interagency Liaison to the New York Police Department (NYPD). In this position, I work also as the NYSP conduit to numerous law enforcement agencies at the local, state, and federal levels. This position is critical to the daily operations of both the NYSP and the respective interacting agencies. One of my responsibilities is to facilitate, maintain, and strengthen law enforcement relationships by "connecting the interagency dots" to an often complicated NYC network. As a result of my work, the contacts I have made provide an important avenue for an expeditious, unfiltered, and accurate exchange of real-time information on a need-to-know basis. Some of these examples include coordinating and supervising NYSP personnel at high-profile multi-agency security details such as Major League Baseball's All-Star Games at Yankee Stadium in 2008 and CitiField in 2013, the National Football League's Super Bowl XLVIII in 2014, and the 10<sup>th</sup> anniversary ceremony of the World Trade Center 9/11 terror attacks which was attended by President Barack Obama.

My 32 years of experience as a law enforcement supervisor and my relationships with state, local, and federal agencies have allowed me to foster an interlocking trellis between domestic and international agencies. It is my desire that I will continue to protect and serve, while building on the proud tradition of the United States Marshals Service.

In my capacity as Vice President of the Nam Knights MC (a military and law enforcement motorcycle club), I am often involved in overseeing many community activities and fundraisers benefitting those in need of financial assistance, as well as participating in numerous military and law enforcement related fundraisers. I participate in regular food drives benefitting the local food bank (People to People), annual Make-A-Wish Foundation fundraisers granting wishes for children with life-threatening medical conditions, hosting Veterans Appreciation Day at Provident Bank Park, POW-MIA Remembrance Day activities, Watchfire and military/law enforcement ceremonies honoring fallen heroes. I am involved also in arranging military deployment and welcome home escorts, parades and dedication/wreath laying.

From 1997 to 2009, I was the race director for the annual Thanksgiving Day 5-mile "Turkey Trot" road race. This annual event has raised thousands of dollars through the years to benefit a variety of local community charitable efforts, including a Rockland County Police Hispanic Society program to supplement educational scholarships for college-bound students. Under my leadership, the event grew to be the largest single road race in the region with well over two thousand participants. I currently serve also on the North Rockland Community Family Day race committee which raises funds for North Rockland residents who are need of financial assistance. I also regularly volunteer and assist with NYSP Police Benevolent Association (PBA) Signal 30 Benefit Fund and law enforcement 10-13 fundraisers throughout the year benefitting the families of State Troopers, Police Officers and members of law enforcement in general.
