Biometric device? Make sure it is QUALIFIED.

TSA is directed by statute to provide guidance for biometric technology in airport access control systems, as well as establish a qualified list of biometric technologies that meet specified standards. Airport operators are encouraged to use the qualified products list to improve upon their existing access control systems by incorporating biometric technologies.

Manufacturers who wish to have their product(s) tested may apply for consideration by submitting the required documentation, as set forth in the Biometrics for Airport Access Control Guidance Package located on the TSA website. Once it has been determined that all required documentation has been received and that the technology meets the established qualification criteria, an independent testing facility will conduct unbiased testing according to the established test plan. Once testing is complete and a qualification decision is made, the results will be sent to TSA for a final decision as to whether or not the technology will be placed on the qualified product list. Please note, the qualified product list is not a guarantee that your technology will be procured. For more information about Biometrics and TSA please visit www.tsa.gov.



The U.S. Agency for International Development (USAID's) Office of Small Business and Disadvantaged Business Utilization (OSDBU) is responsible for ensuring the inclusion of small and disadvantaged businesses in the rebuilding and recovery of Haiti. They will assist small business in the following ways:

- Appointing Small Business Specialists who are assigned by programmatic area and are available to speak with small businesses interested in doing business with USAID;
- Establishing partnerships with internal customers and the U.S. small businesses to advance the dialogue on USAID activities, procurement procedures and the use of small business;
- Creating awareness of the benefits of working with U.S. small businesses to advance the dialogue on USAID activities, procurement procedures and the use of small business;
- Advising U.S. small businesses on marketing their technical services and products to the USAID and other Federal agencies;
- Conducting market research and maintaining a program to locate capable U.S. small businesses to fulfill USAID acquisition requirements. To be included in this database, please send your capabilities statement to REsourceCenter2@usaid.gov. Inclusion in the database does not replace your need to market your services directly to the Agency; and
- Responding to inquiries and requests advice from the U.S. small businesses on contraction and subcontracting opportunities and other acquisition matters.

- Know your niche and company strengths
- Focus on past performance and work performed for similar agencies
- Know your customer: Review the agency forecast and website
- Contact Prime contactors for potential teaming efforts.
- Don't overlook subcontracting or simplified acquisition options
- Always request a debriefing

Big Money Being Invested in AIT

In the wake of the attempted terrorist attack on December 25, 2009, and the security breaches at Newark and JFK airports earlier this year, it became clear to the public and Congress that vulnerabilities at airports continue to exist and that improved security policies, procedures, and technology are required.

Soon after the White House concluded its preliminary review of the Christmas Day incident, the President directed DHS to pursue "enhanced screening technologies, protocols and procedures, especially in regard to aviation and other transportation sectors." Additionally, the President directed the Department to strengthen international relationships and coordination of aviation security policies.

Secretary Napolitano has announced that, in 2010, 450 AIT screening devices will be deployed to airports across the U.S. in an effort to detect prohibited items including explosives. Earlier this month, the Department announced a 2010 deployment schedule for the first group of AIT machines. This group is part of the 150 machines that the Department purchased last year with American Recovery and Reinvestment Act of 2009 (ARRA) funds. Between funding from ARRA and the FY 2010 Department of Homeland Security Appropriations Act, the Secretary has announced that 450 AIT devices will be deployed at airports nationwide. Additionally, in the President's budget request for FY 2011, DHS requested \$360.03 million for checkpoint support.
