Centers for Disease Control and Prevention: The agency is making funds available through its Community Approaches to Reducing Sexually Transmitted Diseases. The purpose of the program to support the planning, implementation, and evaluation of innovative, interdisciplinary projects to reduce STD disparities, promote sexual health, and advance community wellness using community engagement methods. Department of Education: Grants are available for local educational agencies to improve student reading skills and academic achievement by providing students with increased access to up-to-date school library materials, advanced library media centers and well trained and certified library professionals. Department of Labor: Grants are being made available through the Department of Labor's Employment and Training Administration for faith-based and community organizations to provide pre-release and post-release services to ex-offenders returning to high-poverty communities. National Endowment for the Humanities: Preservation and Access Research and Development grants support projects that address major challenges in preserving or providing access to humanities collections and resources. Eligible projects include the development of technical standards, best practices, and tools for preserving and creating access to humanities collections; the exploration of more effective scientific and technical methods of preserving humanities collections. National Institutes of Health: The objective of this research program is to expand understanding of the role of families and interpersonal relationships in the health and wellbeing of older people by increasing scientific knowledge on the effects of family and interpersonal relationships on behavioral and social processes of relevance to aging. National Institutes of Health: This funding opportunity encourages applications to support educational, mentoring, and career development programs for individuals from underrepresented or health disparity populations. The project helps facilitate the development of a nationwide cohort of scientists and a multi-disciplinary national pool of health disparities investigators with necessary skills to conduct health disparities research. National Institutes of Health: Research Centers in Minority Institutions (RCMI) Program grant. Grants help expand the national capability for research in the health sciences by providing support to minority institutions that offer doctorate degrees in the health professions or in a health-related science. These institutions historically have trained professionals from diverse backgrounds who provide health care to minority populations and are uniquely positioned to engage these populations in research and in the translation of research advances into culturally appropriate, measurable and sustained improvements in health outcomes. Substance Abuse and Mental Health Services Administration: Drug Free Communities Mentoring Program (DFC Mentoring) grants provide funds to existing DFC grantees, so that they may serve as Mentors to newly-formed and/or developing coalitions that have never received a DFC grant. To apply for a DFC Mentoring grant, the Mentor coalition must have been in existence for at least five years (not a DFC grantee for five years) and have an active DFC grant in good standing (cannot be on high-risk) at the time of application and for the duration of the funding cycle. The Substance Abuse and Mental Health Services Administration. The Campus Suicide Prevention Grant program provides resources to institutions of higher education, including public and private institutions, State universities, private four-year colleges and universities, and Minority Serving Institutions of higher learning. The purpose of this program is to facilitate a comprehensive approach to preventing suicide in institutions of higher education. The initiative is designed to assist colleges and universities in their efforts to prevent suicide attempts and completions and to enhance services for students with mental and behavioral health problems, such as depression and substance use/abuse that put them at risk for suicide and suicide attempts.
