#### Amendments (PART II) to H.R. 1—Full Year Continuing Appropriations Act of 2011

H.R. 1, Full Year Continuing Appropriations Act (sponsored by Rep. Harold Rogers, R-KY), is scheduled to be considered on the House floor on beginning Tuesday, February, 15, 2011 under a *modified open rule* ([H.Res.92](#)) that provides one hour of general debate, waives all points of order against the bill, and provides for one motion to recommit. After the conclusion of general debate, the rule provides for each amendment to be considered under the five minute rule. The rule makes in order only those amendments that have been pre-filed in the Congressional Record at least one day before it is considered. Additionally, the rule requires all amendments to be pre-filed in the record by the end of session Tuesday. Finally, the rule waives the requirement for a two-thirds majority for the House to adopt a new, same day rule to limit debate or amendments through February 17, 2011.

### AMENDMENTS PRE-PRINTED IN CONGRESSIONAL RECORD ON TUESDAY FEBRUARY 15, 2011

404. **Walden (R-OR).** The amendment adds a new section to the end of the bill that prohibits any funds in the bill to be used for the FCC to “implement the Report and Order of the Federal Communications Commission relating to the matter of preserving the open [Internet](#) and broadband industry practices (FCC 10-201, adopted by the Commission on December 21, 2010).” Essentially, this amendment prohibits the FCC from moving forward with imposing so-called “[network neutrality](#)” requirements on the private sector.
405. **Thompson (R-PA).** The amendment adds a new section to the end of the bill that would delay by one year the elimination of the first month purchase option for power wheelchairs directed under Obamacare. CBO estimates the delay would cost \$50 million, and the amendment offsets the cost with a 1 percent reduction to the Medicare consumer price index update to standard power wheelchairs.

406. **Welch (D-VT).** The amendment requires for \$15 million of the EPA's Program's and Management Account (\$2.5 billion) to be dedicated for small and rural community technical and compliance assistance authorized under section 1442(e) of the Safe Drinking Water Act (42 U.S.C. 300j-1(e)). Additionally, the bill requires the EPA Administrator to give preference to nonprofit organizations that are most qualified, experienced, effective, and supported by small community water systems in the states.
407. **Hall (R-TX).** The amendment adds a new section to the bill (Sec. 1738) requires the EPA to enter into a contract with the National Academy of Sciences, within 60 days of enactment, "to perform a comprehensive review of non-mercury hazardous air pollutants emitted by electric generating units and industrial boilers, and related health and economic data (including impacts on job creation and energy price, supply, and reliability) associated with potential regulation of such non-mercury hazardous air pollutants. The National Academy of Sciences shall prepare recommendations on appropriate regulatory standards for addressing non-mercury hazardous air pollutants and shall establish appropriate health-based exposure standards for such emissions. Upon completion of the study, the National Academy of Sciences shall report findings and recommendations to the Environmental Protection Agency and the Congress within 24 months of entering into the contract. The Environmental Protection Agency is discouraged from issuing any regulatory determination for non-mercury hazardous air pollutants, including a maximum achievable control technology standard for non-mercury hazardous air pollutants from electric generating units and industrial boilers, until the Environmental Protection Agency fully reviews the results and recommendations of such study."
408. **Clyburn (D-SC).** The amendment adds a new section to the end of the bill that requires that at least 10% of all funds for each of the following accounts in the C.R. are dedicated for assistance in persistent poverty counties. This is defined in the amendment as a county that has had 20 % or more of its population living in poverty over the past 30 years, as measured by the 1990, 2000, and 2010 decennial censuses. The accounts are as follows:

  - ◆ Department of Education, Fund for the Improvement of Postsecondary Education
  - ◆ Department of Labor, Employment and Training Administration, Training and Employment Services
  - ◆ Department of Health and Human Services, Health Resources and Services Administration
  - ◆ Department of Housing and Urban Development, Economic Development Initiative
  - ◆ Department of Justice, Office of Justice Programs
  - ◆ Environmental Protection Agency, State and Tribal Assistance Grants, Water and Wastewater

- ◆ Department of Transportation, Federal Highway Administration, Transportation Community and System Preservation
  - ◆ Department of the Treasury, Community Development Financial Institutions
409. **Price (R-GA).** The amendment adds a new section to the end of the bill that prohibits the use of funds for being used to implement Medical Loss Ratio (MLR) requirements imposed under Obamacare.
410. **Price (R-GA).** The amendment eliminates funding for the Labor Relations Board, Salaries and Expenses by reducing the account by \$233,400,000 and moves this amount to the Spending Reduction Account under Division D—Miscellaneous Provisions.
411. **Price (R-GA).** The amendment adds a new section to the end of the bill, which rescinds \$45 billion in discretionary funding from the bill (exempts DOD, SSA, VA). The amendment requires the Director of the Office of Management to determine and identify which accounts should be reduced and by the amount. The Director is required to submit a report within 60 days of enactment to the Secretary of the Treasury and Congress detailing the accounts and amounts determined and identified for rescission.
412. **Price (R-GA).** The amendment zero's out funding under section 1517 of the C.R. that would allow the Federal Reserve and Bureau of Consumer Financial Protection to transfer or obligate up to \$80 million in funds to carry out provisions of the Dodd-Frank law.
413. **Woolsey (D-CA).** The amendment adds a new section to the end of the bill which prohibits funds being used from the DOD's overseas contingency operations budget for military operations in Afghanistan, until the President to seeks to negotiate and enter into a bilateral status of forces agreement with the Government of the Islamic Republic of Afghanistan.
414. **Bishop (D-NY).** The amendment adds a new section to the end of the bill which prohibits funds being used for the National Bio and Agro-Defense Facility in Manhattan, Kansas.
415. **Edwards (D-MD).** The amendment takes \$200 million of \$300 million in unobligated balances that were rescinded under the EPA, and increases funding for the EPA Tribal Assistance Grants by \$2,816,446,000. The sponsor does not clarify where the rest of the funding is coming from to achieve this increase.
416. **Pallone (D-NJ).** The amendment eliminates the pro rata reduction of \$639,463,000 in all of the Institutes, Centers, and Office of the Director accounts within Department of Health and Human Services, National Institutes of Health.
417. **Issa (R-CA).** The amendment adds a new section to the end of the bill which prohibits funds being used by the National Institutes of Health to study the impact of integral yoga on hot flashes in menopausal women.
418. **Issa (R-CA).** The amendment adds a new section to the end of the bill which prohibits funds being used by the National Institutes of Health to examine the potential impact of a soda tax on population health.

419. **Issa (R-CA).** The amendment adds a new section to the end of the bill which prohibits funds being used by the National Institutes of Health to research the use of marijuana in conjunction with opioid medications, such as morphine.
420. **Issa (R-CA).** The amendment adds a new section to the end of the bill which prohibits funds being used by the Department of Health and Human Services to study condom use skills in adult males.
421. **Issa (R-CA).** The amendment adds a new section to the end of the bill which prohibits funds being used by the Department of Health and Human Services to study the concurrent and separate use of malt liquor and marijuana among young adults.
422. **Issa (R-CA).** The amendment adds a new section to the end of the bill which prohibits funds being used by the National Science Foundation to study whether video games improve mental health for the elderly.
423. **Blackburn (R-TN).** The amendment reduces funds for non-security (exempts DoD, DHS, VA) divisions of the C.R. by 5 percent.
424. **Fortenberry (R-NE).** The amendment adds a new section to the end of the bill which prohibits funds being used to provide any of the following types of assistance to Chad: international military education and training (IMET), foreign military financing (FMF), provision of excess defense articles, foreign military forces capacity assistance (section 1206 of the National Defense Authorization Act for Fiscal Year 2006), and direct commercial sales of military equipment.
425. **Hastings (D-FL).** The amendment increases and subsequently decreases funding for the Agricultural Programs, Agricultural Research Service, Salaries and Expenses account by \$750,000.
426. **Hastings (D-FL).** The amendment increases and subsequently decreases funding for the Agricultural Programs, Animal and Plant Health Inspection, Salaries and Expenses account by \$750,000.
427. **Polis (D-CO).** The amendment adds a new section to the end of the bill which prohibits funds being used for the investigation or criminal prosecution under any state or local law of any person for the manufacture, distribution, dispensation, or possession of marijuana. Additionally, the amendment prohibits the use of funds for the enforcement of any federal law prohibiting the manufacture, distribution, dispensation, or possession of marijuana in jurisdictions where such activity is not prohibited under State or local law.
428. **Polis (D-CO).** The amendment reduces the U.S. Immigration and Customs Enforcement, Salaries and Expenses account by \$200 million, from \$5,399,894,000. Additionally, the amendment strikes language requiring U.S. Customs Enforcement to maintain a level of at least 33,400 detention beds through 2011.
429. **Stearns (R-FL).** The amendment adds a new section to the end of the bill which prohibits the payment of attorney's fees or other legal expenses of any former senior executive officer of the Federal National Mortgage Corporation or Federal Home Loan Mortgage Corporation.

430. **Pitts (R-PA).** The amendment adds a new section to the end of the bill which prohibits the use of funds to pay for the salary of any officer or employee of the Department of Health and Human Services, the Department of Labor, or the Department of the Treasury who takes any action to specify or define, through regulations, guidelines, or otherwise, essential benefits.
431. **Fortenberry (R-NE).** This amendment would reduce the appropriation for “Department of Commerce, Bureau of Census, Periodic Censuses and Programs” by \$44 million and move the amount to the Spending Reduction Account.
432. **McClintock (R-CA).** The amendment reduces the total reductions in the C.R. for the DOE Innovative Technology Loan Guarantee Authority Loan Program from \$25 billion to \$3 billion. The amendment also strikes language from the C.R. that prohibits nuclear power facilities and front-end nuclear facilities to be eligible for the program.
433. **McClintock (R-CA).** The Amendment eliminates the total funding amount of \$586,600,000 to the DOE’s Fossil Energy Research Program and increases the Spending Reduction Account by \$586,600,000.
434. **Holt (D-NJ).** This amendment would reduce the appropriation for the Internal Revenue Service, Taxpayer Services account by \$30 million, from \$2,187,836,000.
435. **Holt (D-NJ).** The amendment removes section 1517. The provision in the C.R. allows the Federal Reserve to restrict funding to carry out provisions of the Dodd-Frank law to \$80 million.
436. **Blumenauer (D-OR).** The amendment adds a new section to the end of the bill which prohibits the use of funds for the Corporation for Public Broadcasting to pay for receptions, parties, or similar forms of entertainment for Government officials or employees: Provided further, That none of the funds made available to the Corporation by this Act shall be available or used to aid or support any program or activity from which any person is excluded, or is denied benefits, or is discriminated against, on the basis of race, color, national origin, religion, or sex: Provided further, That none of the funds made available to the Corporation by this Act shall be used to apply any political test or qualification in selecting, appointing, promoting, or taking any other personnel action with respect to officers, agents, and employees of the Corporation: Provided further, That none of the funds made available to the Corporation by this Act shall be used to support the Television Future Fund or any similar purpose.
437. **Woodall (R-GA).** The amendment prohibits USDA employees from carrying out the Bio Crop Assistance Program by striking the \$112 million limitation in the C.R.
438. **Woodall (R-GA).** The amendment prohibits USDA employees from carrying out the Bio Crop Assistance Program by striking the \$112 million limitation in the C.R and adding language to ensure previously obligated contracts are honored.
439. **Doyle (D-PA).** The amendment adds a section to the end of the bill that directs all Departments funded under the C.R, and have 100 million or more in annual expenditures for extramural research, to have the same policy regarding public access to research results previously established by National Institutes of Health. The amendment allows

each Secretary to designate other suitable online depositories to be used in lieu of the National Library of Medicine's PubMed Central currently serving the NIH.

440. **Mica (R-FL).** The amendment adds a new section to the end of the bill which prohibits the use of funds to be used be used for any recruiting or hiring of personnel into the Transportation Security Administration that would cause the agency to exceed a staffing level of two-thirds of the current staff at headquarters and one-half of the current staff, not including screeners, at regional offices.
441. **Denham (R-CA).** This amendment reduces by \$20 million the total appropriated amount of \$7.428 billion for new obligation authority provided for federal buildings, court houses, and other purposes.
442. **Denham (R-CA).** This amendment adds a new section to the bill prohibiting any funds made available by this Act to be used for high-speed rail in California, for the California High Speed Rail Authority, or for projects designed to further high speed rail in the State of California.
443. **Reichert (R-WA).** This amendment cuts \$150 million from the \$913.7 million total appropriated amount for the Department of Commerce, Bureau of the Census, Periodic Censuses and Programs and transfers this \$150 million authority to the total funding for the Department of Justice, Community Oriented Policing Services.
444. **Reichert (R-WA).** This amendment cuts \$298 million from the \$913.7 million total appropriated amount for the Department of Commerce, Bureau of the Census, Periodic Censuses and Programs and transfers this \$298 million authority to the total funding for the Department of Justice, Community Oriented Policing Services
445. **Kinzinger (R-IL).** This amendment adds a new section to the bill prohibiting any funds made available in this Act to be used to participate in any lawsuit that seeks to invalidate the recently enacted Arizona immigration law that seeks to assist in the enforcement of federal immigrations laws throughout Arizona. (Arizona Revised Statutes amended by Arizona Senate Bill 1070, 49th Leg., 2nd Reg. Sess., Ch. 113 (Az. 6 2010) (as amended by Arizona House Bill 2162, 49th 7 Leg.,2nd Reg. Sess., Ch. 211 (Az. 2010)).
446. **Holt (D-NJ).** This amendment eliminates the \$1.5 billion appropriated for the Iraq Security Forces Fund, which provides assistance from the Commander of the U.S. Forces in Iraq with concurrence of the Secretary of State to the security forces in Iraq. This amount is transferred to the spending reduction account under Division D— Miscellaneous Provisions. Funds transferred into the spending reduction account cannot be allocated elsewhere in the bill.
447. **Holt (D-NJ).** This amendment reduces \$309.5 million appropriated for the Department of Justice, General Administration, Detention Trustee and transfers this amount to the aggregate appropriated level for the Department of Justice, Community Oriented Policing Services.
448. **Holt (D-NJ).** This amendment creates a new section to the bill prohibiting any funds made available by this Act to be used by the Transportation Security Administration for acquisition or deployment of backscatter X-ray full body scanner technology.

449. **Holt (D-NJ).** This amendment cuts \$40 million from the \$117.3 million total appropriated amount for salaries and expenses for the Department of the Interior Office of the Secretary and transfers this \$40 million authority to the total funding for the Department of the Interior, National Park Service, Land Acquisition and State Assistance.
450. **Mack (R-FL).** This amendment adds a new section to the bill prohibiting any funds made available by this Act to be used for carrying out the programs under the National Community Service Act of 1990 (42 USC 12501 et seq.) or Part A of title I of the Domestic Volunteer Service Act (42 USC 4952 et seq.).
451. **Mack (R-FL).** This amendment adds a new section to the bill prohibiting any funds made available by this Act to be used to carry out the American Community Survey (ACS). The ACS is an ongoing survey that provides data every year and administered by U.S. Census Bureau.
452. **Mack (R-FL).** This amendment adds a new section to the bill prohibiting any funds made available by this Act to be used to administer the wage-rate requirements of subchapter IV of chapter 31 of title 40, United States Code, with respect to any project or program funded by this Act.
453. **Mack (R-FL).** This amendment adds a new section to the bill prohibiting any funds made available by this Act to be used for the National Railroad Passenger Corporation.
454. **Mack (R-FL).** This amendment adds a new section to the bill prohibiting any funds made available by this Act to be used to carry out the Elementary and Secondary Education Act of 1965 (20 USC 6301 et seq.).
455. **Mack (R-FL).** This amendment adds a new section to the bill prohibiting any funds made available by this Act to be used to implement or enforce the Report and Order of the Federal Communications Commission relating to the matter of preserving the open Internet and broadband industry practices (FCC 10-201, adopted by the Commission on December 21, 2010).
456. **Mack (R-FL).** This amendment eliminates the total \$145 million of appropriated funds for the National Foundation on the Arts and the Humanities, National Endowment for the Arts, Grants and Administration.
457. **Flake (R-FL).** This amendment cuts \$100 million out of the total \$405 million appropriated for the Community Service Block Grant Act under the Department of Health and Human Services, Administration for Children and Families, Children and Families Services Programs. This amount is transferred to the spending reduction account under Division D—Miscellaneous Provisions. Funds transferred into the spending reduction account cannot be allocated elsewhere in the bill.
458. **Frank (D-MA).** This amendment adds a new section to the bill reducing the amounts made available for the Department of the Treasury, Internal Revenue Service, Enforcement; Department of the Treasury, Internal Revenue Service, Operations Support; General Services Administration, Real Property Activities, Federal Building Fund; General Services Administration, General Activities, Government-Wide Policy by \$77,000,000, \$46,000,000, \$7,000,000, \$1,000,000, and \$131,000,000, respectively and

- transfers these amounts to the amount made available for the Independent Agencies, Securities and Exchange Commission, Salaries and Expenses.
459. **Holt (D-NJ).** This amendment reduces and then immediately reinstates \$700,000 of appropriated funds for the Department of Energy, Energy Programs, Science.
460. **Holt (D-NJ).** This amendment strikes Section 1746 of the Act. This section prohibits appropriating funds to the Environmental Protection Agency for purposes of enforcing or promulgating any regulation (other than with respect to section 202 of the Clean Air Act) or order, taking action relating to, or denying approval of state implementation plans or permits because of the emissions of greenhouse gases due to concerns regarding possible climate change.
461. **Holt (D-NJ).** This amendment creates a new section of the bill that enacts into law the following legislation in the 112<sup>th</sup> Congress: **H.R. 131**, a bill to amend the Internal Revenue Code of 1986 to provide a 5-year extension for the real property standard deduction and to adjust such deduction for inflation; **H.R. 132**, the Create Jobs by Expanding the R&D Tax Credit Act of 2011; **H.R. 133**, the Creating Jobs From Innovative Small Business Act of 2011; **H.R. 134**, a bill to amend the Internal Revenue Code to make permanent the credit for increasing research activities; and **H.R. 135**, a bill to amend the Internal Revenue Code of 1986 to encourage teachers to pursue teaching science, technology, engineering, and math subjects at elementary and secondary schools.
462. **Pearce (R-NM).** This amendment creates a new section of the bill that prohibits any funds made available by this Act to be used for a program for which the authorization expired more than 5 years prior to the date of enactment of this Act.
463. **Pearce (R-NM).** This amendment defunds all appropriations or transfers as they apply to the Patient Protection and Affordable Care Act (Public Law 111-148).
464. **Filner (D-CA).** This amendment creates a new section of the bill reducing by \$40,000,000 the amounts made available for the Department of Housing and Urban Development, Administration, Operations and Management and increasing by this amount the funds available for the Department of Housing and Urban Development, Public and Indian Housing, Tenant-Based Rental Assistance and for activities specified in paragraph (6) under the heading Department of Housing and Urban Development, Public and Indian Housing, Tenant-Based Rental Assistance" of division A of Public Law 111-117.
465. **Poe (R-TX).** This amendment creates a new section to the bill prohibiting any funds made available by this Act to any agency for the implementation, enforcement, or administration of the Individual Mandate in Section 1501 of the Patient Protection and Affordable Care Act (Public Law 111-148), and the amendments made by such section, as amended.
466. **Poe (R-TX):** This amendment creates a new section to the bill prohibiting any funds made available by this Act to implement, administer, or enforce any statutory or regulatory requirement pertaining to emissions of carbon dioxide, methane, nitrous oxide, sulfur hexafluoride, hydrofluorocarbons, or perfluorocarbons from stationary sources that is issued or becomes applicable or effective after January 1, 2011.



467. **Goodlatte (R-VA).** This amendment creates a new section to the bill prohibiting any funds made available by this Act to be used to develop, promulgate, evaluate, implement, provide oversight to, or backstop total maximum daily loads or watershed implementation plans for the Chesapeake Bay Watershed.
468. **Goodlatte (R-VA).** This amendment creates a new section to the bill prohibiting any funds made available by this Act to be used to subsidize wireless service under the Low Income Fund program of the Universal Service Fund.
469. **Goodlatte (R-VA).** This amendment creates a new section to the bill prohibiting any funds made available by this Act to be used for construction of the Richard H. Poff Federal Building in Roanoke, Virginia.
470. **Goodlatte (R-VA).** This amendment creates a new section to the bill prohibiting any funds made available by this Act to be used to carry out title XX of the Public Health Service Act (42 USC 300z, et seq.; relating to adolescent family life demonstration projects).
471. **Goodlatte (R-VA).** The amendment adds a provision to the end of the bill that prohibits funds from being made available by this act from being used to fund non-federal museums.
472. **Jackson Lee (D-TX).** The amendment strikes section 1312 of the C.R that establishes the Department of Justice, Legal Activities, Salaries and Expenses, General Legal Activities at \$865,097,000.
473. **Jackson Lee (D-TX).** The amendment amends section of 1340 of the C.R. to increase funding for the Legal Services Corporation by striking reductions to the account listed in the C.R.
474. **Jackson Lee (D-TX).** The amendment strike section 1342 which rescinds \$1,740,000,000 of the funds made available for ``Department of Commerce, Bureau of the Census, Periodic Censuses and Programs".
475. **Jackson Lee (D-TX).** The amendment strikes section 1605 which reduces the level of funding for Department of Homeland Security, Office of the Federal Coordinator for Gulf Coast Rebuilding to \$0.
476. **Jackson Lee (D-TX).** The amendment strikes section 1649 which rescinds \$106,556,000 of unobligated balances available for Department of Homeland Security, U.S. Customs and Border Protection, Construction for construction projects.
477. **Barletta (R-PA).** The amendment reduces the amount made available for Related Programs, United States Institute of Peace', and increasing the amount made available for Low Income Home Energy Assistance, by \$42,676,000.
478. **Barletta (R-PA).** The amendment reduces the appropriated amount of \$450,000,000 to the Department of Homeland Security, Border Security Fencing, Infrastructure, and Technology by \$60,000,000, and it increases the amount appropriated to U.S. Customs and Border Protection, Salaries and Expenses \$8,212,626,000, by \$60,000,000.

479. **Shuler (D-NC).** The amendment inserts language under Title V: Financial Services and General Government, that gives exceptions for taxpayers who are not small, independent oil and gas company, and creates a rule that all persons treated as a single employer under a) and b) of this title be treated as one person. The amendment also dedicates the funds in this act that are allocated to Head Start program be supplemented an amount equal to the total revenues lost by the general treasury in fiscal year 2010 as a result of tax incentives issued under paragraph (3) of section 469(c) of the Internal Revenue Code of 1986 to entities that meet the exception requirements of subsection (a) of this section.
480. **Shuler (D-NC).** The amendment inserts language under Title V: Financial Services and General Government, that prohibits the amount funds made available for re-contouring of roads, construction of earthen berms or “tank traps” to block roads, or for the decommissioning of any roads within the Roy Taylor area of the Nantahala National Forest in North Carolina.
481. **Franks (R-AZ).** The amendment adds “and that the new Government of Egypt fulfills its commitment to the Egypt-Israel Peace Treaty signed on March 26, 1979, and to freedom of navigation of the Suez Canal” to the end of the language “That any assistance made available to “the Government of Egypt shall be provided with the understanding that Egypt will undertake significant economic and democratic reforms that are additional to those that were undertaken in previous fiscal years.”
482. **Heller (R-NV).** The amendment adds language to the end of the bill that prohibits the funds being made available by this act from being used to designate monuments under the Act of June 8, 1906, (commonly known as the “Antiquities Act of 1906”; 16 U.S.C. 431, et seq.).
483. **Fortenberry (R-NE).** The amendment adds language to the end of the bill that prohibits the funds being made available by this act from being used for or in sterilization campaigns.
484. **Cardozo (D-CA).** The amendment adds language to the end of the bill that prohibits the funds being made available by this act from being used to pay the travel expenses of the Secretary of the Treasury.
485. **Burton (R-IN).** The amendment adds language to the end of the bill that prohibits funds from being used for the gathers and removals of free-roaming wild horses and burros, except for the purpose of fertility control.
486. **Bordallo (D-GU).** The Amendment reduces the appropriated amount of \$865,097,000 to the Department of Justice, Legal Activities, Salaries and Expenses, General Legal Activities by \$29,000,000, and it increases the \$2,850,883,000 amount appropriated to the Department of Commerce, National Oceanic and Atmospheric Administration, Operations, Research, and Facilities by \$29,000,000.
487. **Bordallo (D-GU).** The Amendment reduces the appropriated amount of \$15,055,000 to United States Fish and Wildlife Service, Land Acquisition by \$6,679,000, and it increases the \$78,516,000 amount appropriated to Department of the Interior, Departmental Offices, Insular Affairs, and Assistance to Territories by \$6,679,000.

488. **Bordallo (D-GU).** The amendment strikes “and” at the end of section 220 so it reads “September 30, 2013, of which”. The amendment also inserts “and of which \$24,000,000 shall be for the ground-based augmentation system of the NextGen air traffic control system” behind the sentence reading \$470,000,000 shall remain available through September 30, 2011.
489. **Weiner (D-NY).** The amendment increases the \$290,500,000 amount to the “Department of Justice, Community Oriented Policing Services (Including Transfers of Funds)” by \$501,500,000. The amendment also increases the amount in division B of Public Law 111–117 by this division by substituting:  
 increasing “40,385,000” by “\$25,385,000”;  
 increasing “\$25,385,000” by \$168,723,000  
 Increasing “\$170,223,000” by \$168,723,000;  
 Increasing “\$298,000,000” by \$298,000,000;
- Lastly the amendment reduces the \$3,131,000,000 amount appropriated to “National Aeronautics and Space Administration, Cross Agency Support” by \$501,500,000
490. **Chu (D-CA).** This amendment would increase the maximum Pell grant amount for which a study shall be eligible during the 2011-2012 year.
491. **Woolsey (D-CA).** This amendment would prohibit funding for the Food and Drug Administration to be used to approve any application submitted under section 512 of the Federal Food, Drug, and Cosmetic Act for approval of genetically engineered salmon intended for human consumption.
492. **Holt (D-NJ).** This amendment would reduce funding for the Department of Energy, Energy Programs, Fossil Energy Research and Development by \$133,625,000. The amendment would increase funding to the DOE Office of Science by \$445,625,000, and would reduce funding to the Department of energy, Atomic Energy Defense Activities, National Nuclear Security Administration, Weapons Activities by \$312,000,000.
493. **Holt (D-NJ).** This amendment would strike the limitation on funds to the Department of Energy, Energy Programs, Office of Science.
494. **Holt (D-NJ).** This amendment would increase funding to the Department of the Interior, National Park Service, Land Acquisition and State Assistance by \$40,000,000. It would reduce, by \$40,000,000, the amount for the Department of the Interior Office of the Secretary, Salaries and Expenses.
495. **Hall (R-TX).** This amendment would prohibit funding to be used to implement, establish, or create a NOAA Climate Service (NCS) as described in the “Draft NOAA Climate Service Strategic Vision and Framework” published at 75 Fed. Reg. 57739 (September 22, 2010) and updated on 12/20/2010.
496. **Matheson (D-UT).** This amendment would reduce total funding in this legislation (other than for the Department of Defense and Homeland Security) by \$600,000,000.
497. **Matheson (D-UT).** This amendment would reduce total funding in this legislation (other than for the Department of Defense and the U.S. Postal Service) by \$280,000,000.

498. **Johnson (R-OH).** This amendment would prohibit funding to be used to develop, carry out, implement, or enforce proposed regulations published June 18, 2010 by the Office of Surface Mining Reclamation and Enforcement for the Department of the Interior.
499. **Cardoza (D-CA).** This amendment would prohibit funding to be used to pay the expenses of official travel for the Secretary of the Treasury.
500. **Polis (D-CO).** This amendment would reduce funding for the U.S. Immigration and Customs Enforcement, Salaries and Expenses by \$200,000,000. This amendment would also eliminate the requirement that the U.S. Immigration and Customs Enforcement maintain a level of not fewer than 33,400 detention beds throughout fiscal year 2011. The amendment would then add \$200,000,000 to the Homeland Security Spending Reduction Account.
501. **Polis (D-CO).** This amendment would eliminate funding for the Executive Office of the President and Funds Appropriated to the President, Office of National Drug Control Policy, Salaries and Expenses. This amount was set at \$24,886,000.
502. **Polis (D-CO).** This amendment would eliminate funding for the Executive Office of the President and Funds Appropriated to the President, Office of National Drug Control Policy, Salaries and Expenses. This amount was set at \$24,886,000.
503. **Lamborn (R-CO).** This amendment would add a new section at the end of the bill that would appropriate an amount to the Secretary of Defense that is equal to the difference between: the sum of the amounts authorized to the Department of Defense by division A of the Ike Skelton National Defense Authorization Act for FY 2011, and the sum of the amounts actually appropriated for the Department of Defense by titles I through IX of this continuing resolution. This amendment contains an offset by reducing future appropriations for the executive branch.
504. **Lamborn (R-CO).** This amendment would add a new section at the end of the bill that would appropriate an amount to the Secretary of Defense that is equal to the difference between: the sum of the amounts authorized to the Department of Defense by division A of the Ike Skelton National Defense Authorization Act for FY 2011, and the sum of the amounts actually appropriated for the Department of Defense by titles I through IX of this continuing resolution. This amendment contains an offset by reducing future appropriations for the executive branch.
505. **DeGette (D-CO).** This amendment would reestablish funds for the program under title X of the Public Health Service Act. Funds for this program had been cut by the underlying bill.
506. **Holt (D-NJ).** This amendment would reduce funding for the Department of the Treasury, Internal Revenue Service, Enforcement. This amendment would then increase the amounts provided from the Federal Reserve to the Bureau of Consumer Financial Protection for activities authorized to be carried out by such Bureau under title X of the Dodd-Frank Wall Street Reform and Consumer Protection Act by \$63,000,000.
507. **Akin (R-MO).** This amendment would prohibit funding to be used to terminate liabilities with respect to assault vehicles of the Marine Corps or the Expeditionary Fighting Vehicle.

508. **Bartlett (R-MD).** This amendment would prohibit funding to be used for grant agreements or contracts with research facilities defined in 7 U.S.C. Section 2132(e) if those agreements or contracts allow or encourage the breeding of chimpanzees. These “facilities,” as defined by U.S.C., include schools, institutions, organizations or individuals that intend to use live animals in research, test or experiments. The specific code is [linked here](#).
509. **Connolly (D-VA).** This amendment would increase funding for Agricultural Programs, Farm Service Agency, Agricultural Credit Insurance Fund Program Account to \$2,150,000,000. This funding had been reduced to \$1,975,000,000. This amendment also reinstates funding for the Department of Transportation, Federal Transit Administration, Grants to the Washington Metropolitan Area Transit Authority. Those funds were prohibited by the underlying legislation. Conservatives have long argued against taxpayer subsidies to the Washington Metropolitan Area Transit Authority.
510. **Del. Norton (D-DC).** This amendment would enact the District of Columbia Home Rule Act (sec. 1-206.02(c)(1), D.C. Official Code), the Closing of a Public Alley in Square 0441, S.O. 09-8516, Act of 2010 (D.C. Act 18-0639). This public alley is bounded by T Street N.W. to the North, Wiltberger Street N.W. to the East, 7<sup>th</sup> Street N.W. to the West and S. Street N.W. to the South, this is in Ward 1.
511. **Nadler (D-NY).** This amendment would increase funding for numerous programs under the Department of Transportation, including the: Department of Transportation Federal Aviation Administration Facilities and Equipment; Department of Transportation Office of the Secretary, National Infrastructure Investments; Department of Transportation Federal highway Administration, Surface Transportation Priorities; Department of Transportation Federal Transit Administration Grants for Energy Efficiency and Greenhouse Gas Reductions; Department of Transportation Federal Railroad Administration Railroad Safety Technology Program; Department of Transportation Federal Railroad Administration Capital for High Speed Rail Corridors and Intercity Passenger Rail Service; Department of Transportation Maritime Administration Assistance to Small Shipyards; Department of Transportation Federal Transit Administration Grants to Washington Metropolitan Area Transit Authority; Department of Transportation Federal Transit Administration, Capital Investment Grants; Department of Transportation, Federal Railroad Administration, Rail Line Relocation and Improvement Program, Department of Transportation, Federal Railroad Administration, Capital and Debt Service Grants to the National Railroad Passenger Corporation, Department of Transportation Federal Railroad Administration Capital Assistance for High Speed Rail Corridors and Intercity Passenger Rail Service; Department of Transportation Office of the Secretary, National Infrastructure Investments, Department of Transportation Federal Transit Administration Capital Investment Grants, Department of Transportation Federal Railroad Administration Railroad Safety Technology Program, Department of Transportation Federal Railroad Administration, Capital Assistance to States – Intercity Passenger Rail Service, and the Department of Transportation Federal Transit Administration, Grants for Energy Efficiency and Greenhouse Gas Reductions.
512. **Grimm (R-NY).** This amendment would reduce funding for the National Aeronautics and Space Administration Cross Agency Support by \$195,150,000. It would increase funding for the Department of Health and Human Services, Administration for Children and Families, Low Income Home Energy Assistance by \$195,150,000.

513. **Grimm (R-NY).** This amendment would make underlying reductions to the Department of Transportation, Federal Railroad Administration, Capital Assistance for High Speed Rail Corridors and Intercity Passenger Rail Service not apply to maintenance programs.
514. **Price (D-NC).** This amendment would prohibit funding to be used to enforce requirements in section 34(a)(1)(A) of the Federal Fire Prevention and Control Act of 1974 (15 U.S.C. 2229a(a)(1)(A)). This would allow certain fire department to continue to use grant programs to rehire existing personnel, as opposed to only being used to hire new personnel.
515. **Bishop (R-UT).** This amendment would prohibit funding to be used for the National Landscape Conservation System.
516. **Camp (R-MI).** This amendment would prohibit funding to be used for the opening of the locks at the Thomas J. O'Brien Lock and Dam or the Chicago River Controlling Works.
517. **Fortenberry (R-NE).** This amendment would reduce funding to the Bilateral Economic Assistance, Funds Appropriated to the President, Economic Support Fund by \$200,000,000, and then increase funding by \$200,000,000.
518. **Campbell (R-CA).** This amendment would reduce all funding in the underlying legislation (except for amounts for the Departments of Defense, Homeland Security, and Veterans Affairs) by 5.5%.
519. **Campbell (R-CA).** This amendment would reduce all Department of Defense and Homeland Security funding in the underlying legislation by 3.5%.
520. **Quigley (D-IL).** This amendment would reinstate funding for the Assistant to the President for Energy and Climate Change. This funding is eliminated by the underlying legislation.
521. **Braley (D-IA).** This amendment would allow the Environmental Protection Agency to implement or enforce section 211(o) of the Clean Air Act. This section deals with the regulations of the renewable fuel program. The underlying legislation prohibits funding to be used for enforcing or promulgating any regulation due to concerns regarding possible climate change.
522. **Del. Bordallo (D-GU).** This amendment would reduce funding for the Agricultural Programs, Agricultural Marketing Service, Marketing Services by \$5,000,000. The amendment would increase funding for Agricultural Programs, National Institute of Food and Agriculture, Research and Education Activities by \$5,000,000.
523. **Paul (R-TX).** This amendment would eliminate funding for the International Security Assistance, Funds Appropriated to the President, Pakistan Counterinsurgency Capability Fund (set at \$1,000,000,000 by the underlying text). It would also eliminate funding for the International Security Assistance, Funds Appropriated to the President, Foreign Military Financing Program (set at \$5,385,000,000 by the underlying text). This amendment would also eliminate grants to Israel and Egypt (set at \$1,300,000,000 and \$300,000,000 by the underlying text). It would eliminate funds to the International

- Security Assistance, Funds Appropriated to the President, Foreign Military Financing Program (set at \$789,000,000 by the underlying text). The Spending Reduction Accounts for State, Foreign Operations, and Related Programs would be increased by \$1,000,000,000, and then \$5,385,000,000.
524. **Conyers (D-MI).** This amendment would prohibit funding to be used under section 501 of the Foreign Intelligence Surveillance Act, for an order requiring the production of library circulation records, library patron lists, book sales records, or book customer lists.
525. **Schweikert (R-AZ).** This amendment states that in the event that the debt limit is reached, the Department of the Treasury shall tender the principal and interest on debt held by the public shall take priority over all other obligations.
526. **Wu (D-OR).** This amendment would prohibit funding to be used by the Federal Energy Regulatory Commission to site, construct, expand, or operate liquid natural gas facilities (LNG).
527. **Deutch (D-FL).** This amendment reduces the amount provided for the Department of Housing and Urban Development, Management and Administration, Administration, Operations and Management by \$25,000,000. The amendment then increases funding for the Department of housing and Urban Development, Community Planning and Development, Community Development Fund by \$25,000,000. The amendment also states that these funds are to be allocated to states and local government that show significant numbers of homes affected by problem drywall as defined by the Consumer Product Safety Commission. These funds shall be exempt from the national objective and overall low-and moderate-income benefit requirements. In administering these funds, the Secretary may waive or specify alternative requirements for any provision of any statute or regulation in connection with the obligation or the use of such funds except for requirements related to fair housing, nondiscrimination, labor standards, and the environment, upon a finding that such a waiver is necessary to expedite or facilitate the use of such funds.
528. **Carter (R-TX).** This amendment would prohibit funding to pay the salary or expenses of any of the following positions: Senior Advisor to the Secretary of the Treasury Assigned to the Presidential Task Force on the Auto Industry; Assistant to the President for Homeland Security and Counterterrorism; Assistant to the President for Energy and Climate Change; White House Director of Urban Affairs; Associate Director, Technology Policy, Office of Science and Technology Policy; Senior Advisor, Environmental Protection Agency, Great Lakes Restoration Plan; Director, White House Office of Health Reform; Chair of the Recovery Accountability and Transparency Board; Special Counsel to the President for Ethics and Government Reform; Intellectual Property Enforcement Coordinator; Special Master for TARP Executive Compensation, Department of the Treasury; Special Envoy To Oversee the Closure of the Detention Center at Guantanamo Bay; Special Envoy for Sudan; Special Representative for Afghanistan and Pakistan; Chairman, Council on Jobs and Competitiveness; Special Advisor for Green Jobs, Enterprise and Innovation, Council on Environmental Quality; Associate General Counsel and Chief Diversity Officer, Federal Communications Commission; Special Envoy for the Middle East; Director of Recovery for Auto Communities and Workers; Special Advisor for the Persian Gulf and Southwest Asia; Special Assistant and Senior Director to the President and Weapons of Mass Destruction Coordinator; Assistant to the President and Special Advisor to the Secretary of the

Treasury on the Bureau of Consumer Financial Protection; Deputy Director for Management, Office of Management and Budget; and the Special Envoy to Monitor and Combat Anti-Semitism.

529. **Alexander (R-LA).** This amendment would direct the Administrator of the Federal Emergency Management Agency, during FY 2011, to not use the assumption that a current existing levee or flood control structure does not exist to designate an area as having new flood hazards pursuant to issuance, revision, updating, or other process to implement changes in flood insurance maps, except in cases where no affected community notifies the Federal Emergency Management Agency of objections to the Administrator's hazard modeling processes within 90 days of enactment of this act.
530. **Nunes (R-CA).** This amendment would insert a new section at the end of the bill providing that the amount otherwise provided by this act for the Mid-Pacific Region of the Bureau of Reclamation within the Water and Related Resources account is hereby reduced by \$72,000,000. The Mid-Pacific Region requested \$214,421,000 for [FY 2011](#), but is not mentioned specifically elsewhere in the C.R.
531. **Nunes (R-CA).** This amendment would insert language after the funding level language for “Department of the Interior, Bureau of Reclamation, Water and Related Resources” providing that the amount otherwise provided by this section for the Mid-Pacific Region of such Bureau is hereby reduced by \$72,000,000. The Mid-Pacific Region requested \$214,421,000 for [FY 2011](#), but is not mentioned specifically elsewhere in the CR.
532. **Young (R-AK).** This amendment would strike the language in section 1825 that provides that no funds shall be available for educational programs authorized under the [Native Hawaiian Education Act](#) or [Alaska Native Educational Equity, Support, and Assistance Act](#).
533. **Young (R-AK).** This amendment would insert a new section at the end of the bill prohibiting the use of any funds provided in this Act by the Environmental Appeals Board to consider, review, reject, remand, or otherwise invalidate any permit issued for Outer Continental Shelf sources located offshore of the States along the Arctic Coast under section 328(a) of the Clean Air Act ([42 U.S.C. 7627\(a\)](#)).
534. **Royce (R-CA).** This amendment would insert a new section at the end of the bill reducing the amount made available by this Act for motor vehicles for all civilian agencies by 20 percent.
535. **Scott (D-VA).** This amendment would reduce the appropriation for “Department of Justice, General Administration, Detention Trustee” by \$100 million, and increase the appropriation for “Department of Justice, Office of Justice Programs, Juvenile Justice Programs” by \$100 million.
536. **Welch (D-VT).** This amendment would insert a new section at the end of the bill that would reduce the amount appropriated for “Operation and Maintenance, Defense-Wide” by \$150 million, and increase the amount appropriated for “Operation and Maintenance, Army National Guard” by \$150 million.



537. **Welch (D-VT).** This amendment would reduce the amount appropriated for “Operation and Maintenance, Defense-Wide” by \$150 million, and increase the amount appropriated for “Operation and Maintenance, Army National Guard” by \$150 million.
538. **Welch (D-VT).** This amendment would insert a new section at the end of the bill providing that none of the funds made available by this Act may be used by the Secretary of Education to contract with non-profit servicers for Federal Direct Loan aid to higher education students.
539. **Sensenbrenner (R-WI).** This amendment would insert a new section at the end of the bill providing that none of the funds made available by this Act may be used by the Department of Transportation for any program to check helmet usage or create checkpoints for motorcycle drivers or riders.
540. **LaTourette (R-OH).** This amendment would strike the entirety of the CR and substitute itself. The substitute cuts over \$100 billion, and does so through “across the board” cuts, instead of targeted program reductions and eliminations. It retains 302(b) spending limits set by the Appropriations Committees for 11 spending bills, protects the Veterans Benefits Administration and Veterans Housing Administration from cuts, and retains the base funding levels in the C.R. for Defense and Military Construction.
541. **Castor (D-FL).** This amendment would strike section 1327, which sets the funding level for “Department of Commerce, National Oceanic and Atmospheric Administration, Operations, Research and Facilities.” The section also provides that the set-aside for specific projects contained in the [Consolidated Appropriations Act of 2010](#) shall not apply.
542. **Castor (D-FL).** This amendment would strike the portion of section 1819 that sets aside \$6,151,783,000 for the Head Start Act from the \$7,796,499,000 appropriated to “Department of Health and Human Services, Administration for Children and Families, Children and Families Services Programs.”
543. **Mica (R-FL).** This amendment would insert a new section at the end of the bill providing that none of the funds made available by this Act may be used for any recruiting or hiring of personnel into the Transportation Security Administration that would cause the agency to exceed two-thirds of the current employees at headquarters or one-half of the current non-screener workforce at regional offices.
544. **Castor (D-FL).** This amendment would strike section 1607, which provides a funding level of \$341,575,000 for “Department of Homeland Security, U.S. Customs and Border Protection, Automation Modernization” and sets aside \$153,090,000 for the “Automated Commercial Environment.”
545. **Pompeo (R-KS).** This amendment would insert a new section at the end of the bill providing that none of the funds made available by this Act to carry out the activities of [15 U.S.C. 2055a](#), which authorizes the Consumer Product Safety Commission to create a consumer product safety information database.
546. **Pompeo (R-KS).** This amendment would insert a new section at the end of the bill providing that none of the funds made available by this Act may be used by the Consumer Product Safety Commission to promulgate, implement, administer, or enforce

a final rule relating to testing and labeling for requirements for product certification of children's toys based on the proposed rule published in the Federal Register on [May 20, 2010](#).

547. **Pompeo (R-KS).** This amendment would insert a new section at the end of the bill providing that none of the funds made available by this Act may be used by the Consumer Product Safety Commission to publish a notice of requirements for accreditation of third party conformity assessment bodies for testing the conformity of products with section 106 or 108 of the [Consumer Product Safety Improvement Act of 2008](#) or rules promulgated under either such section. Those sections pertain to mandatory toy safety standards and a prohibition on the sale of children's toys containing more than .1% of certain [phthalates](#).
548. **Jones (R-NC).** This amendment would insert a new section at the end of the bill providing that none of the funds made available by this Act may be used to develop or approve a new limited access privilege program (as described in [16 U.S.C. 1853a](#)) for any fishery under the jurisdiction of the South Atlantic, Mid-Atlantic, New England, or Gulf of Mexico Fishery Management Council.
549. **Welch (D-VT).** This amendment would insert a provision in section 1269 that would require the Secretary of Agriculture to transfer an additional \$149 million in addition to the \$112 million already provided for "Related Agencies and Food and Drug Administration, Independent Agencies, Commodity Futures Trading Commission."
550. **King (R-IA).** This amendment would reduce the amount appropriated for "Department of Health and Human Services, Centers for Disease Control and Prevention, Disease Control, Research, and Training" by \$750 million, and increase the Labor, Health and Human Services, Education, and Related Agencies Spending Reduction Account by \$750 million.
551. **King (R-IA).** This amendment would reduce the amount appropriated for "Department of Health and Human Services, Centers for Disease Control and Prevention, Disease Control, Research, and Training" by \$750 million, and increase the Labor, Health and Human Services, Education, and Related Agencies Spending Reduction Account by \$750 million.
552. **Schrader (D-OR).** This amendment would insert a new section at the end of the bill which would amend the funding levels for agencies and accounts under the Commerce, Justice, and Science Appropriations Act to 89% of 2010 levels; for agencies and accounts under the Defense Appropriations Act to 101% of 2010 levels; for agencies and accounts under the Department of Homeland Security Appropriations Act to \$42,517,000,000; Military Construction and Veterans Affairs Appropriations Act to \$74,682,000,000; and all other Appropriations Acts contained in the CR to 96% of FY 2010 levels.
553. **McMorris Rodgers (R-WA).** This amendment would insert a new section at the end of the bill providing that none of the funds made available by this Act may be used to pay the salaries of employees of the Treasury Department to implement the individual mandate, employer mandate, or free choice voucher requirements for employers from ObamaCare.

554. **Price (R-GA).** This amendment would insert a new section at the end of the bill that states “It is the sense of the House of Representatives that the current budgetary framework as provided for in the Congressional Budget and Impoundment Control Act of 1974 and subsequent Acts should be repealed and replaced with a new framework which forces Congress to balance the budget; relies on zero-growth based budgeting; sets forth binding spending limits; makes it easier to review and eliminate federal programs and agencies; and narrows the criteria for designating emergency spending.”
555. **Boustany (R-LA).** This amendment would exempt conditional loan guarantee commitments from the reduction of the limit by \$25 billion in the total principal amount authorized for commitments to guarantee loans by the “Department of Energy, Title 17 Innovative Technology Loan Guarantee Authority Loan Program.”
556. **Pearce (R-NM).** This amendment would, under Title VII—Interior, Environment, and Related Agencies, eliminate the appropriation of \$2,590,000 for “Bureau of Land Management, Construction,” eliminate the appropriation of \$2,750,000 for “Bureau of Land Management, Land Acquisition,” eliminate the appropriation of \$23,737,000 for “United States Fish and Wildlife Service, Construction,” eliminate the appropriation of \$15,055,000 for “United States Fish and Wildlife Service, Land Acquisition,” eliminate the appropriation of \$171,713,000 for “National Park Service, Construction,” eliminate the appropriation of \$14,100,000 for “National Park Service, Land Acquisition and State Assistance,” and eliminate the appropriation of \$9,100,000 for “Department of Agriculture, Forest Service, Land Acquisition.” Those reductions would be applied as an increase to the Interior, Environment, and Related Agencies Spending Reduction Account of \$239,045,000.
557. **Gardner (R-CO).** This amendment would insert a new section at the end of the bill providing that none of the funds made available in this Act may be used by the Environmental Protection Agency to propose, finalize, implement, or enforce any regulation under authorities granted in the [Toxic Substances Control Act](#) that includes [firearms](#) or [sporting goods](#).
558. **Alexander (R-LA).** This amendment would insert a new section stating that FEMA may not use the assumption that a currently existing levee or flood control structure does not exist to designate an area as having new flood hazards pursuant to issuance, revision, updating, or any other process to implement changes in flood insurance maps used under the national flood insurance program, except in cases where no affected community notifies the Agency within 90 days of the enactment of the CR.
559. **Alexander (R-LA).** This amendment would insert a new section at the end of the bill providing that none of the funds made available in this Act may be used to designate an area protected by a currently existing levee or flood control structure as having new flood hazards pursuant to issuance, revision, updating, or any other process to implement changes in flood insurance maps used under the national flood insurance program, except in cases where no affected community notifies FEMA of objections to the hazard modeling processes within 90 days of the enactment of the CR.
560. **Flores (R-TX).** This amendment would reduce the amount appropriated to “White House, Salaries and Expenses” by \$4,530,000, the amount to “Executive Residence at the White House, Operating Expenses” by \$332,000, the amount to “White House Repair and Restoration” by \$405,000, the amount to “National Security Council, Salaries

- and Expenses” by \$2,979,000, the amount to “Office of Administration, Salaries and Expenses” by \$17,771,000, the amount to “Office of Management and Budget, Salaries and Expenses” by \$10,220,000.
561. **Peters (D-MI).** This amendment would insert a new section at the end of the bill that prohibits funds from being used by the Animal and Plant Health Inspection Service to conduct lethal wildlife control activities under the Wildlife Services program for the purpose of protecting livestock, crops or other agricultural interests. It would also reduce the appropriation for “Agricultural Programs, Animal and Plant Health Inspection Service, Salaries and Expenses” by \$28 million.
562. **Reyes (D-TX).** This amendment would increase the appropriation for “Department of Homeland Security, U.S. Customs and Border Protection, Salaries and Expenses” by \$60 million, and reduce the appropriation for “Department of Homeland Security, U.S. Customs and Border Protection, Border Security Fencing, Infrastructure, and Technology” by \$60 million.
563. **Noem (R-SD).** This amendment would insert a new section at the end of the bill providing that none of the funds made available in this Act may be used to modify the national primary ambient air quality standard or the national secondary ambient air quality standard applicable to coarse particulate matter under [section 109](#) of the Clean Air Act.
564. **Bass (R-NH).** This amendment would reduce the appropriation for “Department of Health and Human Services, Substance Abuse and Mental Health Services Administration, Substance Abuse and Mental Health Services” by \$98 million; increase the appropriation for home energy assistance needs arising from a natural disaster or other emergency under the heading “Department of Health and Human Services, Administration for Children and Families, Low Income Home Energy Assistance” by \$50 million; and increase the Labor, Health and Human Services, and Education Spending Reduction Account by \$48 million.
565. **Bass (R-NH).** This amendment would reduce the appropriation for “Department of Health and Human Services, Substance Abuse and Mental Health Services Administration, Substance Abuse and Mental Health Services” by \$98 million, and increase the appropriation for home energy assistance needs arising from a natural disaster or other emergency under the heading “Department of Health and Human Services, Administration for Children and Families, Low Income Home Energy Assistance” by \$50 million.
566. **Boren (D-OK).** This amendment would insert a new section at the end of the bill providing that none of the funds made available by this Act may be used to require a person to report information to the Department of Justice regarding the sale of multiple rifles or shotguns to the same person.
567. **Hayworth (R-NY).** This amendment would insert a new section at the end of the bill prohibiting funds to be used to implement section 3403 of the Patient Protection and Affordable care Act, which creates an Independent Medicare Advisory Board.
568. **Issa (R-CA).** This amendment would insert a new section at the end of the bill providing that none of the funds made available by this Act may be used to provide grants (as

defined in [Sec. 6302 and 6304](#) of Title 31 U.S.C). Grants allocated under a statutory formula or grants to states, territories, tribal areas, D.C., outlying areas and freely associated states would be exempt from the amendment's prohibition.

569. **Issa (R-CA).** This amendment would insert a new section at the end of the bill providing that none of the funds made available by this Act may be used to fund periodic step-increases in pay for federal employees as described in [Section 5335](#) of Title V of the United States Code.
570. **Matheson (D-UT).** This amendment would insert a new section at the end of the bill reducing the amount made available by this Act for motor vehicles for all civilian agencies by 20 percent.
571. **Hultgren (R-IL).** This amendment would insert a new section authorizing the Department of Energy to proceed with “the new experiments requested” for the High Energy Physics program.
572. **Rush (D-IL).** This amendment would require that the first \$100 million in funding appropriated under the header “Department of Health and Human Services, Health Resources and Services Administration, Health Resources and Services” be expended on the Trauma Service Availability Grants that originated in ObamaCare.
573. **Cooper (D-TN).** This amendment would insert a new section at the end of the bill which would amend the funding levels for agencies and accounts under the Homeland Security Appropriations Act to 100% of FY 2010 levels; for agencies and accounts under the Labor, Health and Human Services, and Education Appropriations Act to 95% of FY 2010 levels (except for Pell Grants, which would receive 100% of FY 2010 levels); for agencies and accounts under the Military Construction and Veterans Affairs Appropriations Act to 100%; and all other Appropriations Acts contained in the CR (except Defense) to 95% of FY 2010 levels.
574. **Pearce (R-NM).** This amendment would insert a new section at the end of the bill providing that none of the funds made available by this Act may be contributed to the Intergovernmental Panel on Climate Change (IPCC).
575. **Rehberg (R-MT).** This amendment would insert a new section at the end of the bill providing that none of the funds made available by this Act under the Title appropriating funds for Labor, Health and Human Services, and Education may be paid to any employee, officer, contractor, or grantee of any department or agency to implement any provisions of ObamaCare.
576. **Eshoo (D-CA).** This amendment would insert a new section at the end of the bill providing that none of the funds made available by this Act may be used to enter into any contract with a corporation or other business entity that does not disclose their political contributions.
577. **Price (R-GA).** This amendment would insert a new section at the end of the bill providing that none of the funds made available by this Act may be used to pay salaries and expenses of personnel to carry out and implement Title X (Bureau of Consumer Financial Protection) of the Dodd-Frank Wall Street Reform and Consumer Protection Act.

- 578. **Price (R-GA).** This amendment would insert a new section at the end of the bill providing that none of the funds made available by this Act may be used to pay the salaries and expenses of personnel to carry out and implement the National Labor Relations Act.
  
- 579. **Jackson Lee (D-TX).** This amendment would strike Section 1649, which rescinds \$106,556,000 in unobligated balances available for "Department of Homeland Security, U.S. Customs and Border Protection, Construction" for construction projects.
  
- 580. **Jackson Lee (D-TX).** This amendment would strike Section 1605, which provides for no funding for "Department of Homeland Security, Office of the Federal Coordinator for Gulf Coast Rebuilding."
  
- 581. **Jackson Lee (D-TX).** This amendment would strike Section 3002, which prohibits any Federal agency administering funds provided by division A of the American Recovery and Reinvestment Act of 2009 (Public Law 111– 12 5) from providing funding or reimbursement to any entity awarded funds from such Act for the cost associated with physical signage or other advertisement indicating that a project is funded by such Act.
  
- 582. **Jackson Lee (D-TX).** This amendment would strike Section 3001, which rescinds all unobligated balances remaining as of February 11, 2011, of the discretionary appropriations provided by division A of the American Recovery and Reinvestment Act (Stimulus Bill). The rescissions provided for by the section do not apply to funds appropriated or otherwise made available to Offices of Inspector General and the Recovery Act Accountability and Transparency Board.
  
- 583. **Tom Reed (R-NY).** This amendment would insert a new section at the end of the bill providing that none of the funds made available by this Act may be used to provide Overseas Comparability Pay Adjustments for any member of the Foreign Service serving abroad.
